



Morgan Asset Management for December 31, 2021. Current next 12-months consensus earnings estimates are \$228. Average P/E and standard deviations are calculated using 25 years of IBES history. Shiller's P/E uses trailing 10-years of inflation-adjusted earnings as reported by companies. Dividend yield is calculated as the next 12-months consensus dividend divided by most recent price. Price-to-book ratio is the price divided by book value per share. Price-to-cash flow is price divided by NTM cash flow. EY minus Baa yield is the forward earnings yield (consensus analyst estimates of EPS over the next 12 months divided by price) minus the Moody's Baa seasoned corporate bond yield. Std. dev. over-/under-valued is calculated using the average and standard deviation over 25 years for each measure. *P/CF is a 20-year average due to cash flow availability.

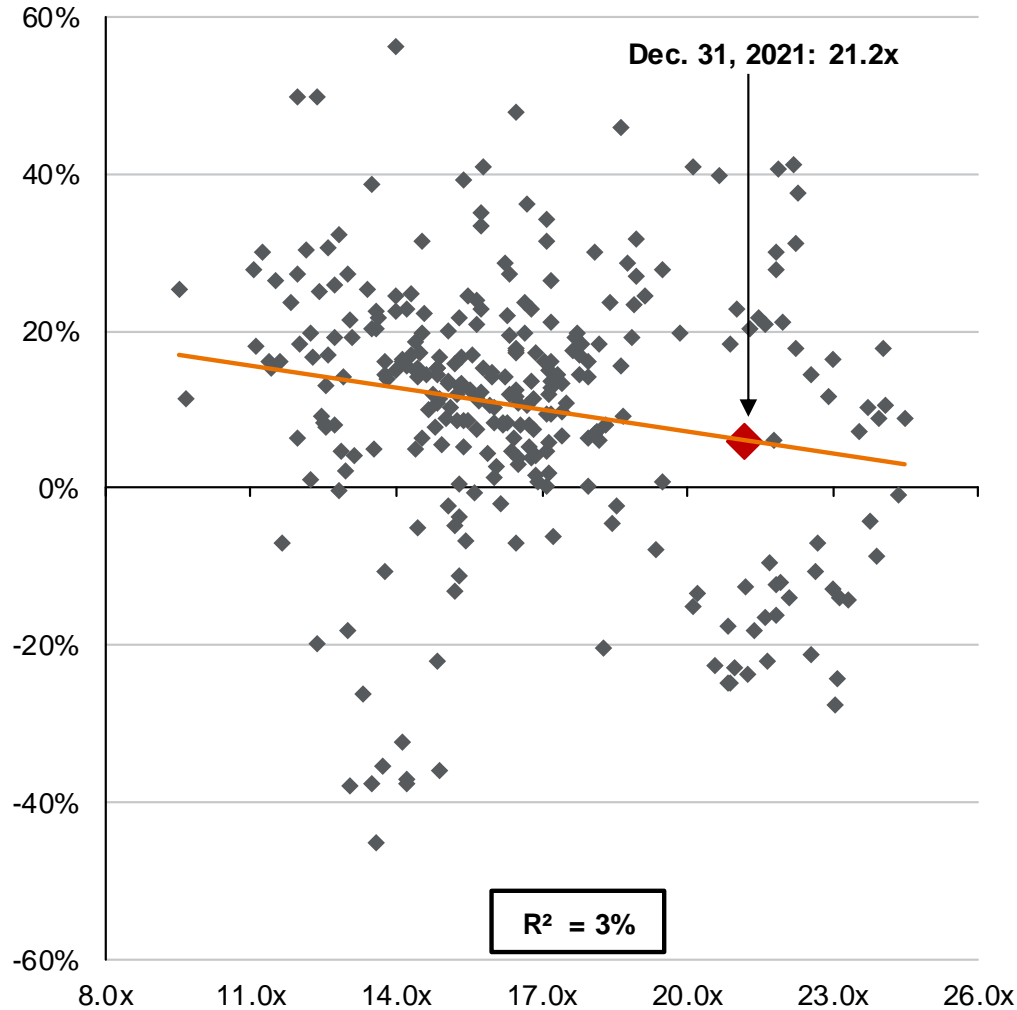

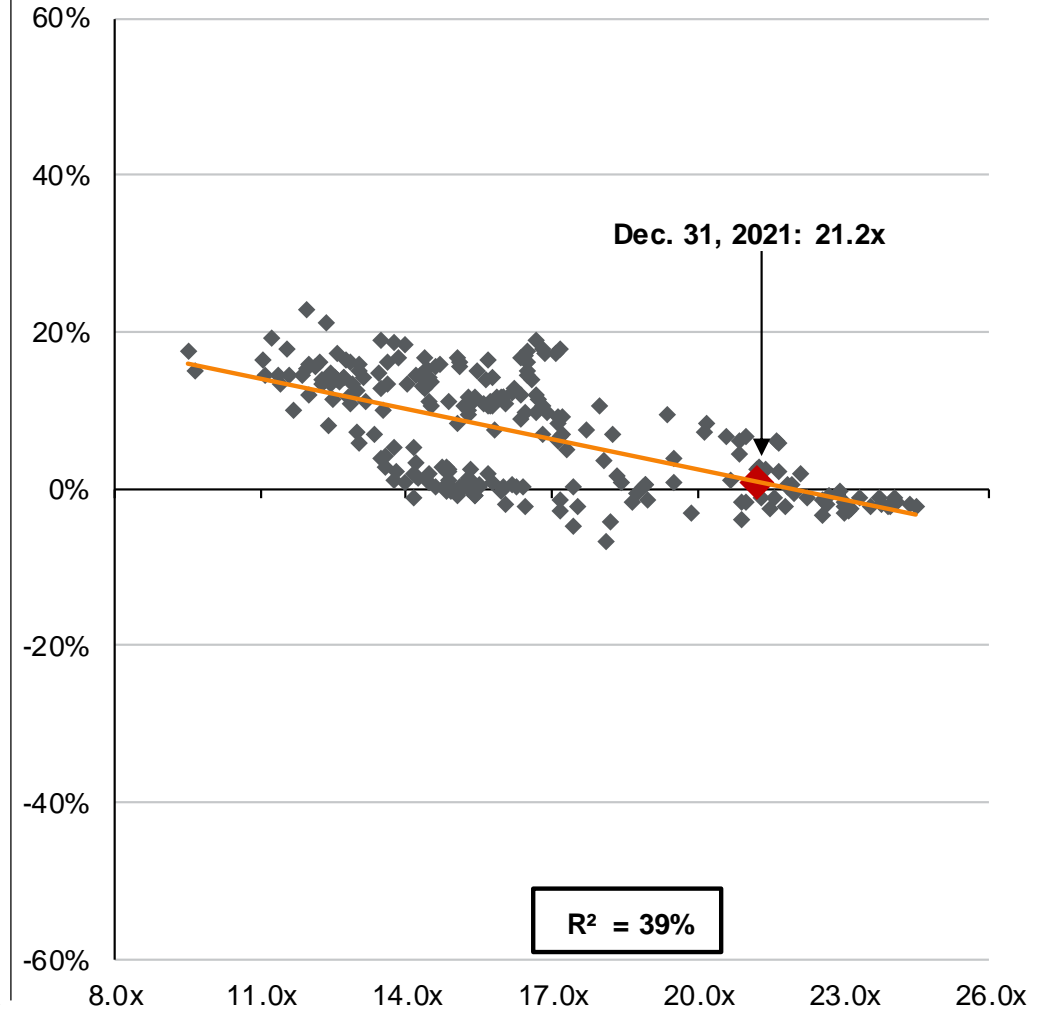
Forward P/E and subsequent 1-yr. returns

S&P 500 Total Return Index



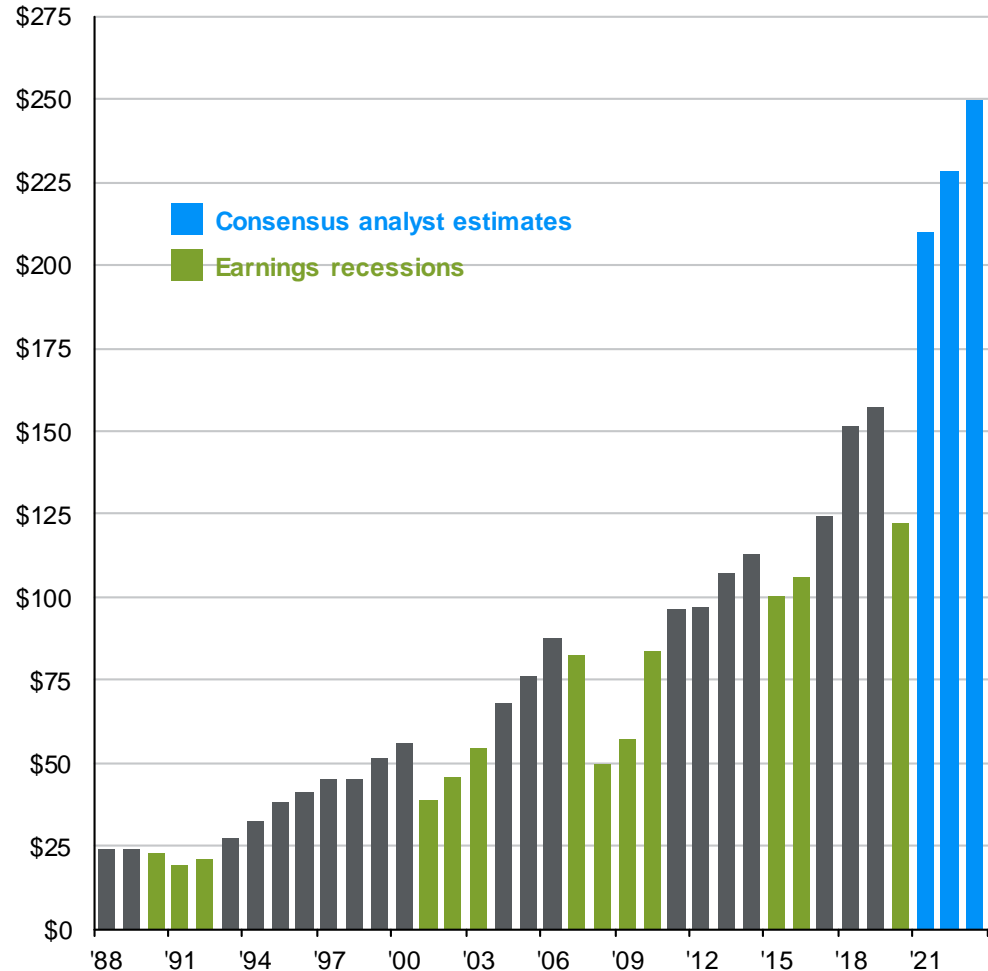

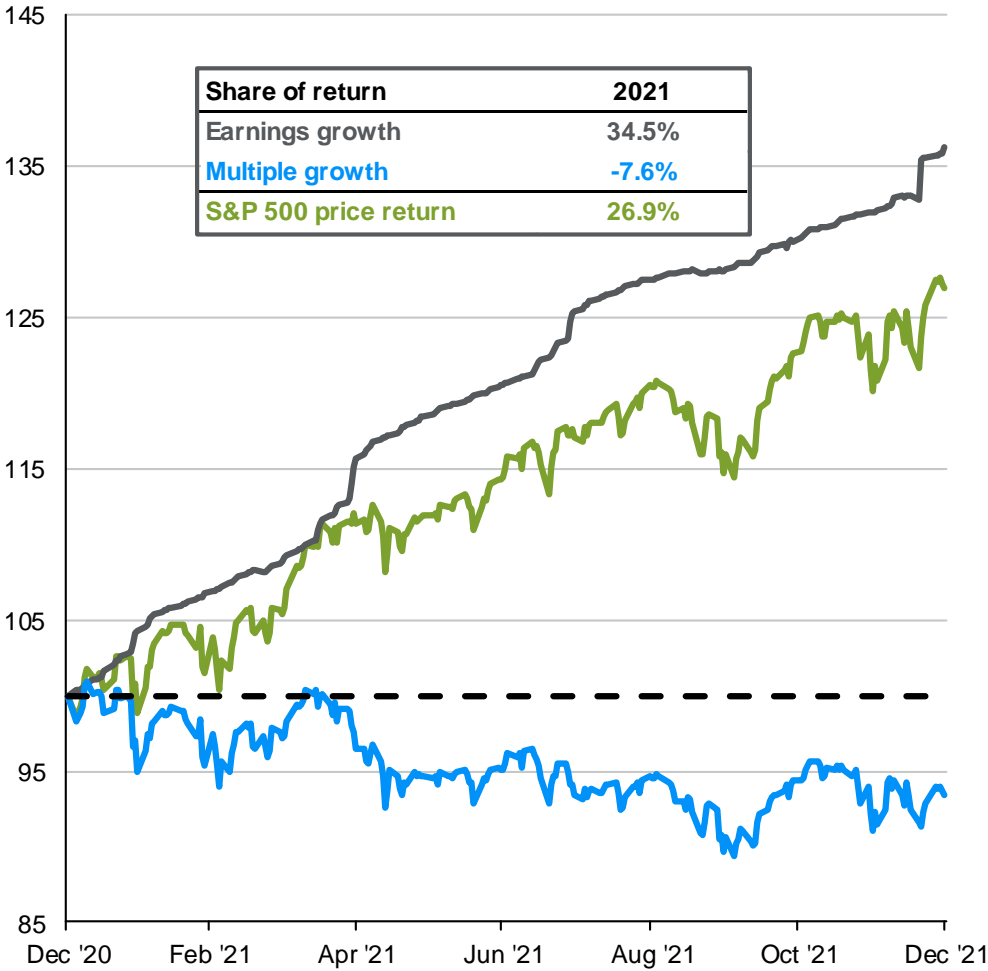
S&P 500 earnings per share

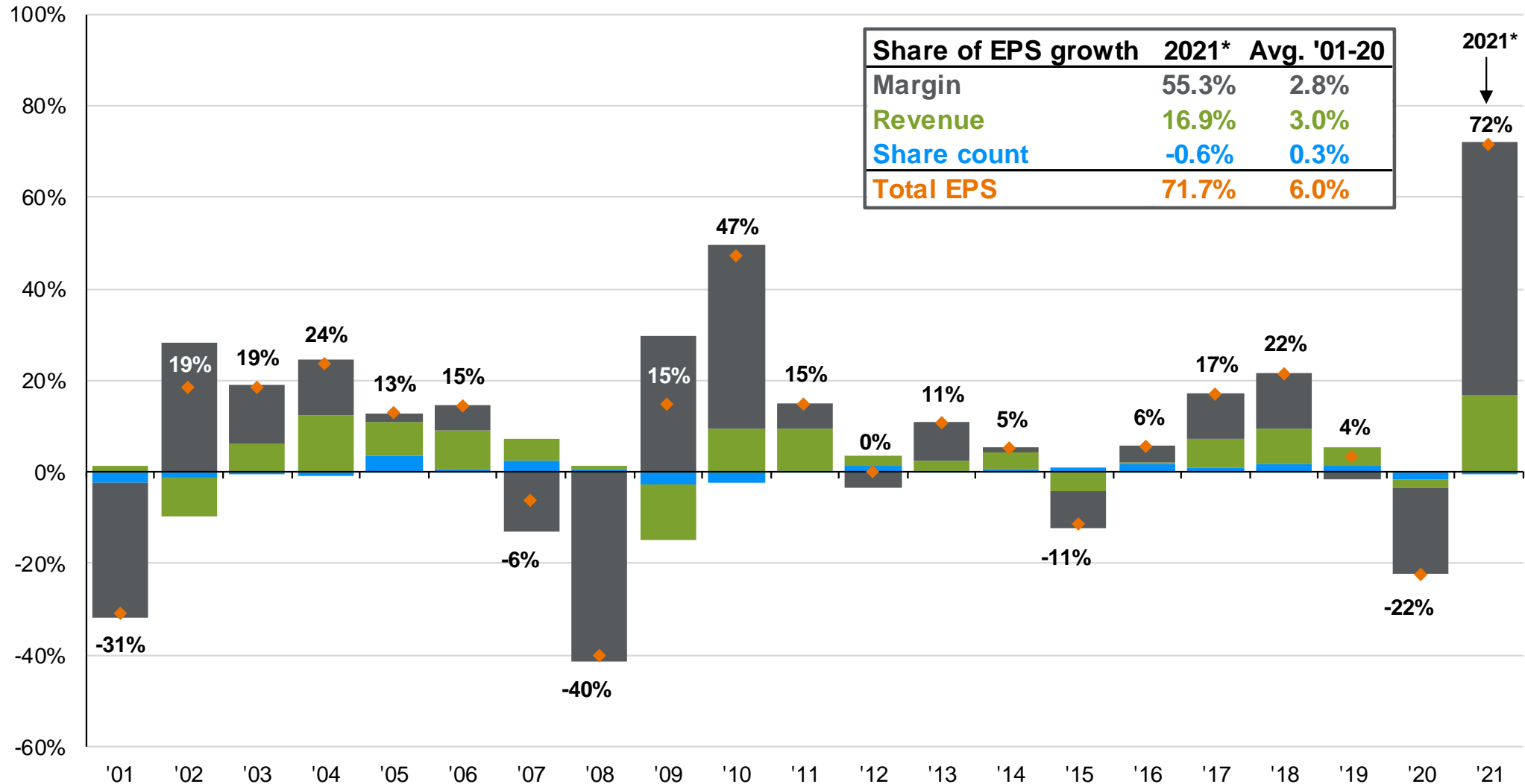

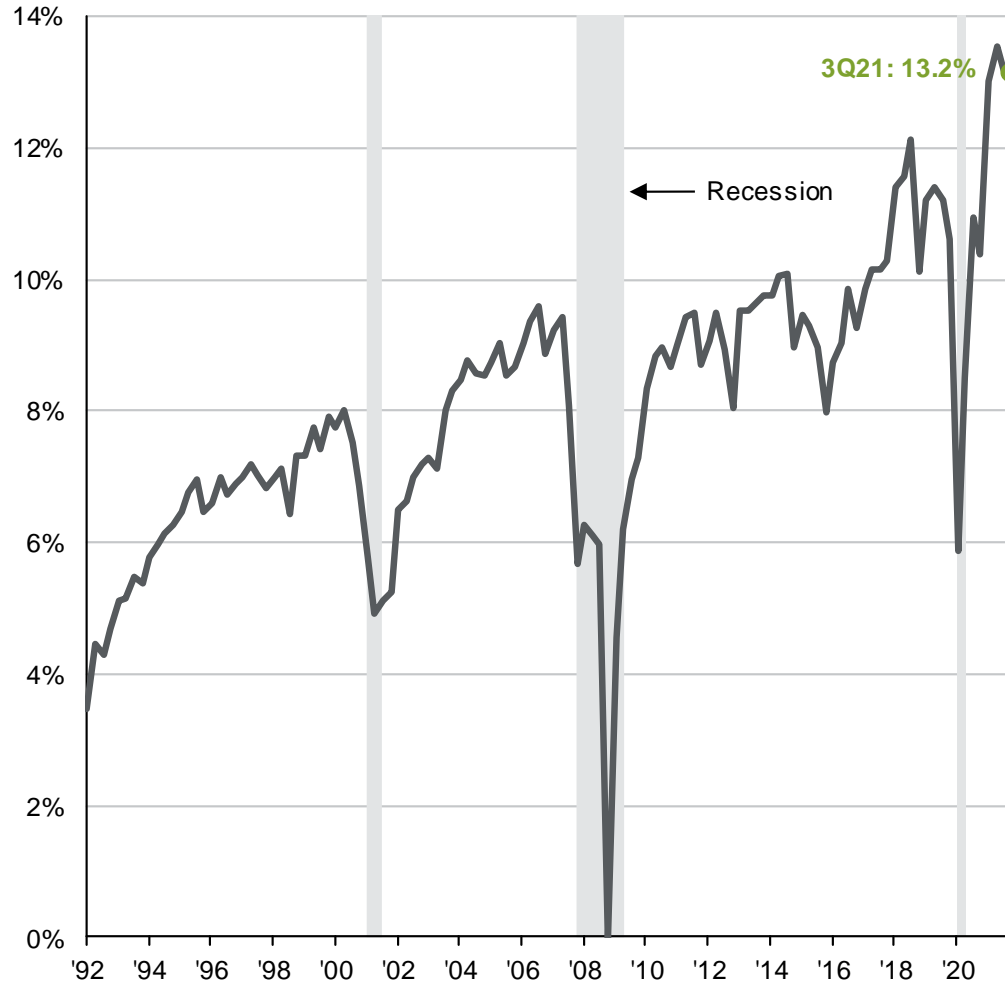

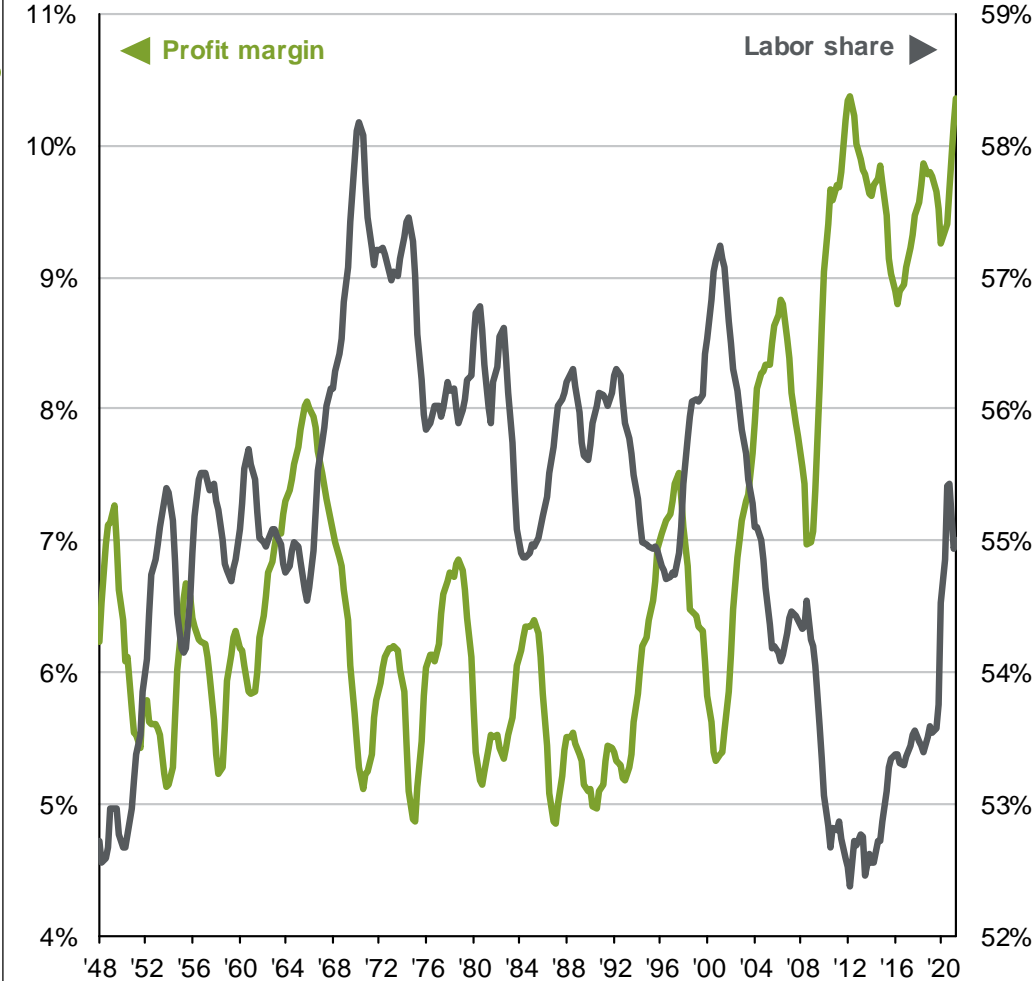

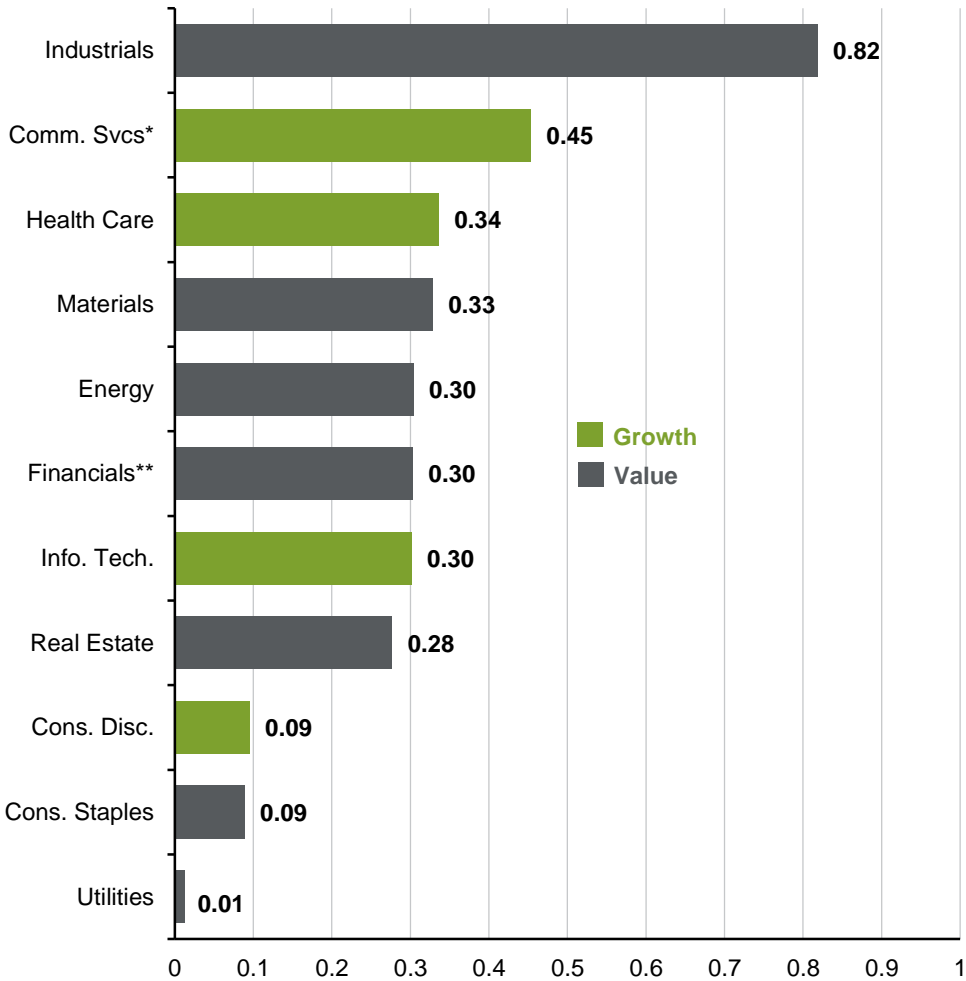
Value vs. Growth relative valuations

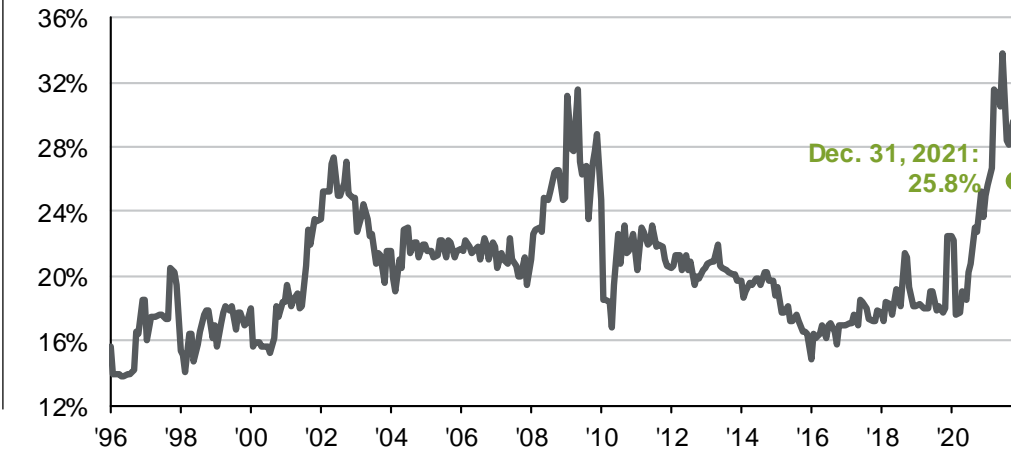
Weight of the top 10 stocks in the S&P 500

As of 12/1/2021, the top 10 companies in the index were AAPL(6.8%), MSFT (6.5%), AMZN (3.9%), TSLA (2.3%), GOOGL (2.2%), GOOG (2.1%), NVDA(2.1%), FB (1.9%), BRK.B (1.3%), JPM (1.2%), and JNJ (1.2%). The remaining stocks represent the rest of the 494 companies in the S&P 500.

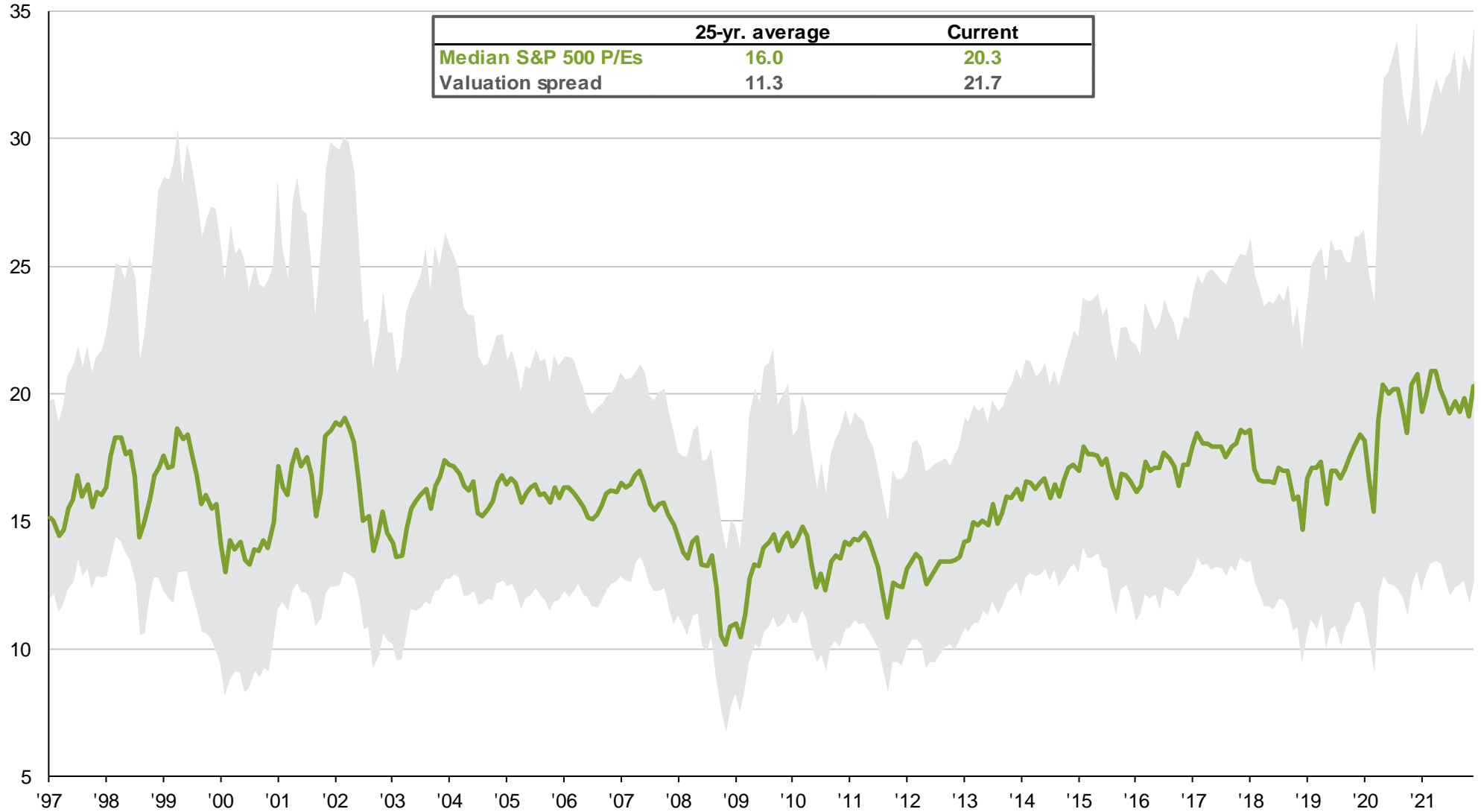
S&P 500: Valuation dispersion

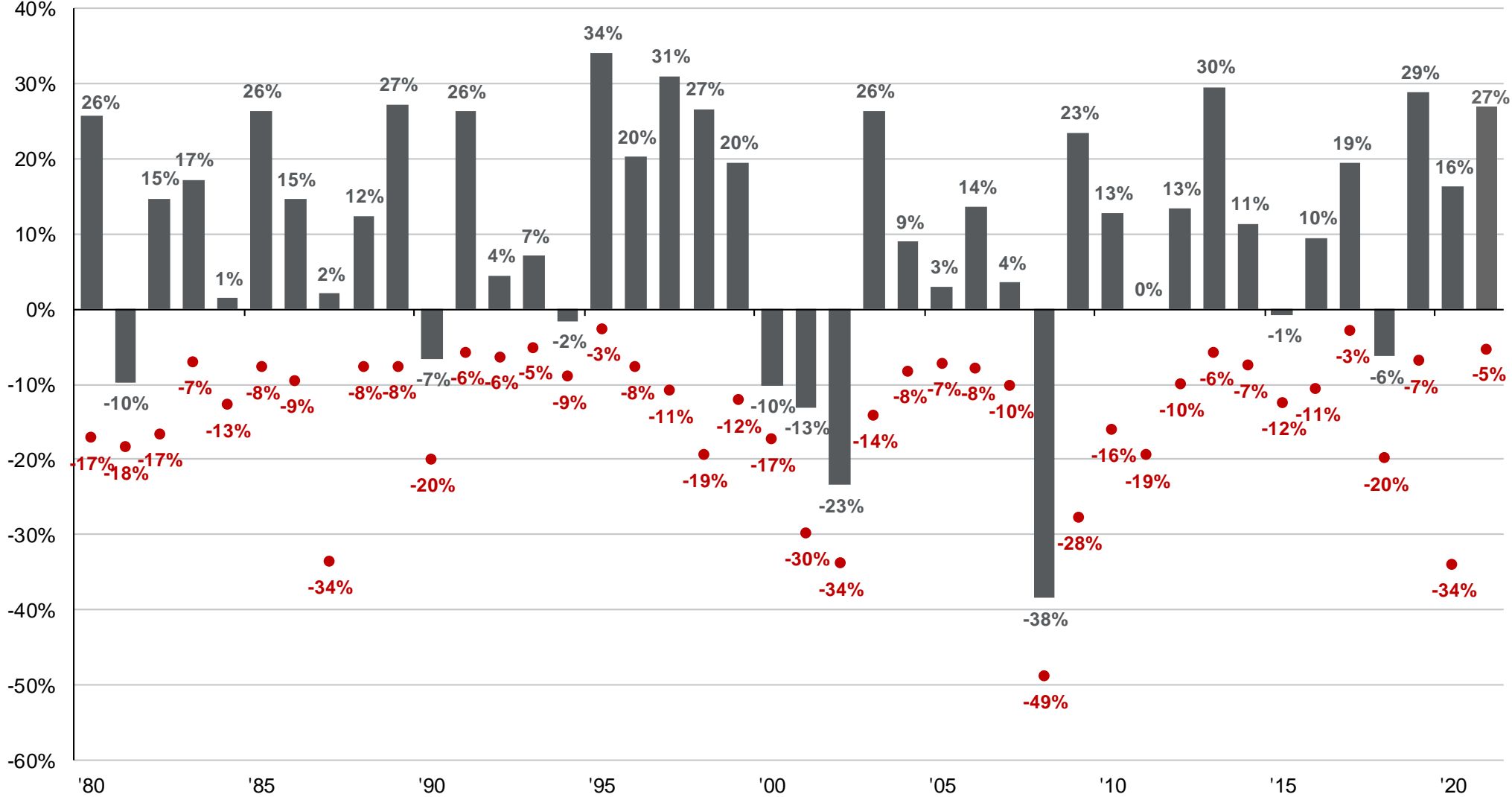

The MSCI High Dividend Yield Index aims to offer a higher than average dividend yield relative to the parent index that passes dividend sustainability and persistence screens. The MSCI Minimum Volatility Index optimizes the MSCI USA Index using an estimated security co-variance matrix to produce low absolute volatility for a given set of constraints. The MSCI Defensive Sectors Index includes: Consumer Staples, Energy, Health Care and Utilities. The MSCI Cyclical Sectors Index contains: Consumer Discretionary, Communication Services, Financials, Industrials, Information Technology and Materials. Securities in the MSCI Momentum Index are selected based on a momentum value of 12-month and 6-month price performance. Constituents of the MSCI Sector Neutral Quality Index are selected based on stronger quality characteristics to their peers within the same GICS sector by using three main variables: high return-on-equity, low leverage and low earnings variability. Constituents of the MSCI Enhanced Value Index are based on three variables: price-to-book value, price-to-forward earnings and enterprise value-to-cash flow from operations. The Russell 2000 is used for small cap. The MSCI USA Diversified Multiple Factor Index aims to maximize exposure to four factors – Value, Momentum, Quality and Size. Annualized volatility is calculated as the standard deviation of quarterly returns multiplied by the square root of 4. *Guide to the Markets* – U.S. Data are as of December 31, 2021.

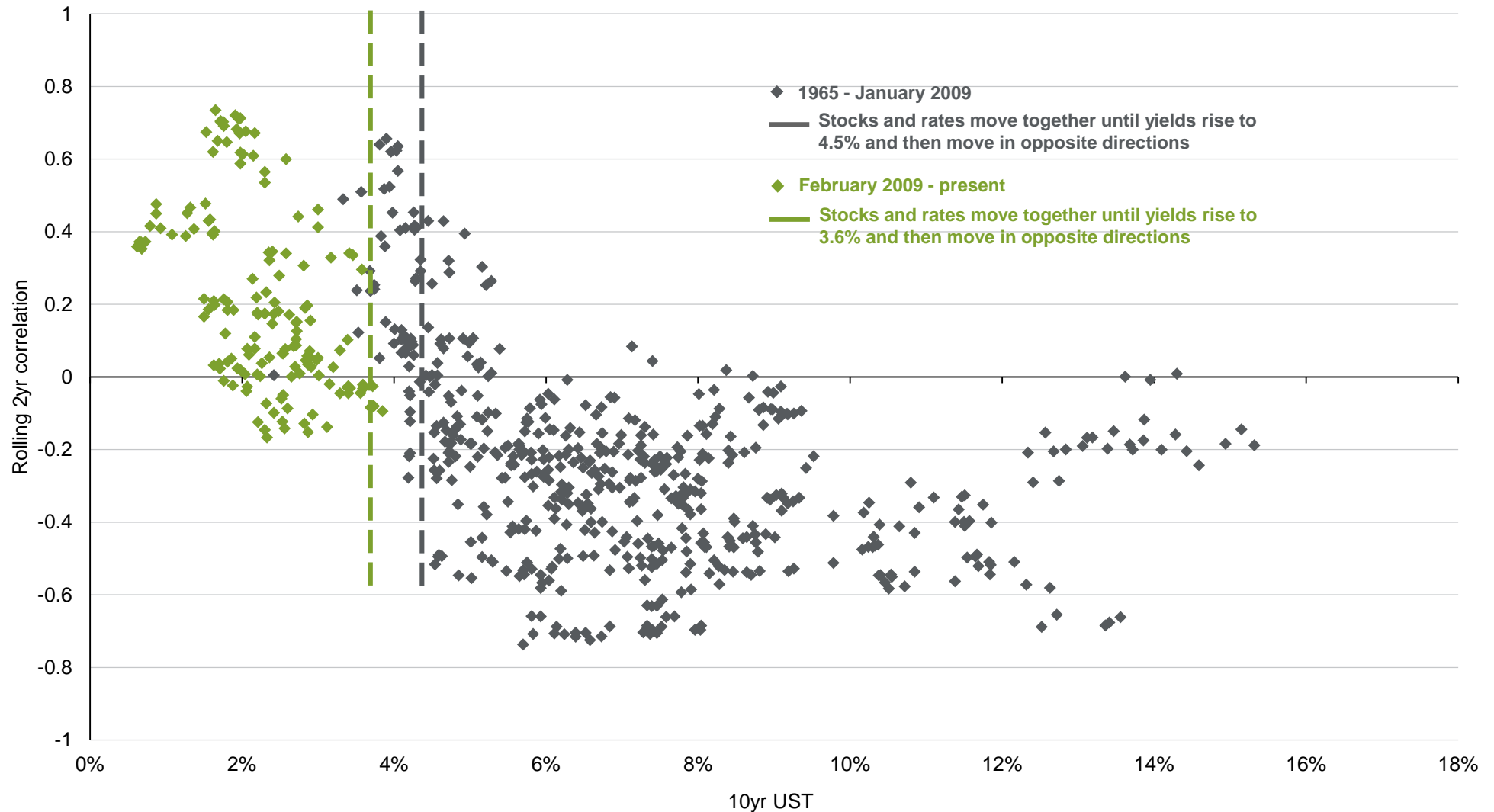

Monthly S&P 500 returns, 10yr U.S. Treasury, rolling 2yr correlations, 1965 – present



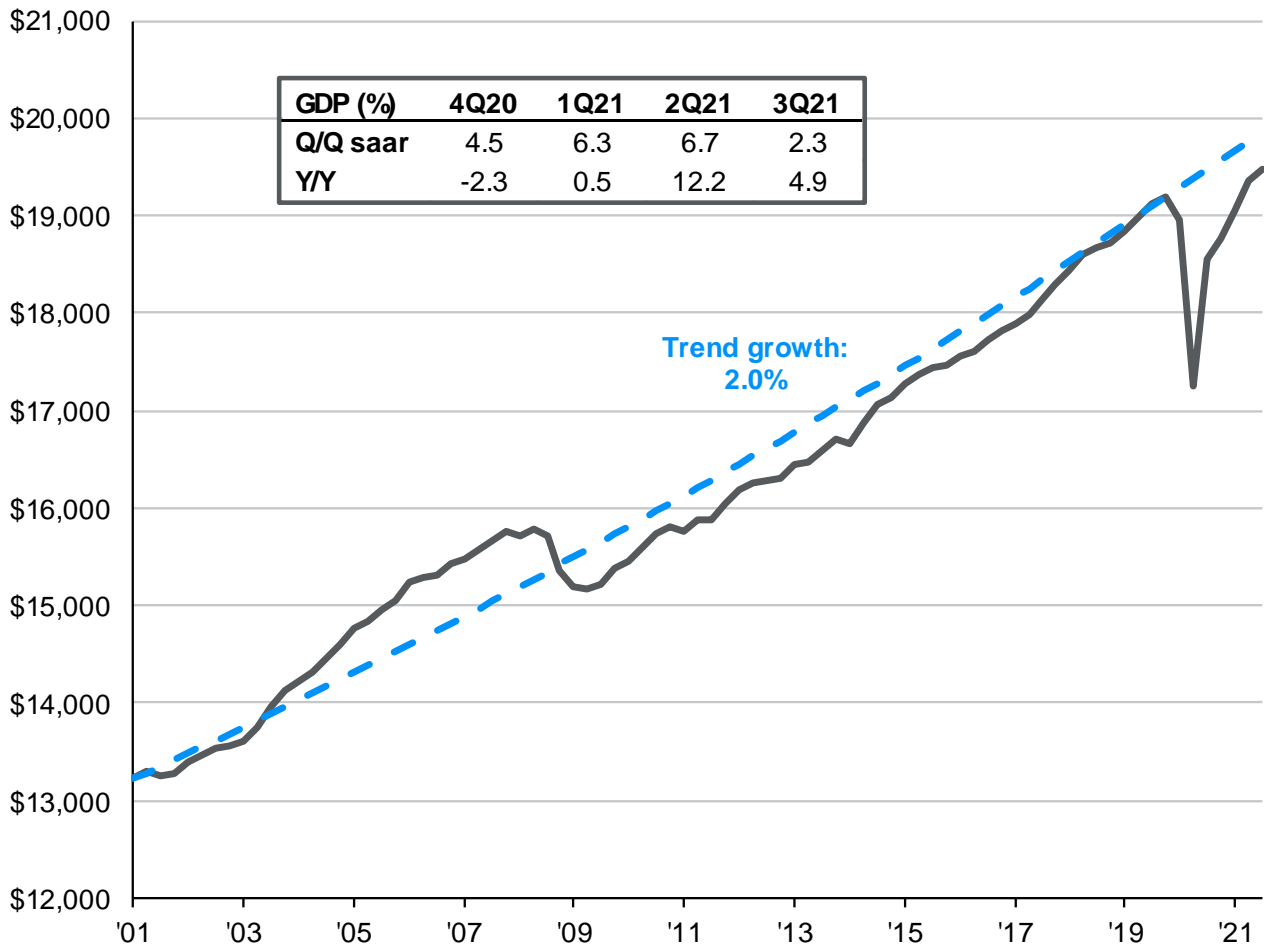

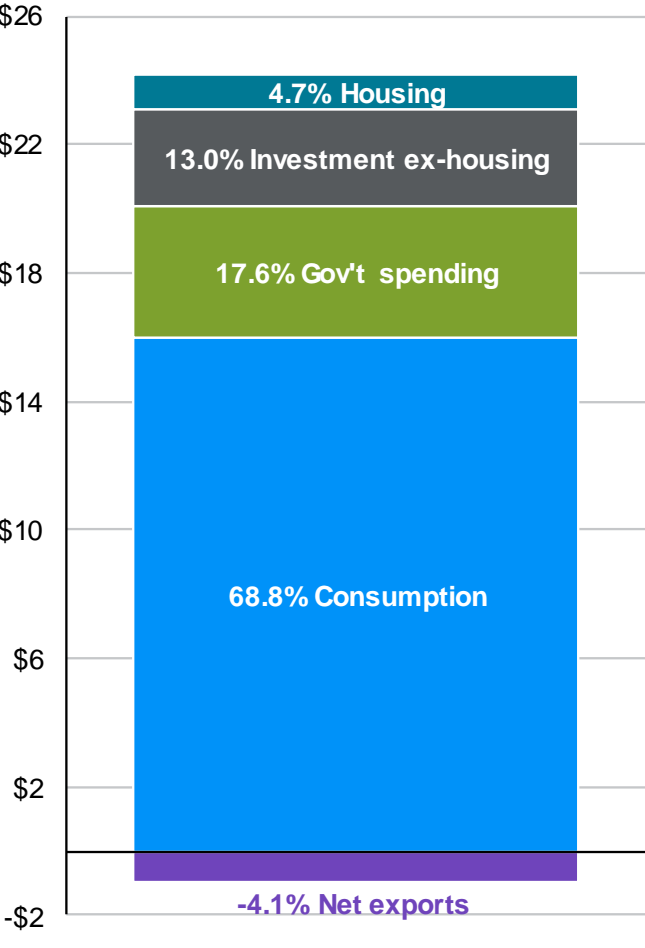

3Q21 nominal GDP, USD trillions



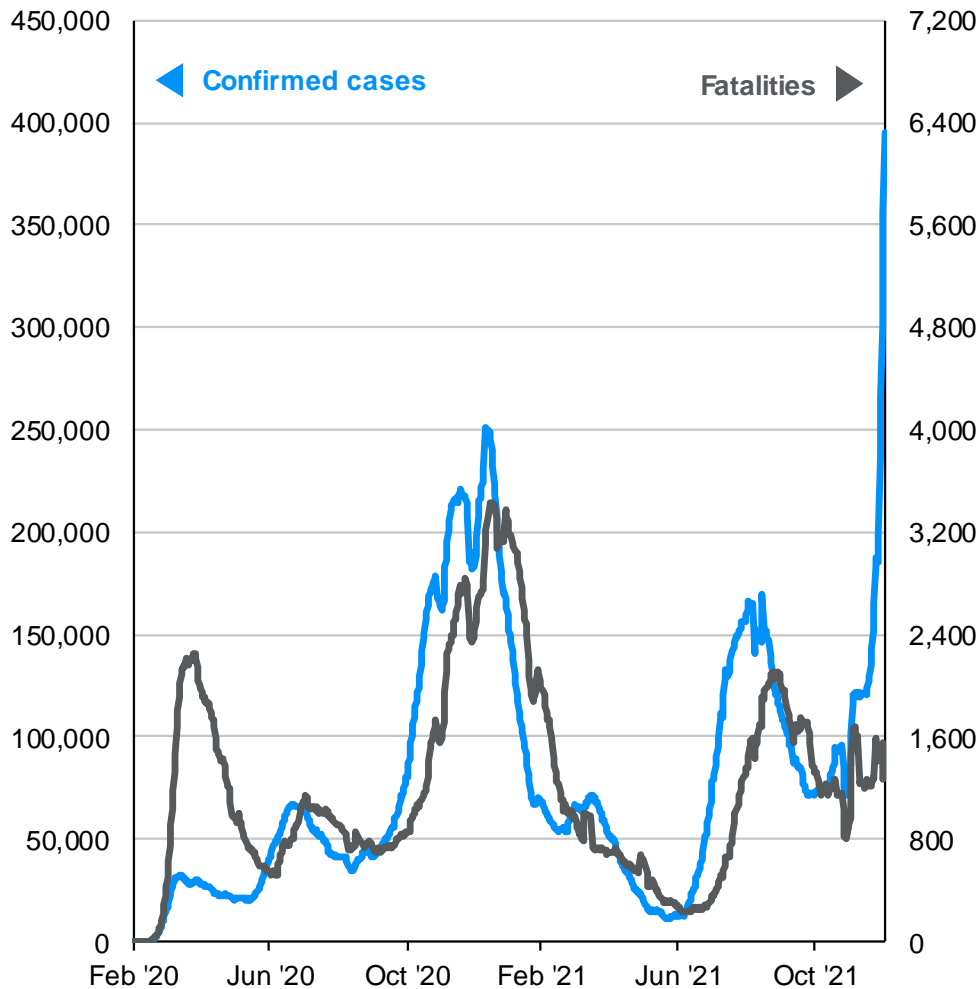

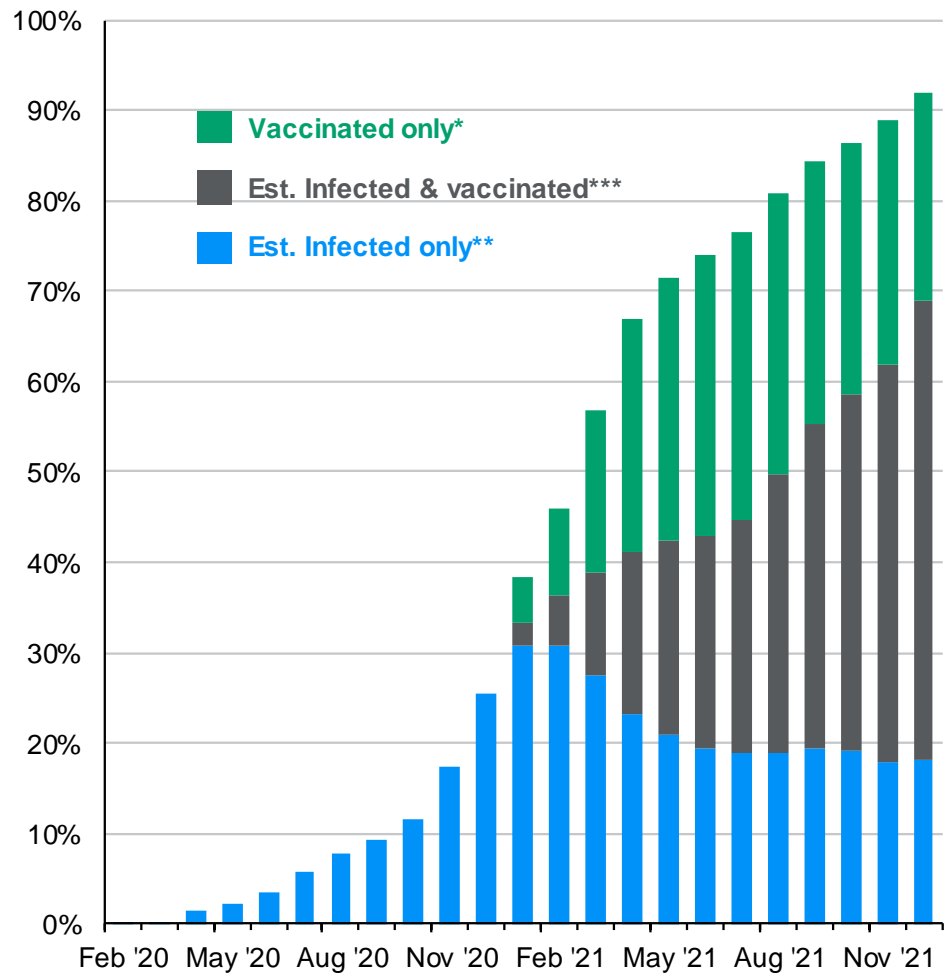
Change in confirmed cases and fatalities in the U.S.

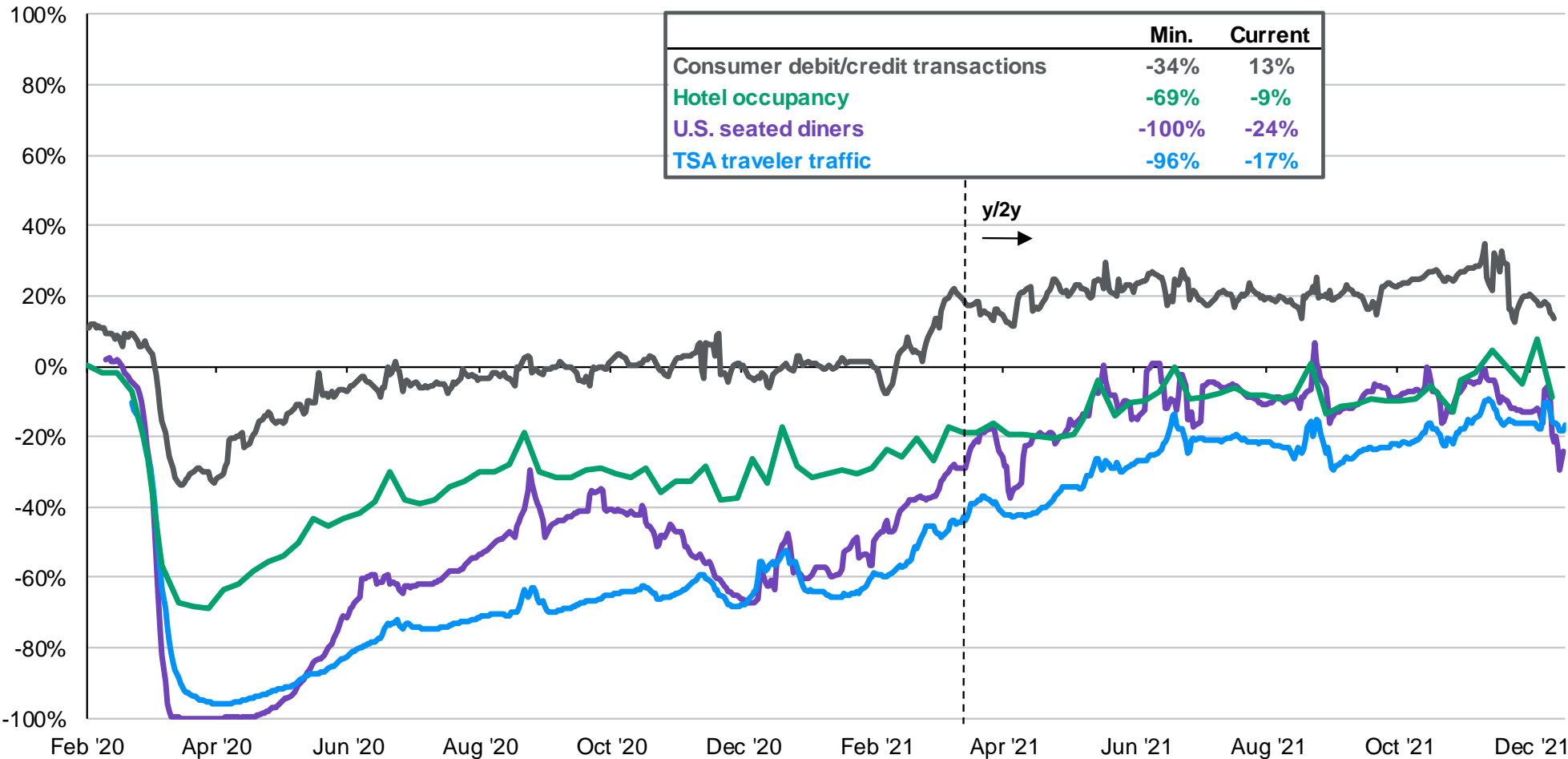

Year-over-year % change; Year-over-2 year after 3/15/21*



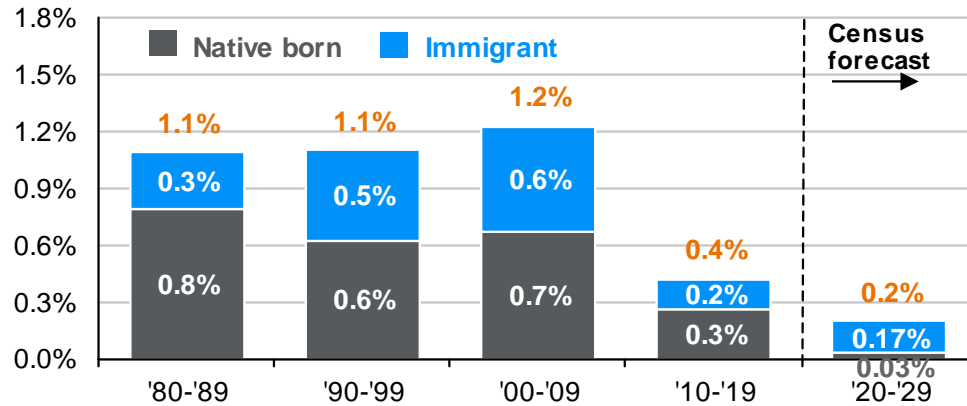

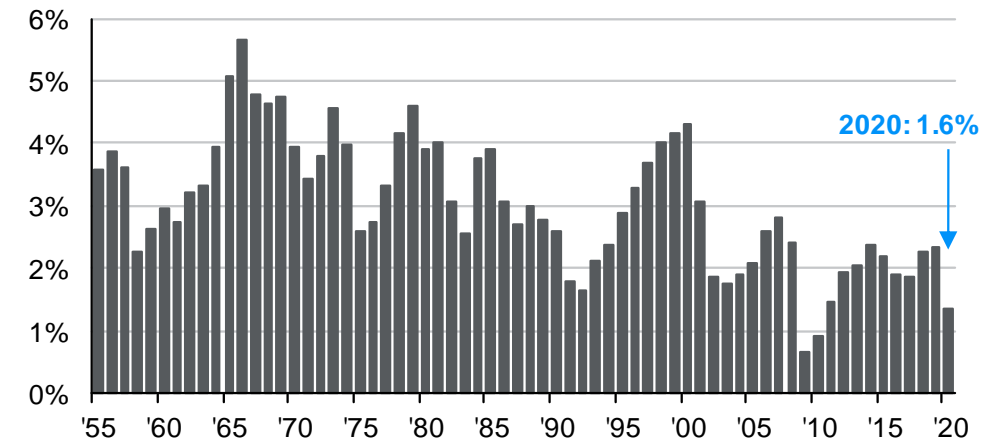

Percent increase in civilian non-institutional population ages 16-64



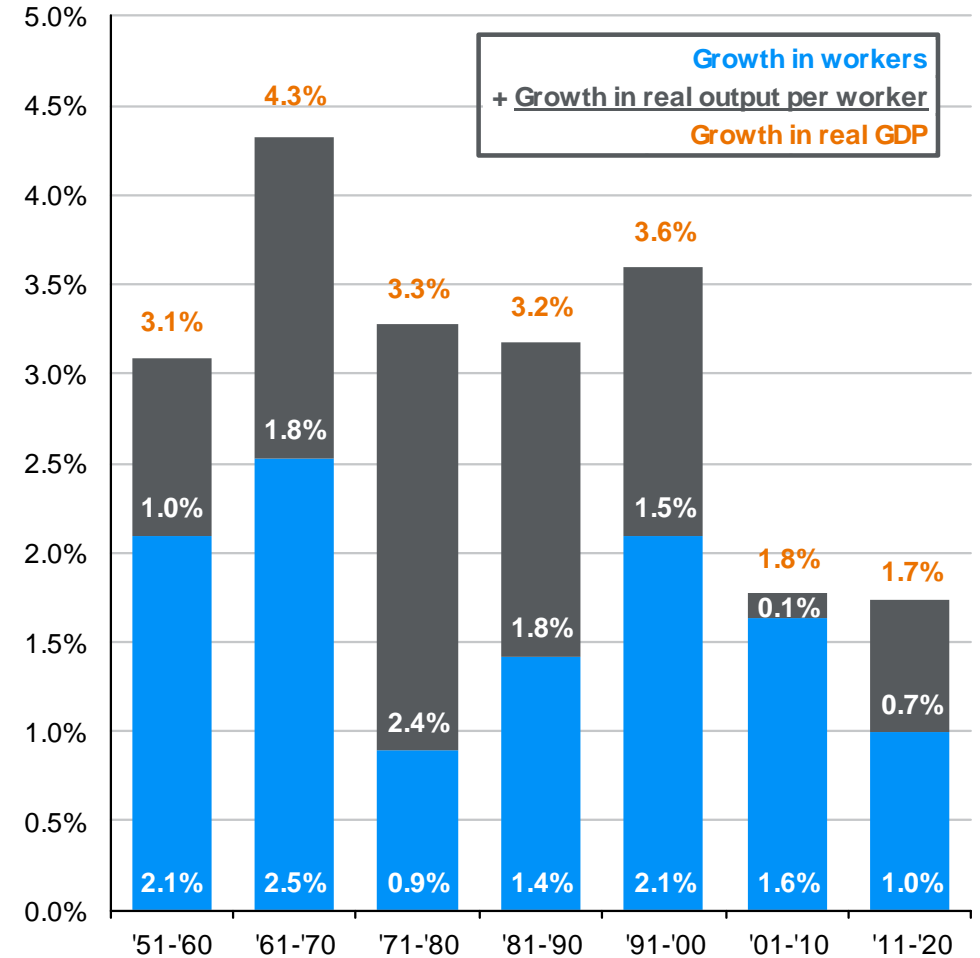
Growth in private non-residential capital stock

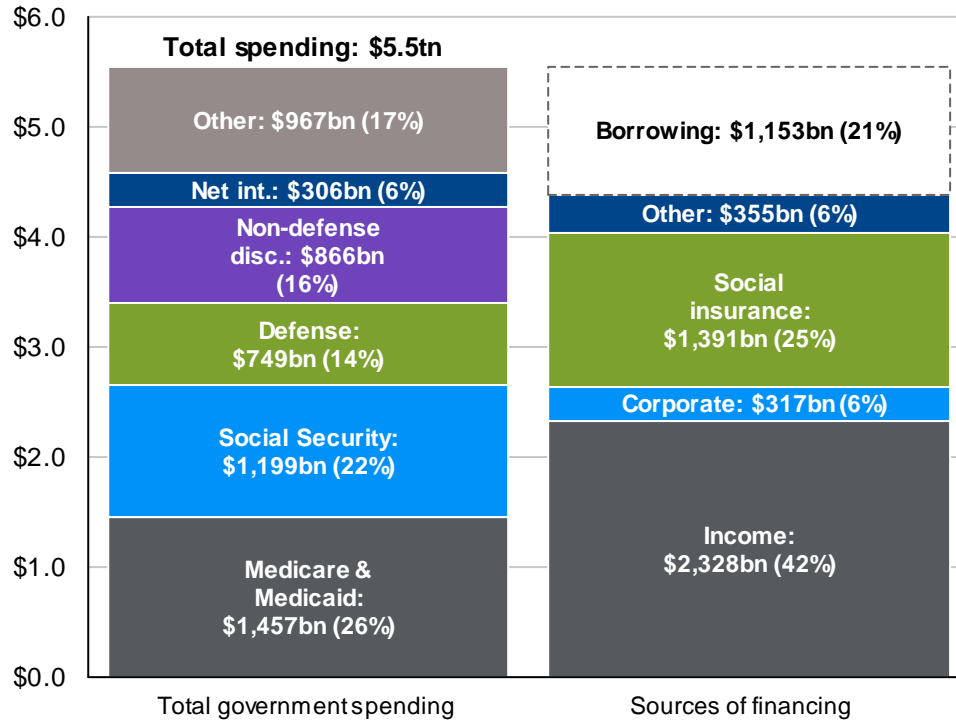

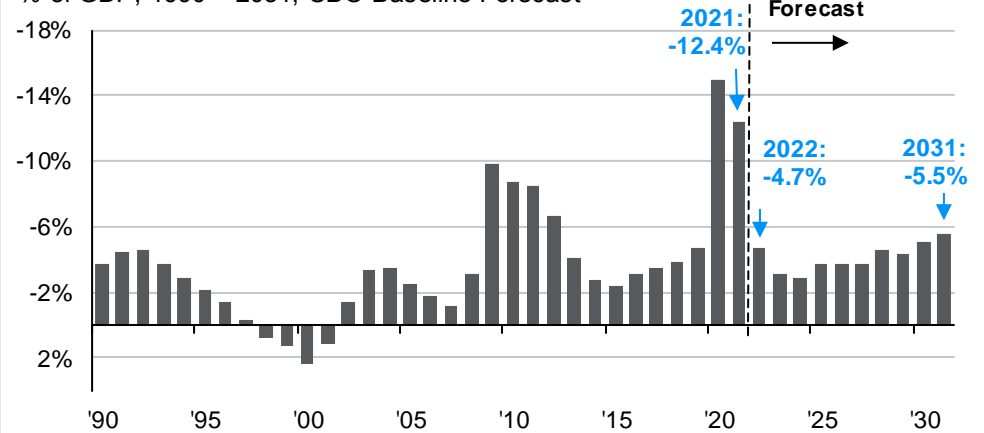

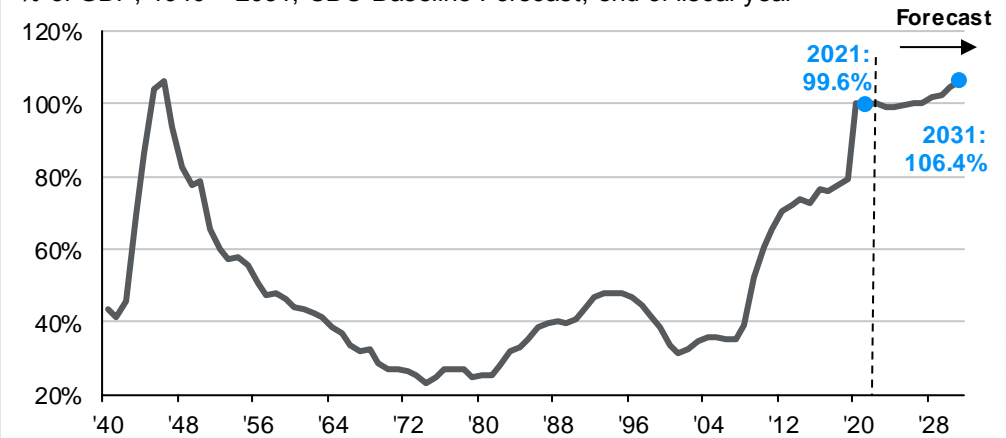
Federal budget surplus/deficit

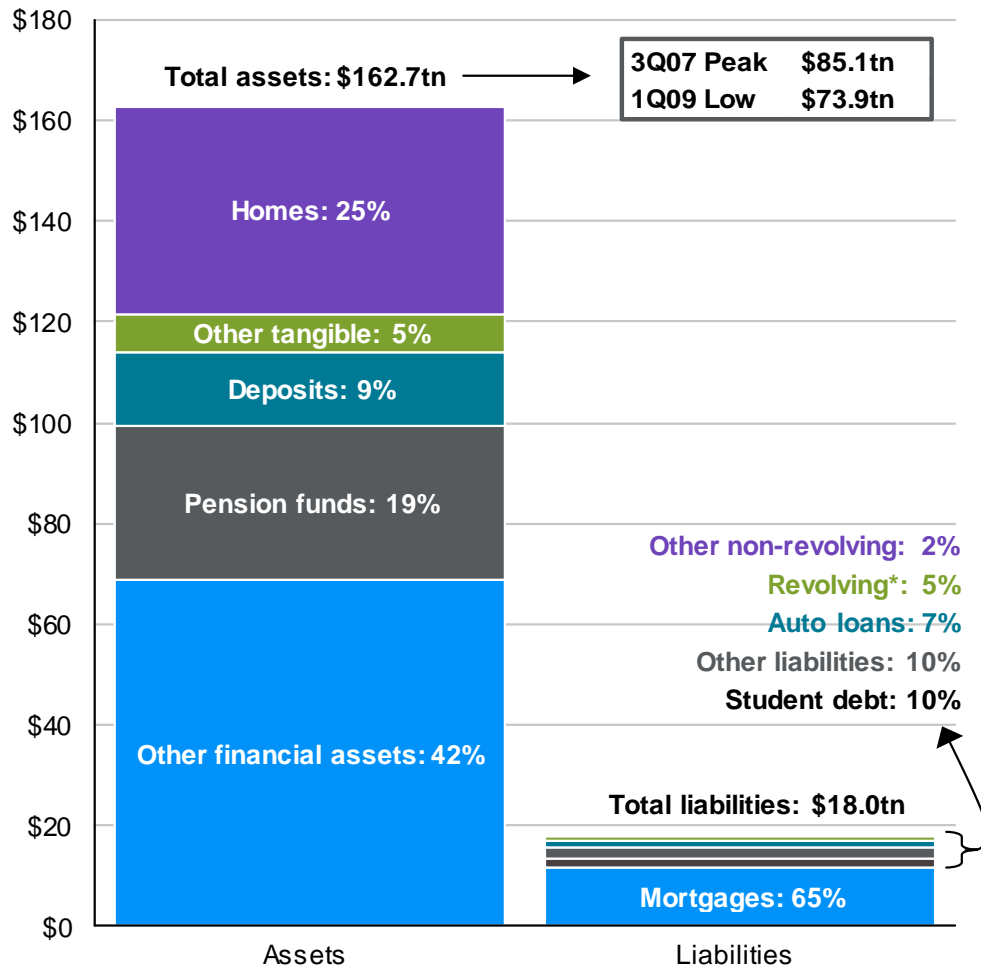

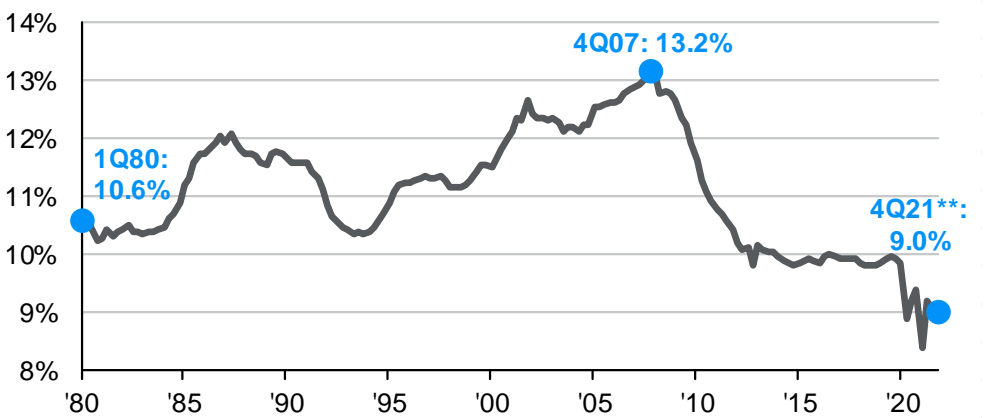

3Q21, trillions of dollars outstanding, not seasonally adjusted



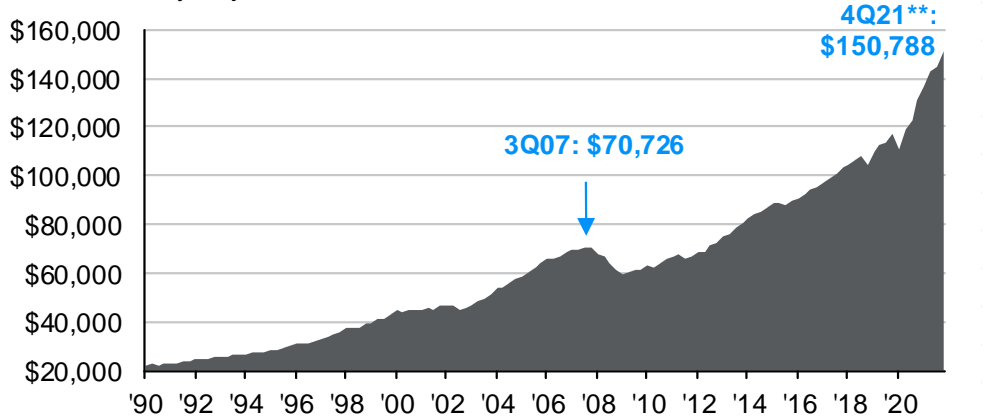
Household debt service ratio

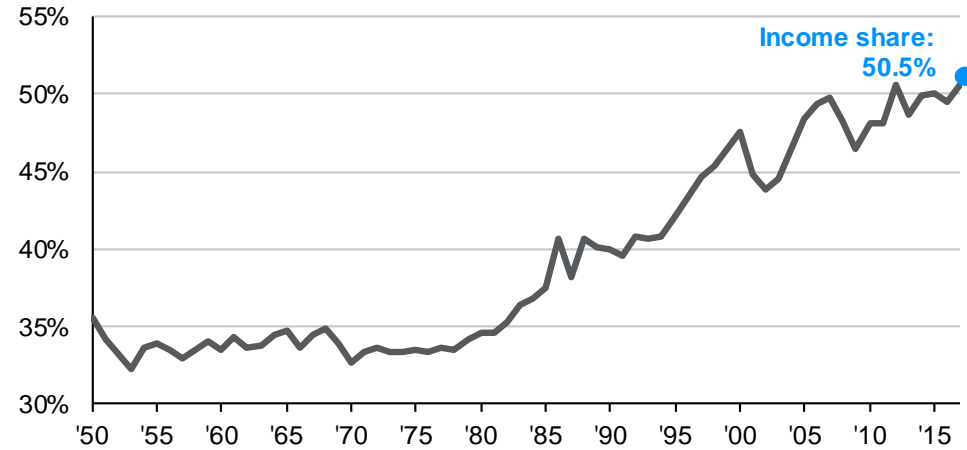

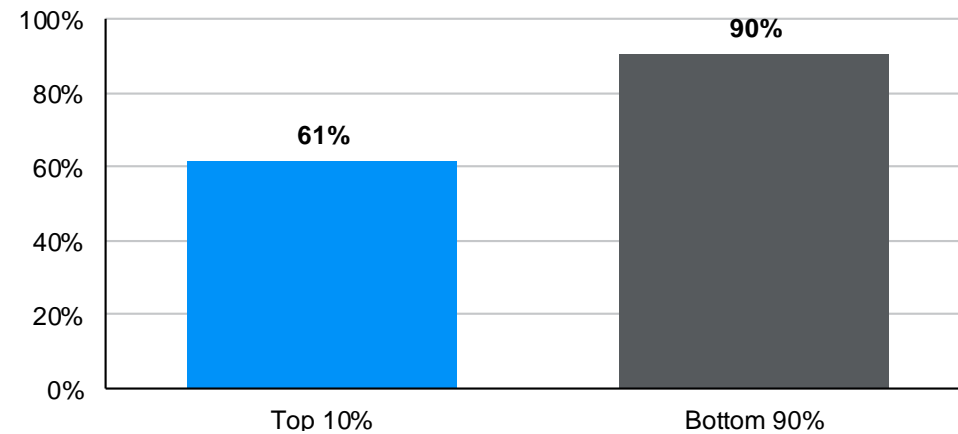

Top 10% share of pre-tax national income

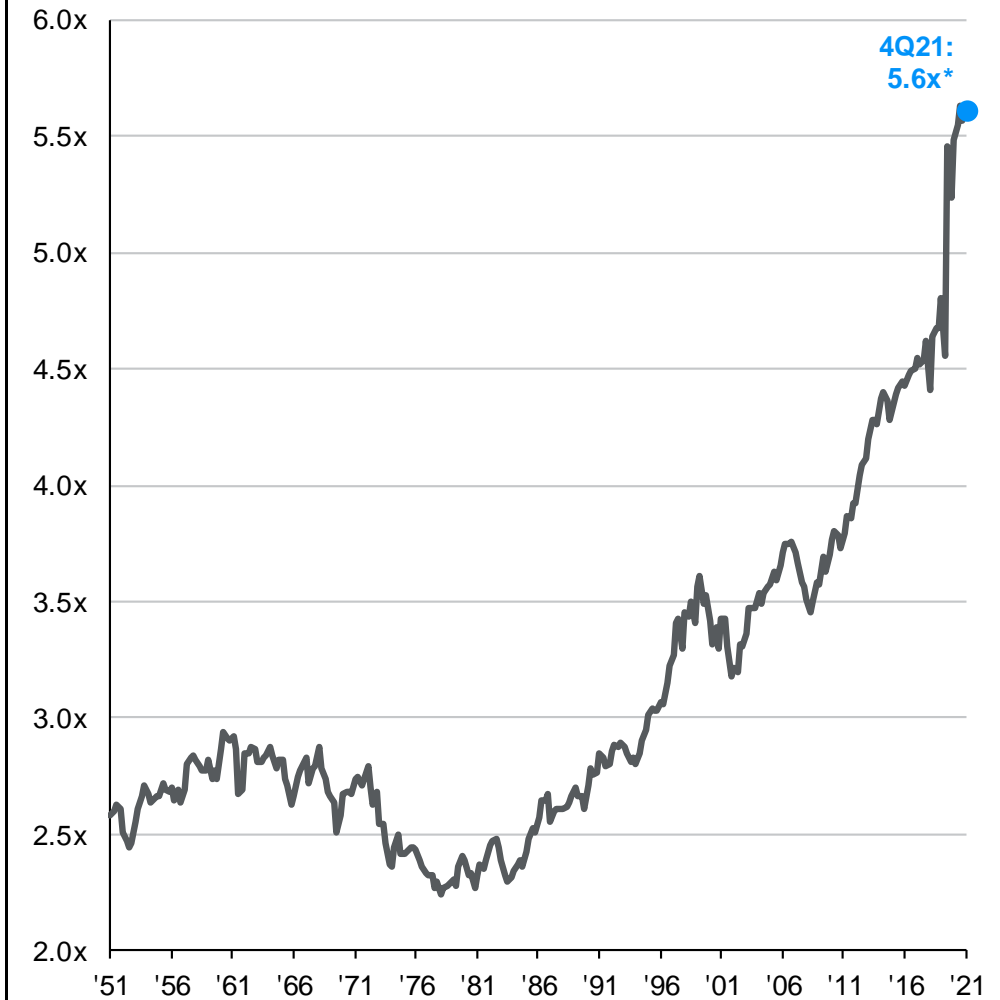


Spending as a share of income after tax

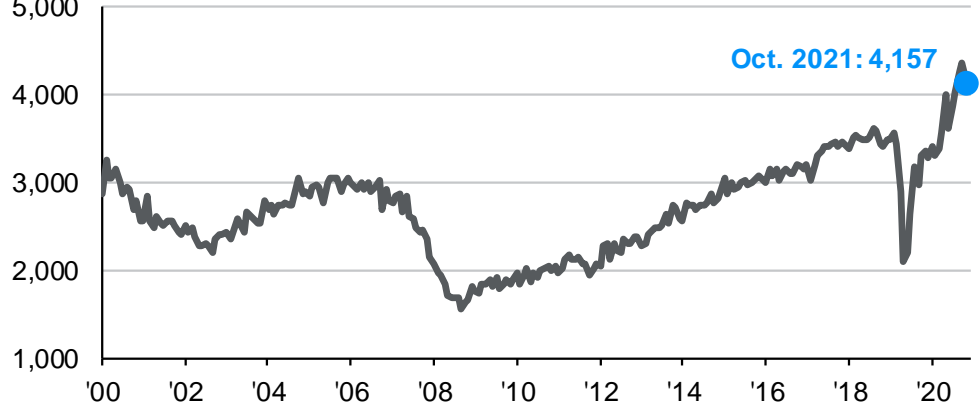

Total nonfarm job openings, thousands, seasonally adjusted



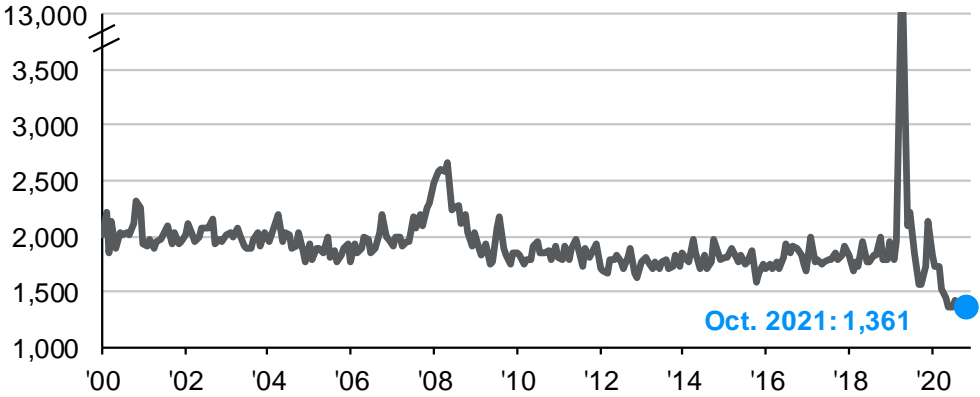
JOLTS quits

Total nonfarm layoffs, thousands, seasonally adjusted



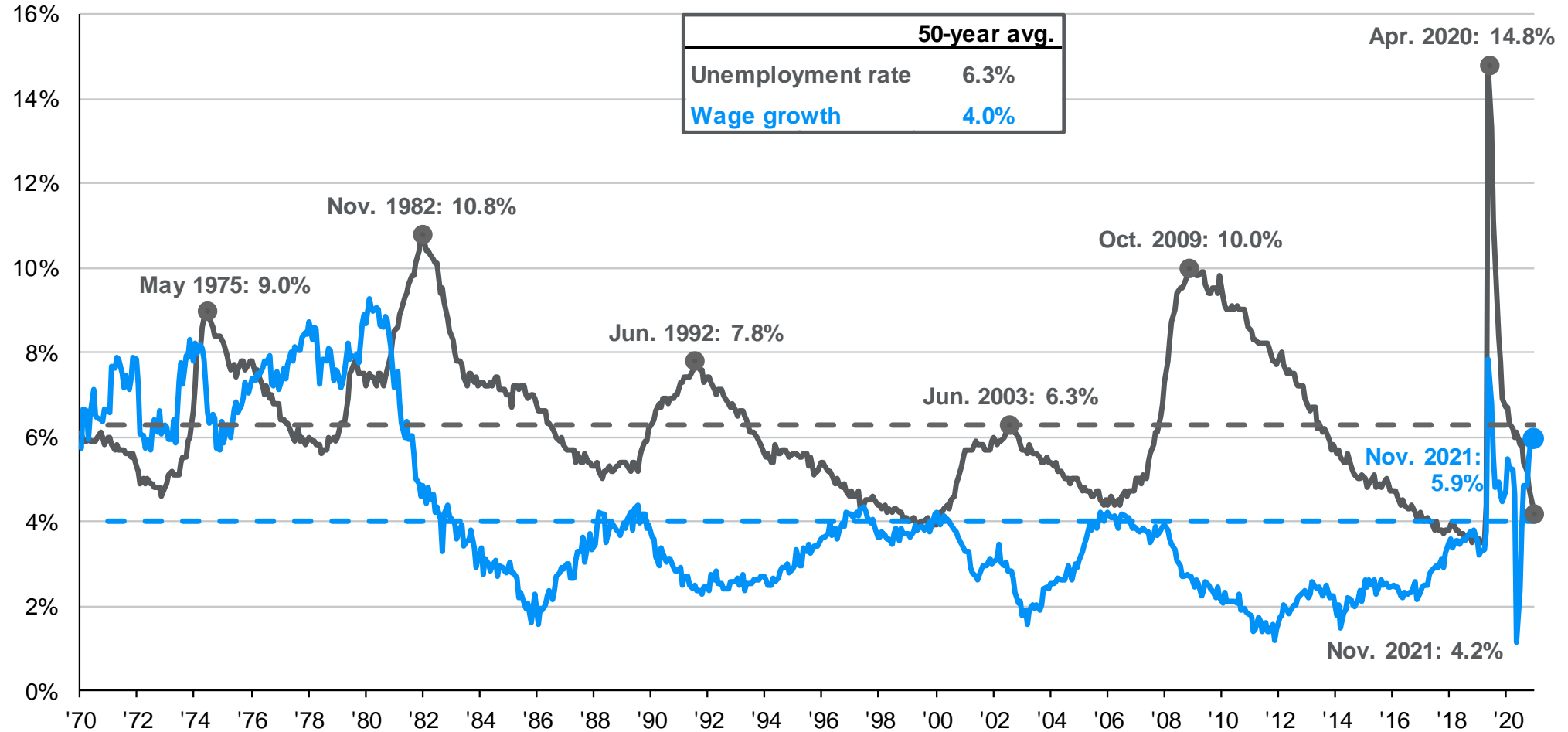

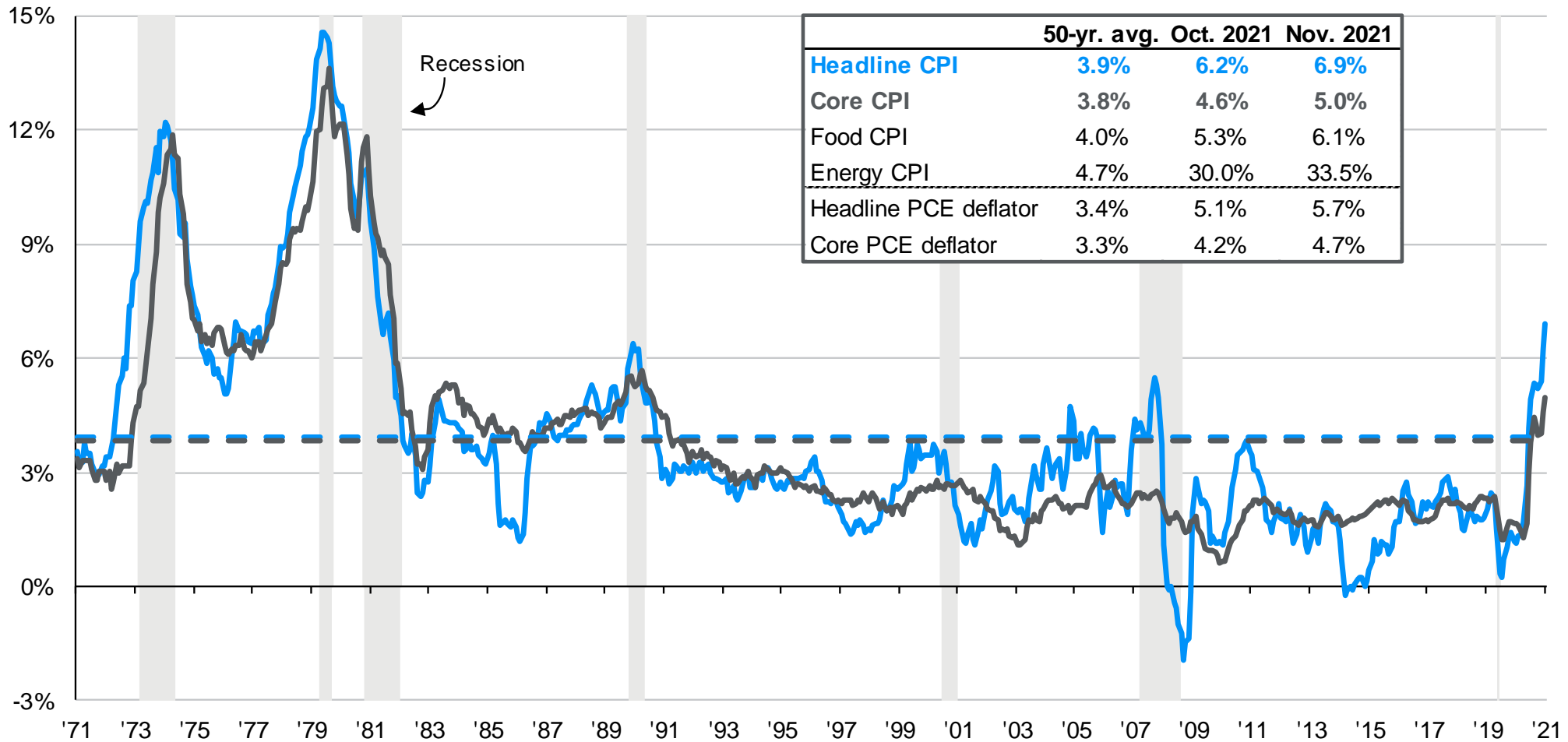

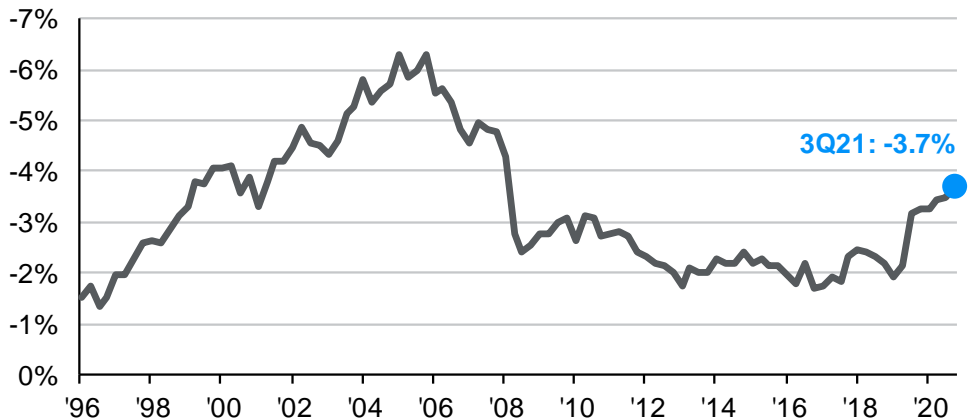

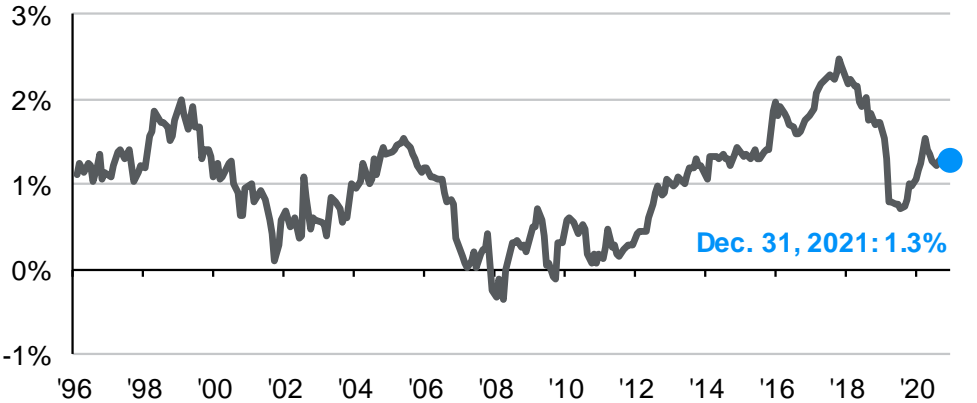

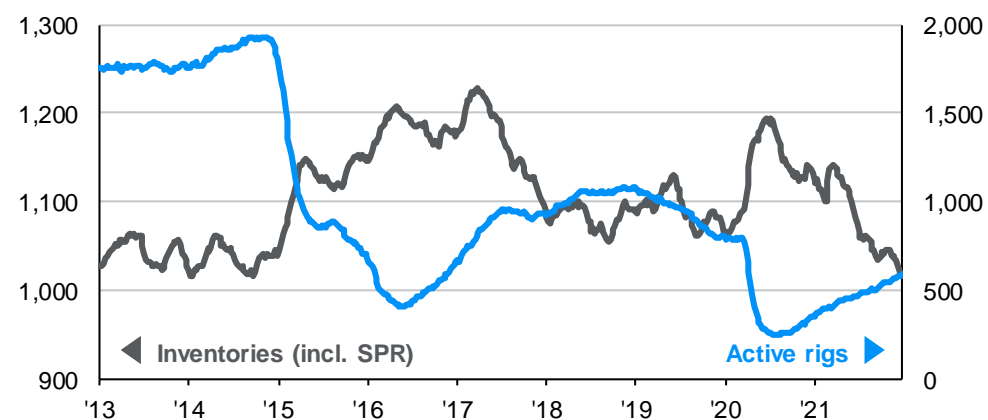

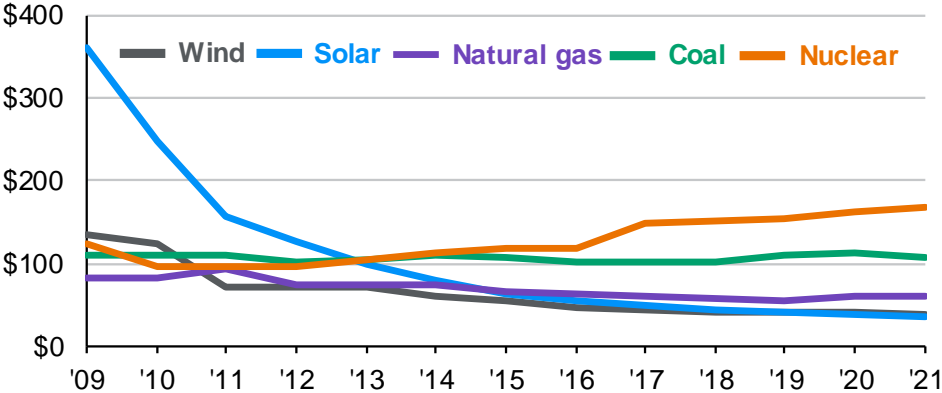

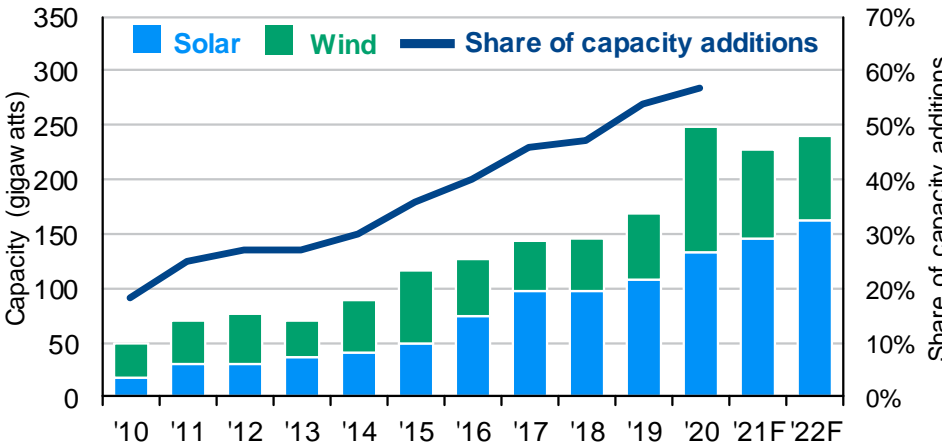


Cost of wind, solar, natural gas, nuclear and coal

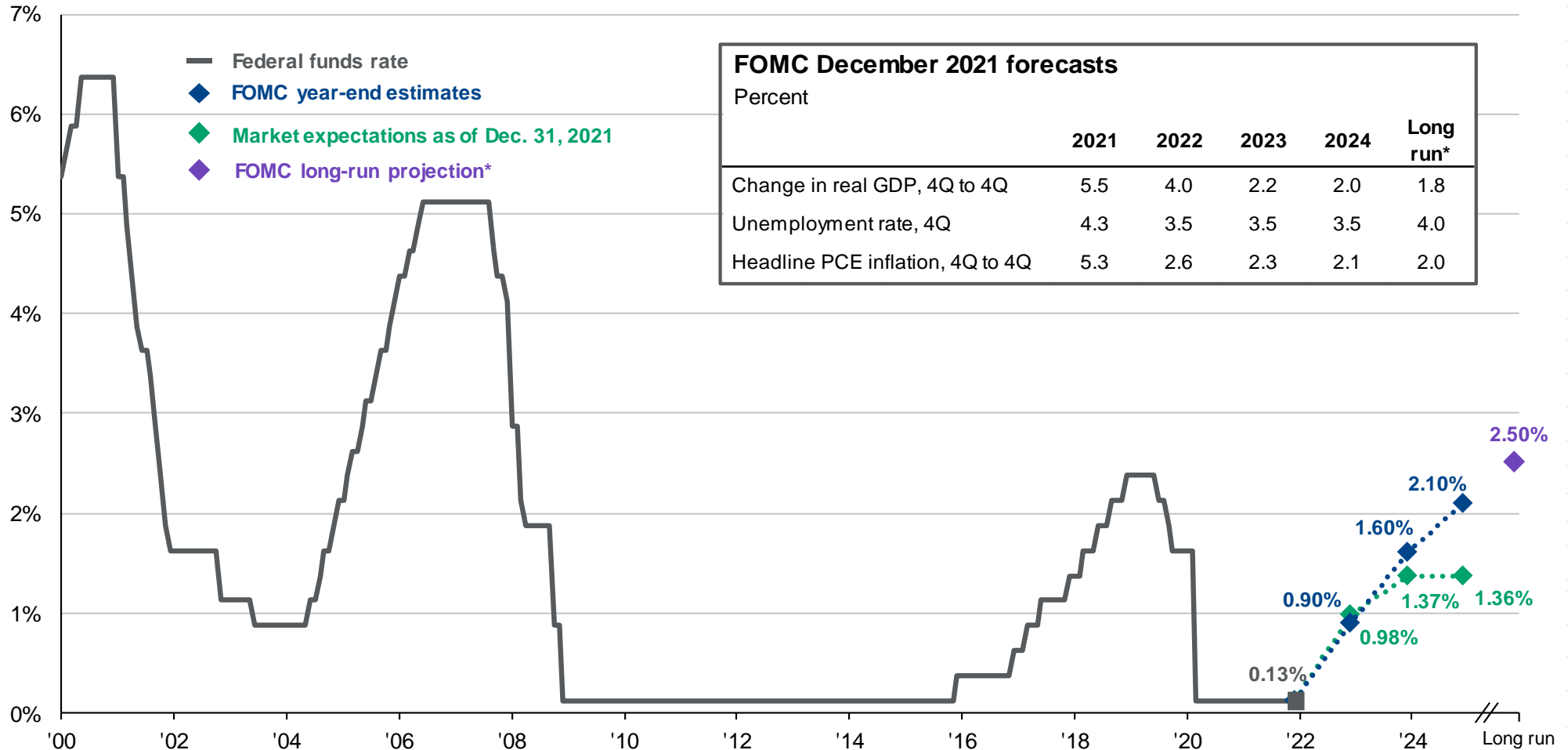

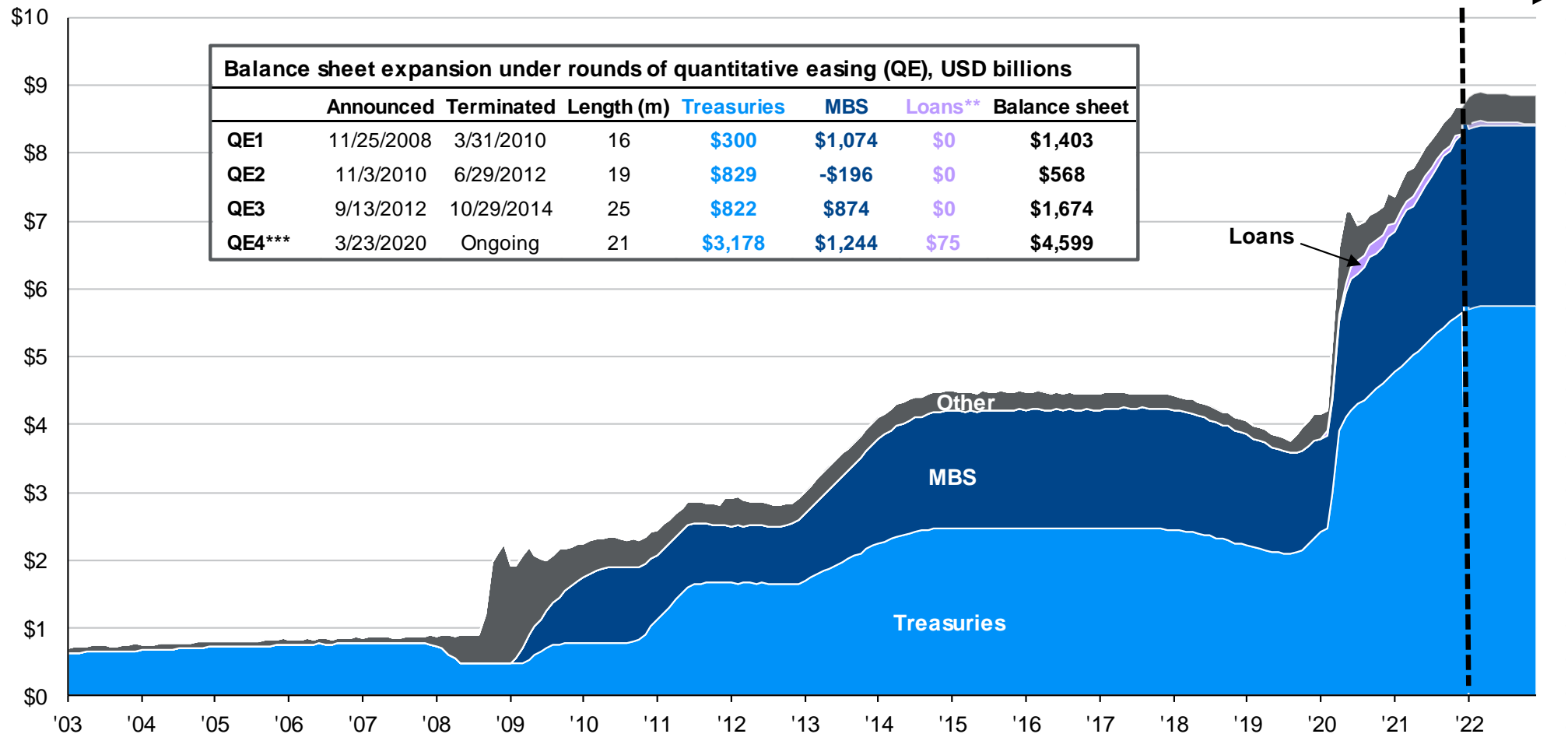

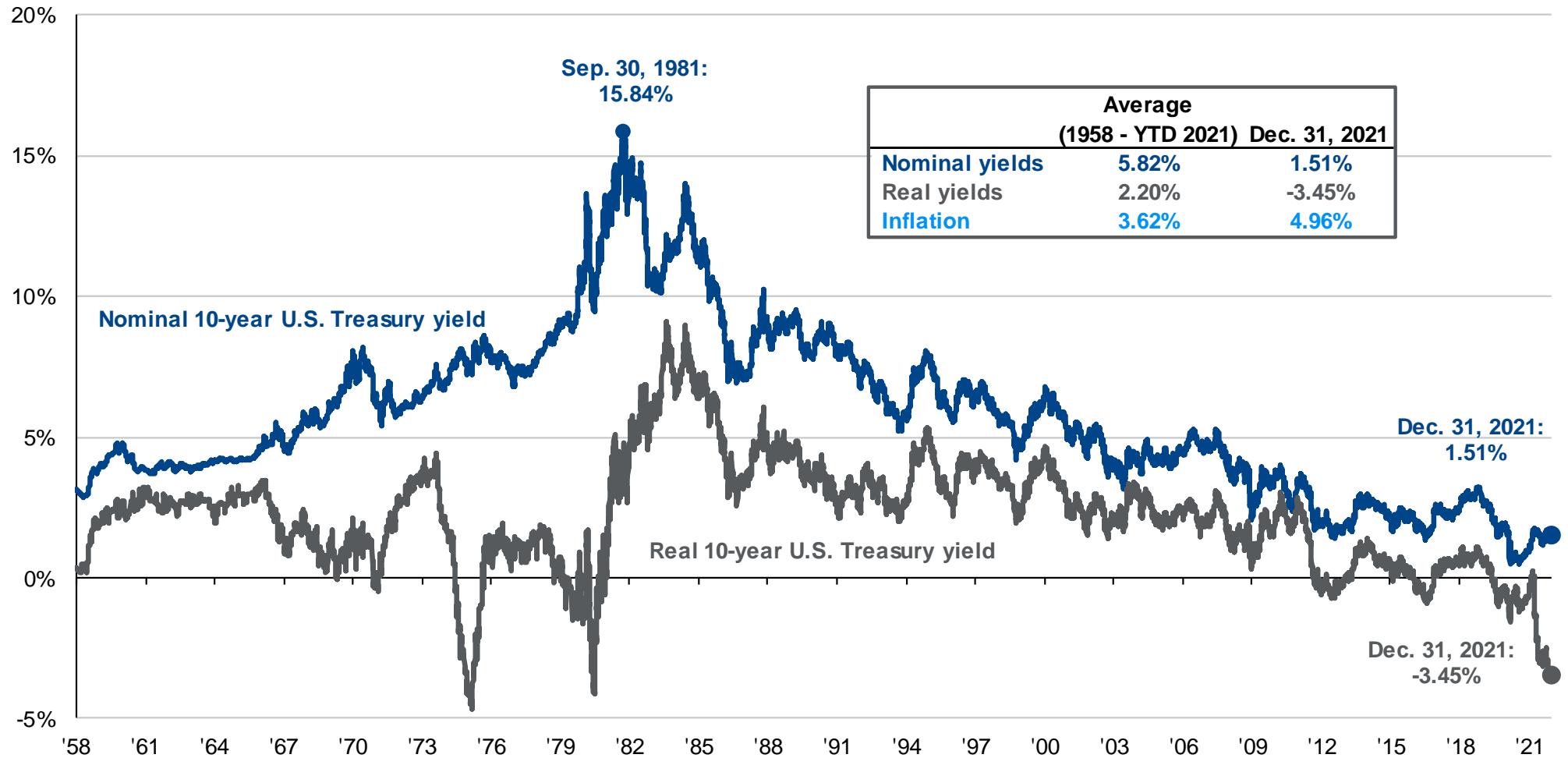

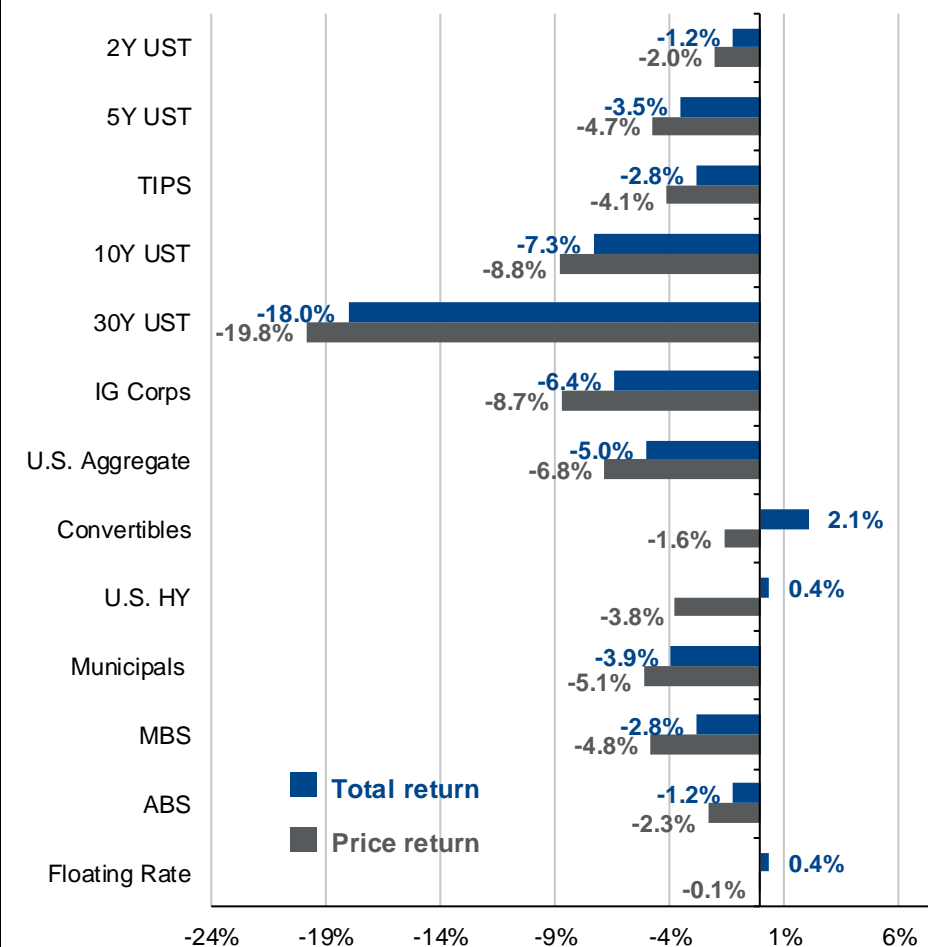

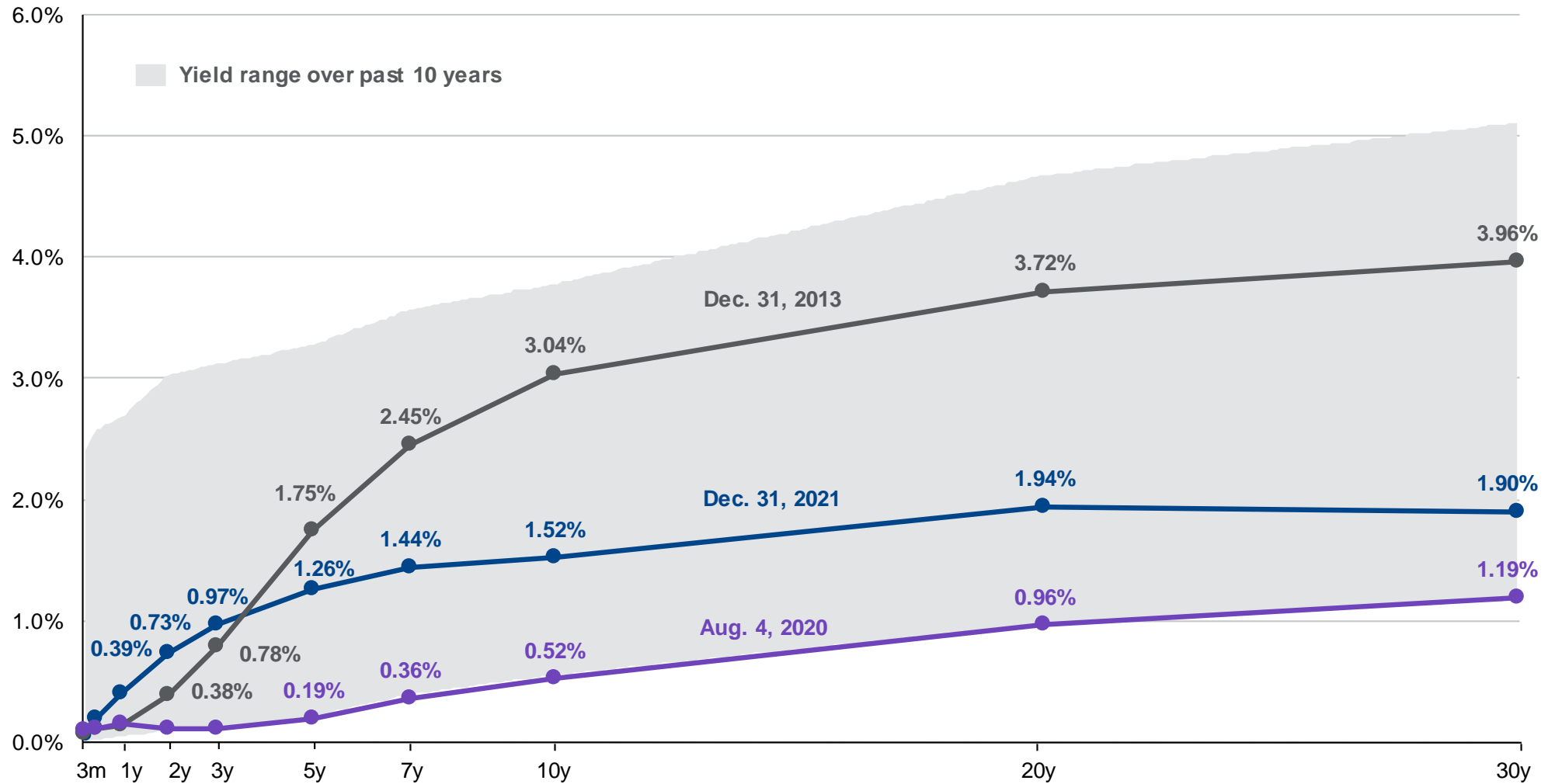

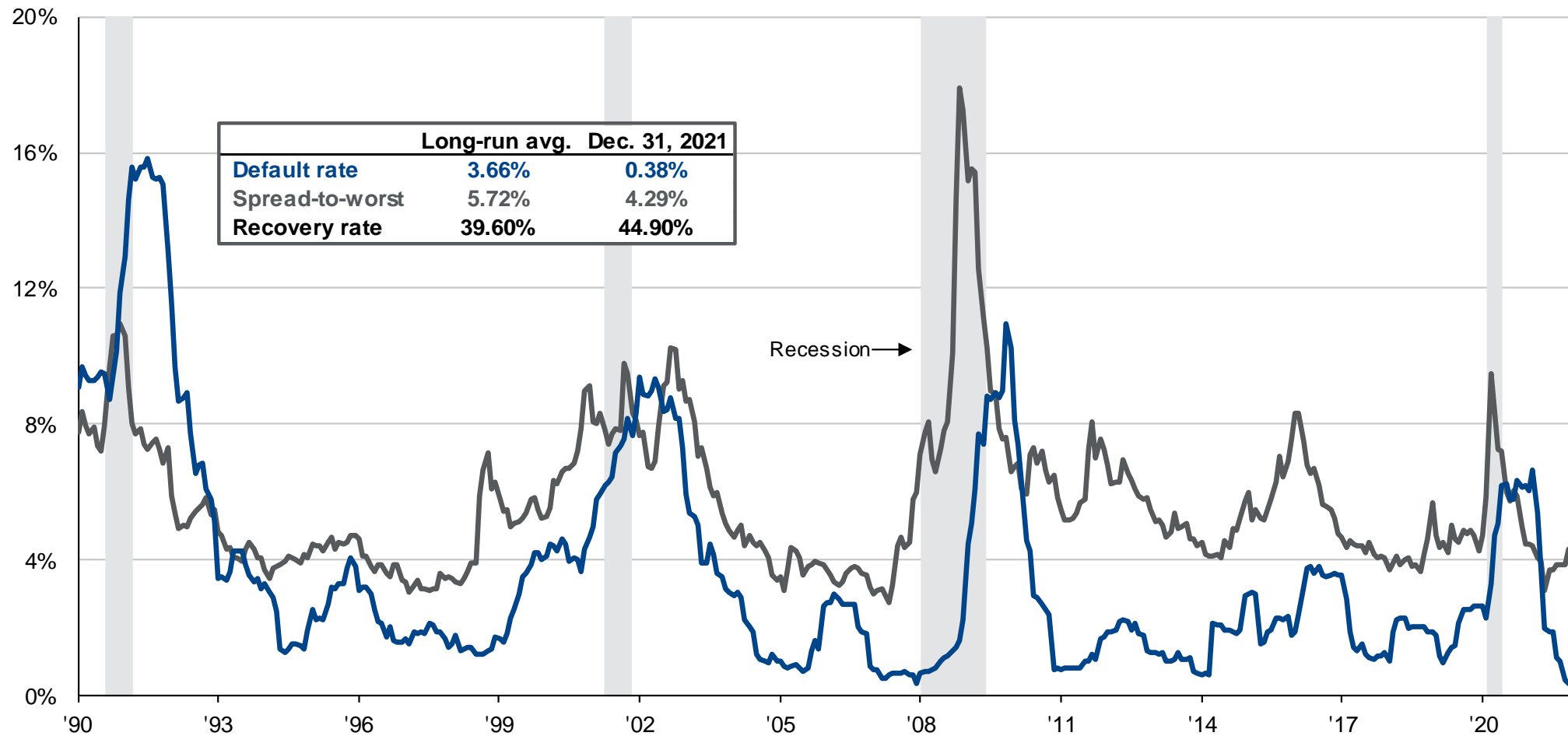

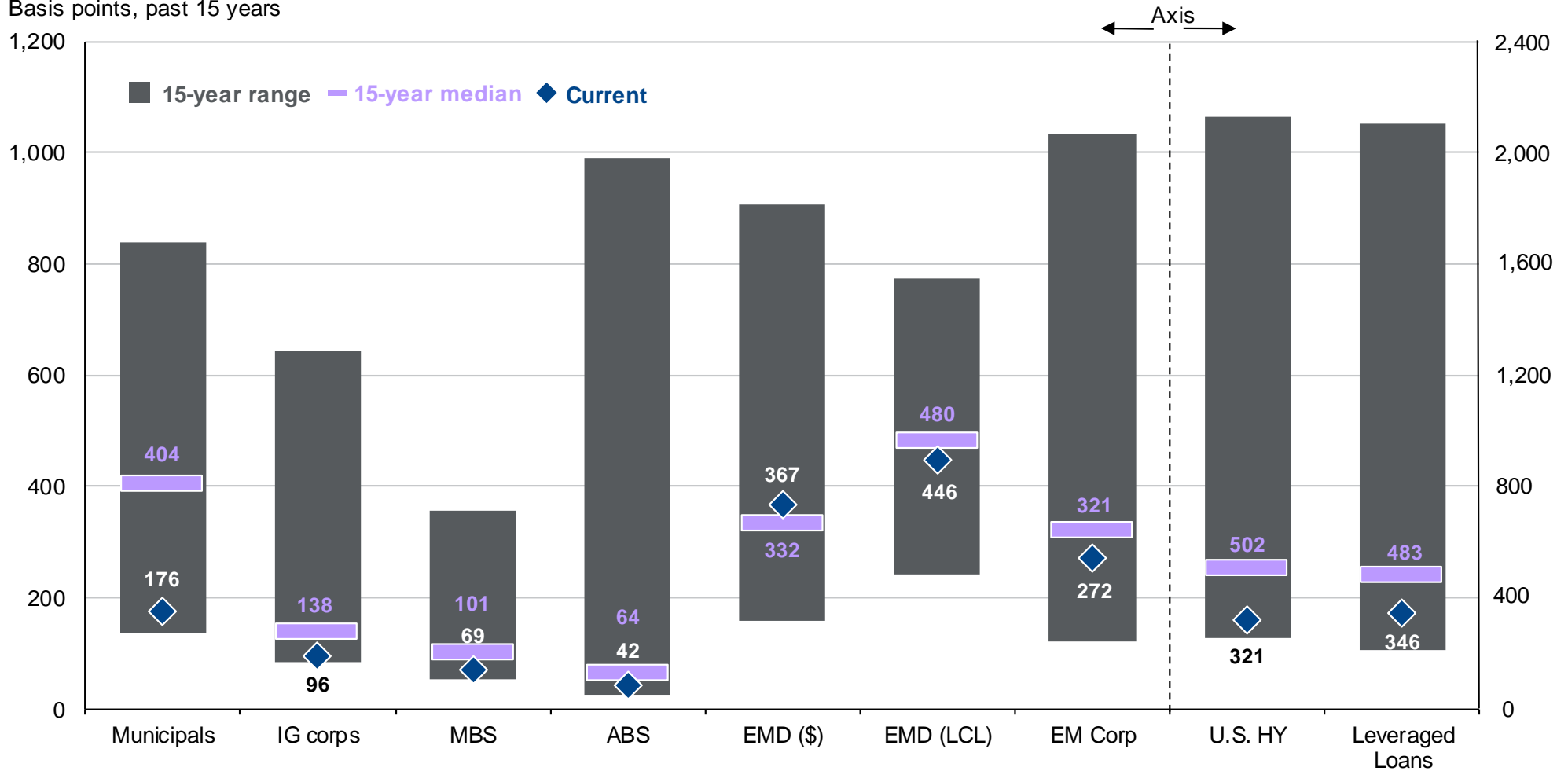

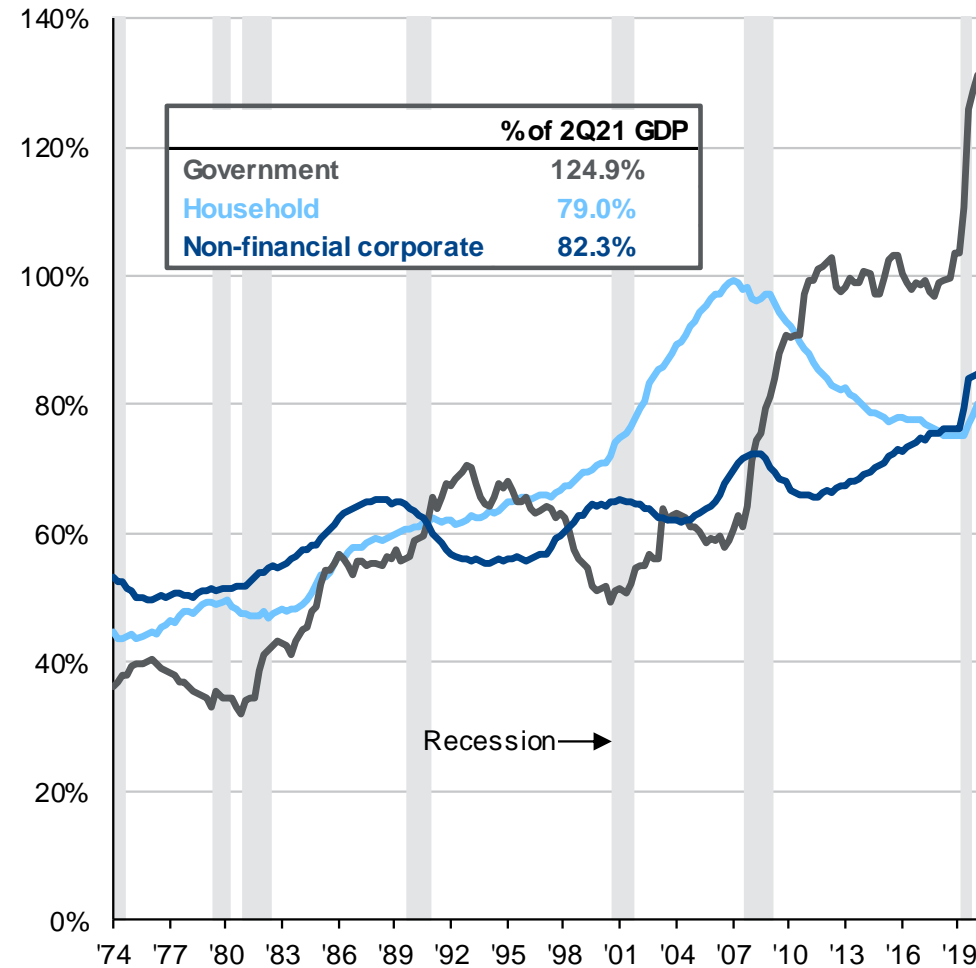

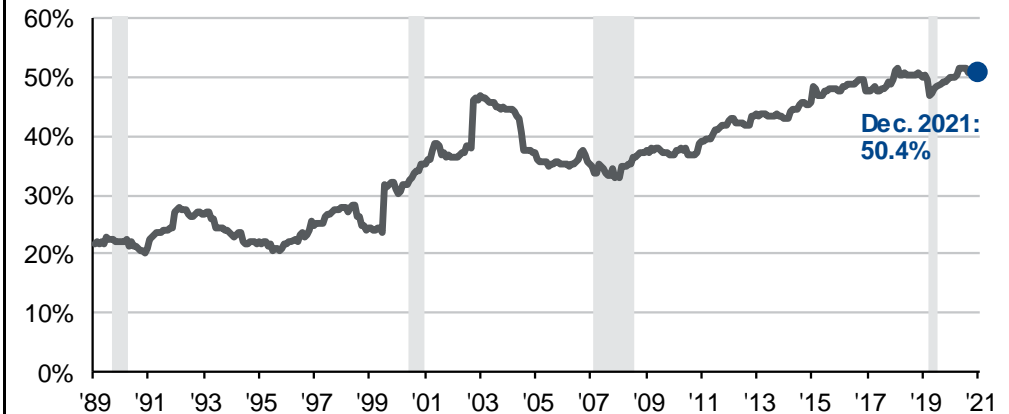

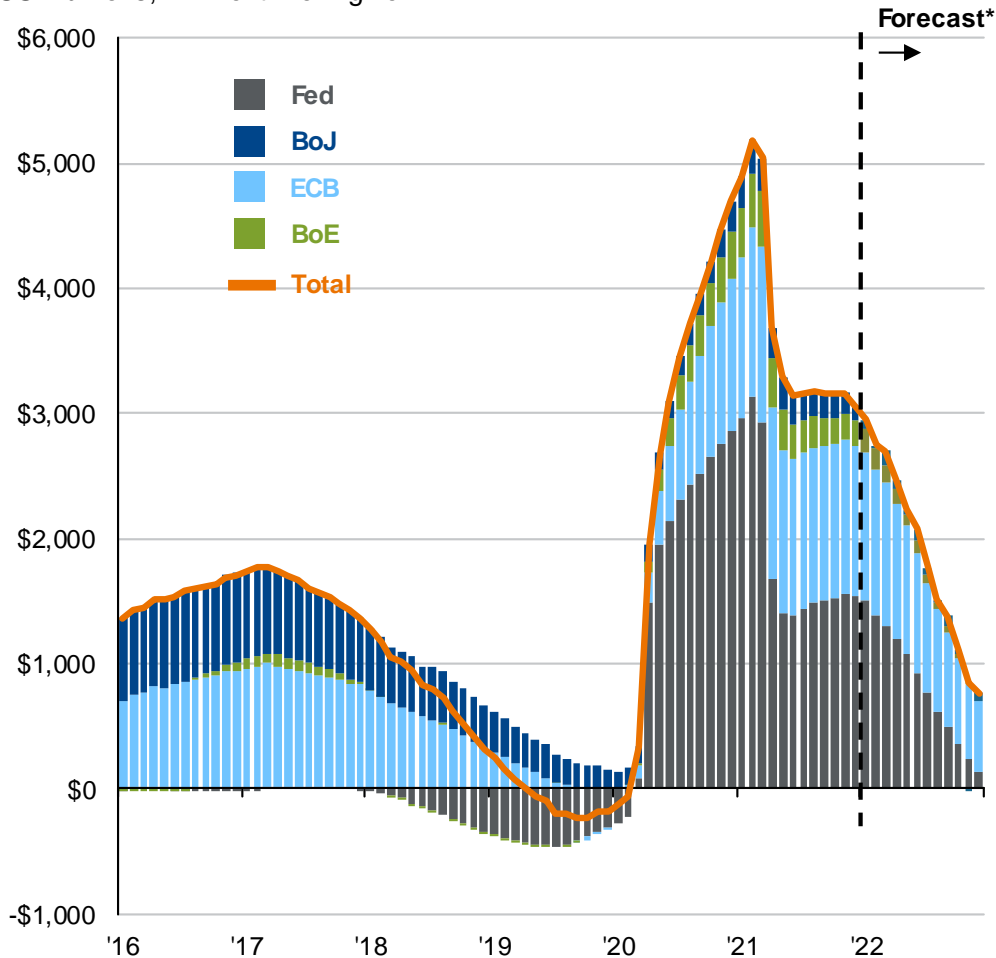

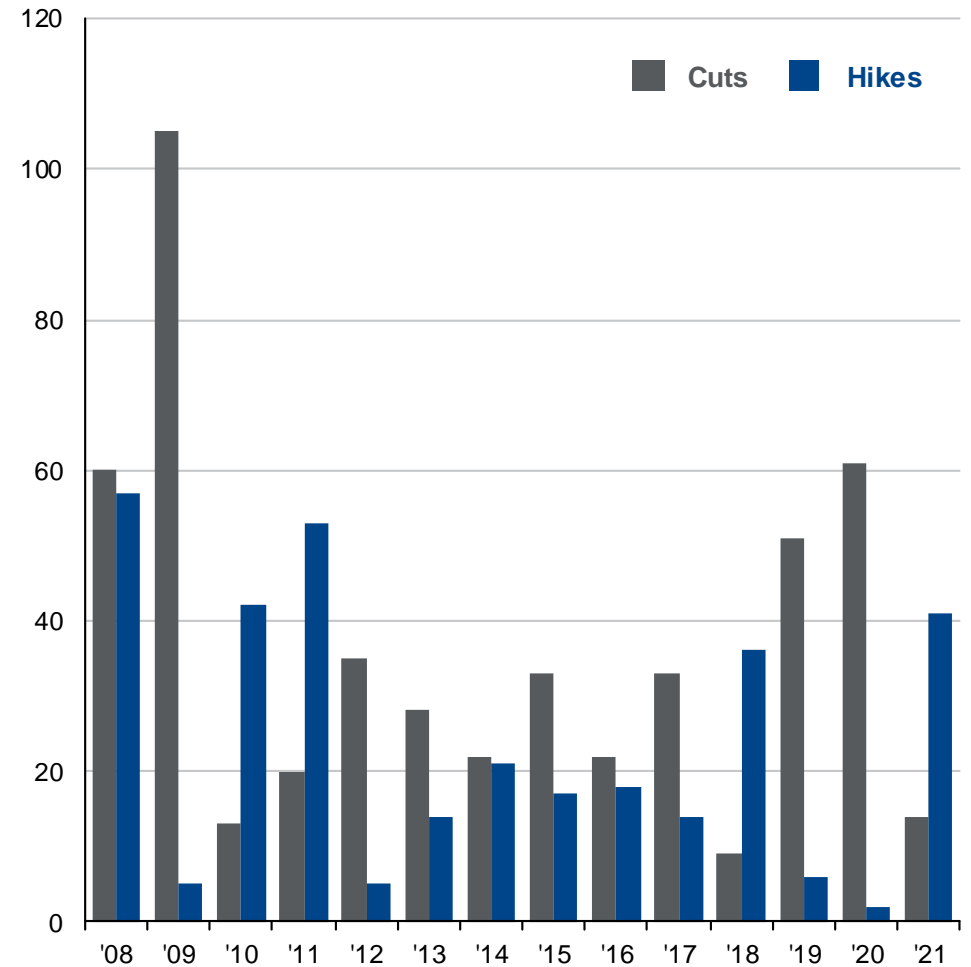

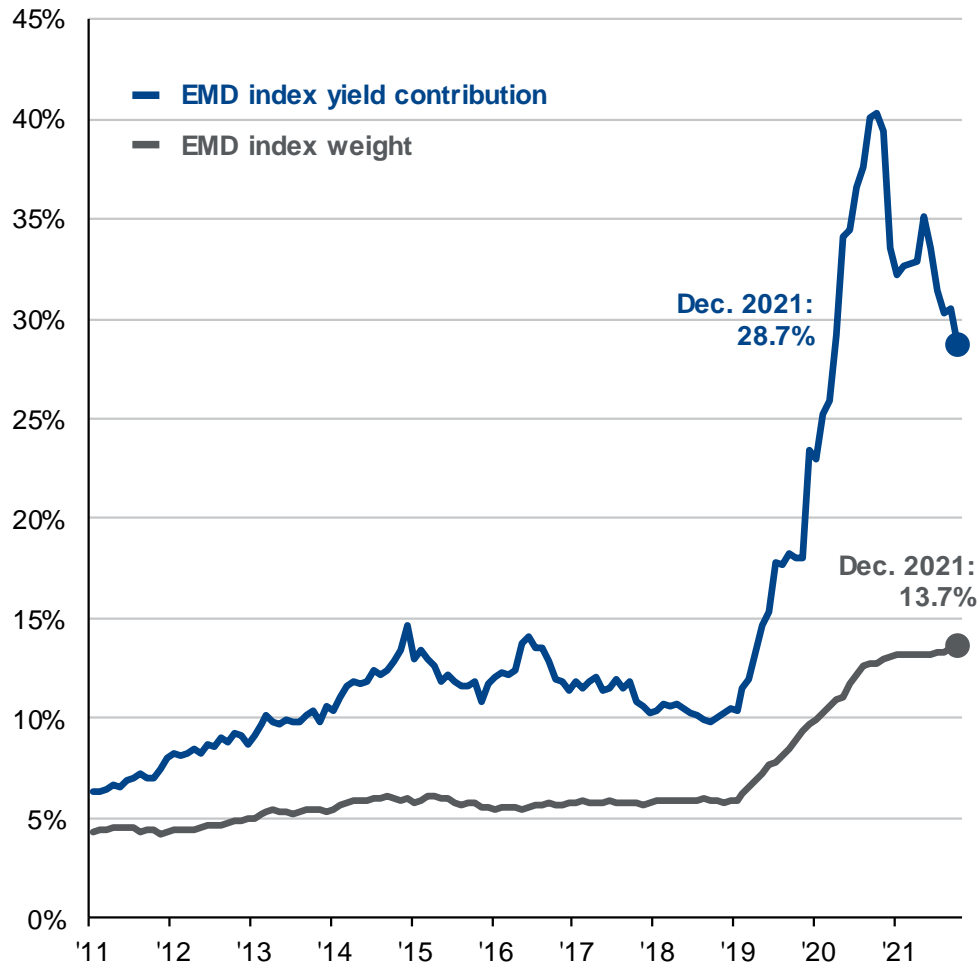

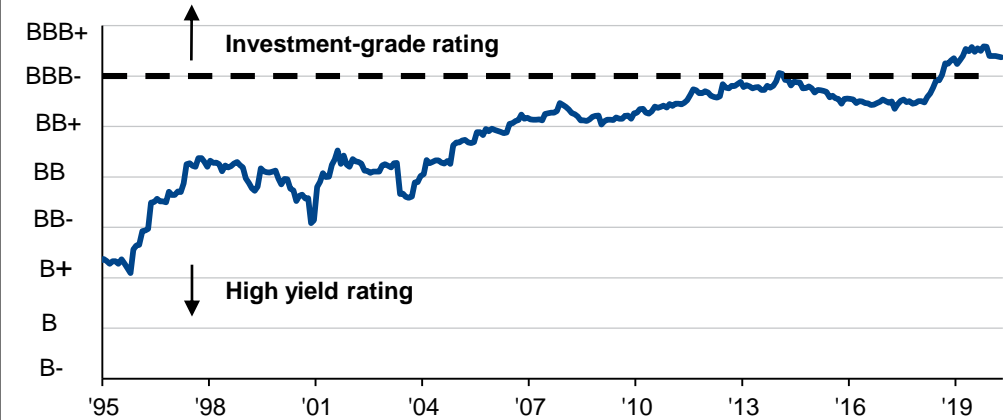

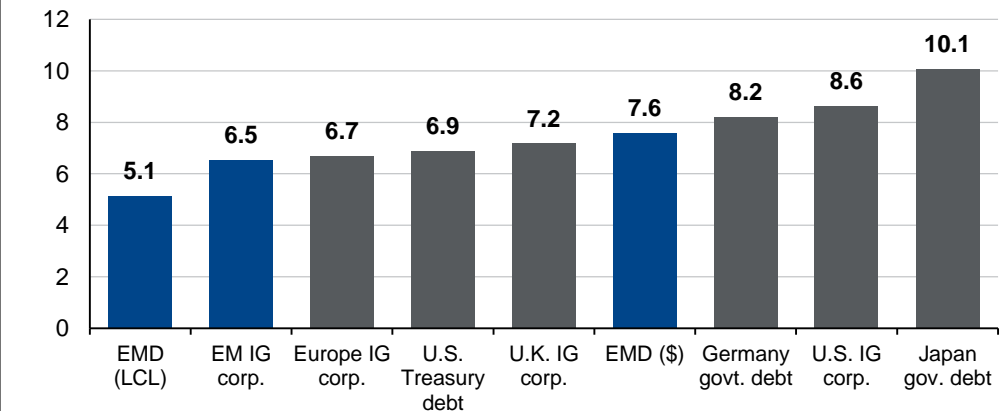
Average credit rating of EM debt universe

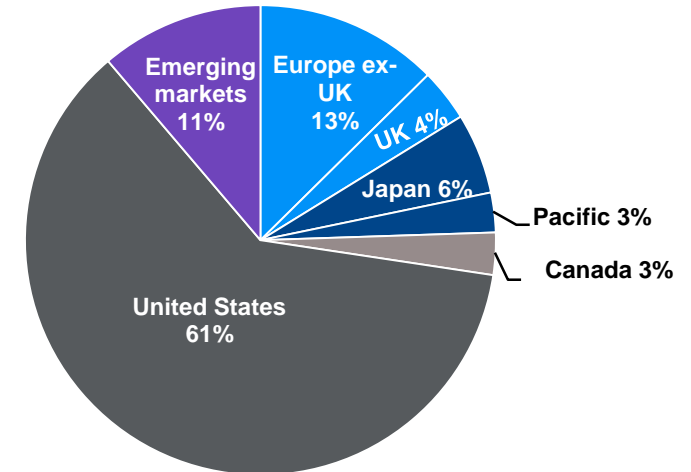

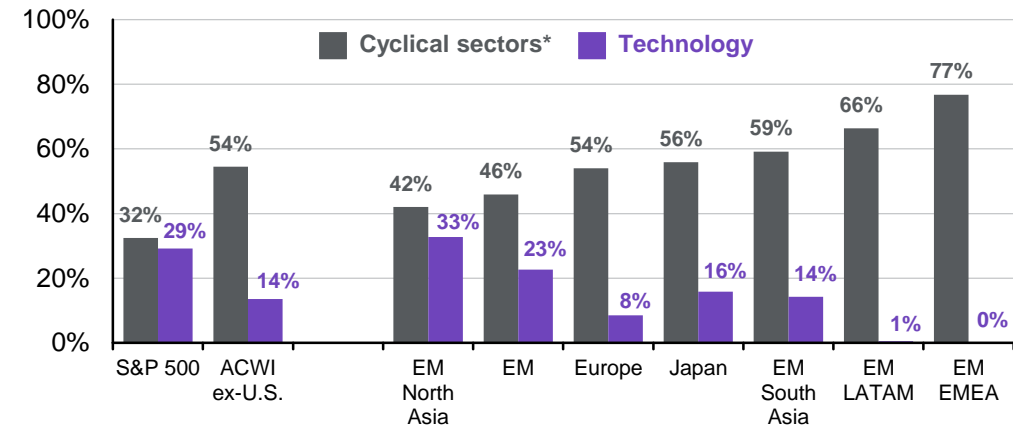
Weights in MSCI All Country World Index

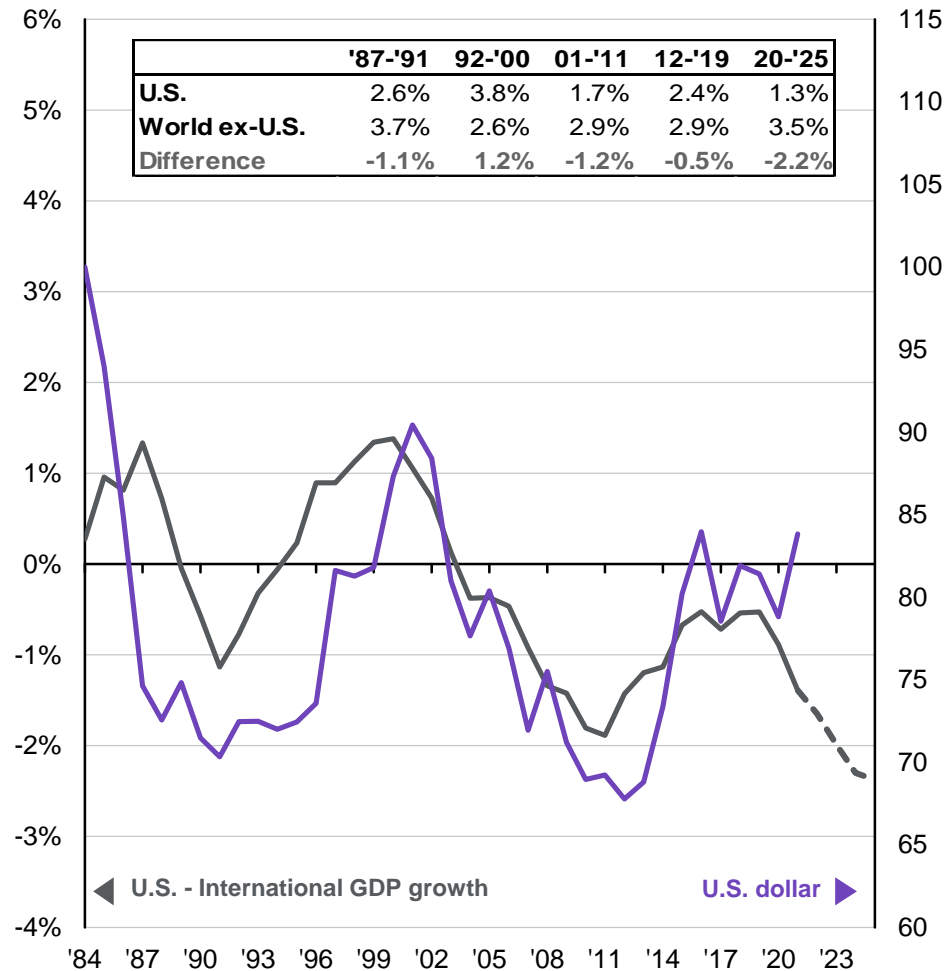

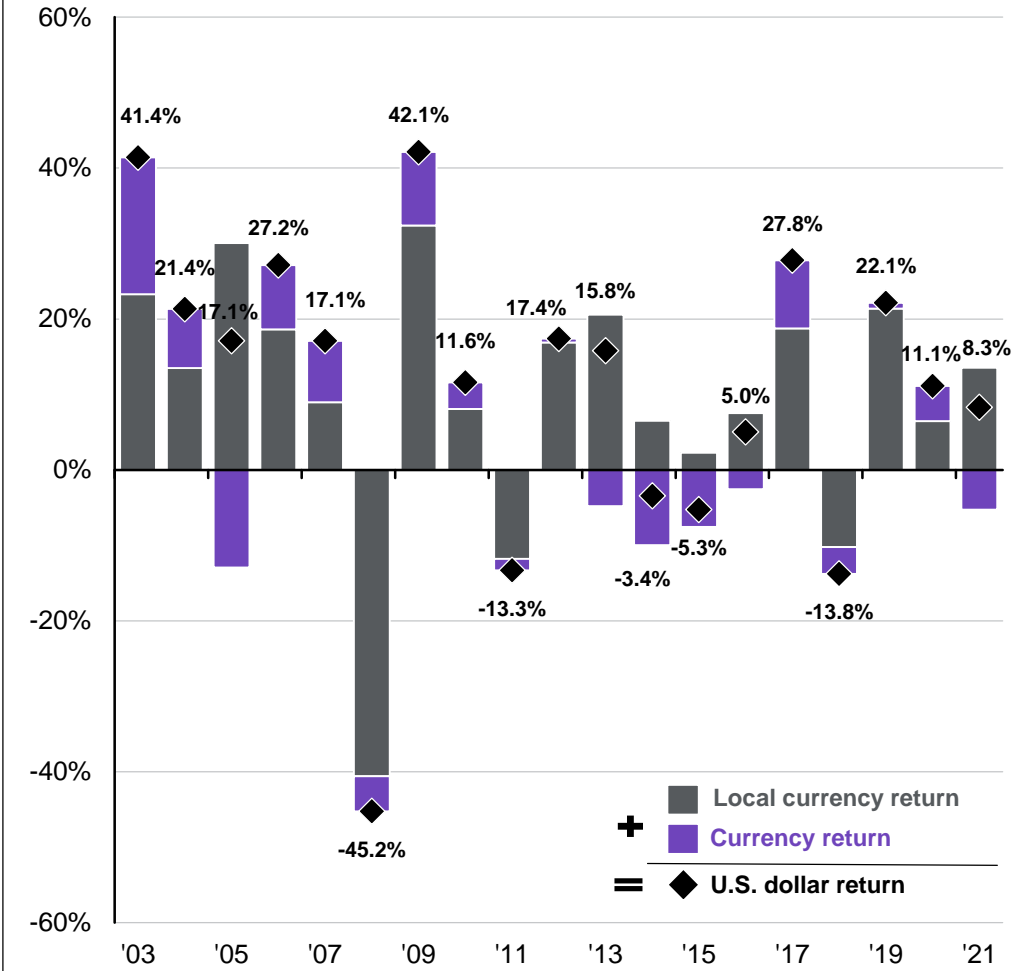
U.S. dollar and international GDP growth

Cycles of U.S. equity outperformance

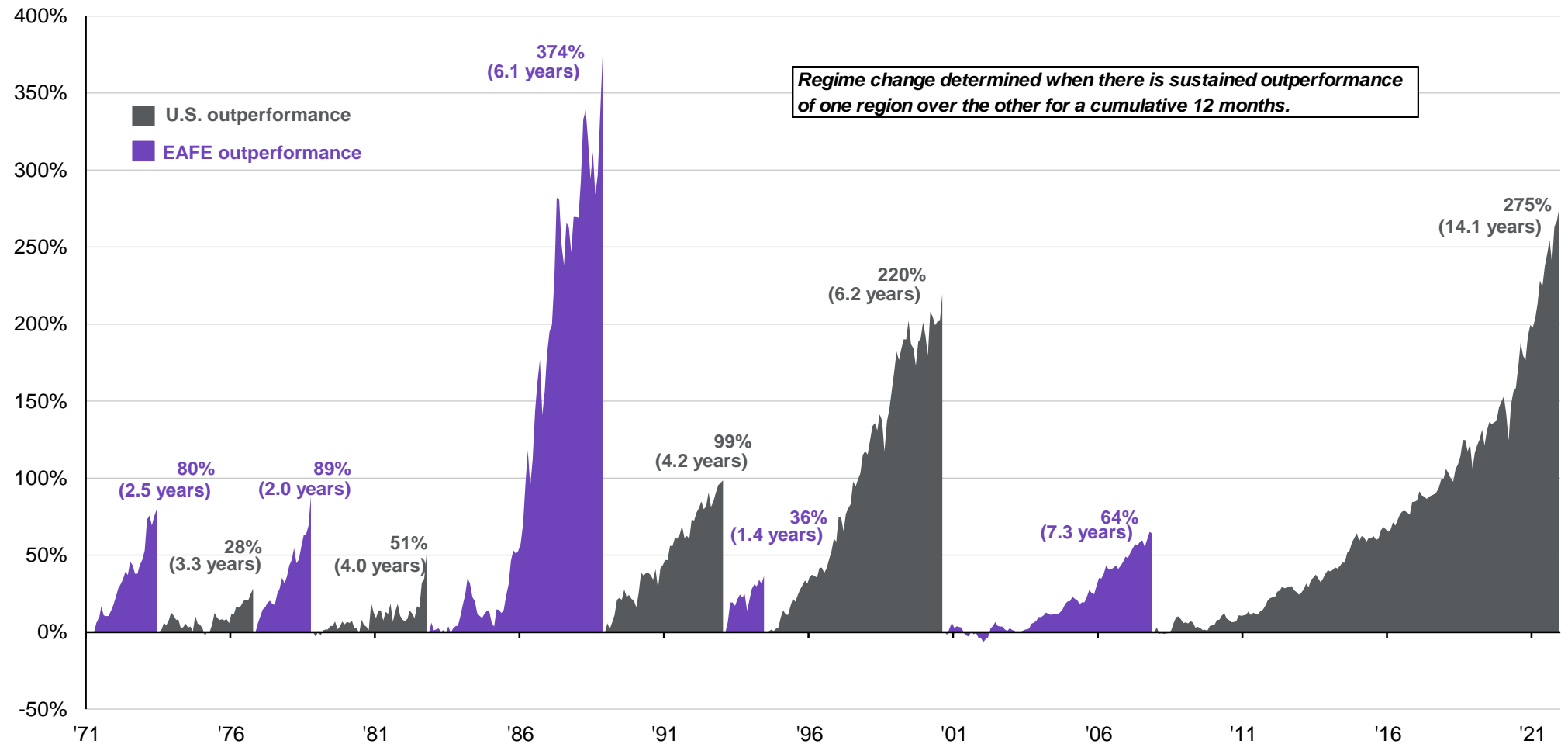

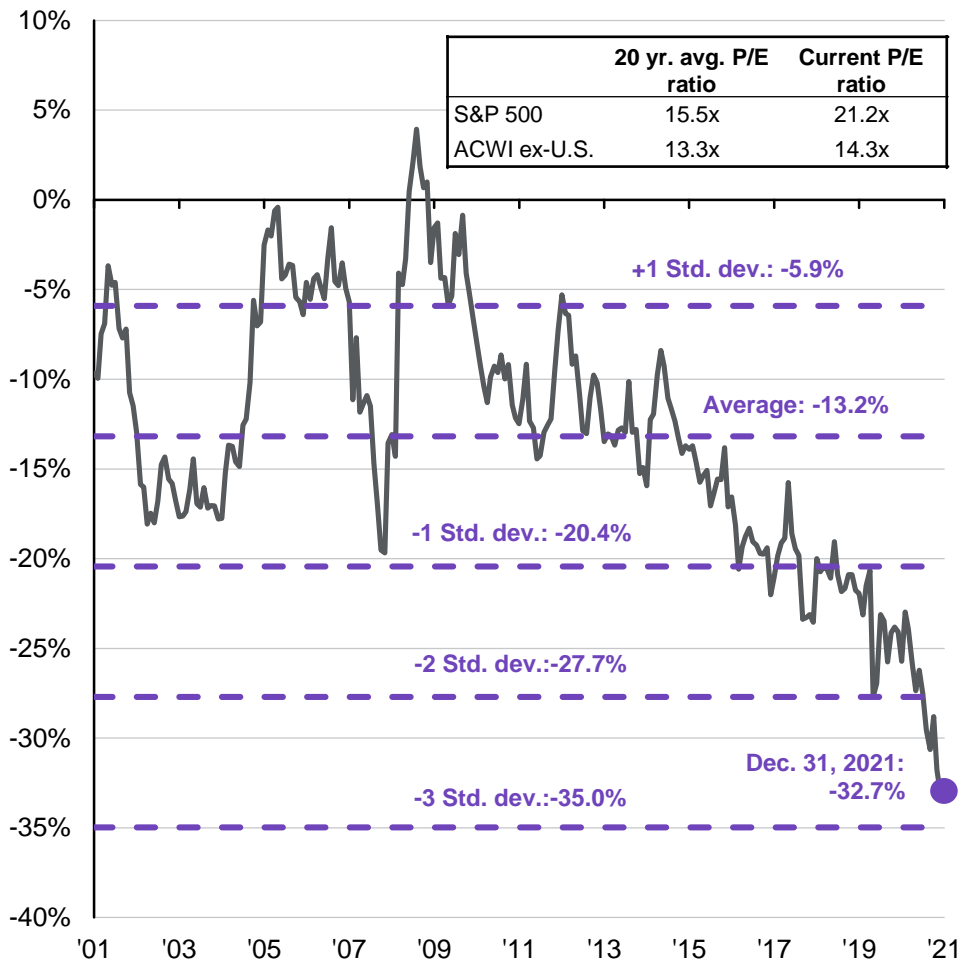

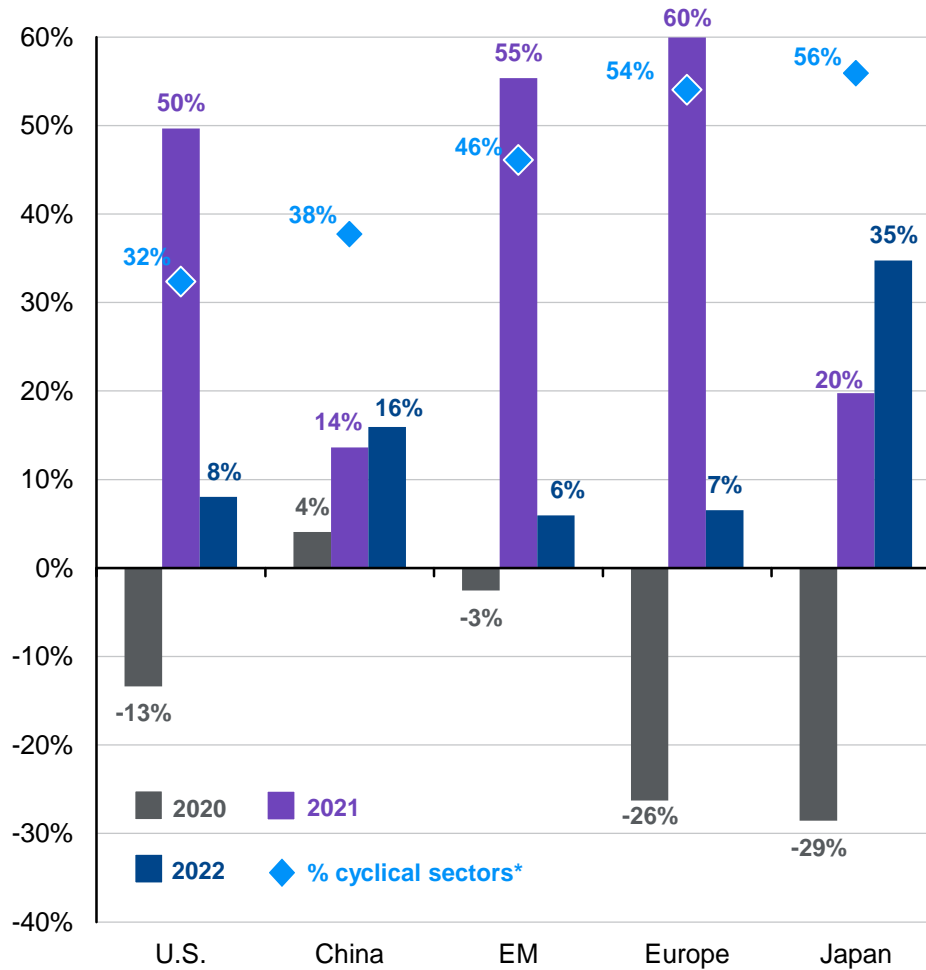

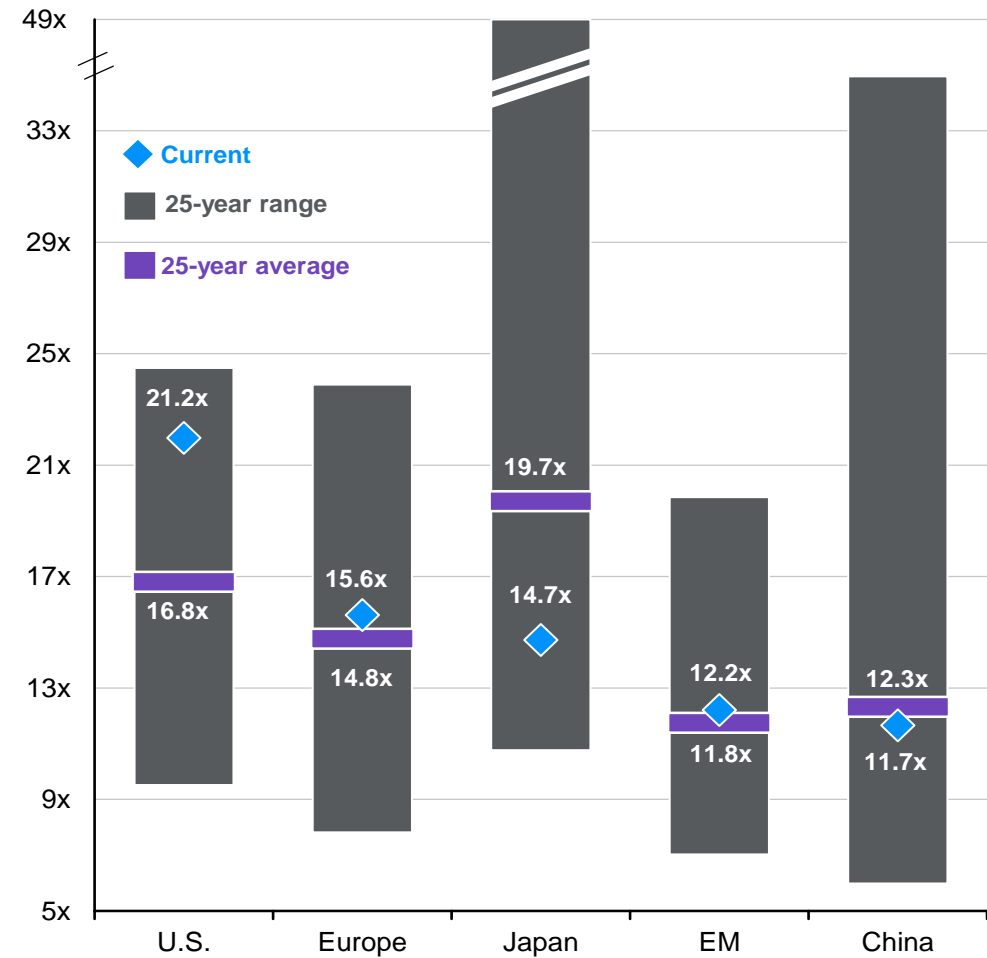

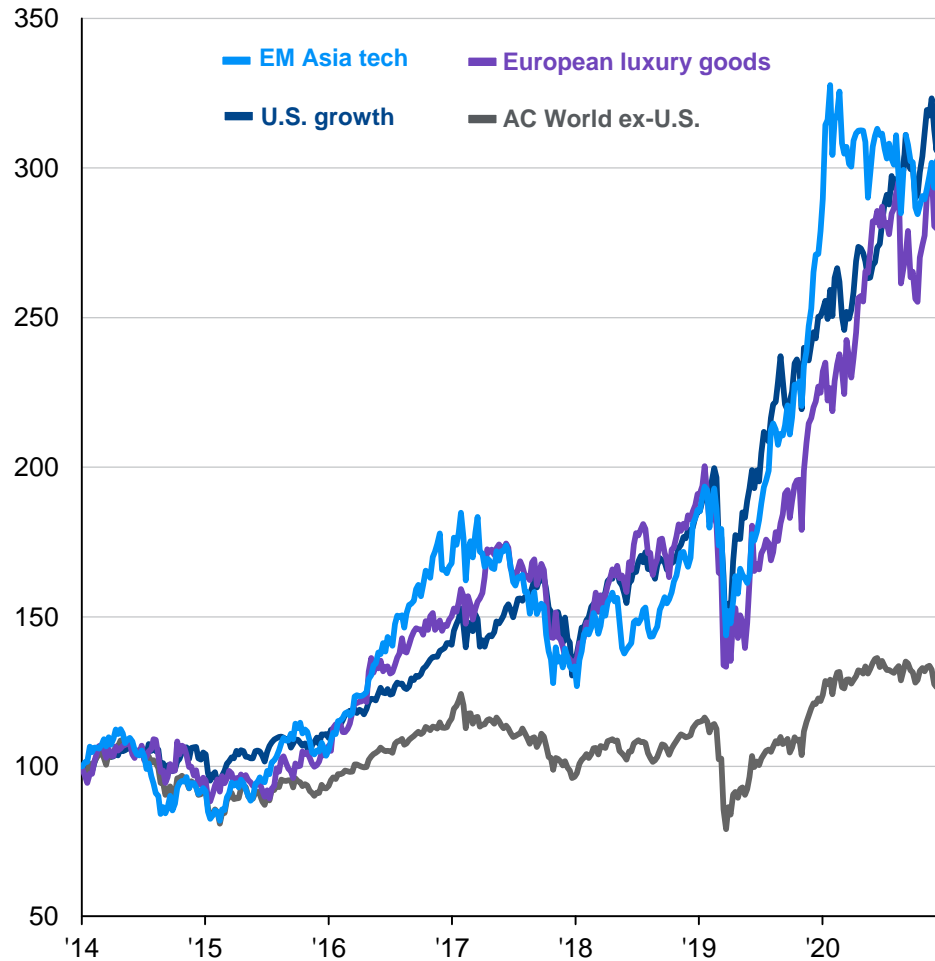

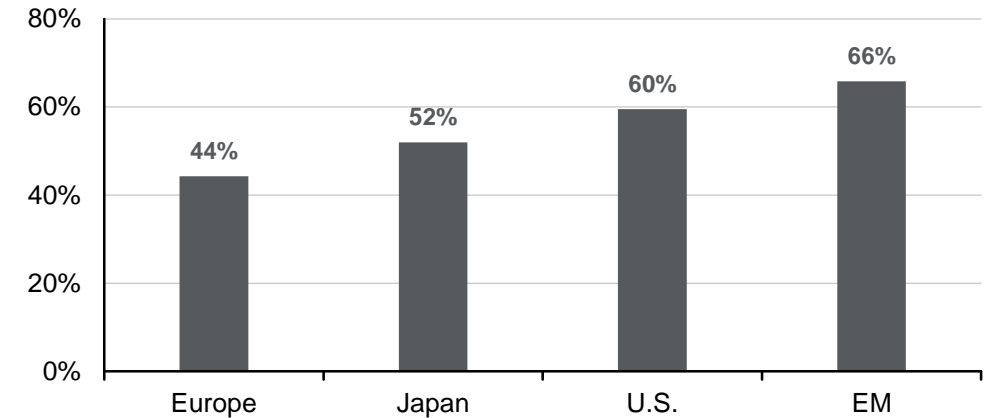
Returns of thematic indices

Total return, U.S. dollar, Dec. 31, 2014 = 100



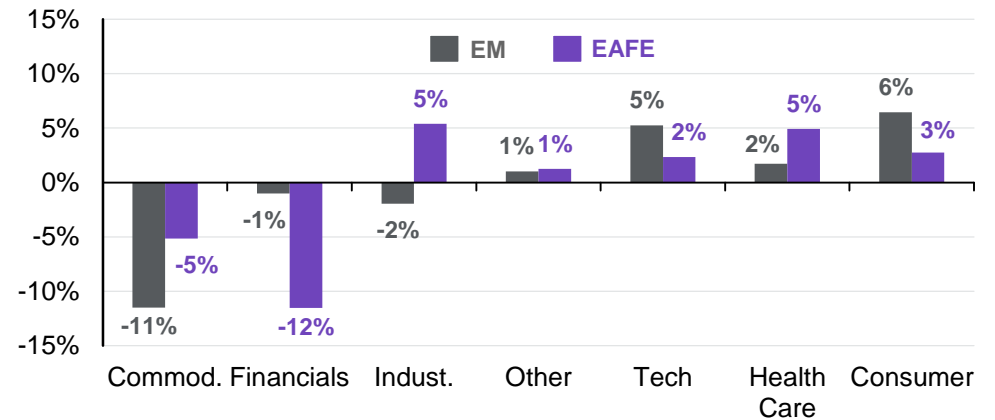
Revenue exposure vs. country of listing

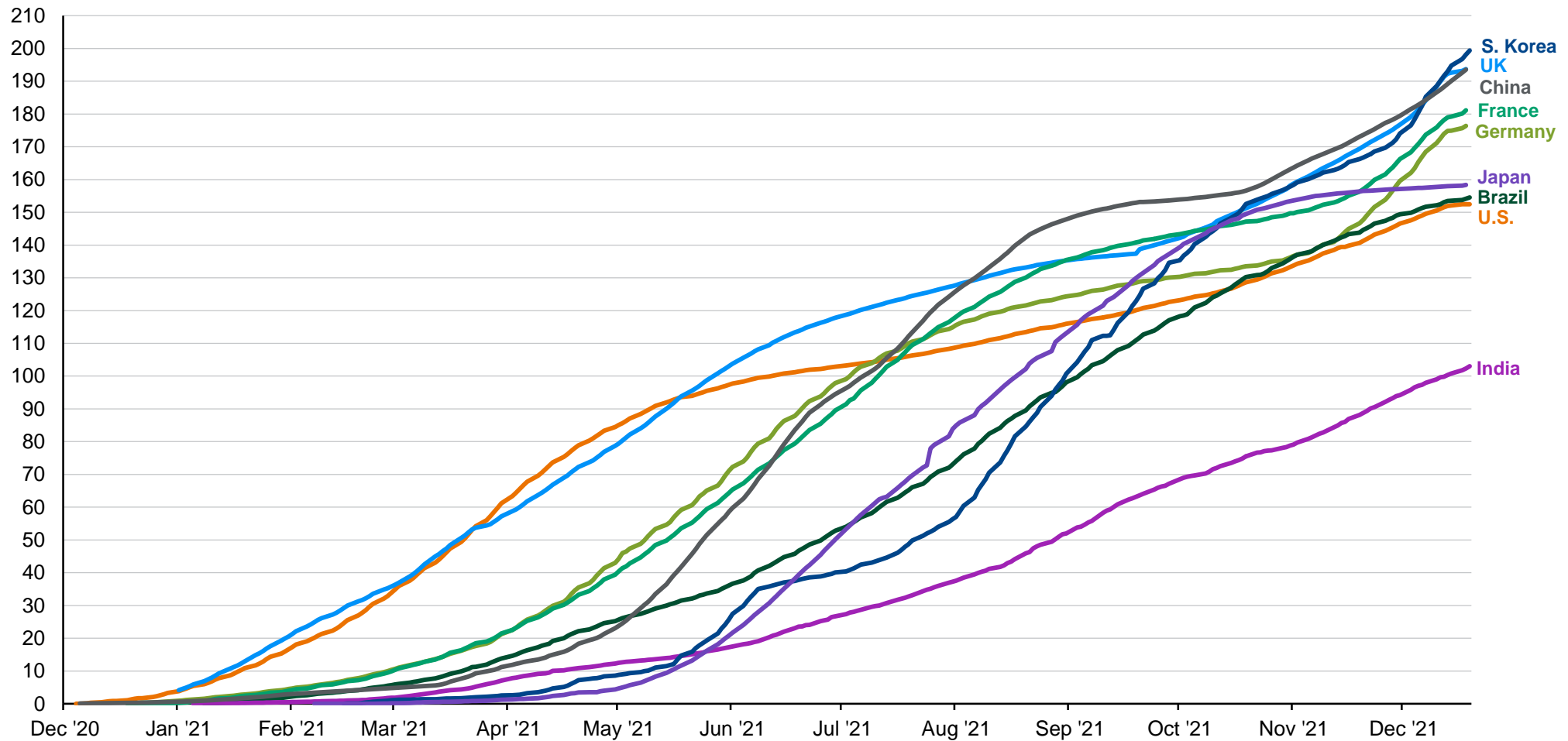

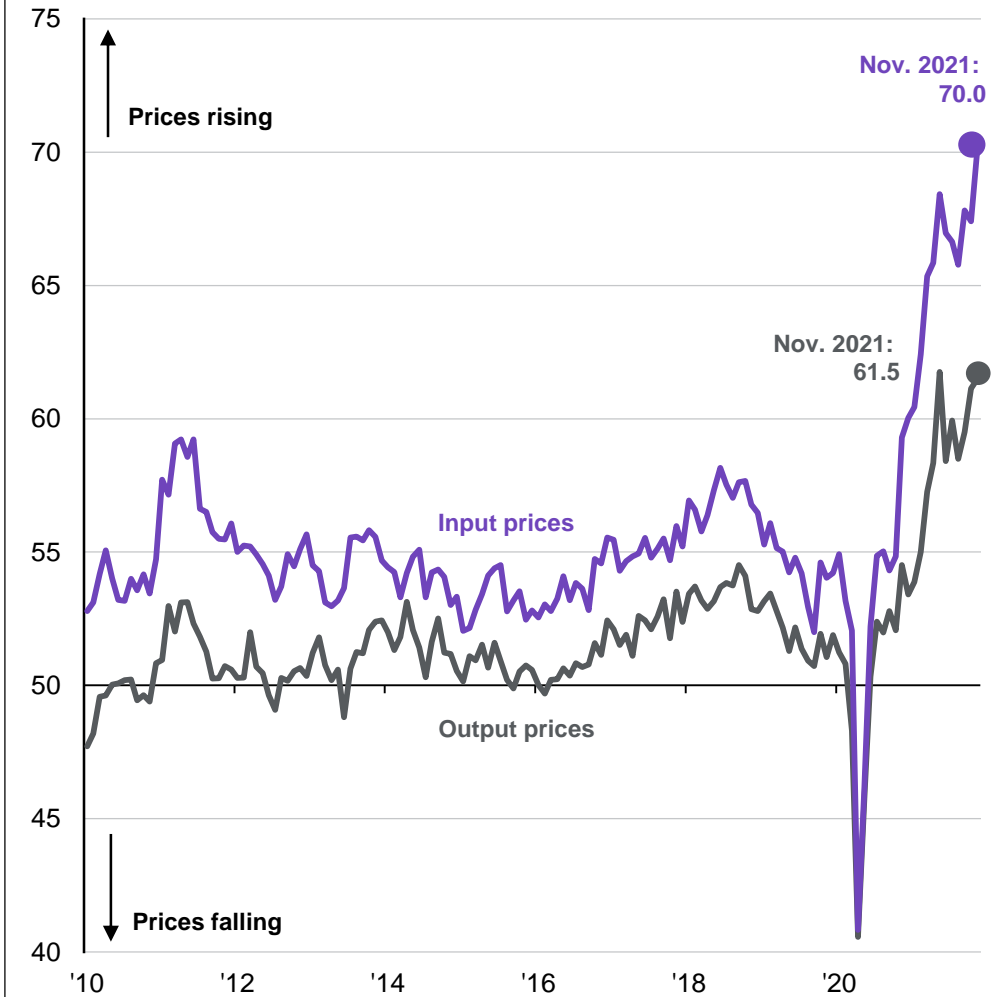

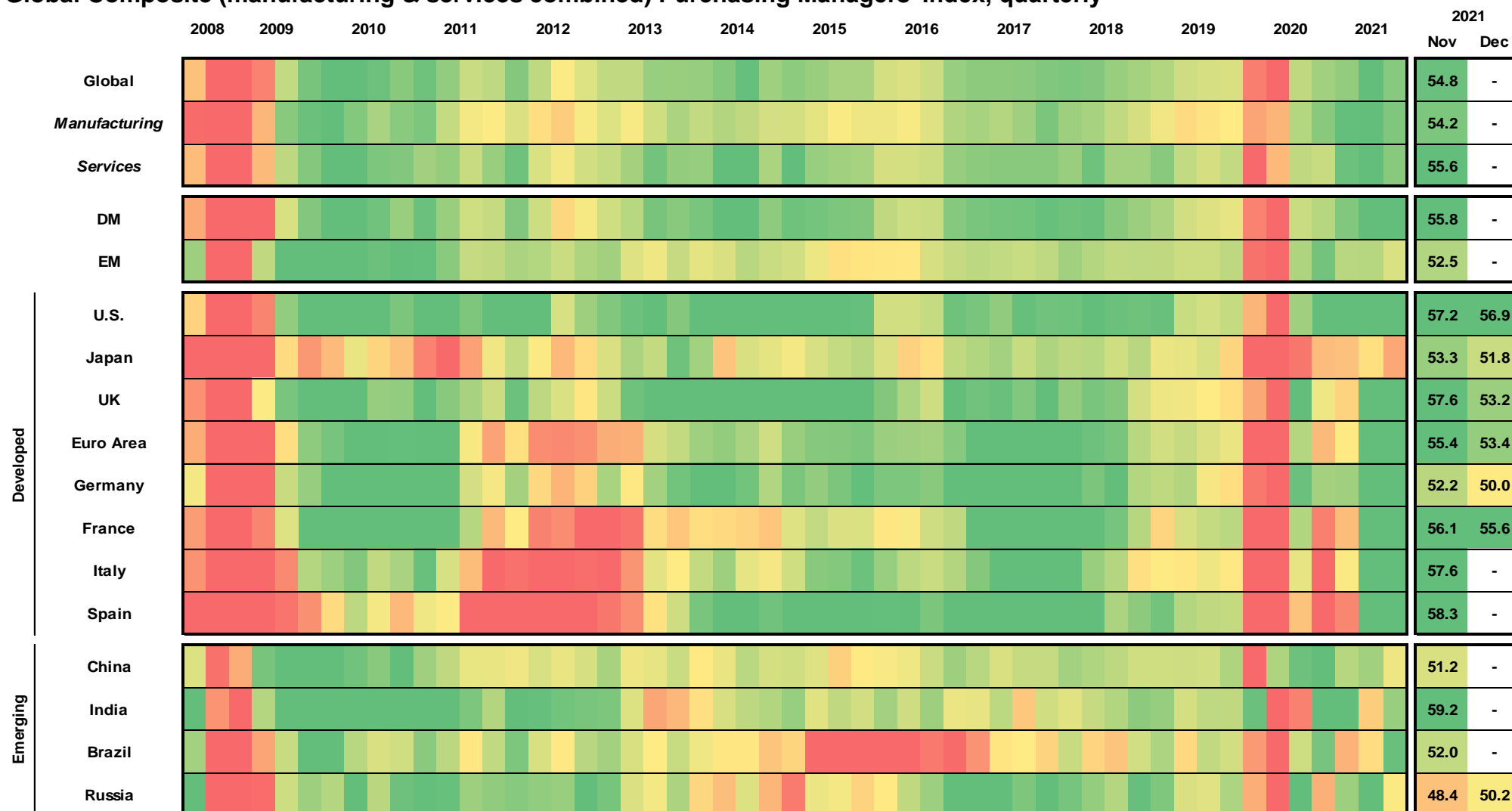

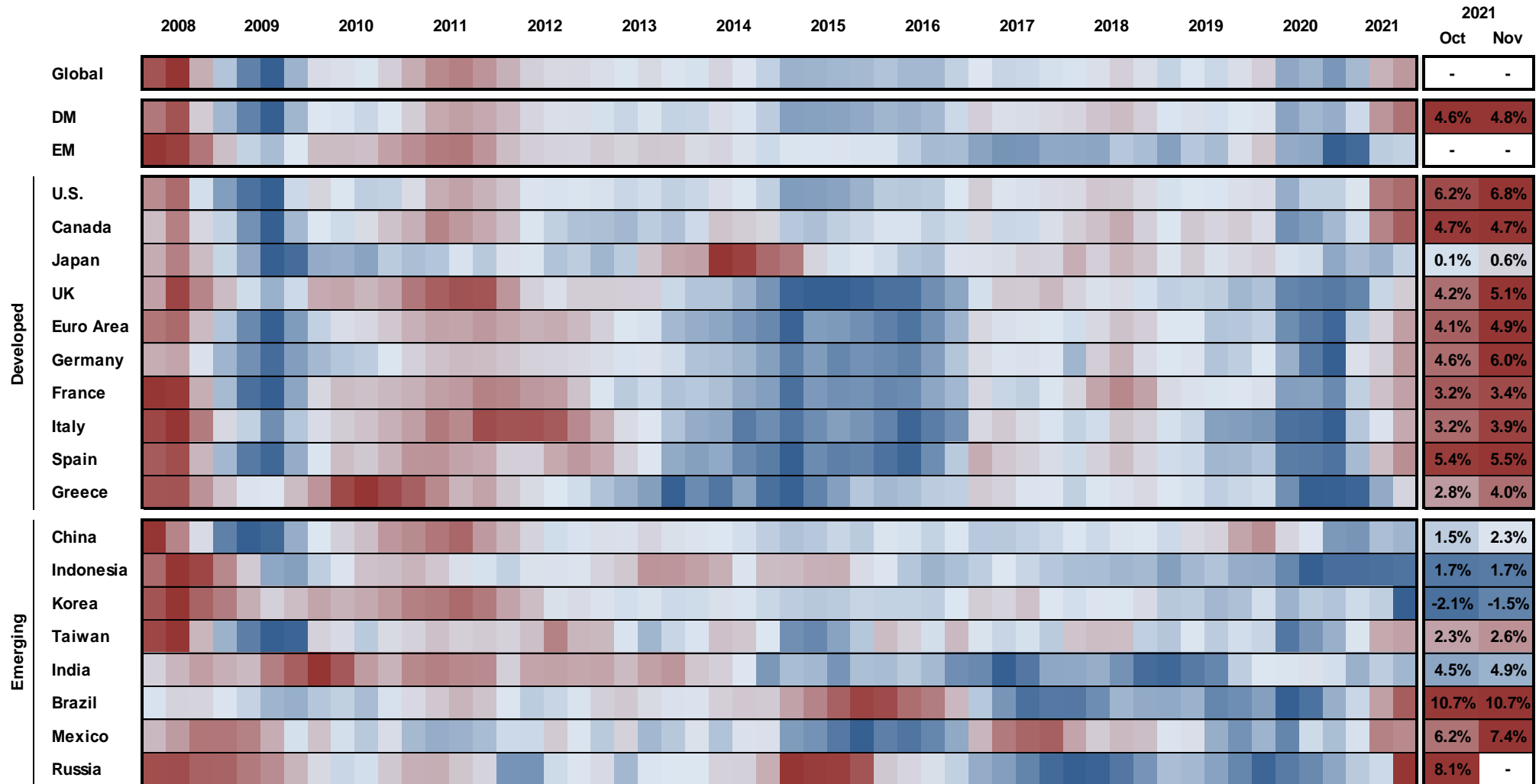

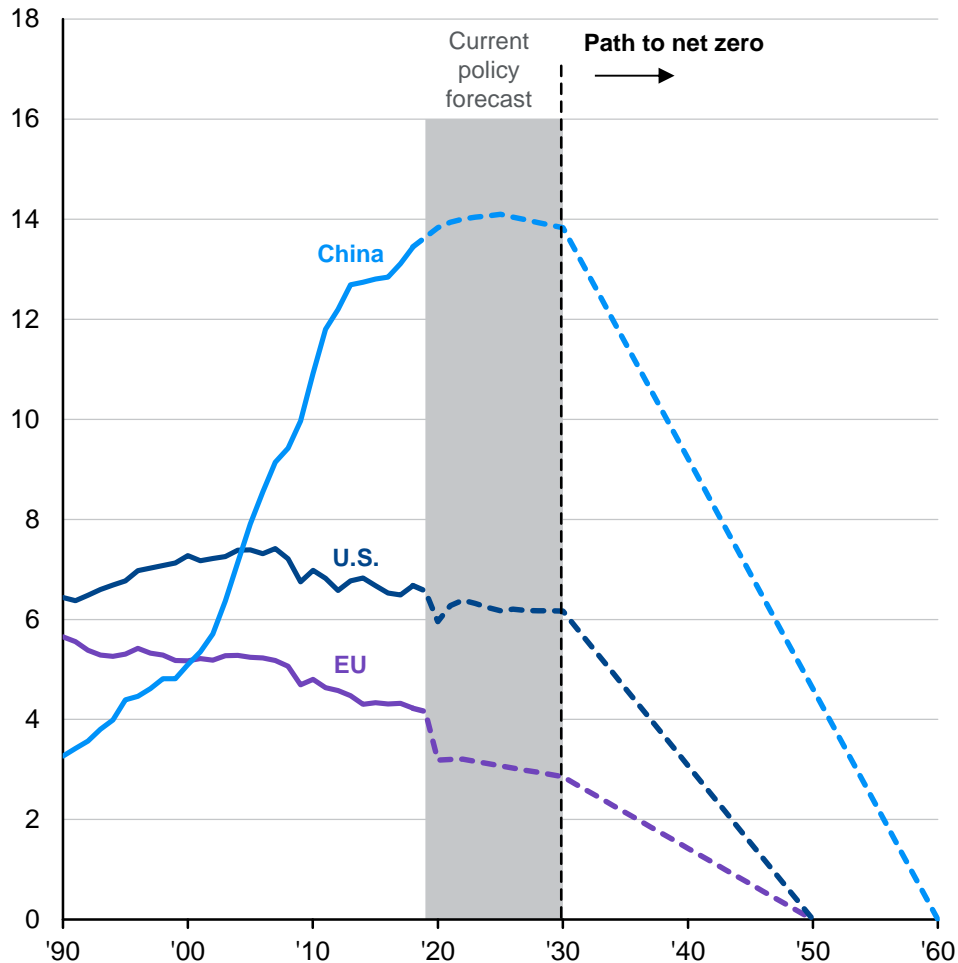

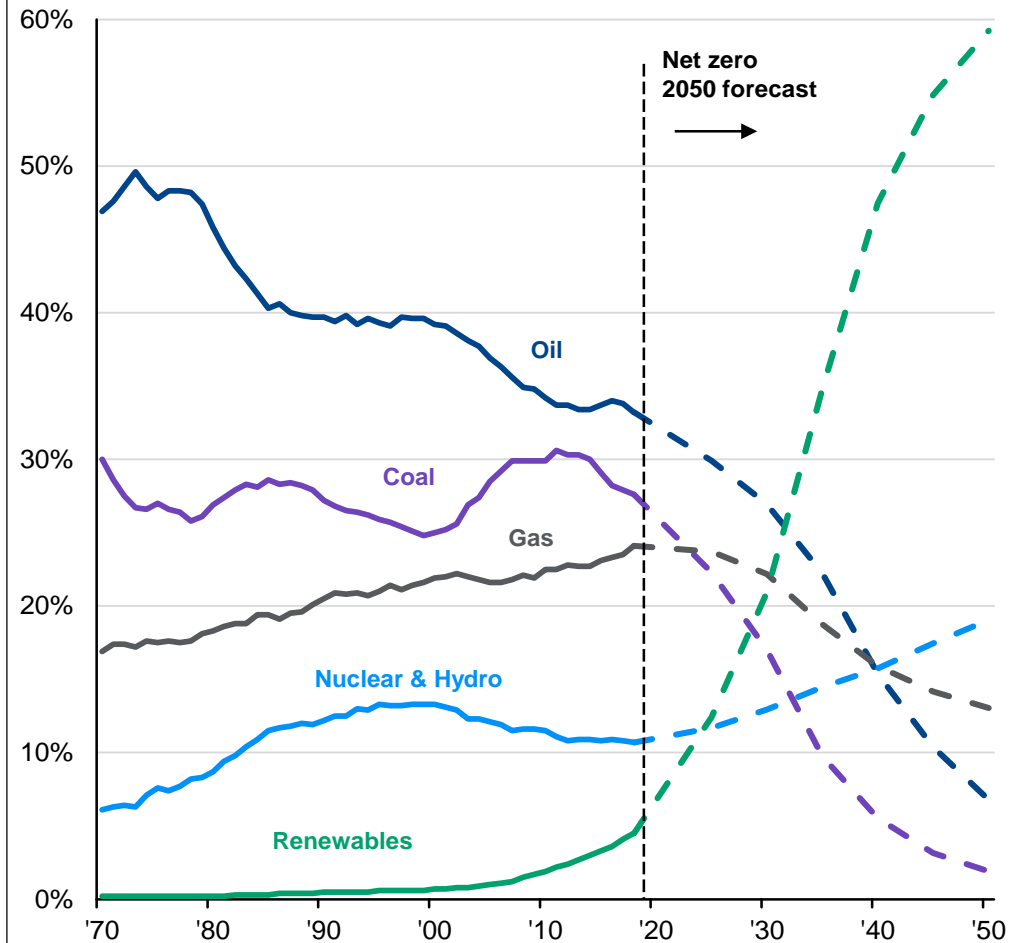

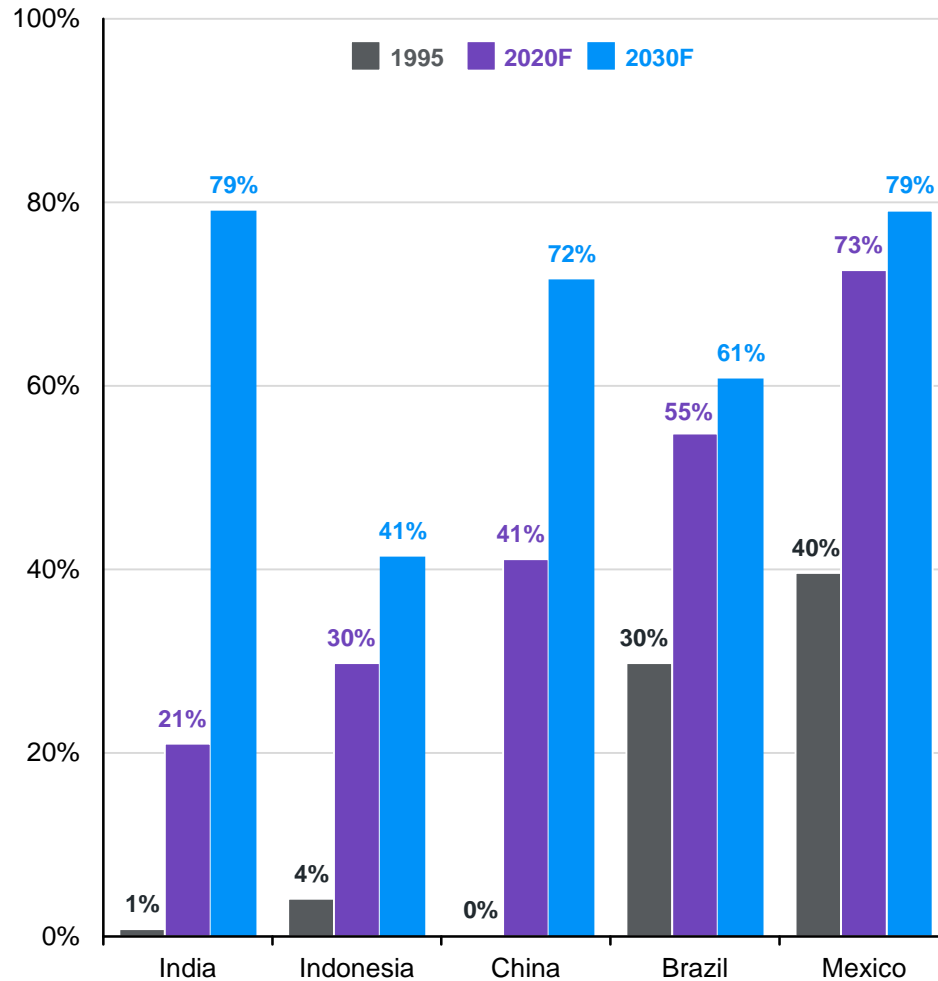

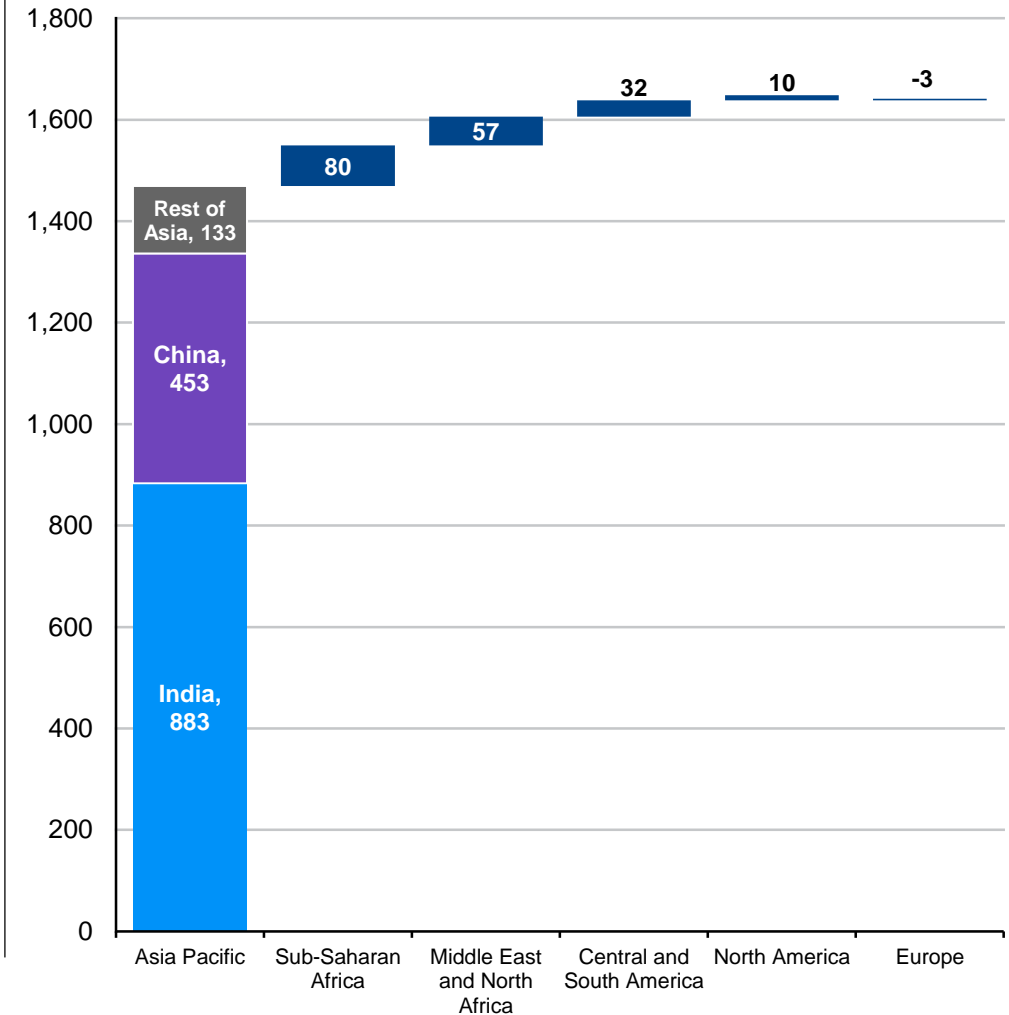

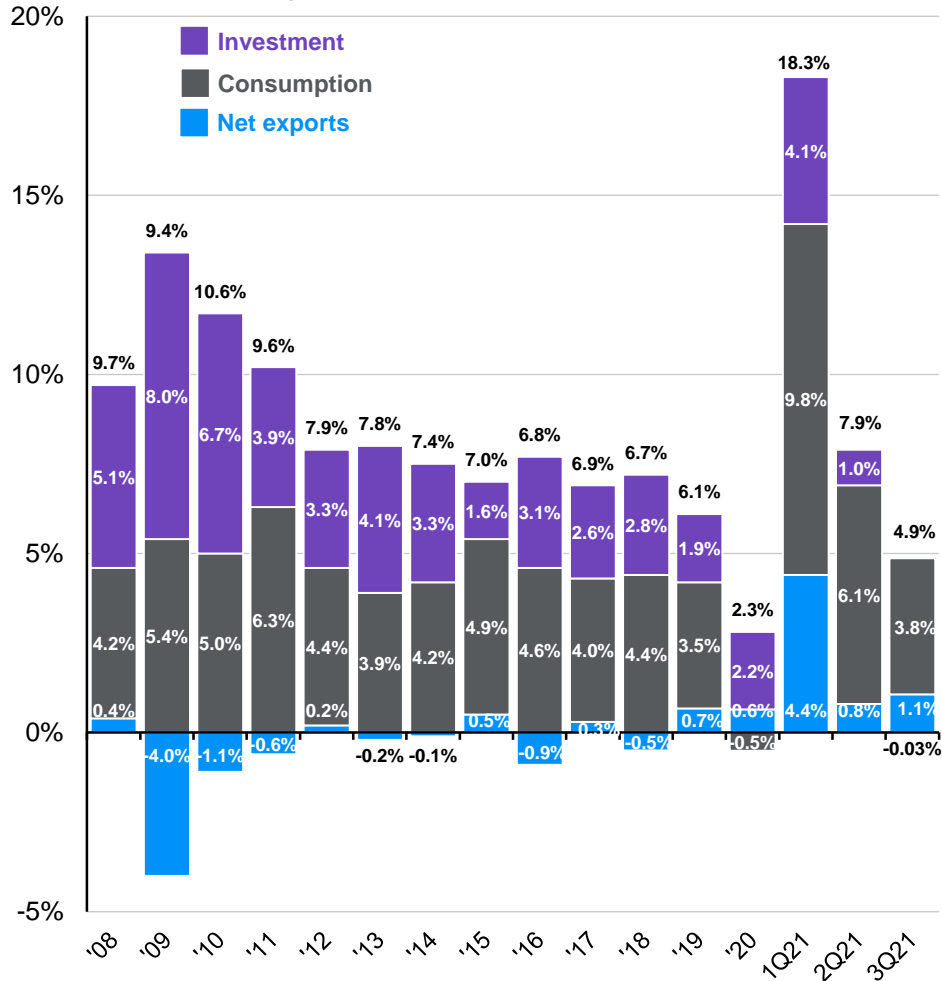

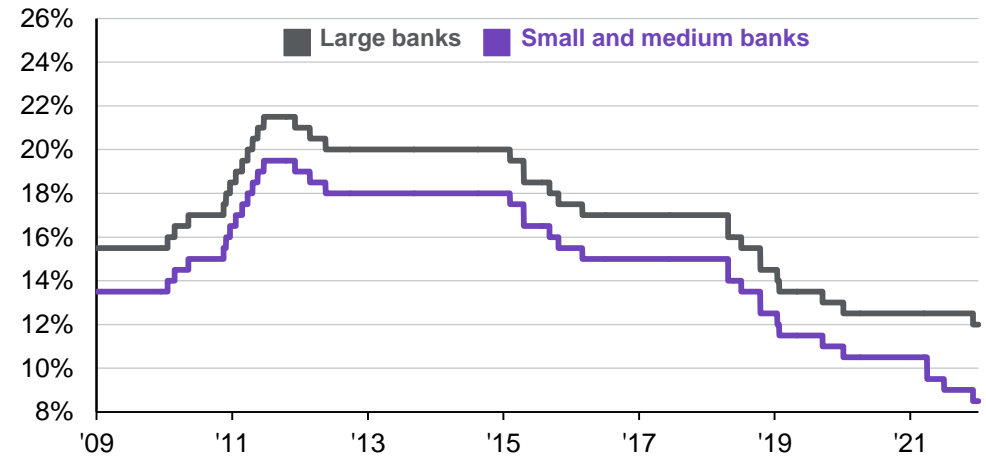

Year-over-year % change

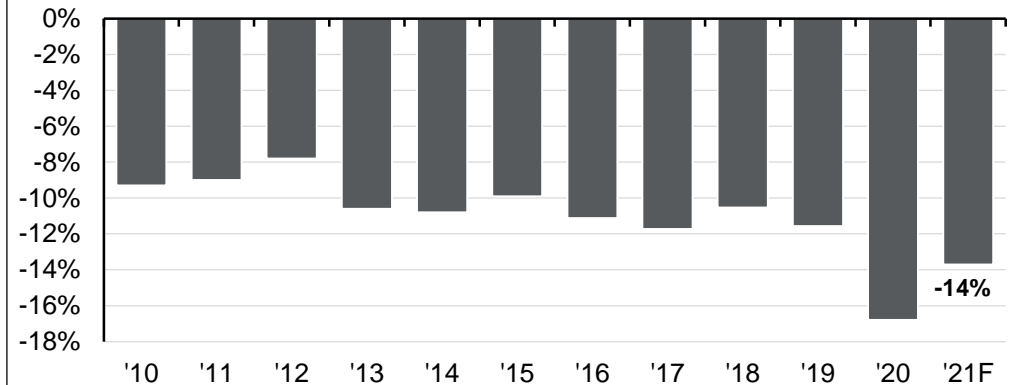


Monetary stimulus: Reserve requirement ratio

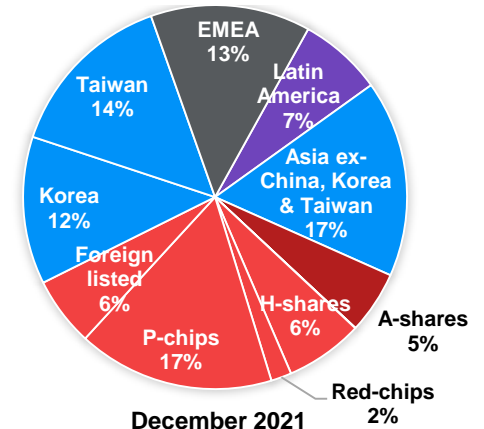

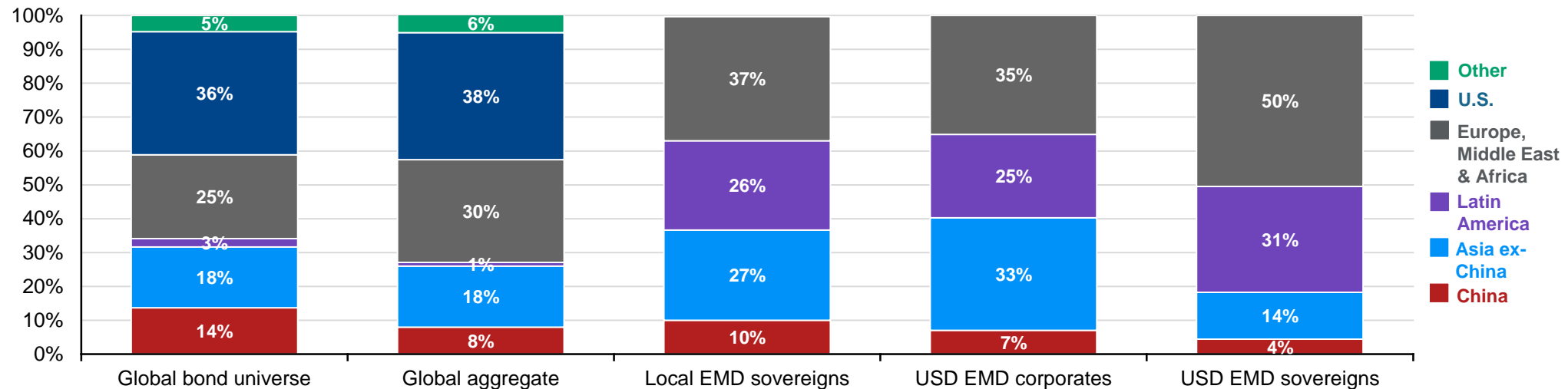

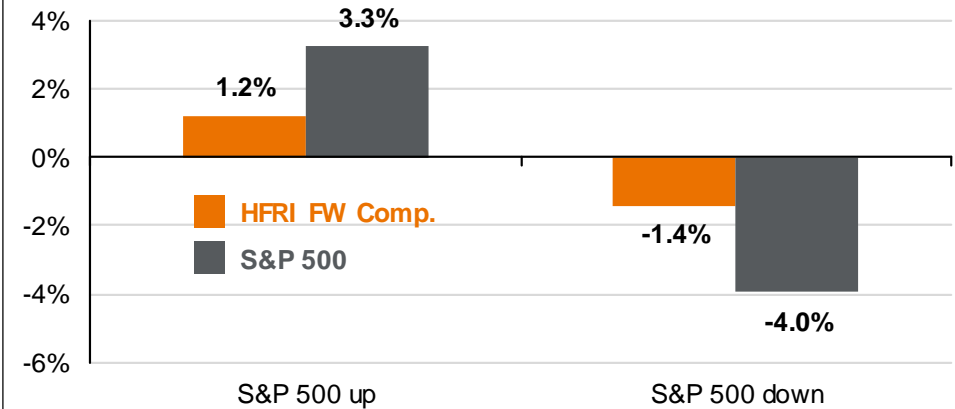

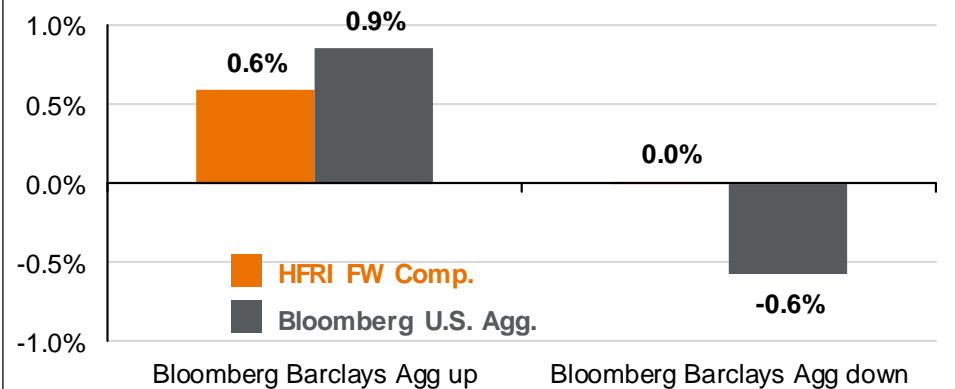
Hedge fund returns in different market environments

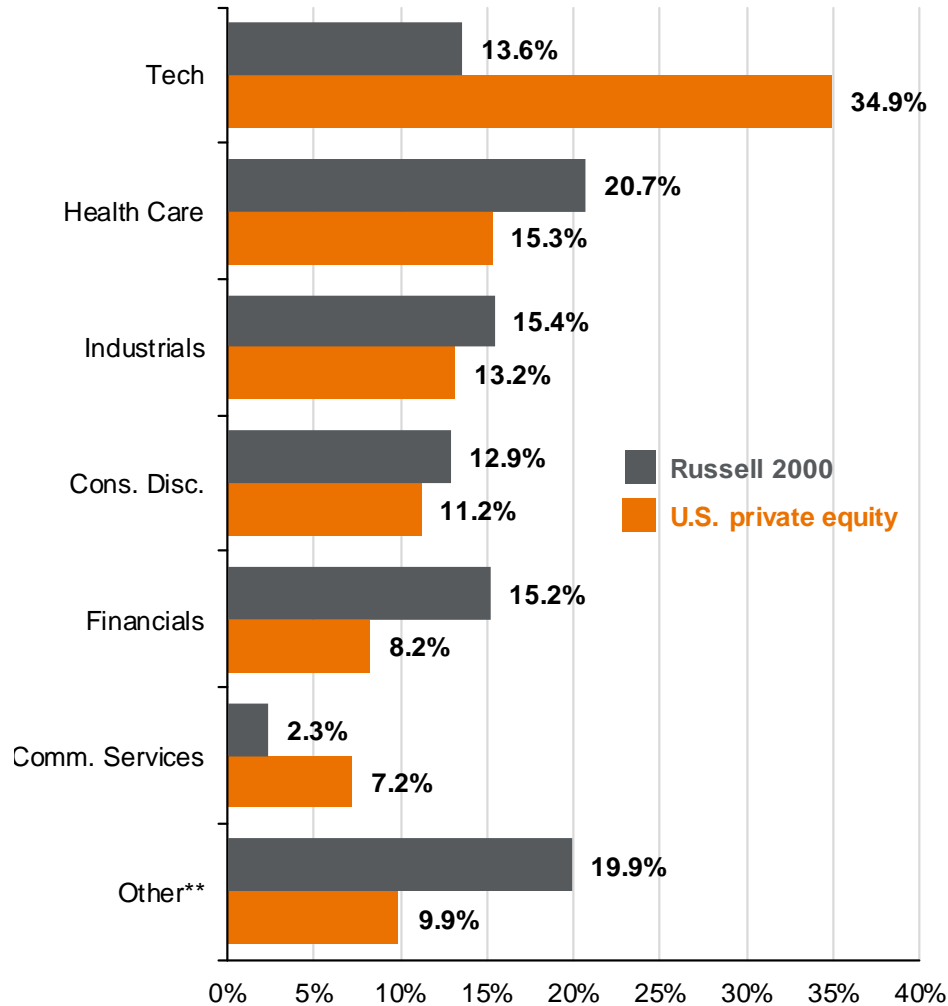

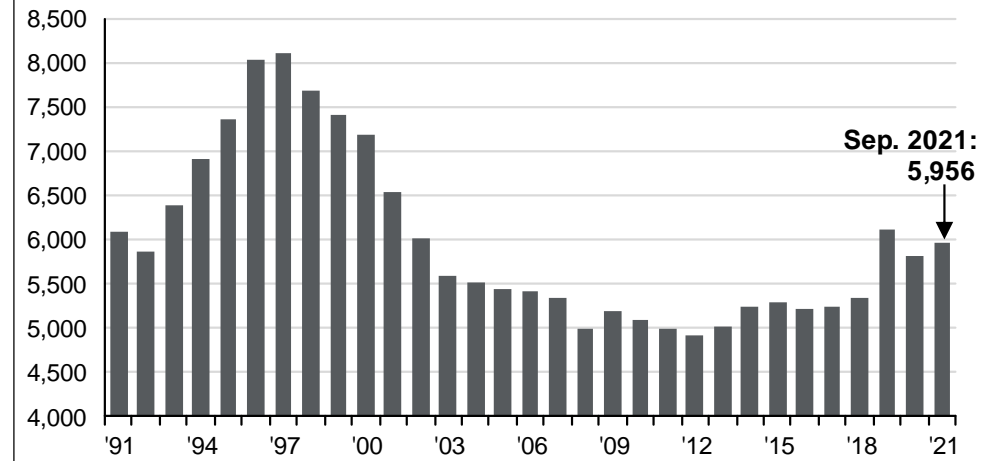

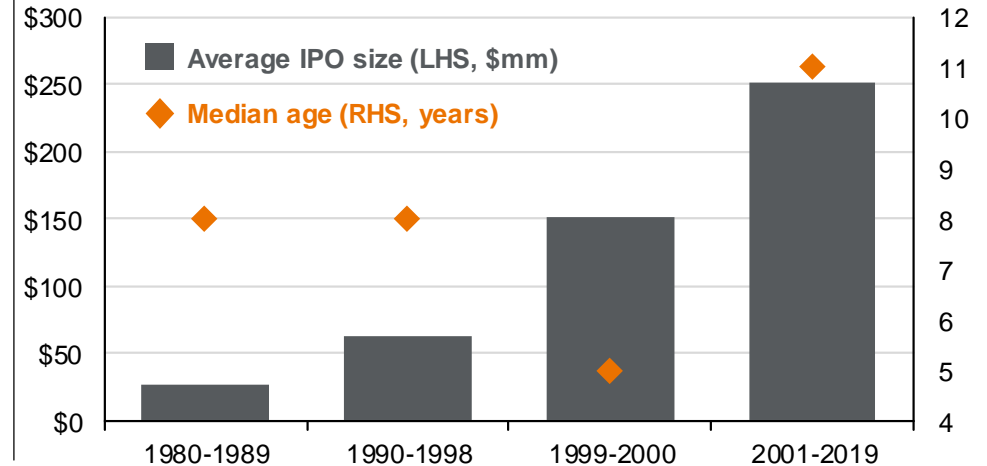
Private vs. public equity sector weights

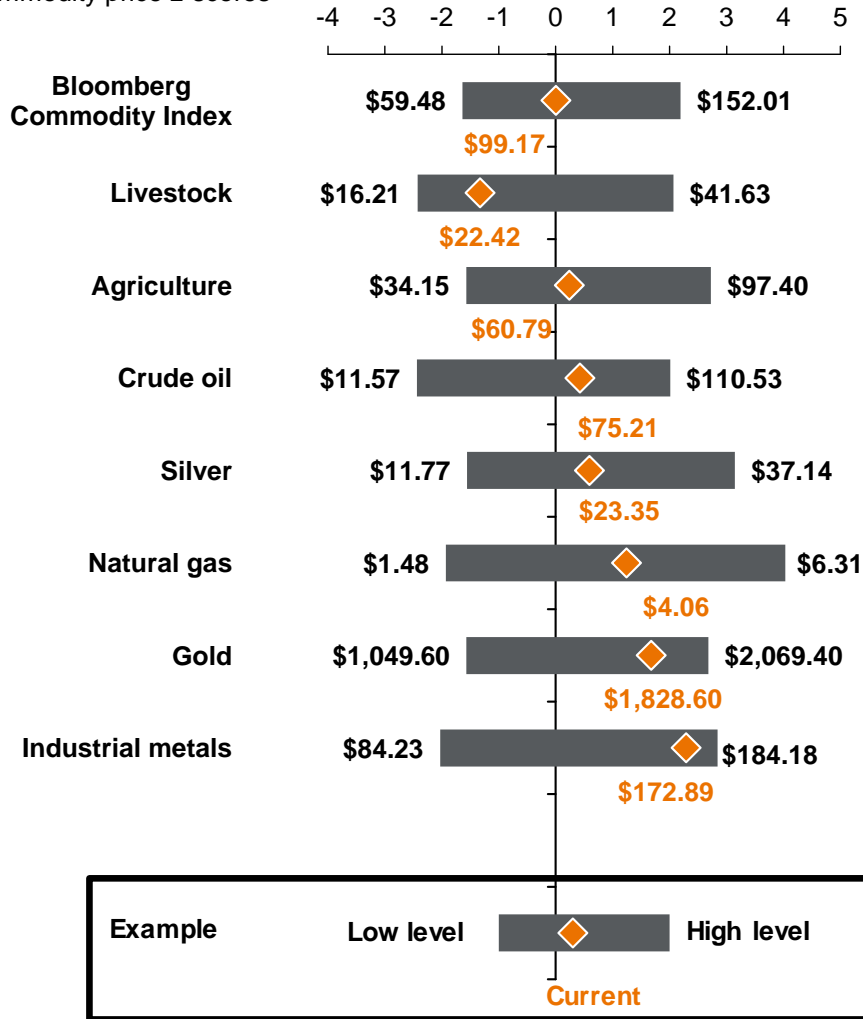

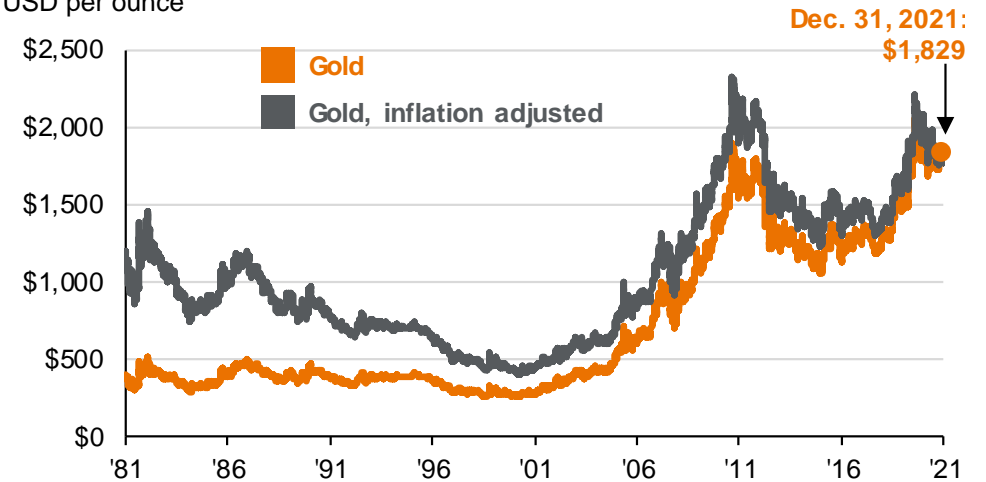

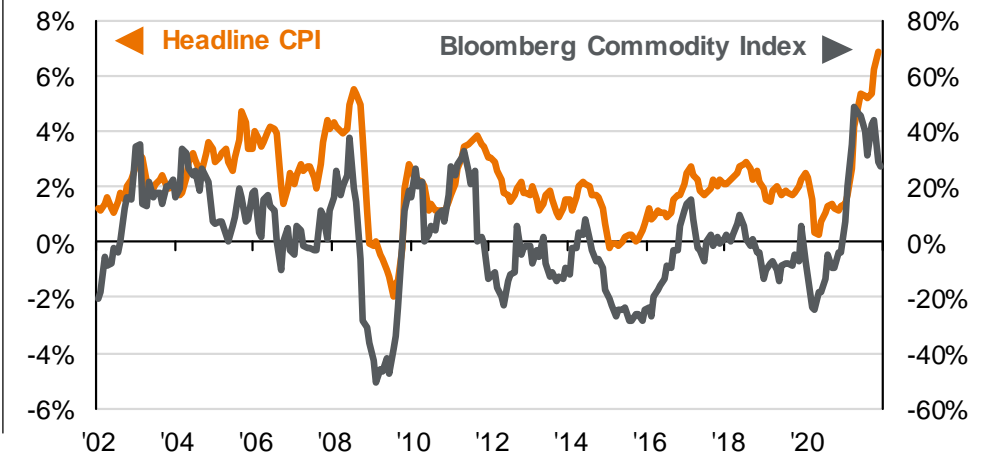

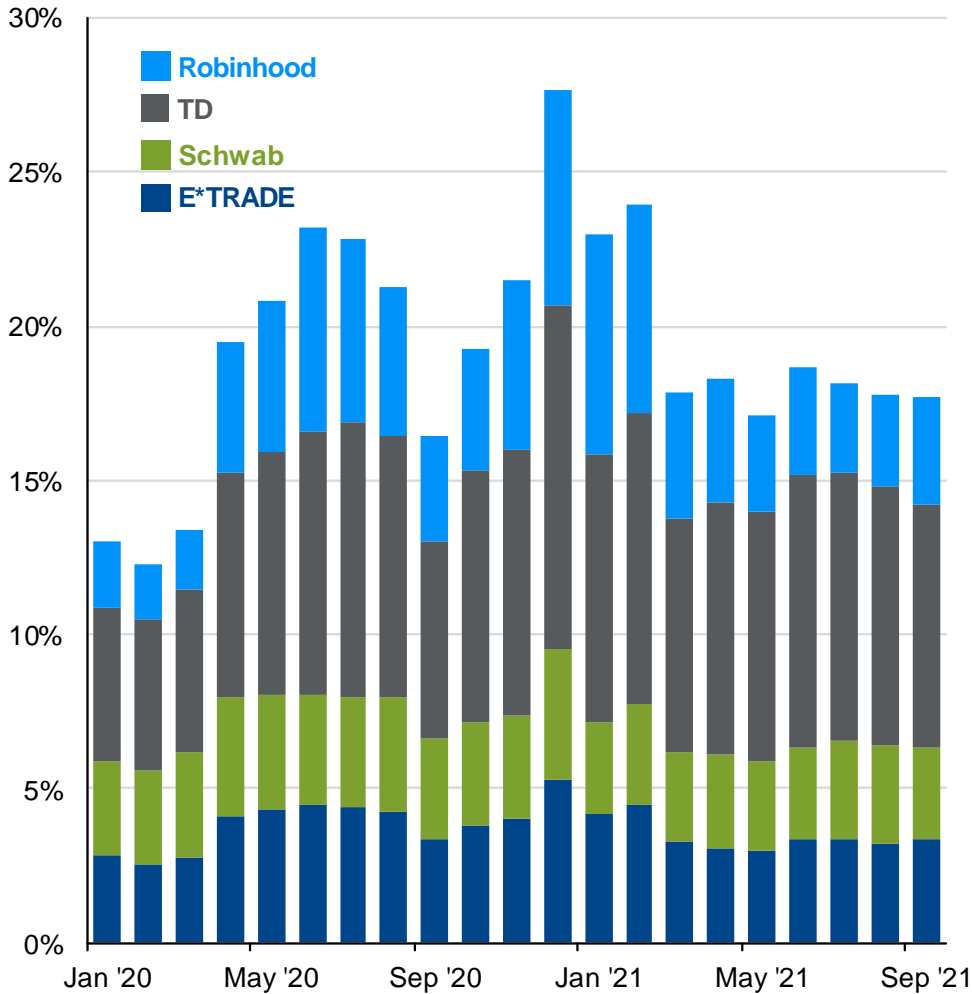

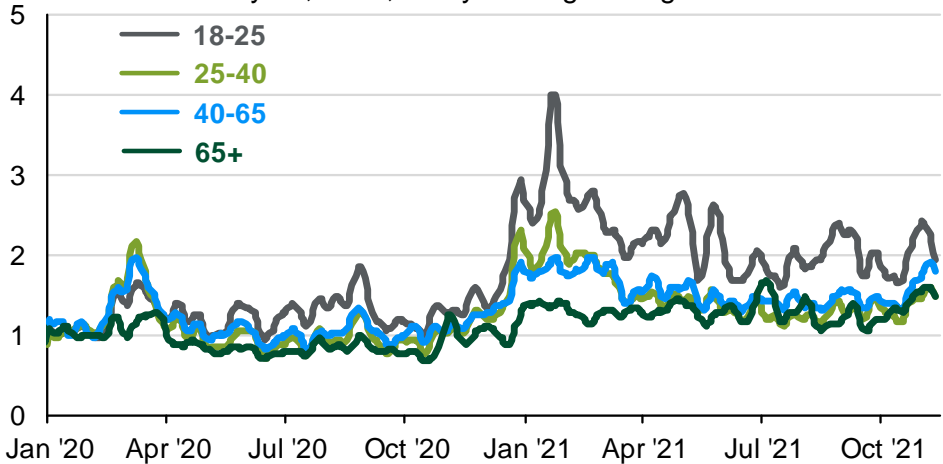


Market volume and investment flows

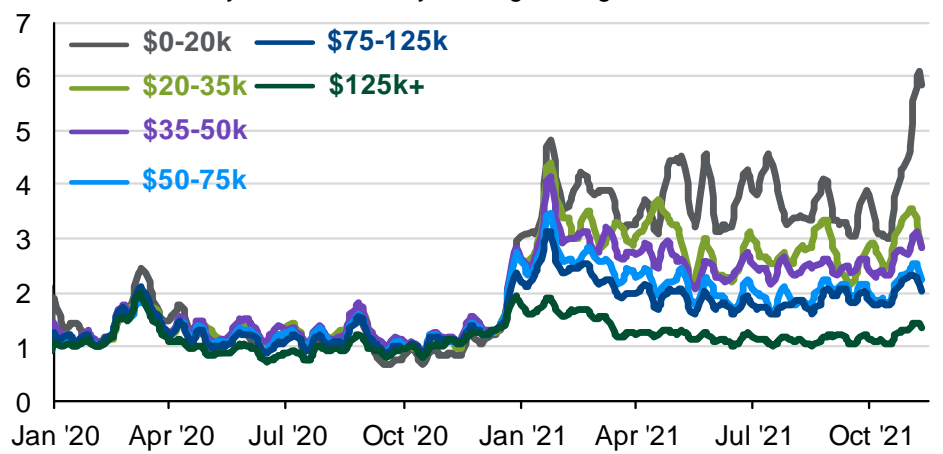
Flow by firm as % of total U.S. equity market volume

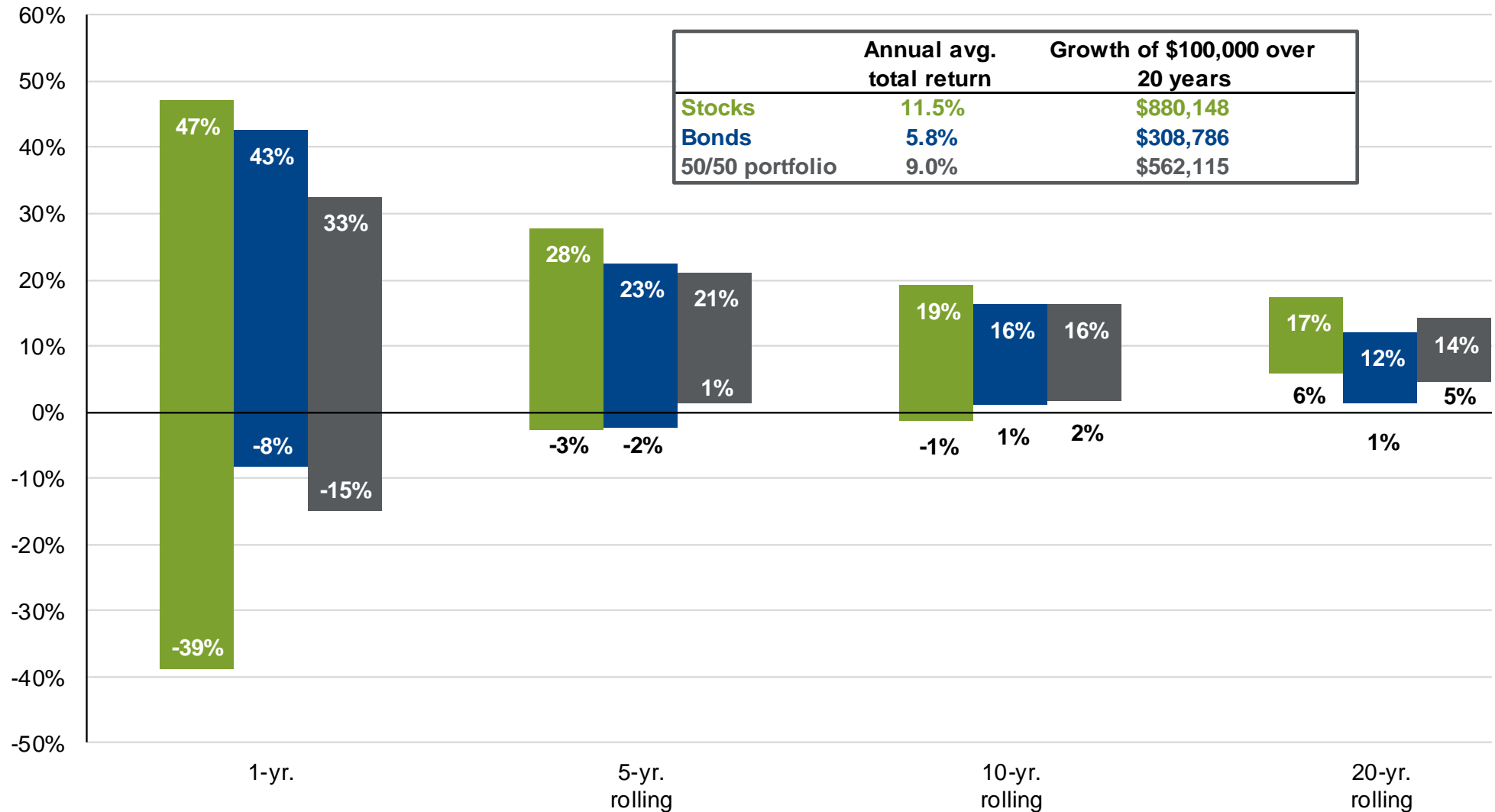

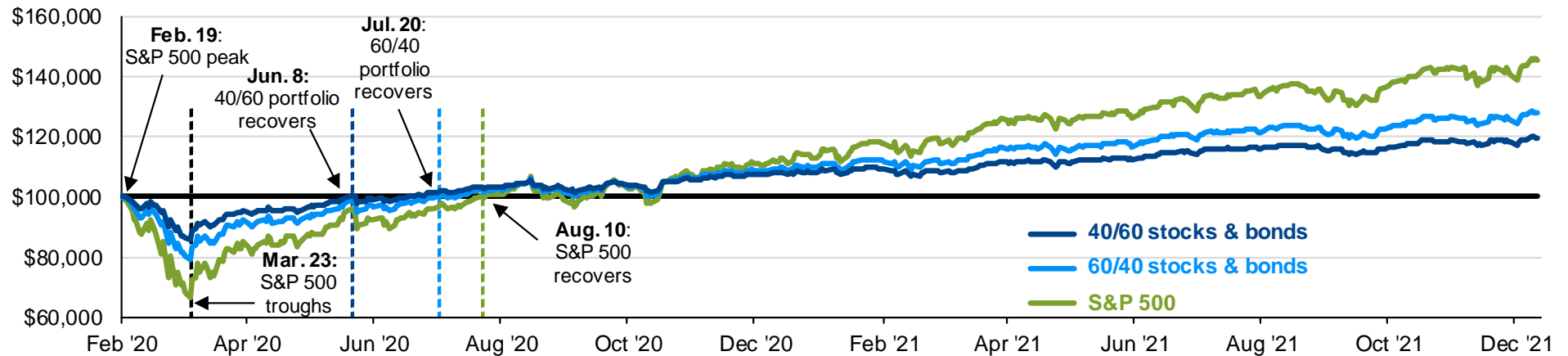

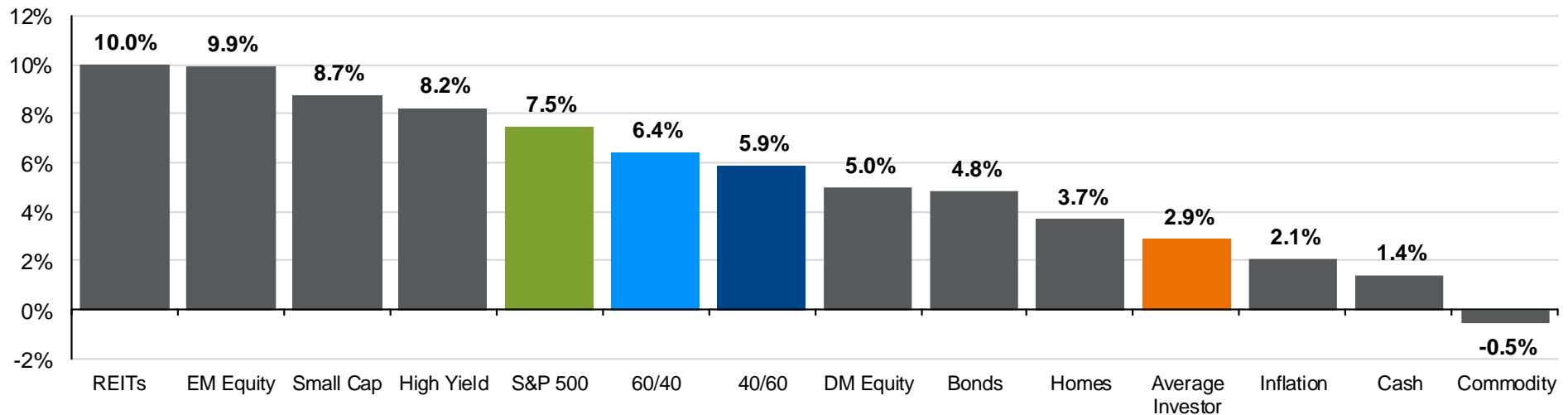

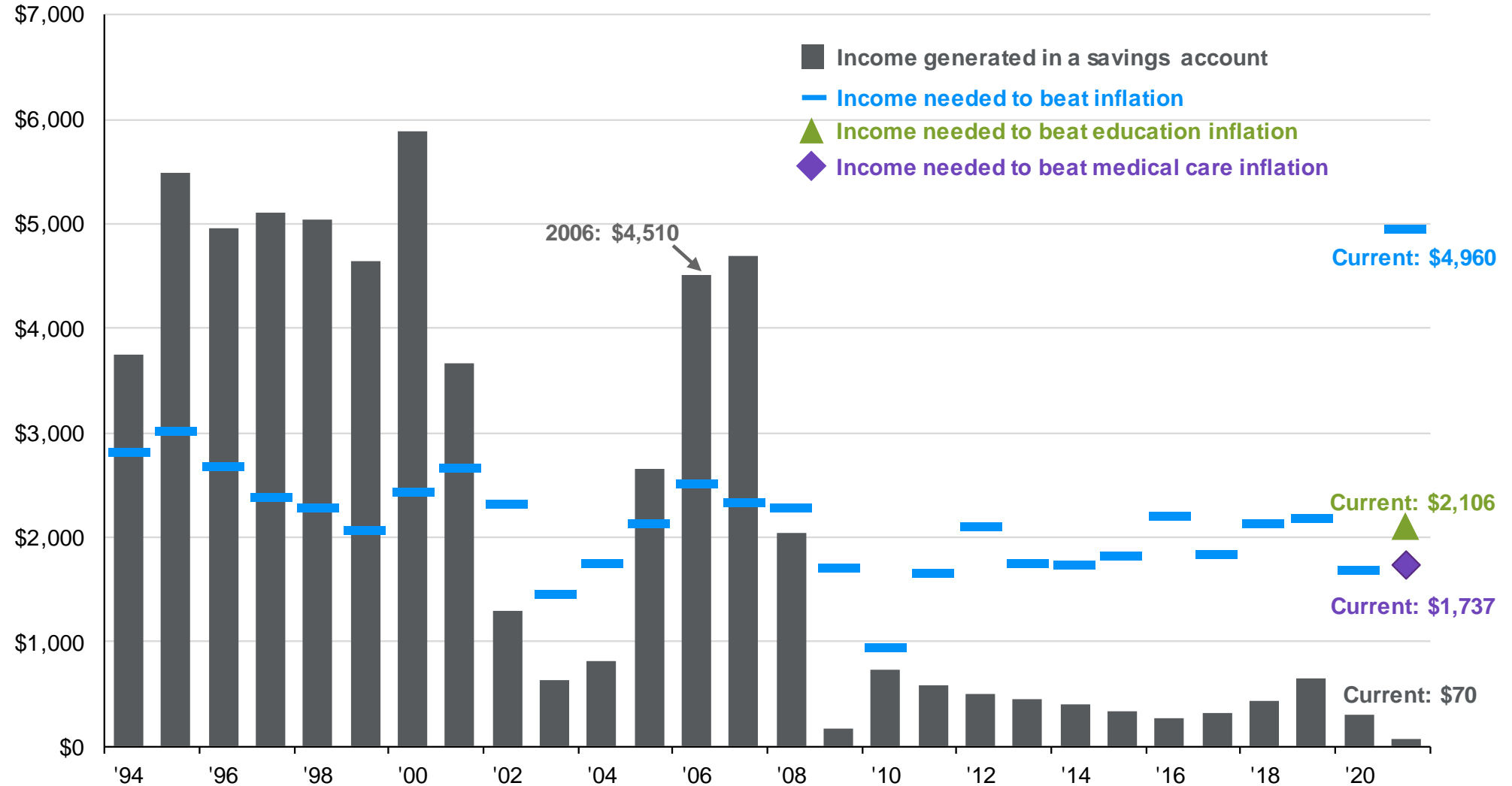

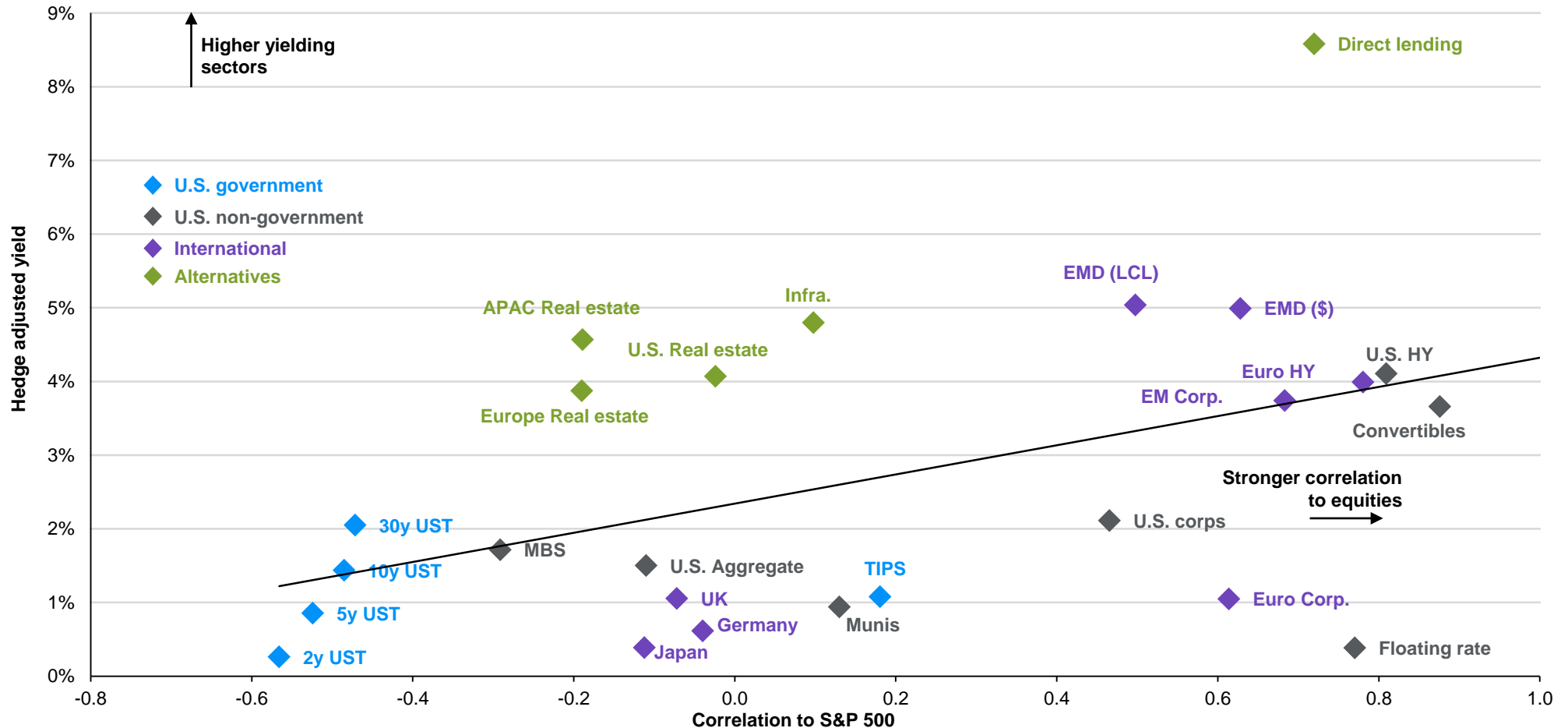

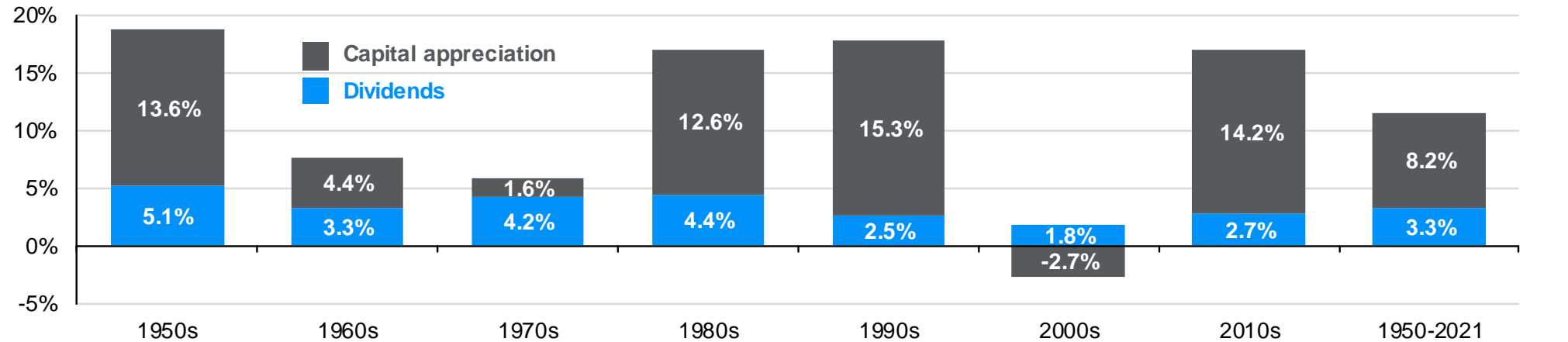

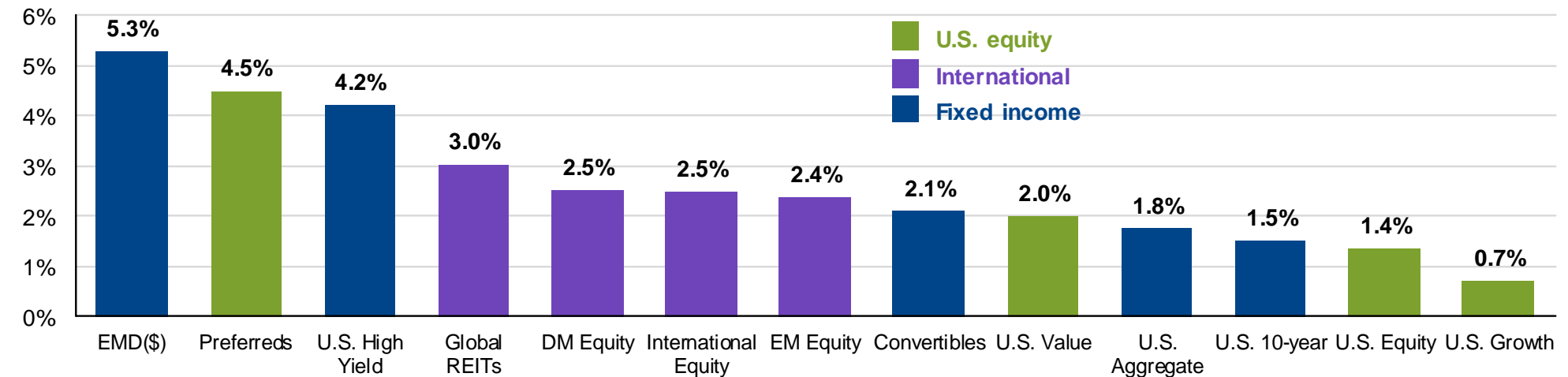

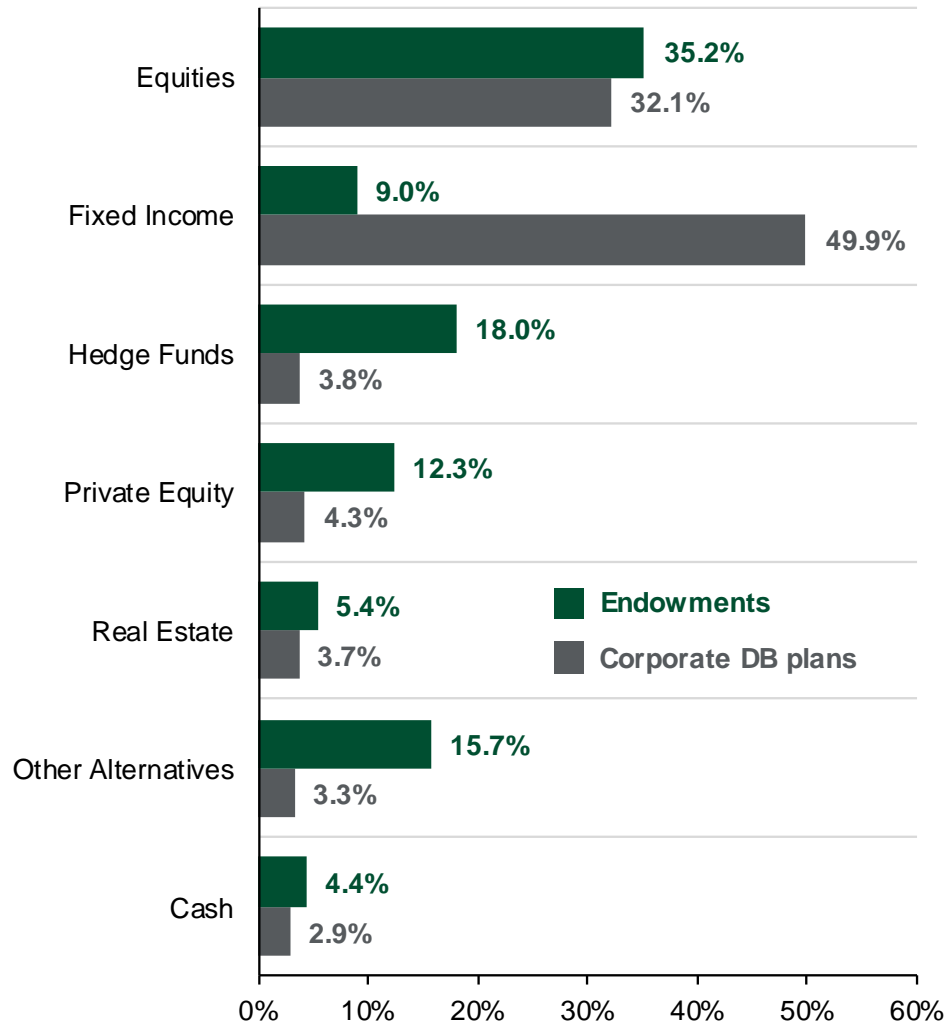

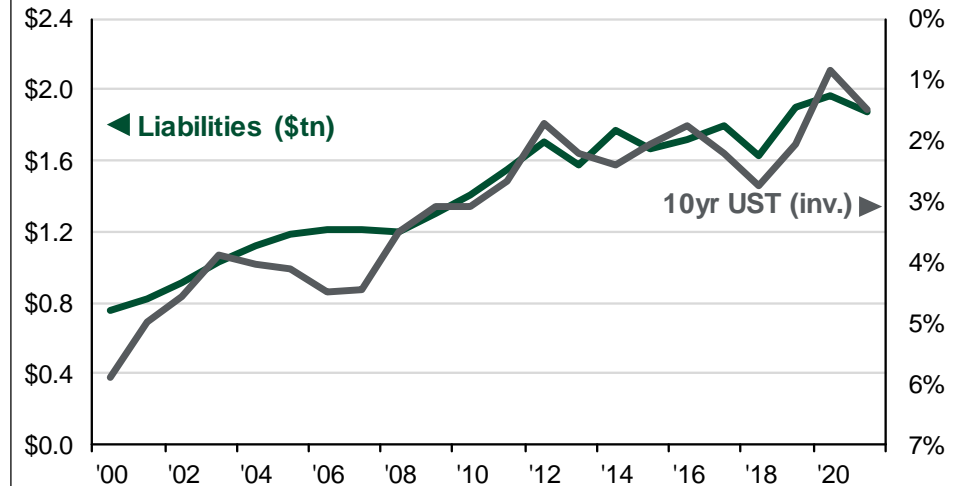

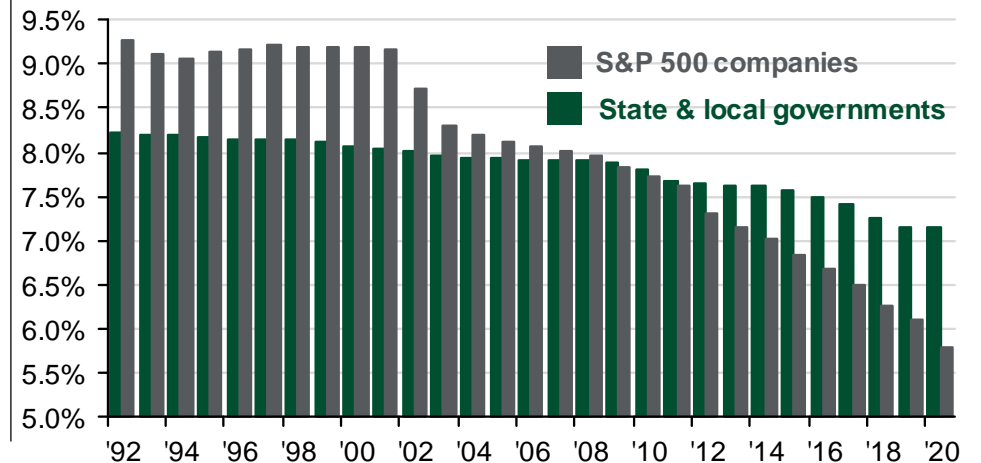

The **Alerian MLP Index** is a composite of the 50 most prominent energy Master Limited Partnerships (MLPs) that provides investors with an unbiased, comprehensive benchmark for the asset class.

The **CS/Tremont Hedge Fund Index** is compiled by Credit Suisse Tremont Index, LLC. It is an asset-weighted hedge fund index and includes only funds, as opposed to separate accounts. The Index uses the Credit Suisse/Tremont database, which tracks over 4500 funds, and consists only of funds with a minimum of US\$50 million under management, a 12-month track record, and audited financial statements. It is calculated and rebalanced on a monthly basis, and shown net of all performance fees and expenses. It is the exclusive property of Credit Suisse Tremont Index, LLC.

The **HFRI Monthly Indices (HFRI)** are equally weighted performance indexes, utilized by numerous hedge fund managers as a benchmark for their own hedge funds. The HFRI are broken down into 4 main strategies, each with multiple sub strategies. All single-manager HFRI Index constituents are included in the HFRI Fund Weighted Composite, which accounts for over 2200 funds listed on the internal HFR Database.

The **NAREIT EQUITY REIT Index** is designed to provide the most comprehensive assessment of overall industry performance, and includes all tax-qualified real estate investment trusts (REITs) that are listed on the NYSE, the American Stock Exchange or the NASDAQ National Market List.
