



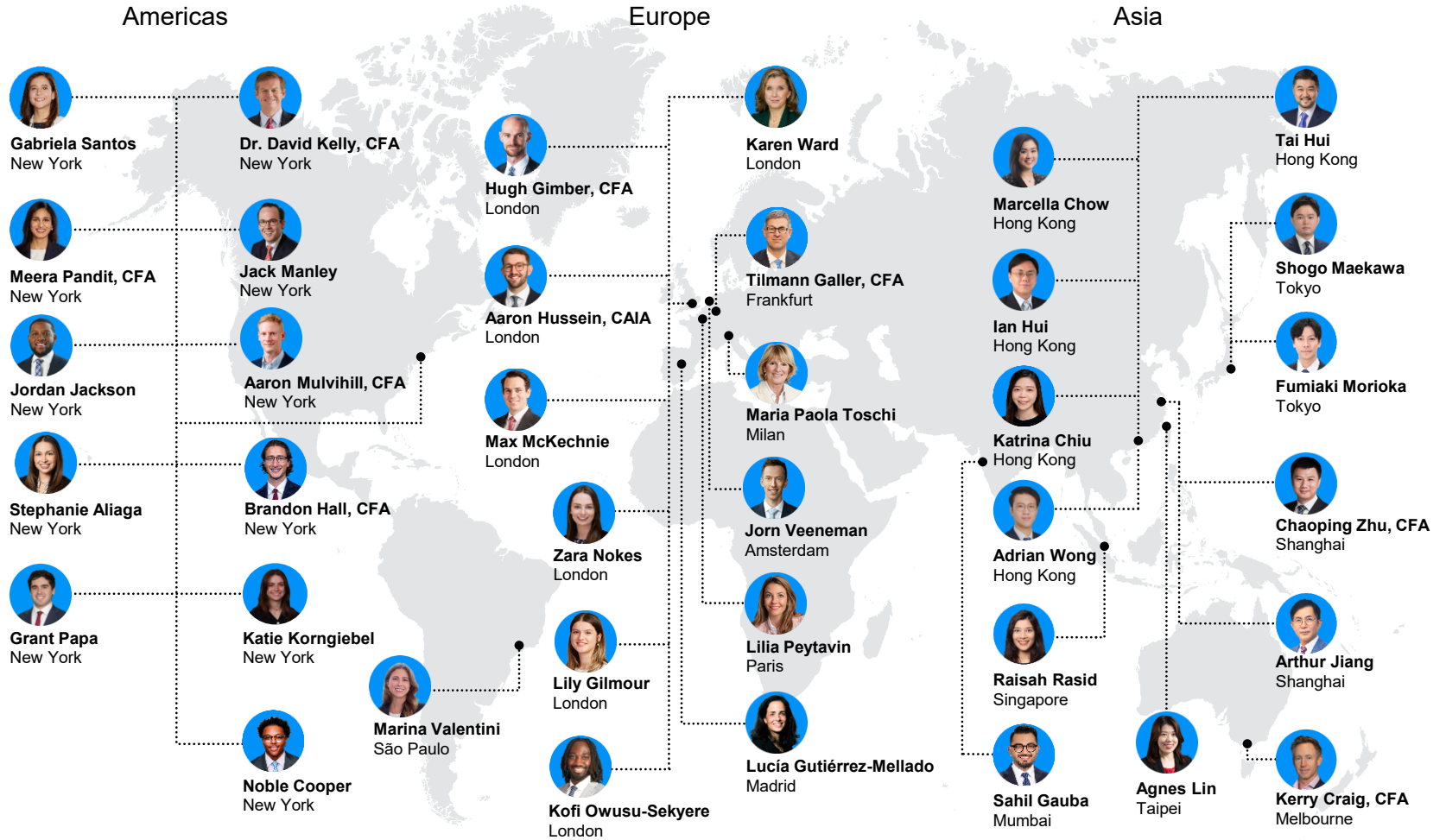

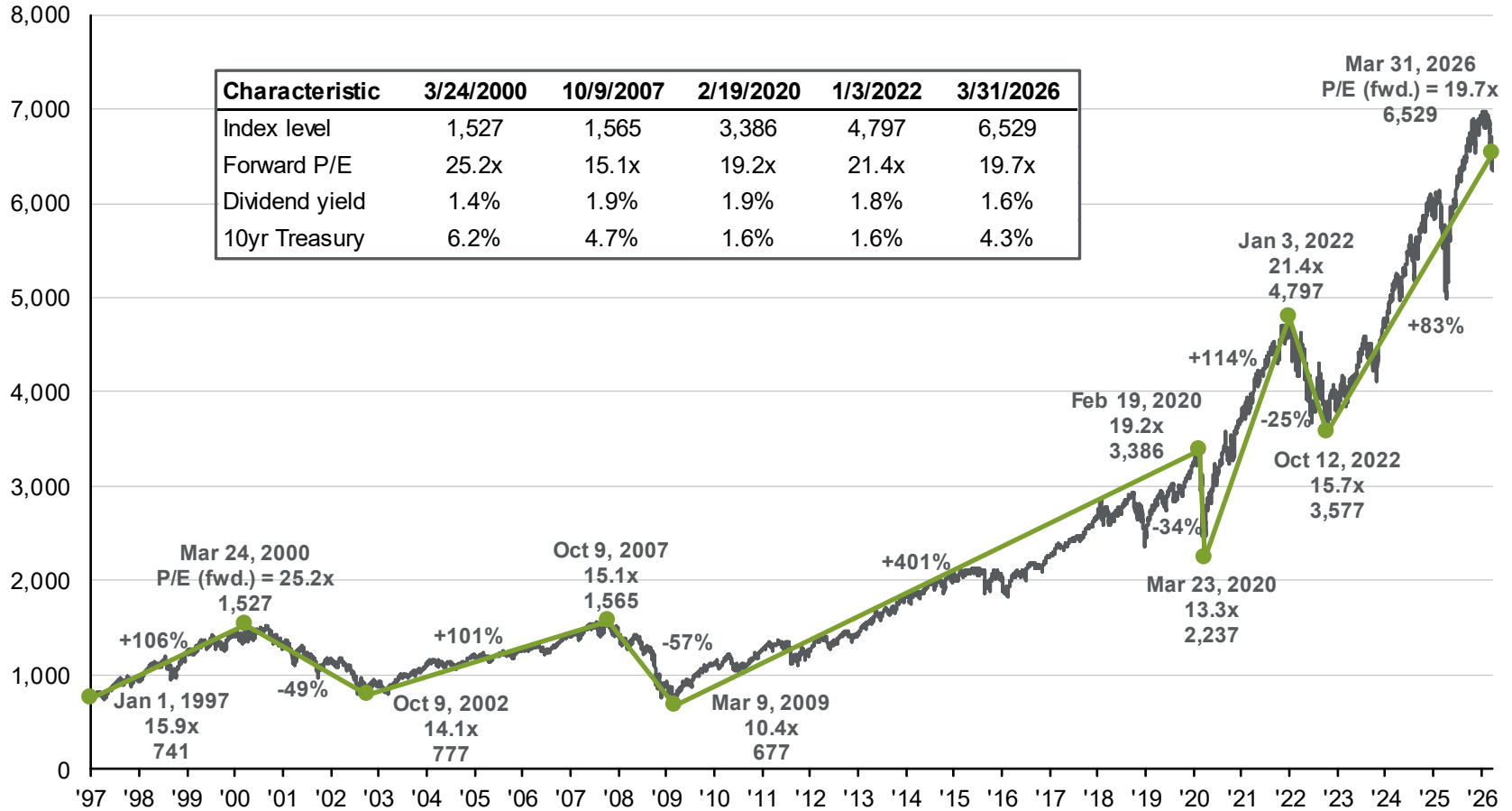

S&P 500 Price Index



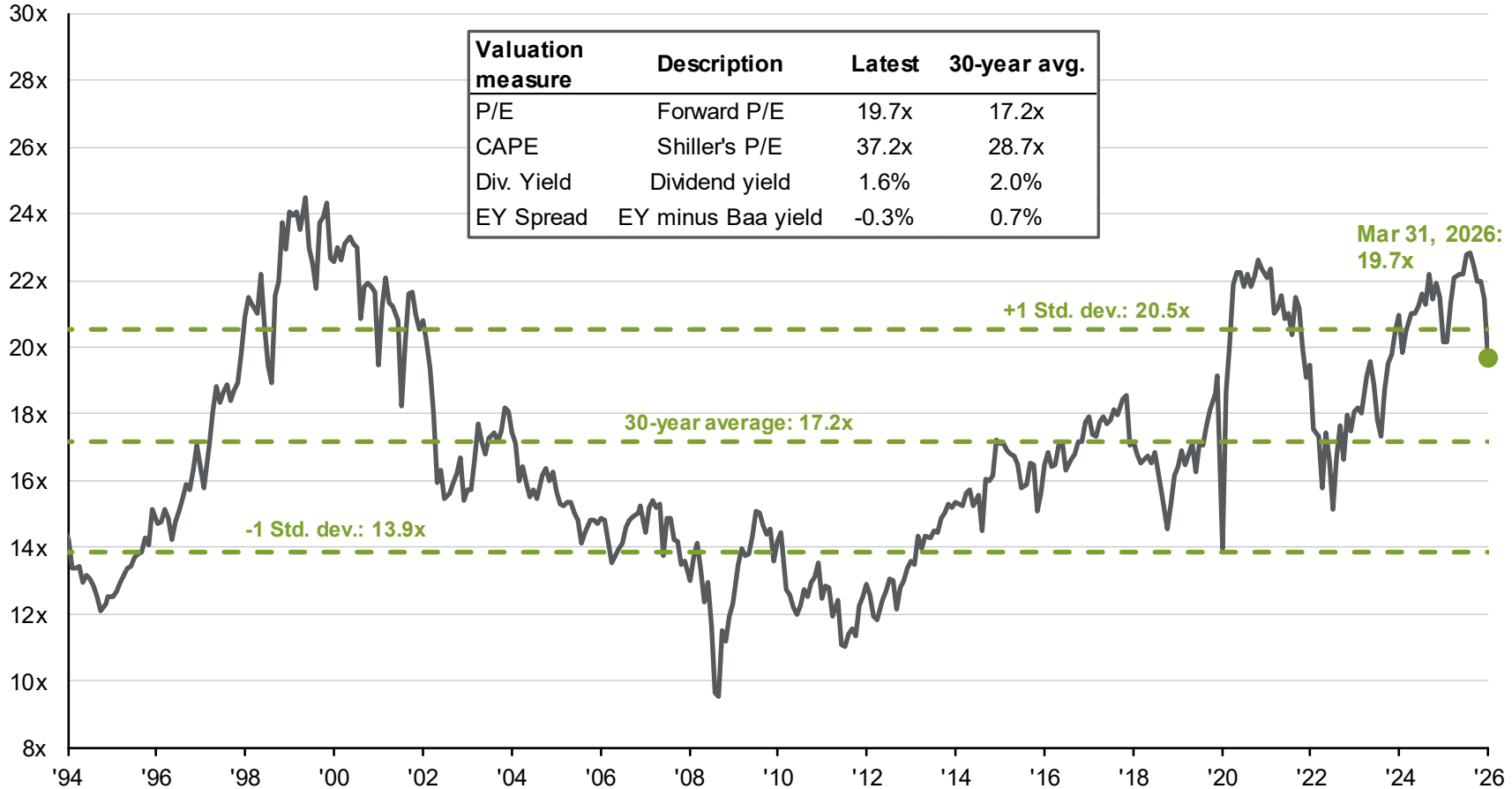

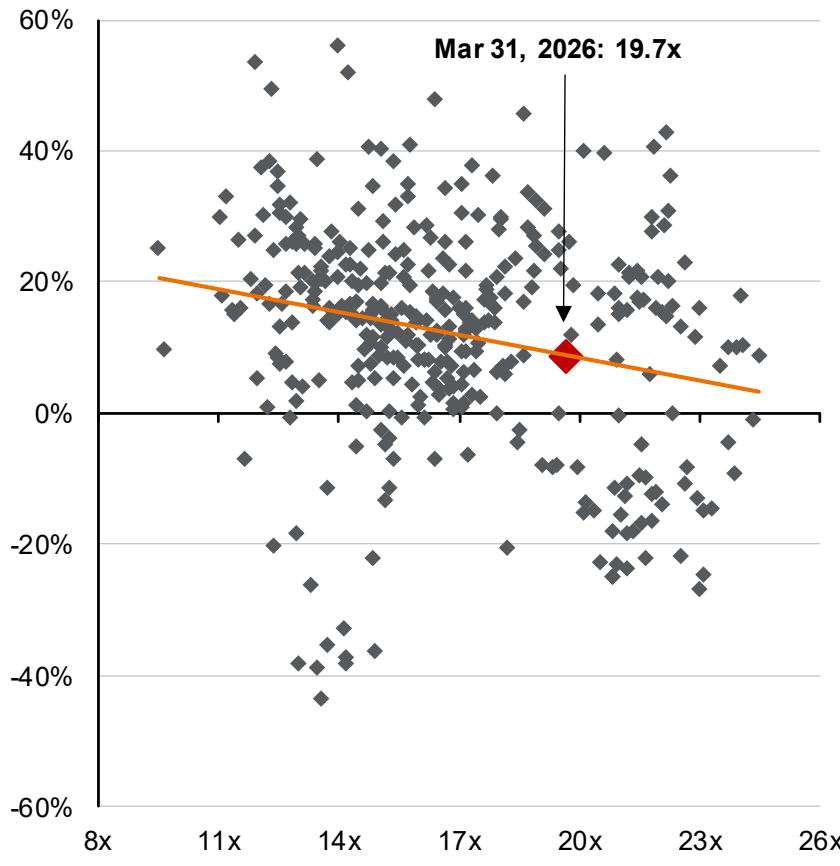

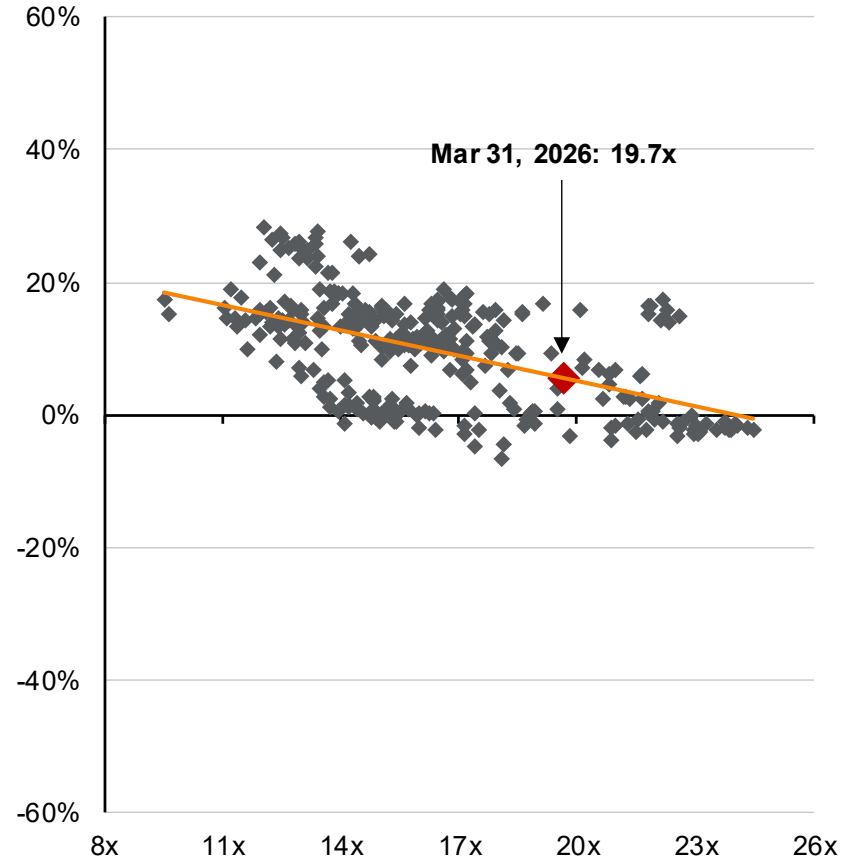
Forward P/E and subsequent 1-year returns

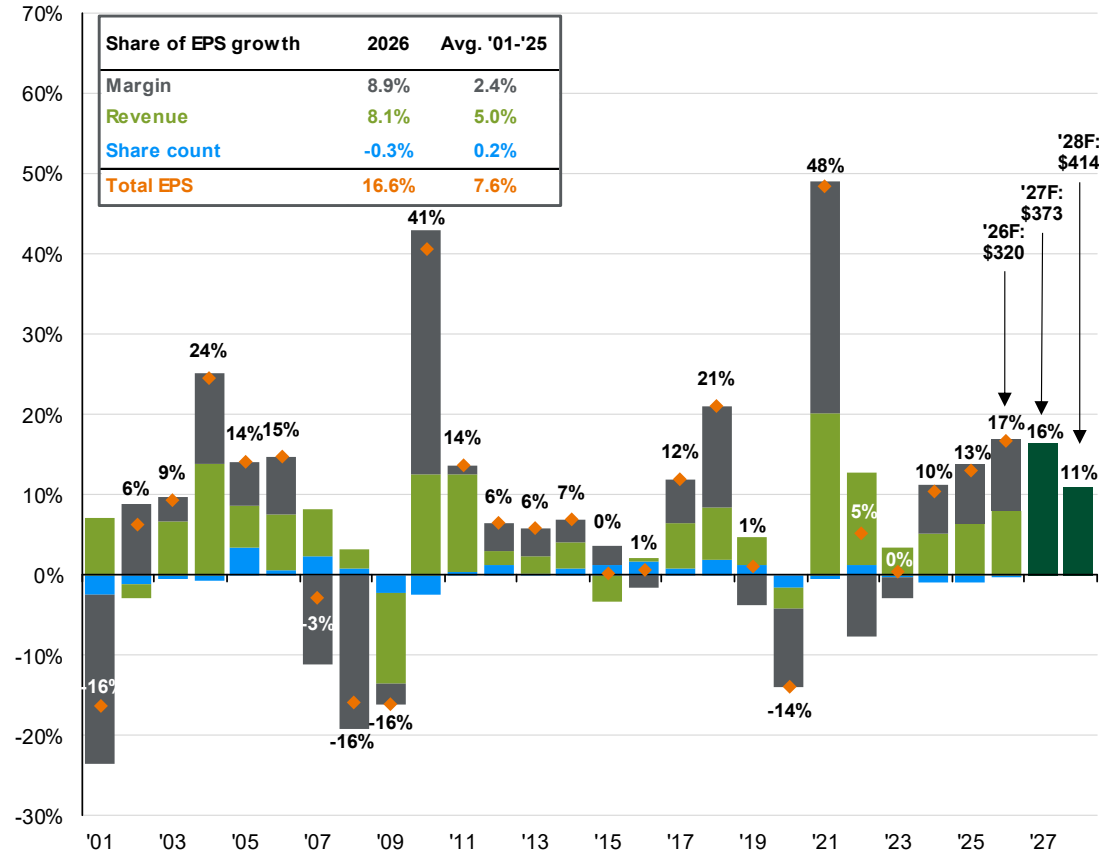

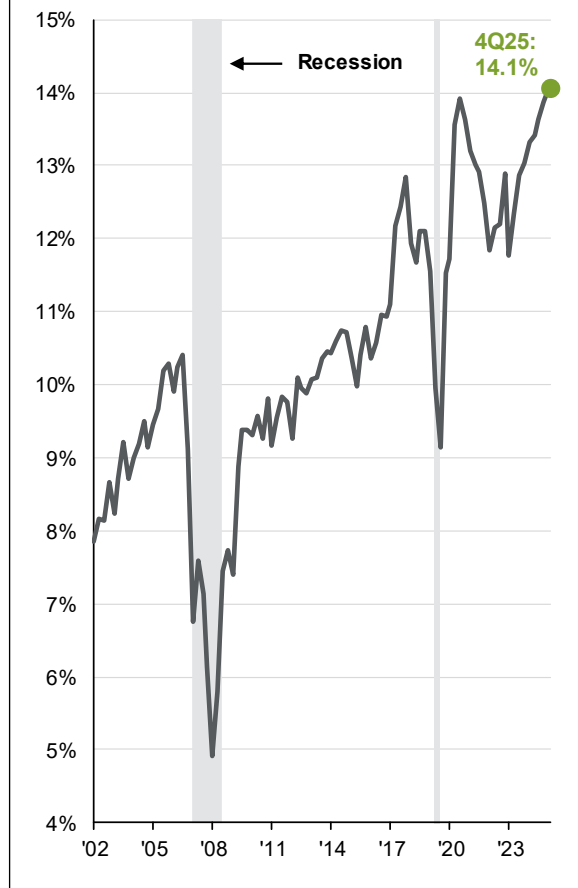
S&P 500 EPS growth

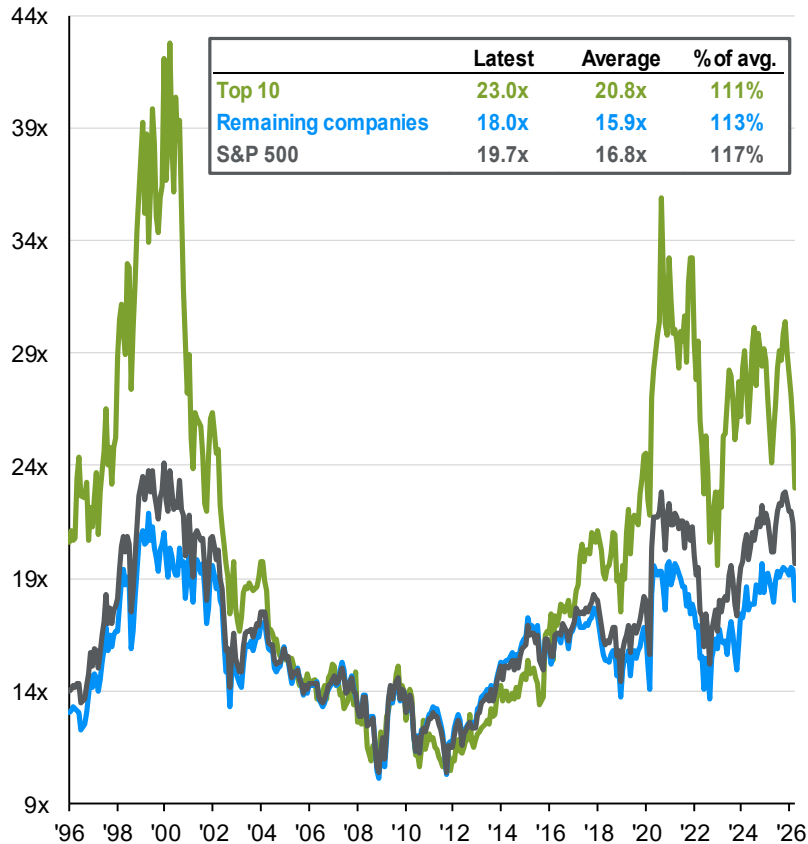

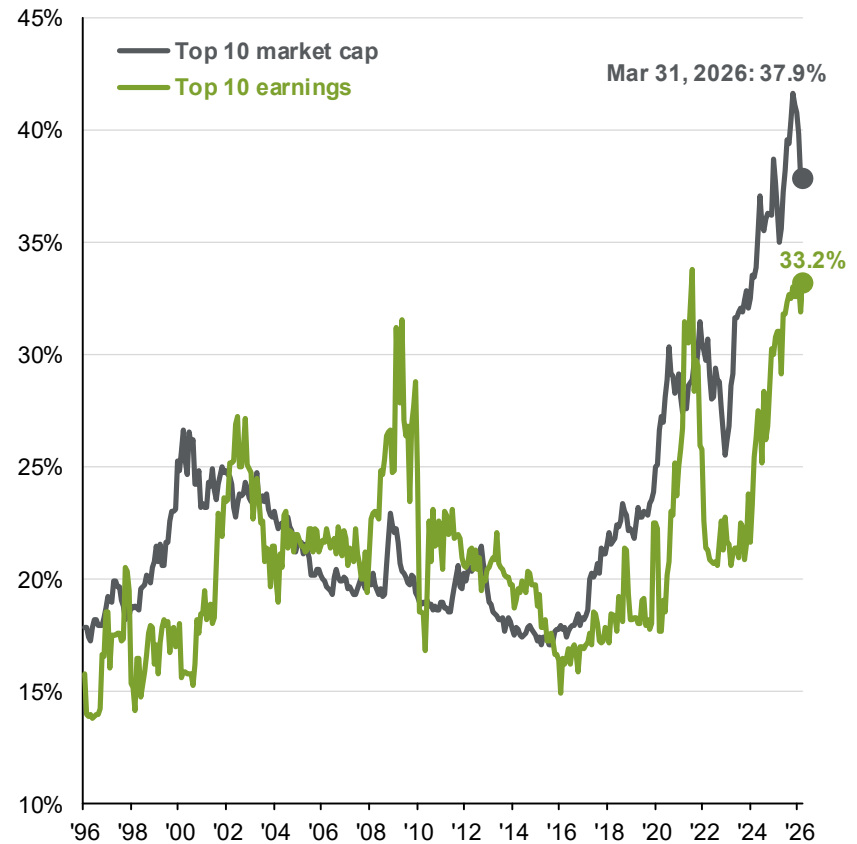
P/E of top 10 and remaining companies in S&P 500

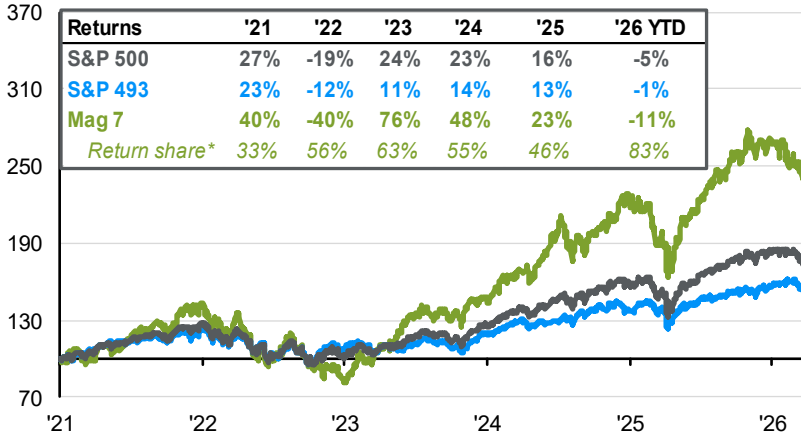

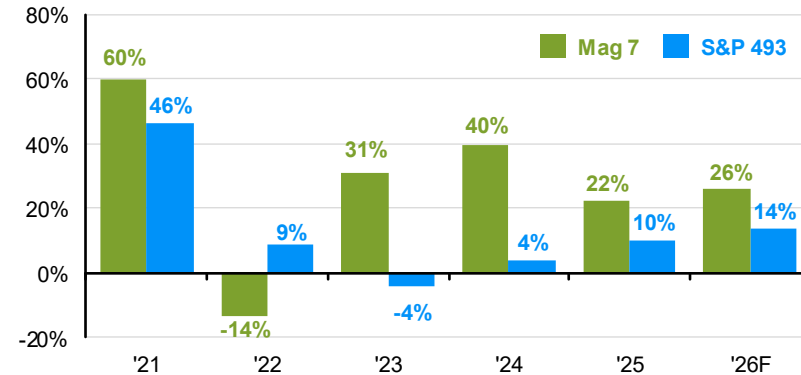

Indexed to 100 on 1/1/2021, price return

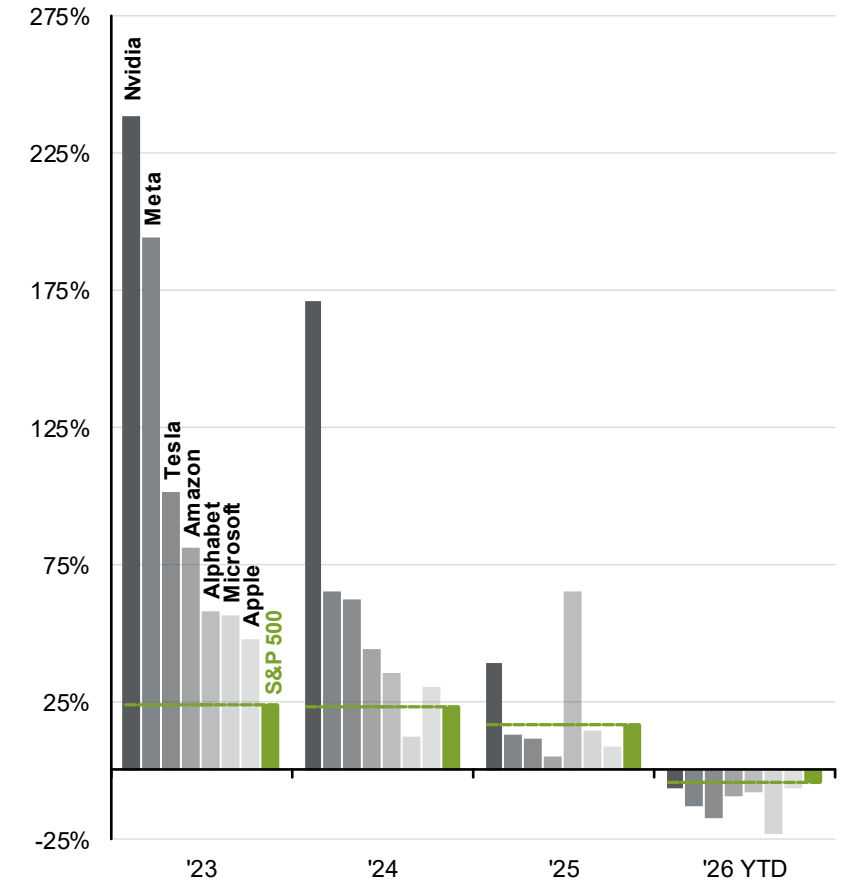


Year-over-year earnings growth

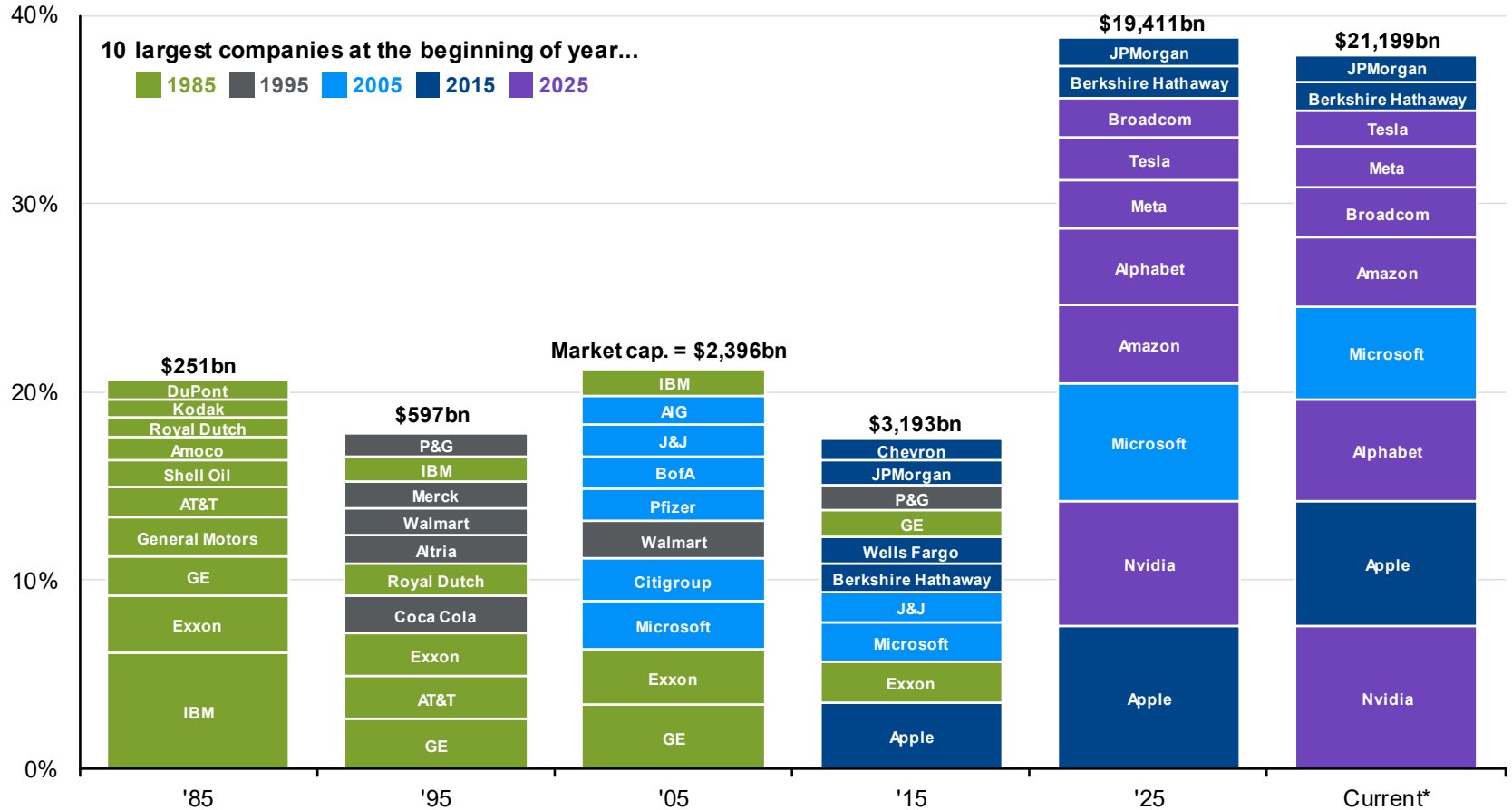

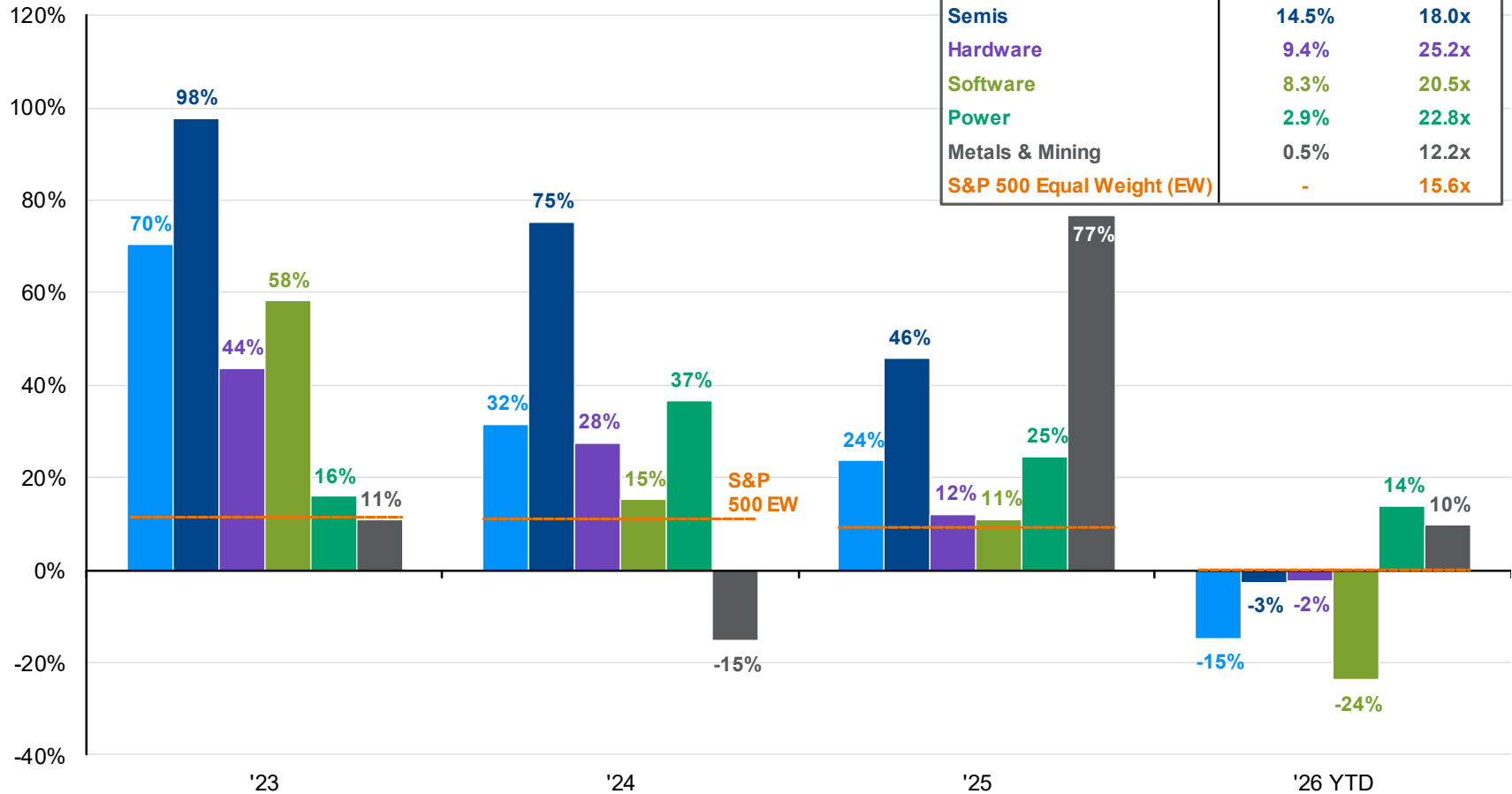

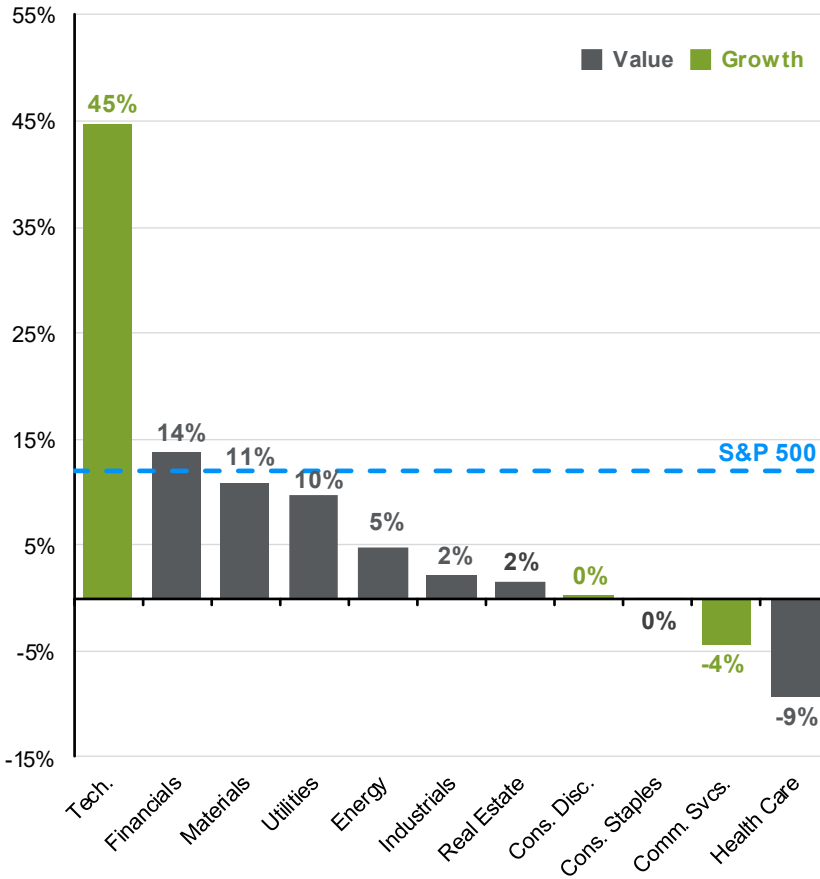

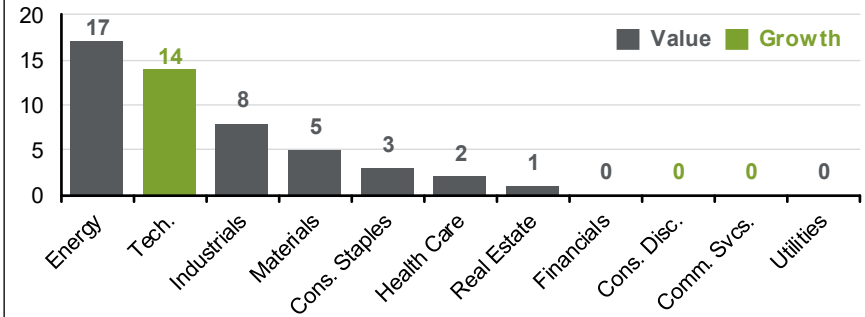
S&P 500 earnings growth by sector

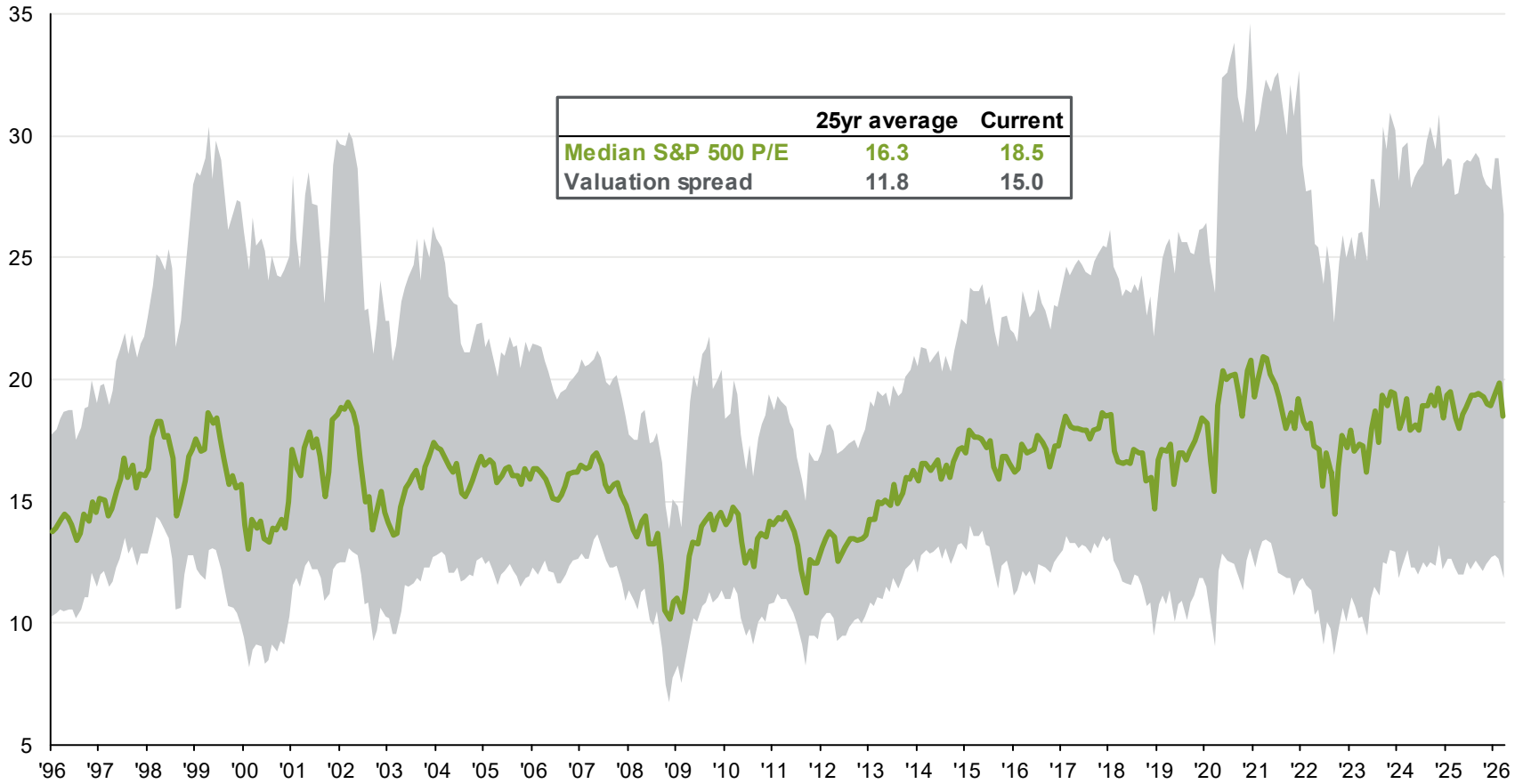

Dispersion between the forward P/E of S&P 500 stocks in the 20th and 80th percentile



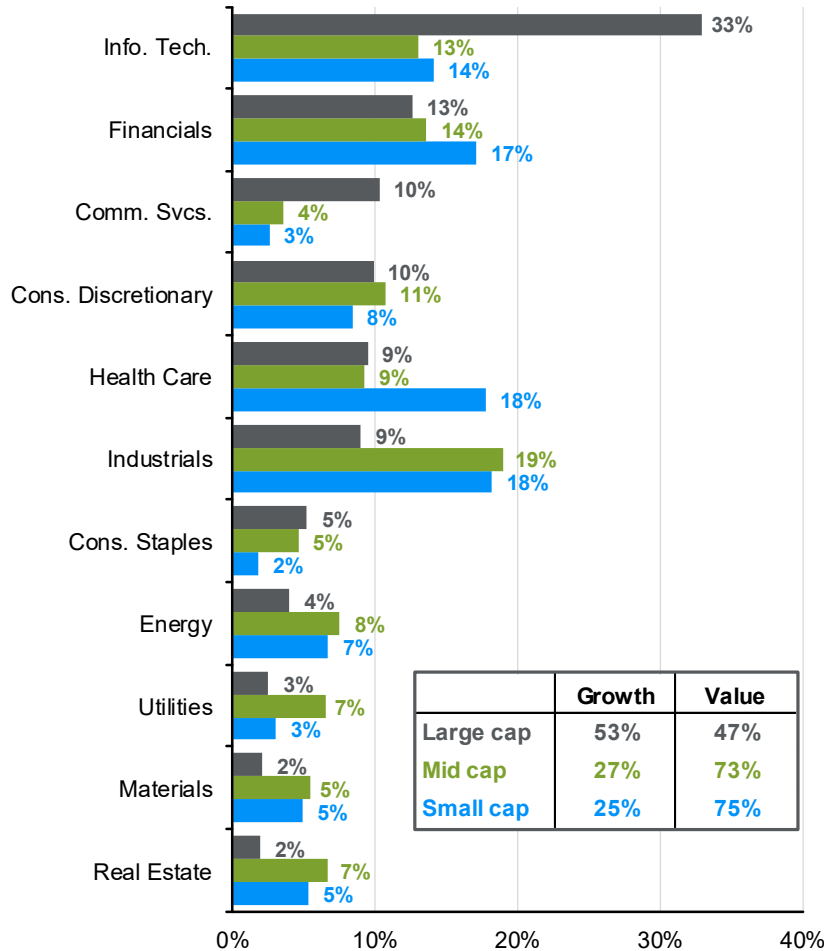

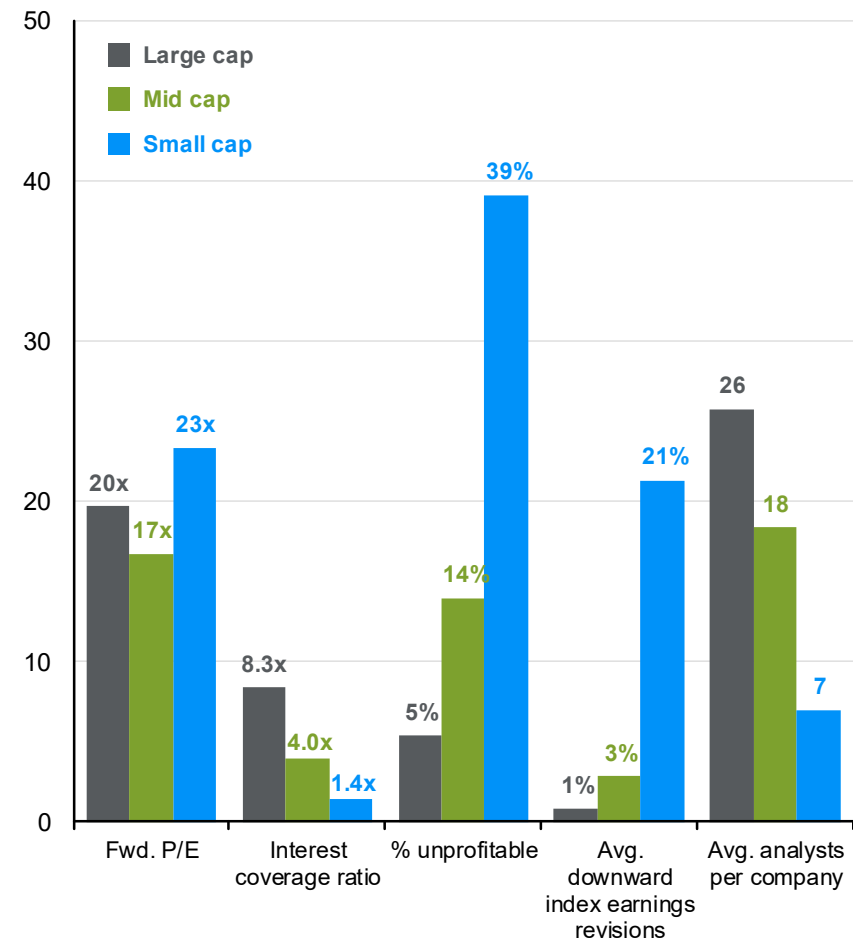

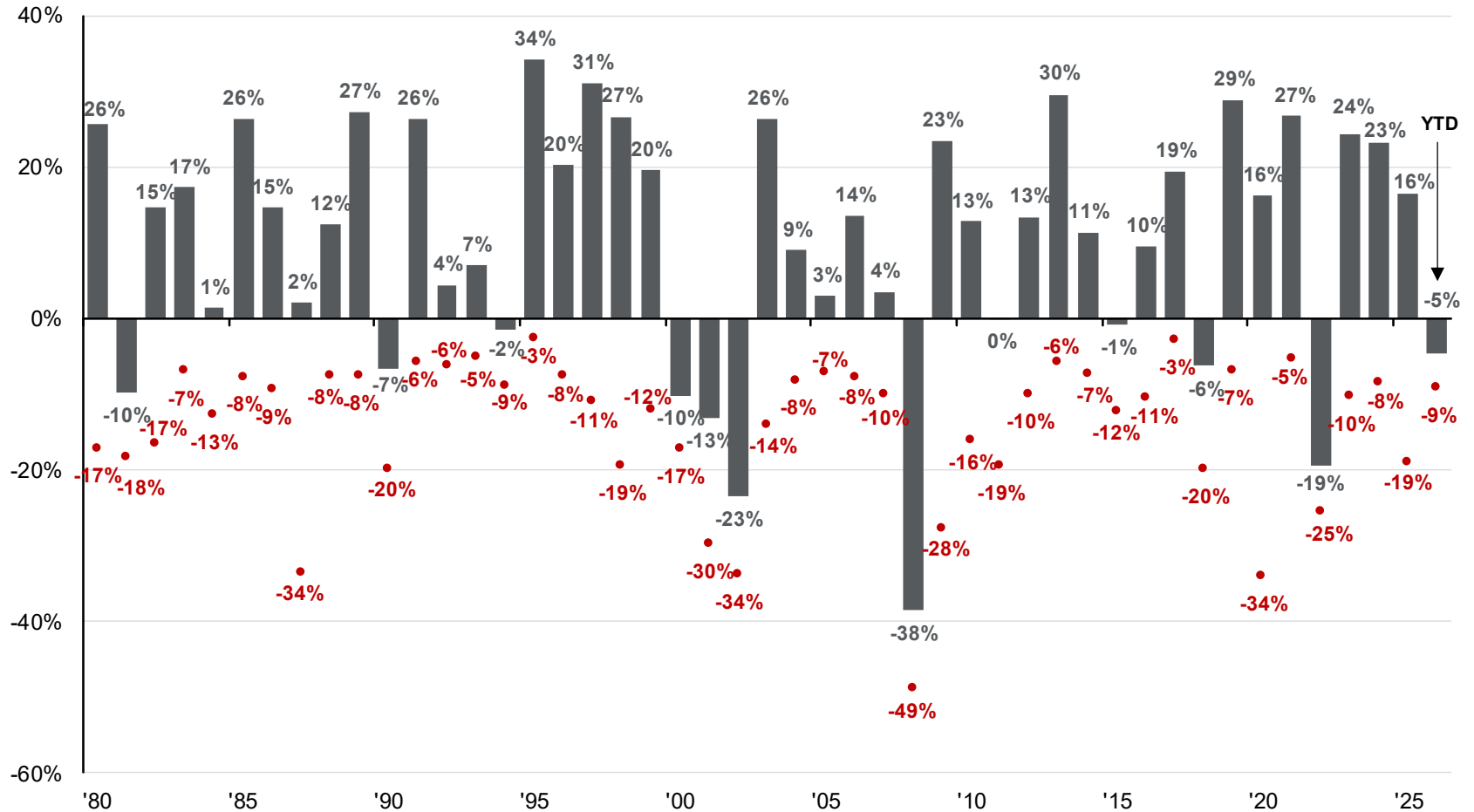

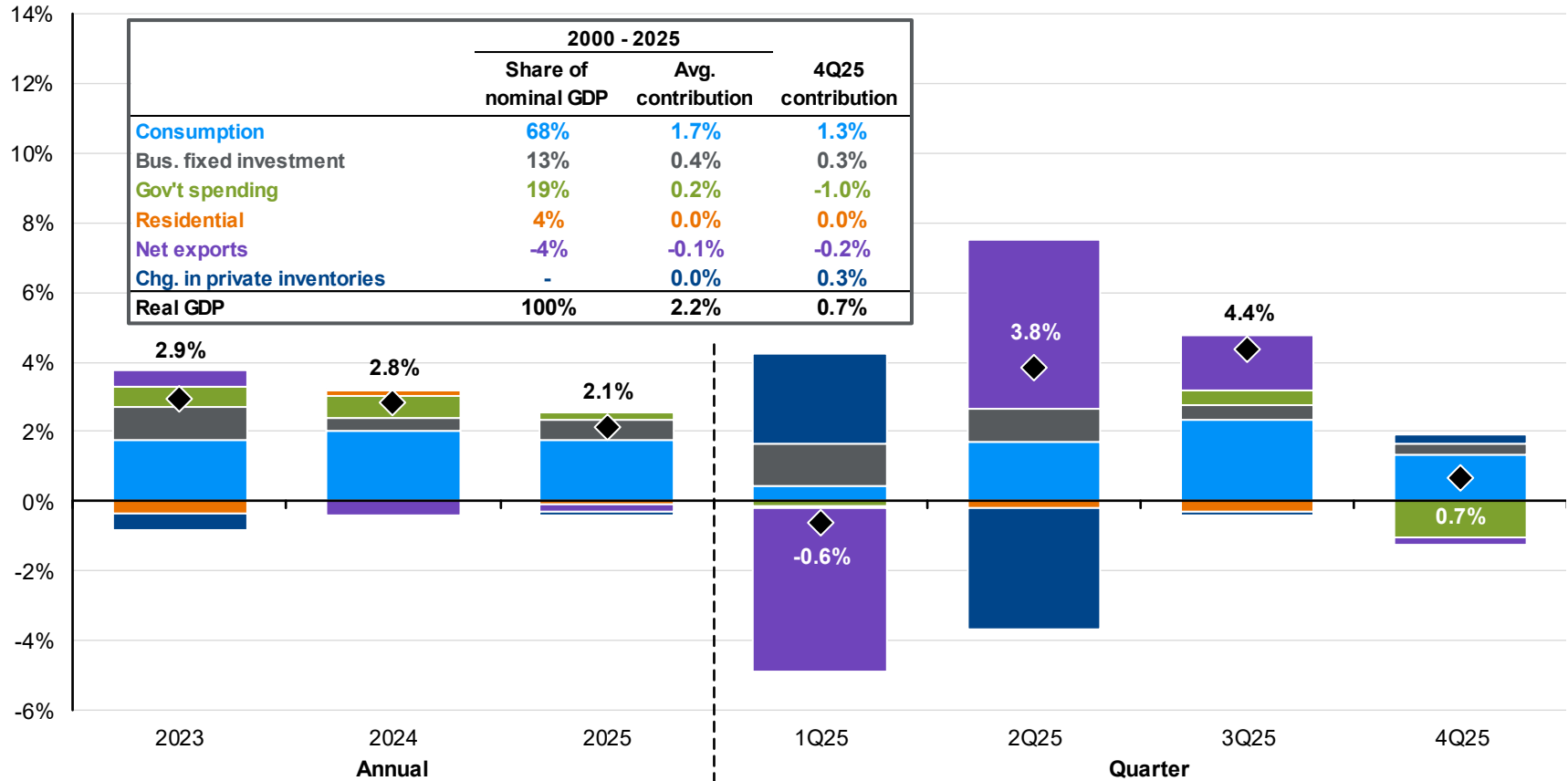

Seasonally adjusted annualized rate



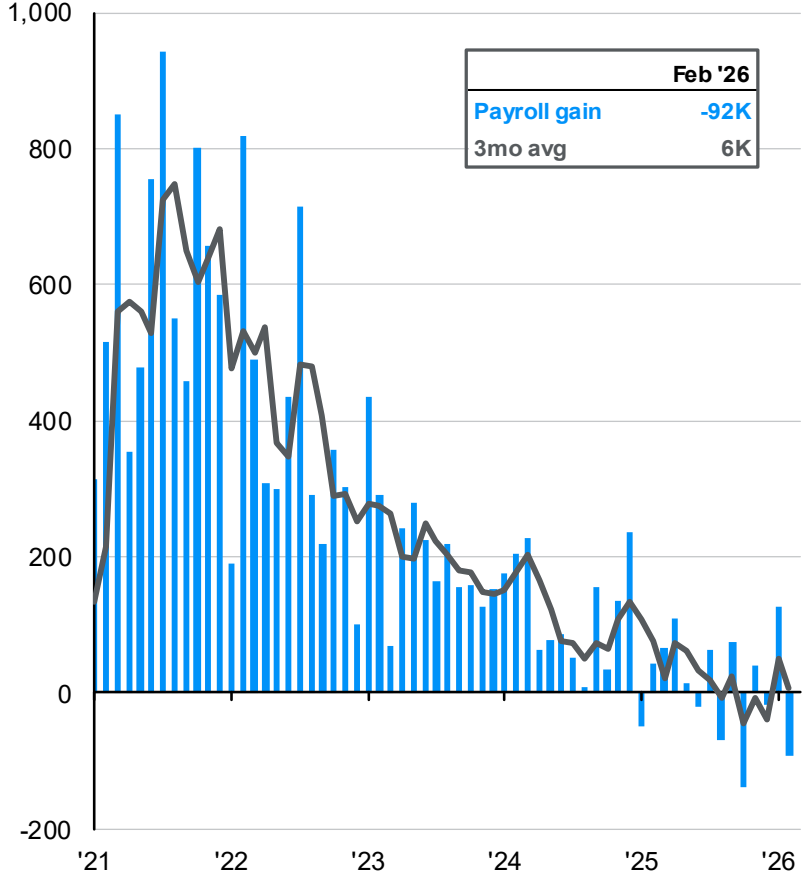

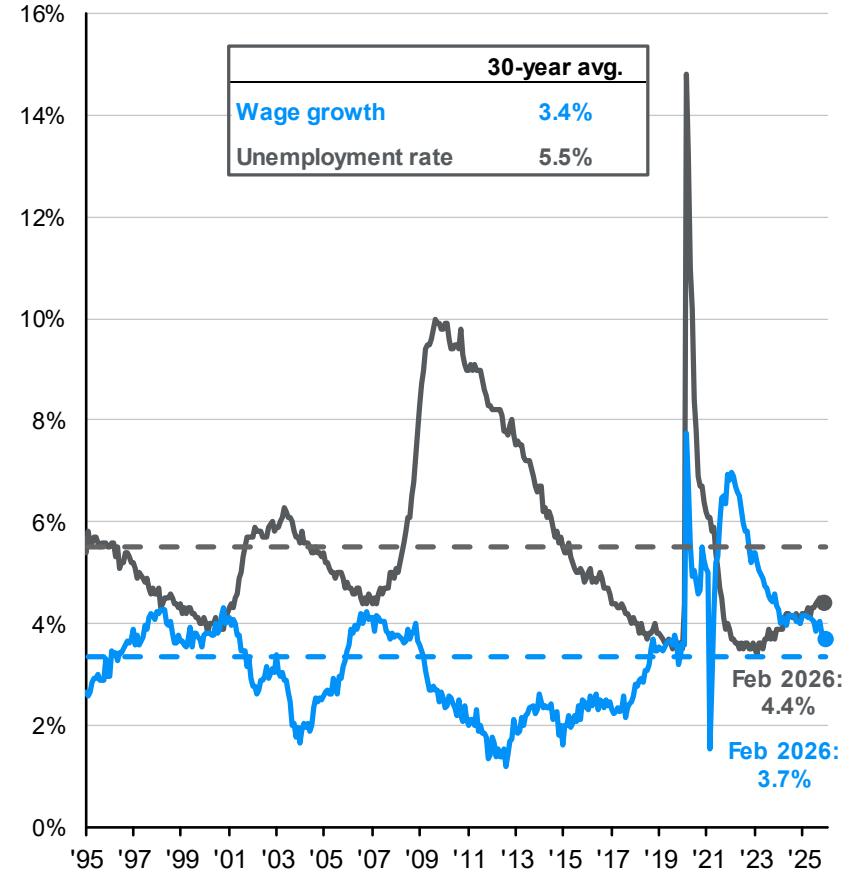
Nonfarm payroll gains

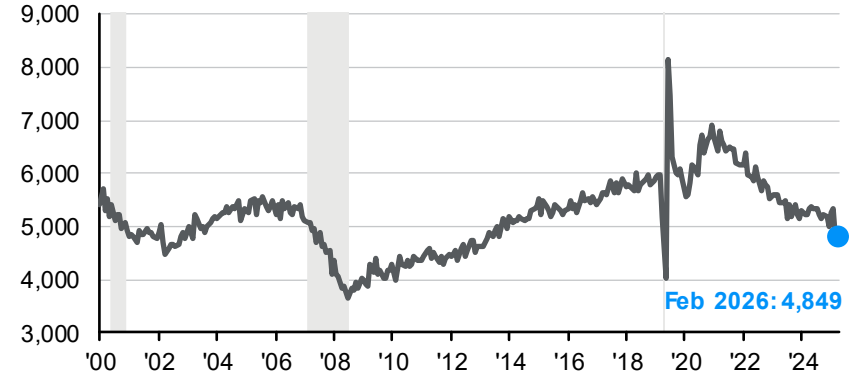
JOLTS job openings*

Total job openings, thousands, seasonally adjusted



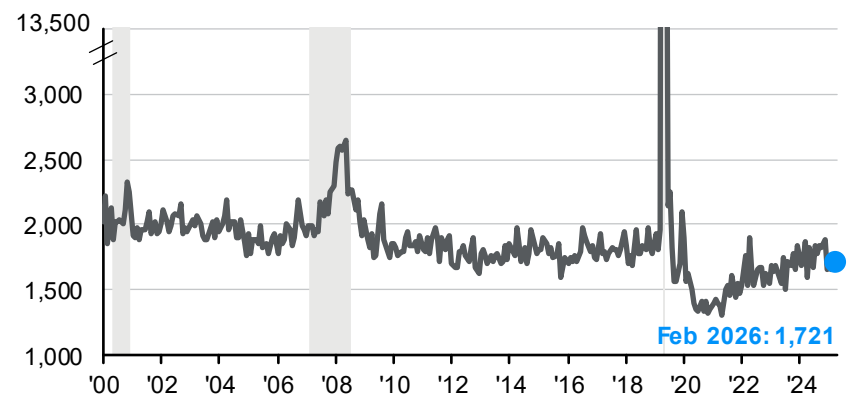
JOLTS hires

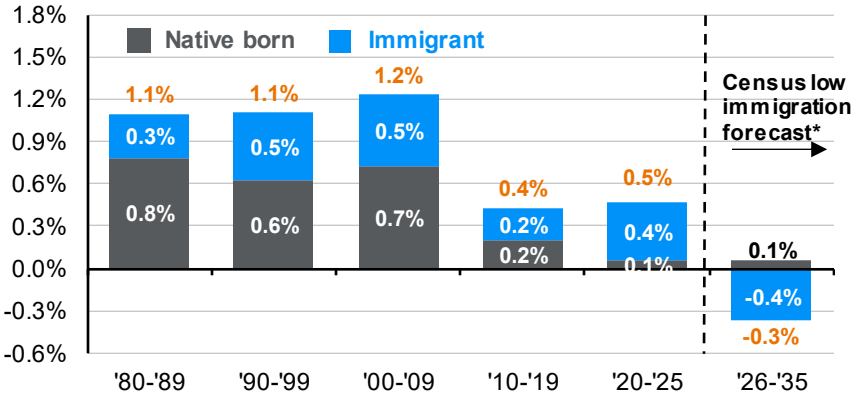

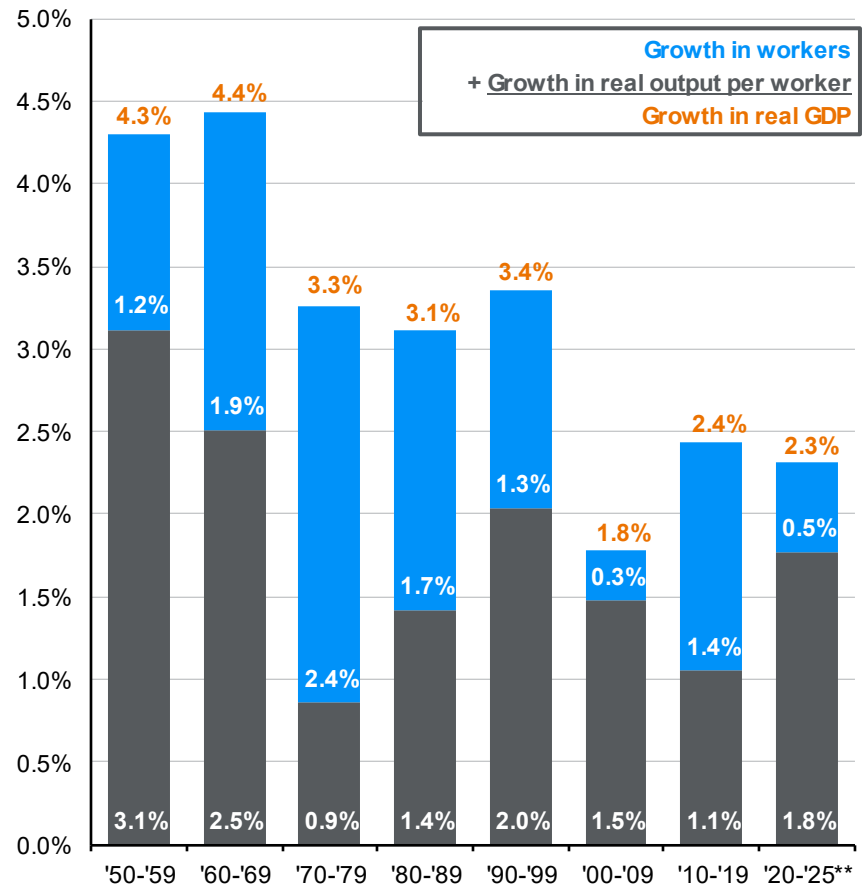
Growth in working-age population

Percent increase in civilian non-institutional population ages 16-64



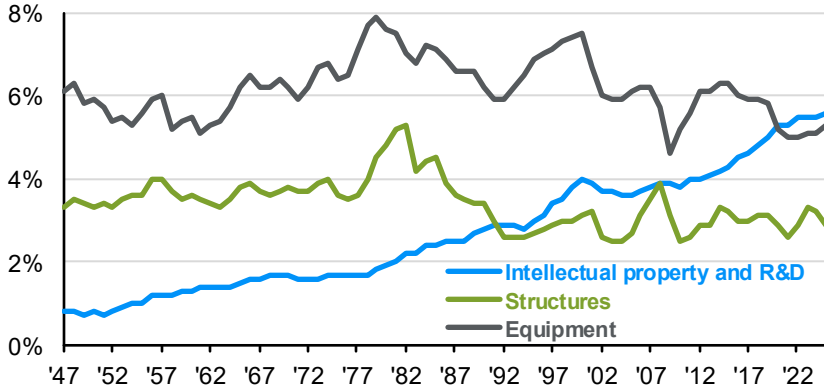

Share of capital spending as a percent of GDP, annual



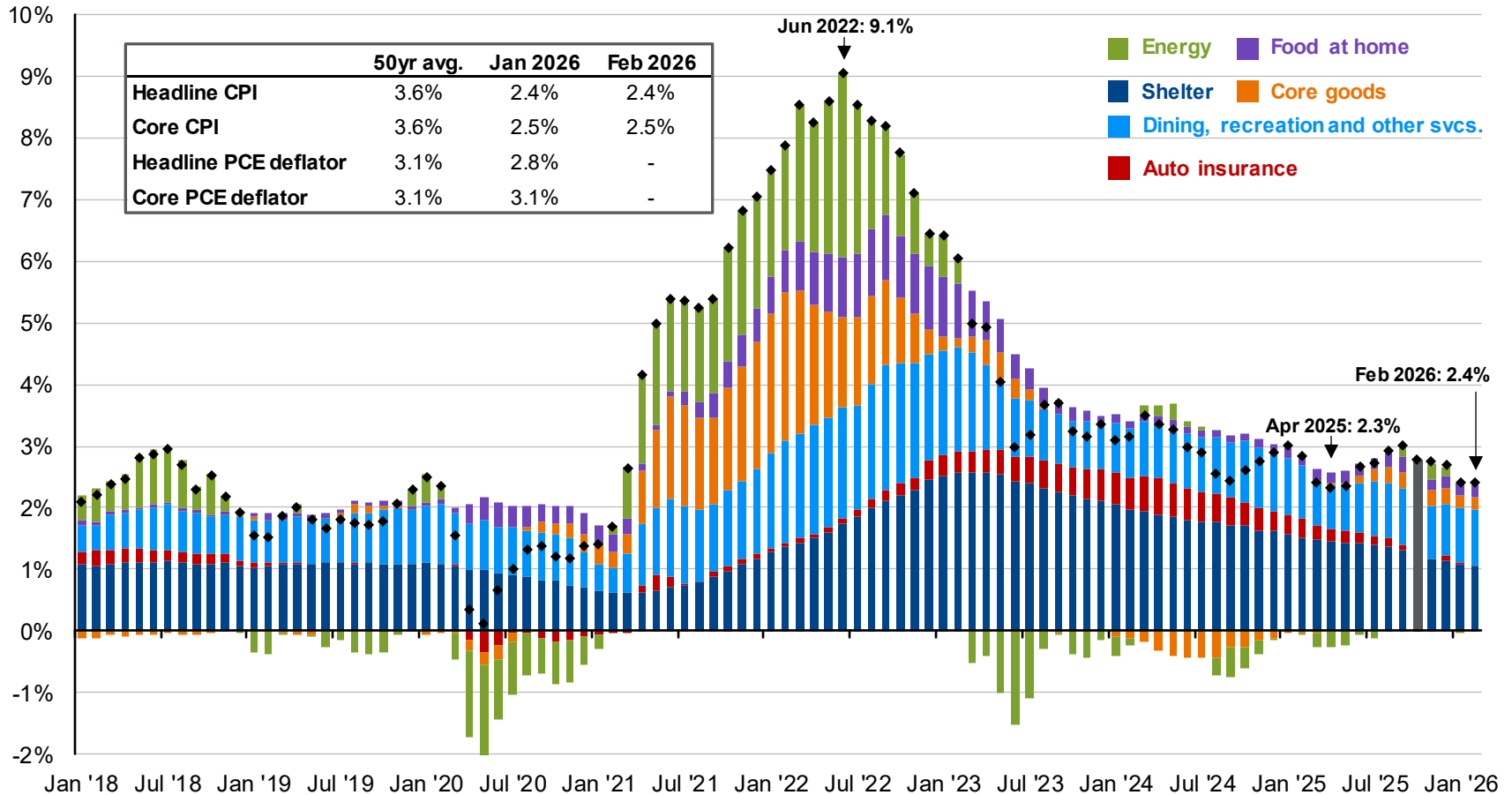

Contribution to year-over-year % change in CPI, non-seasonally adjusted



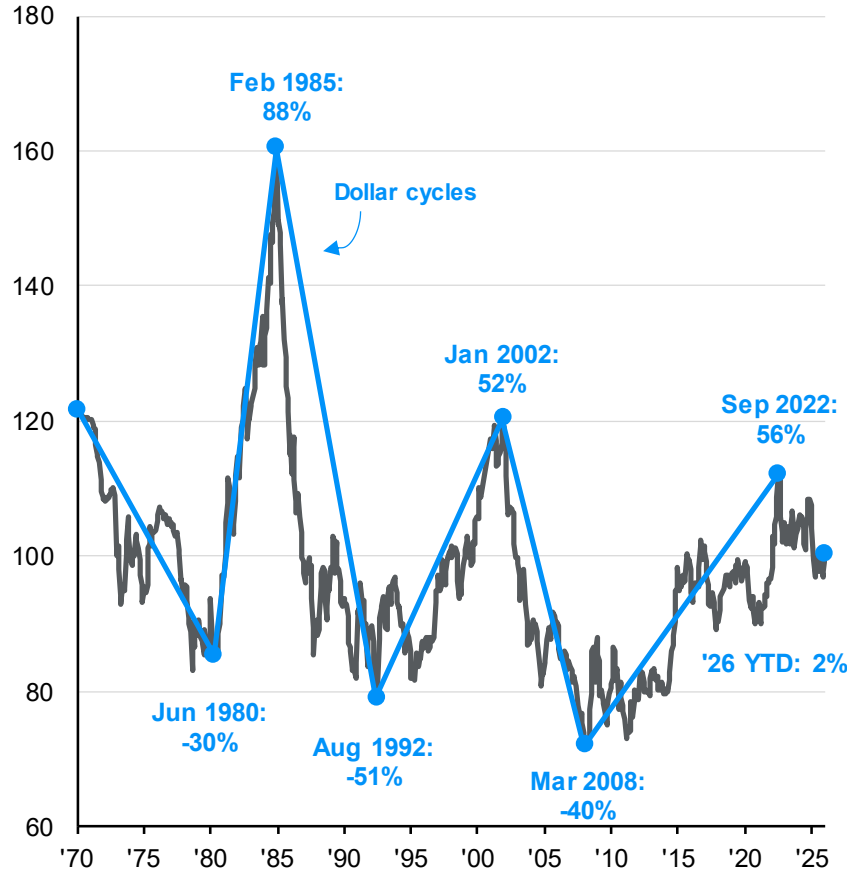

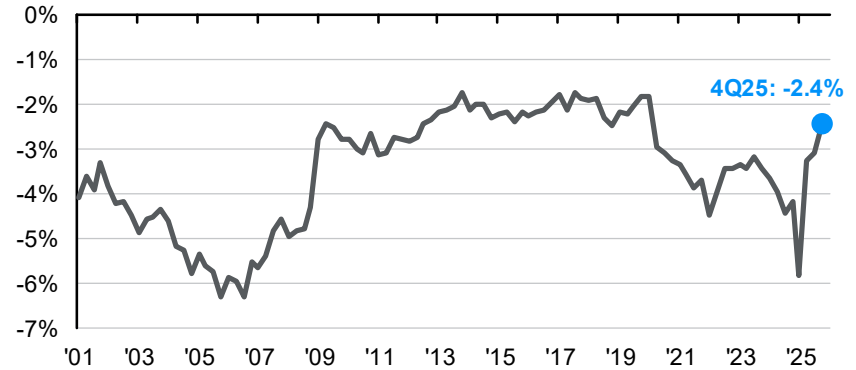

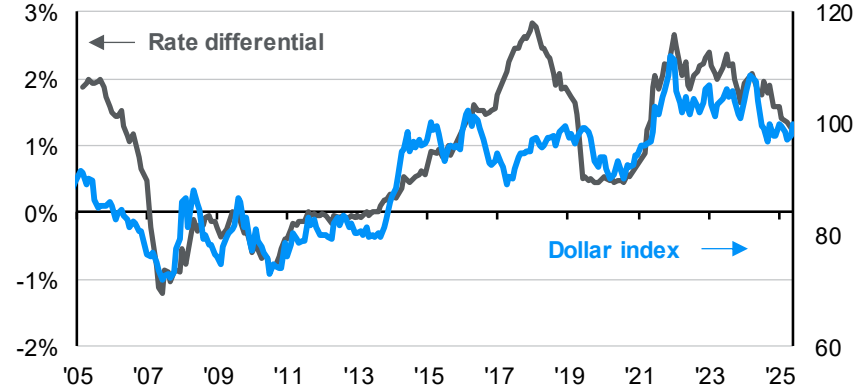

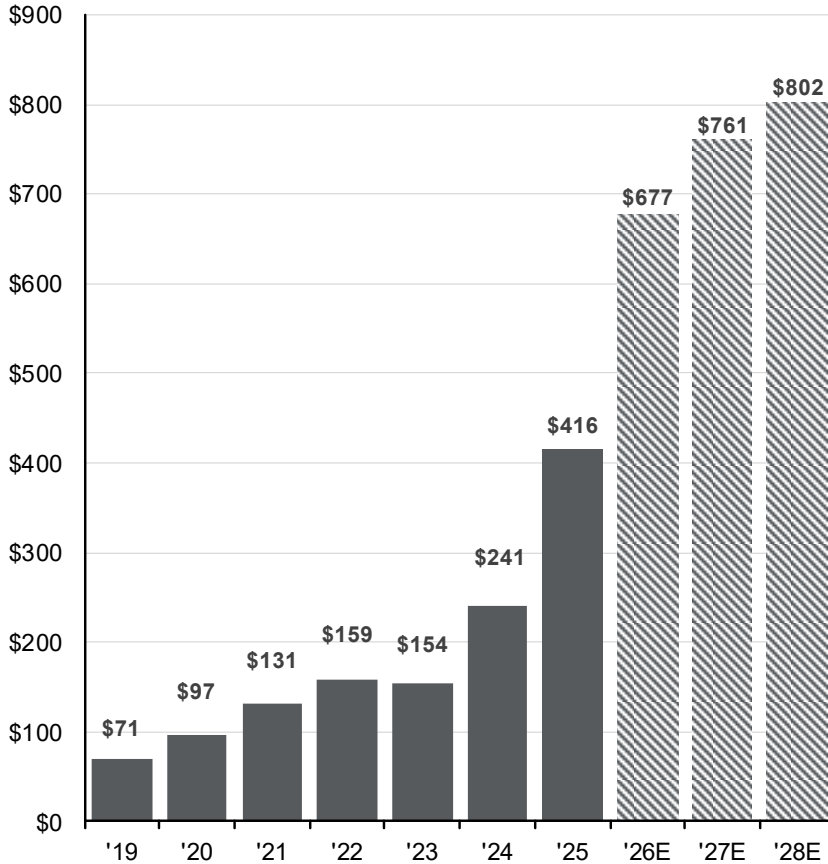

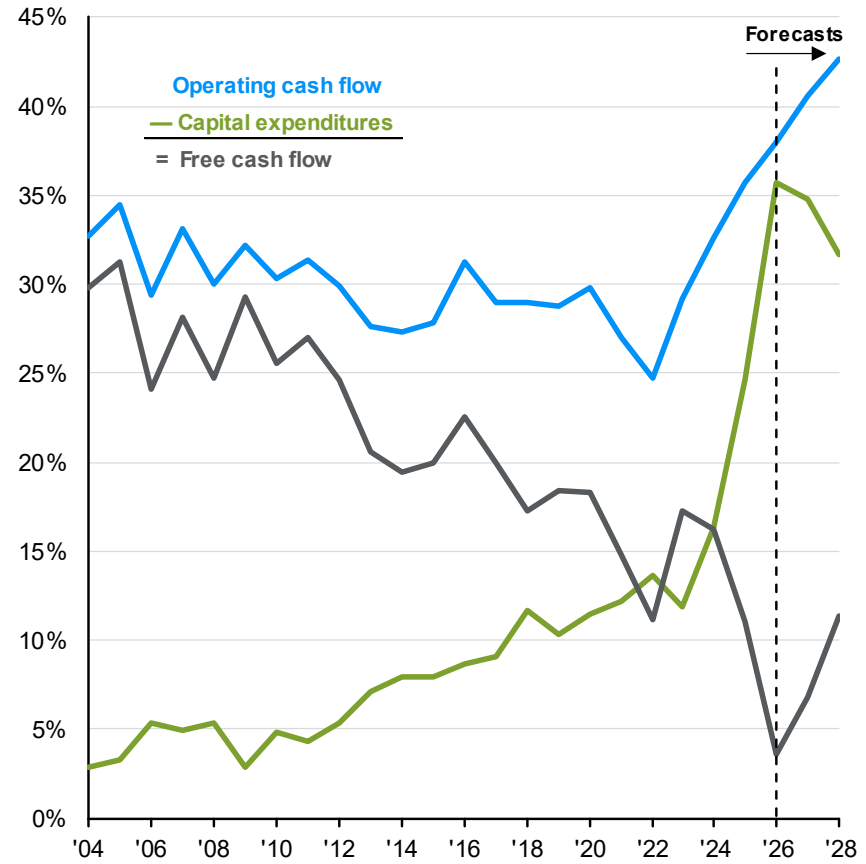
Capex from the major AI hyperscalers*

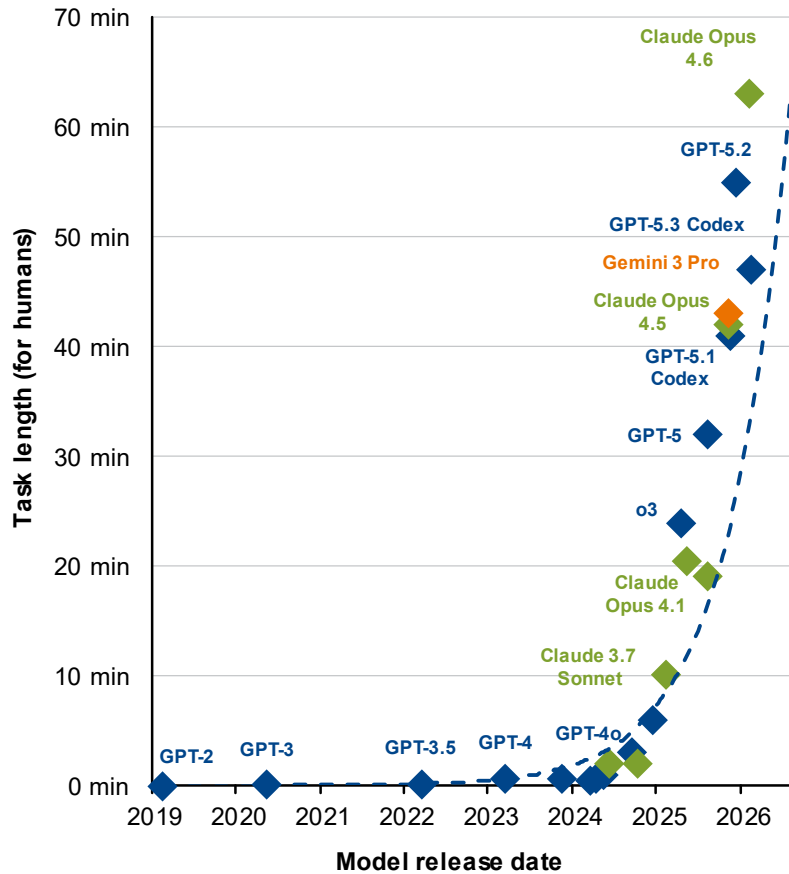

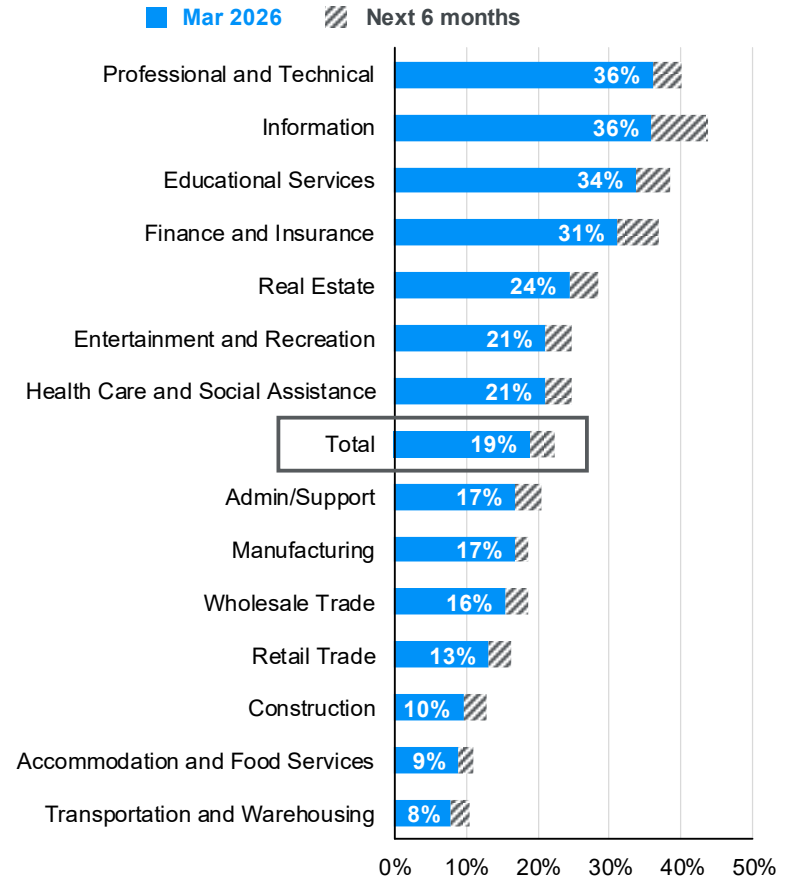
Length of tasks AI agents can autonomously complete

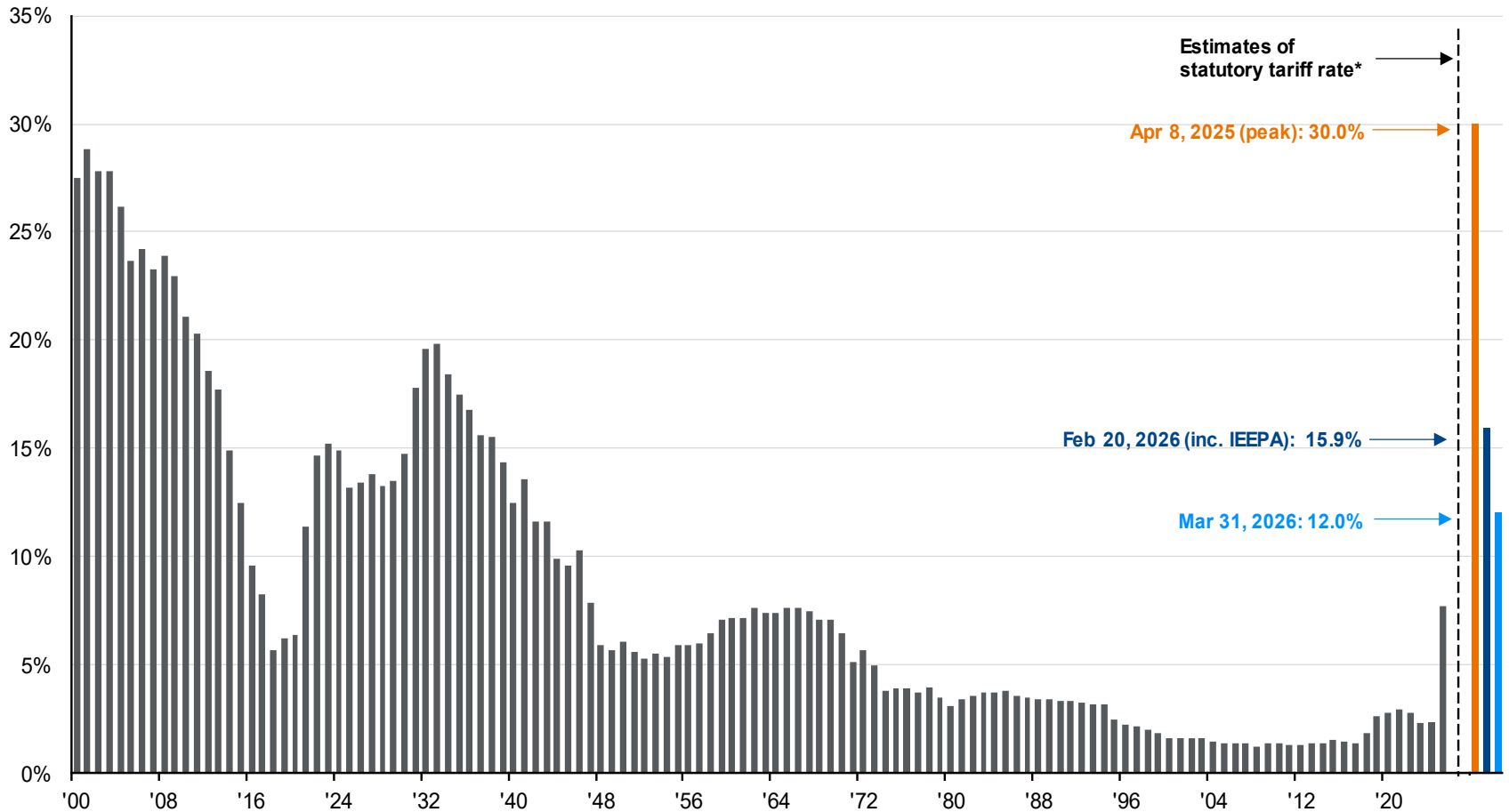

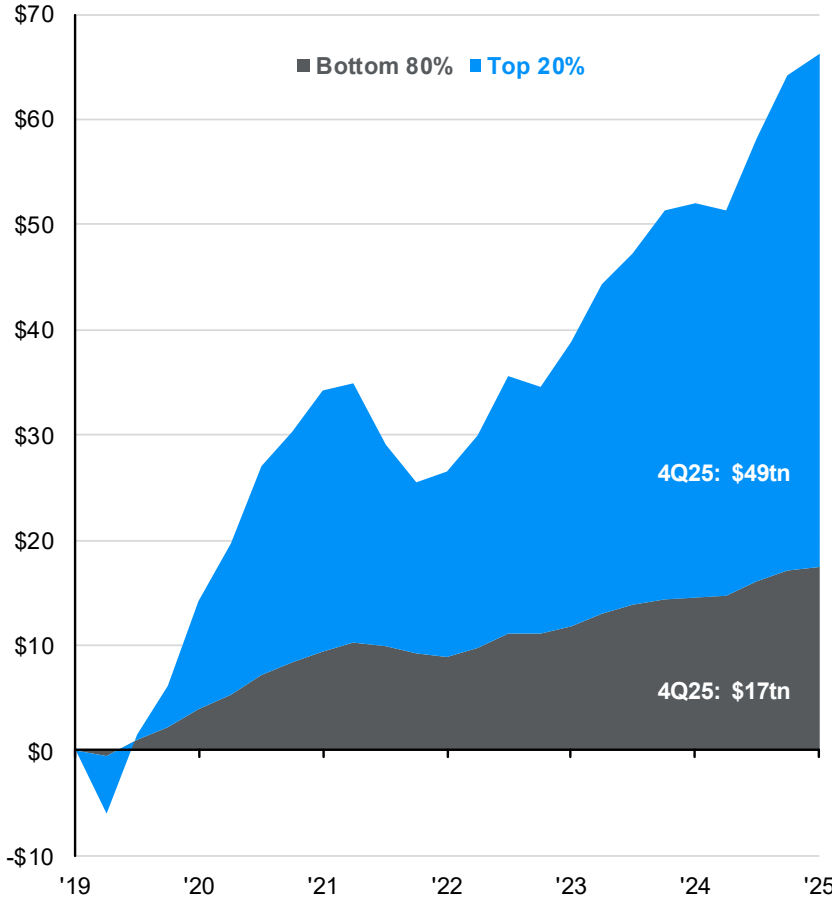

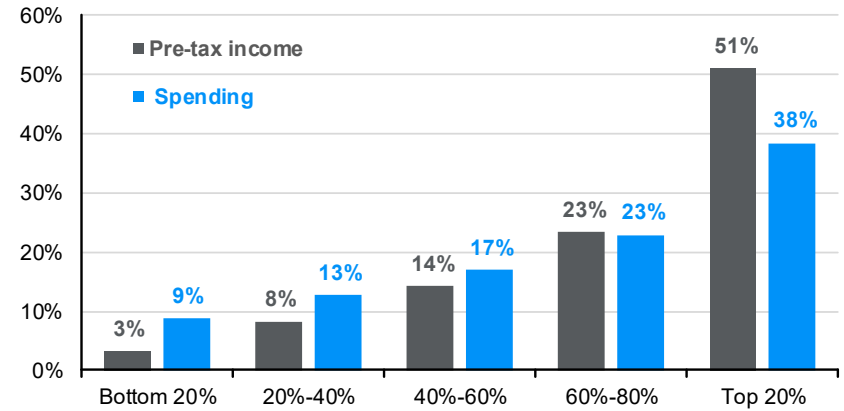
Net worth growth by income cohort

Cumulative growth from 4Q19, by pre-tax income cohort, USD trillions



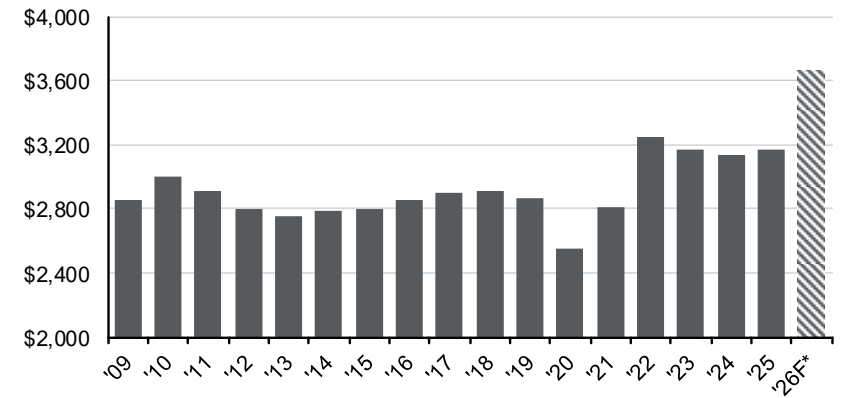
Consumer share of total pre-tax income and spending

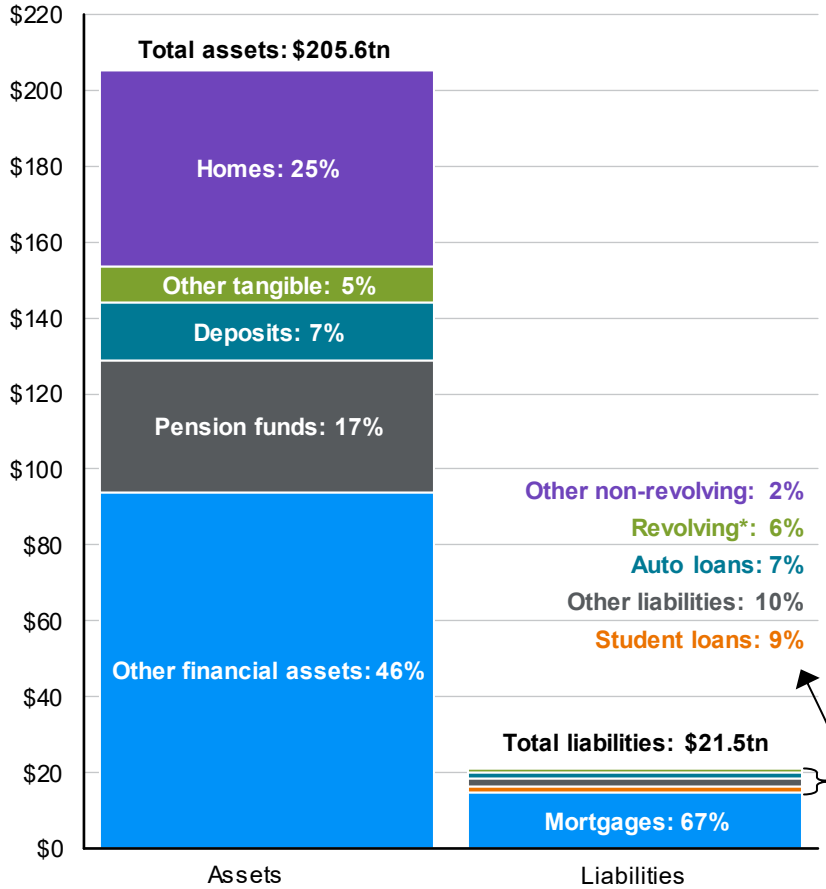

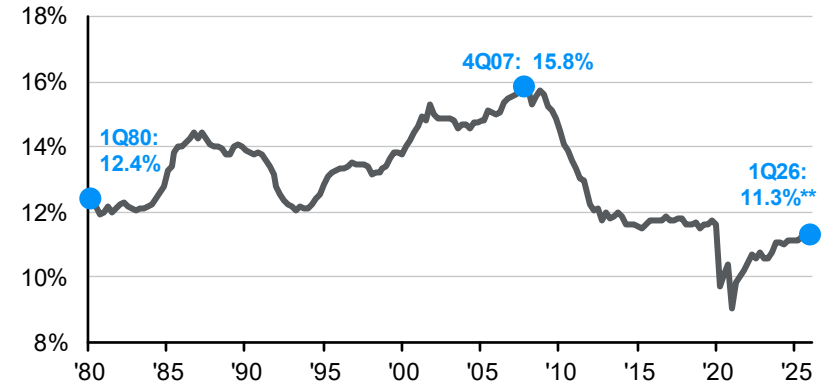
Consumer balance sheet

4Q25, USD trillions, not seasonally adjusted



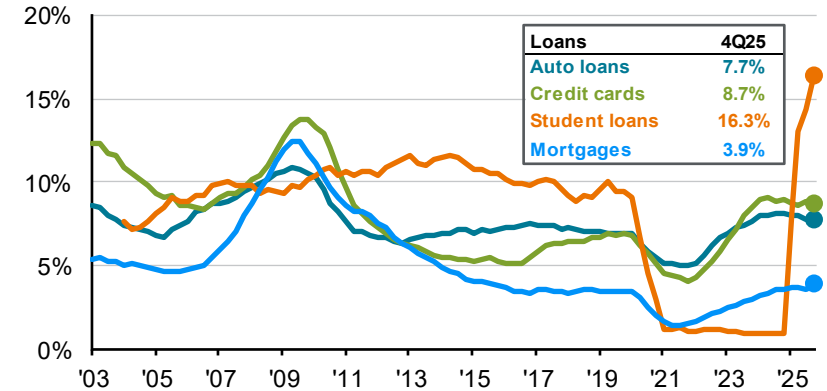
Household debt service ratio

% of balance delinquent 30+ days



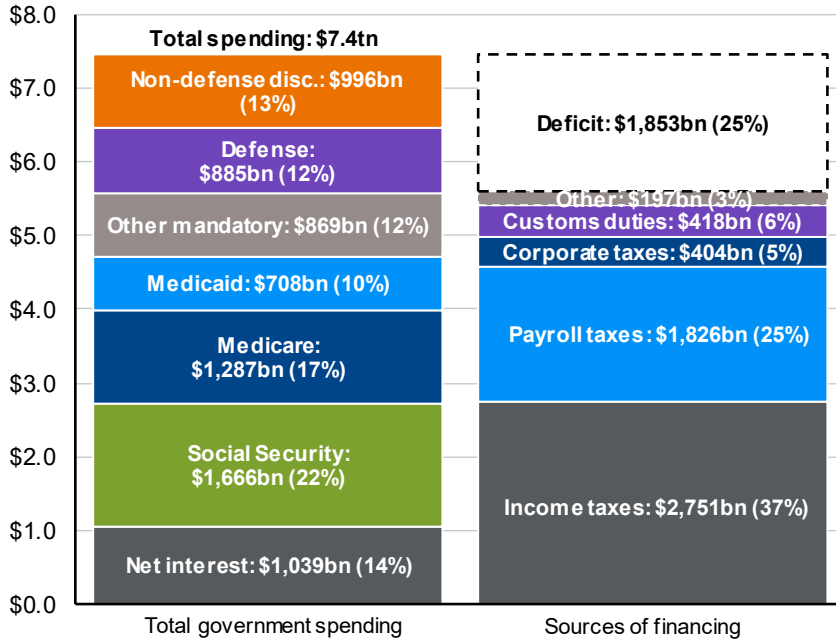

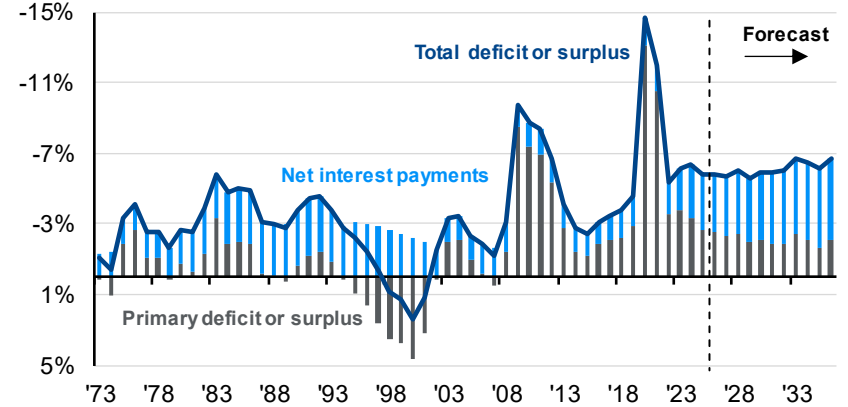

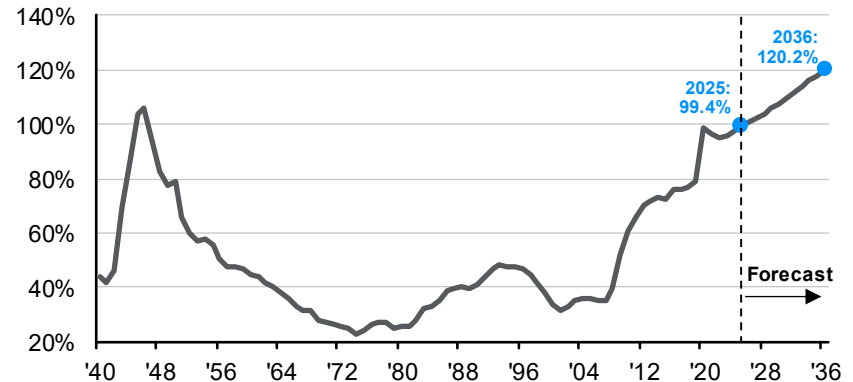
Federal deficit and net interest payments

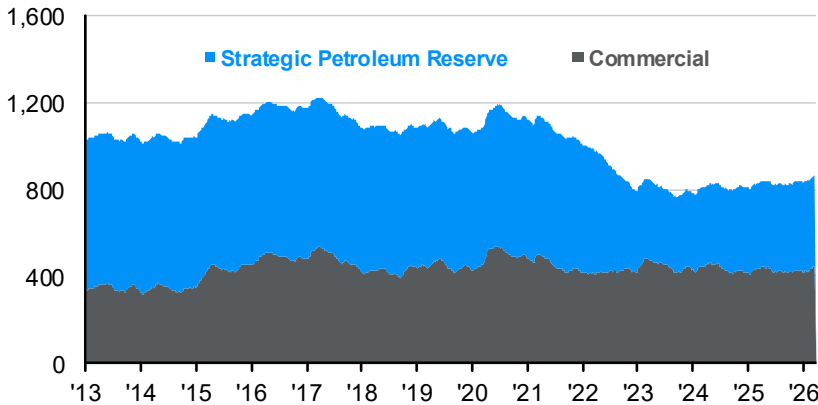

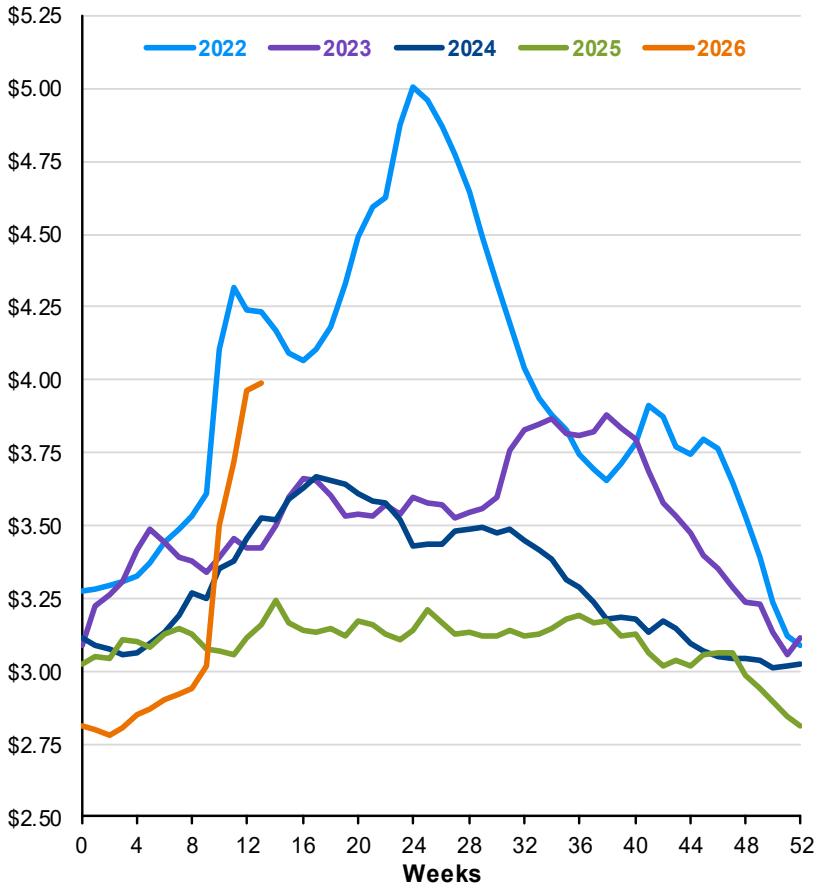

All regular formulations, USD per gallon, weekly



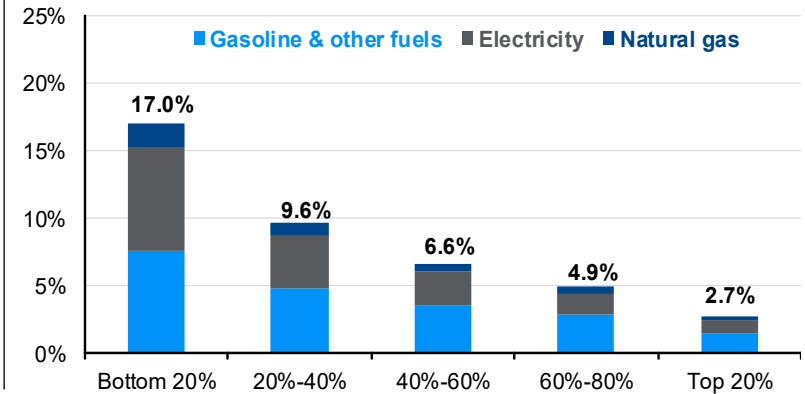
U.S. net imports of petroleum and related products*

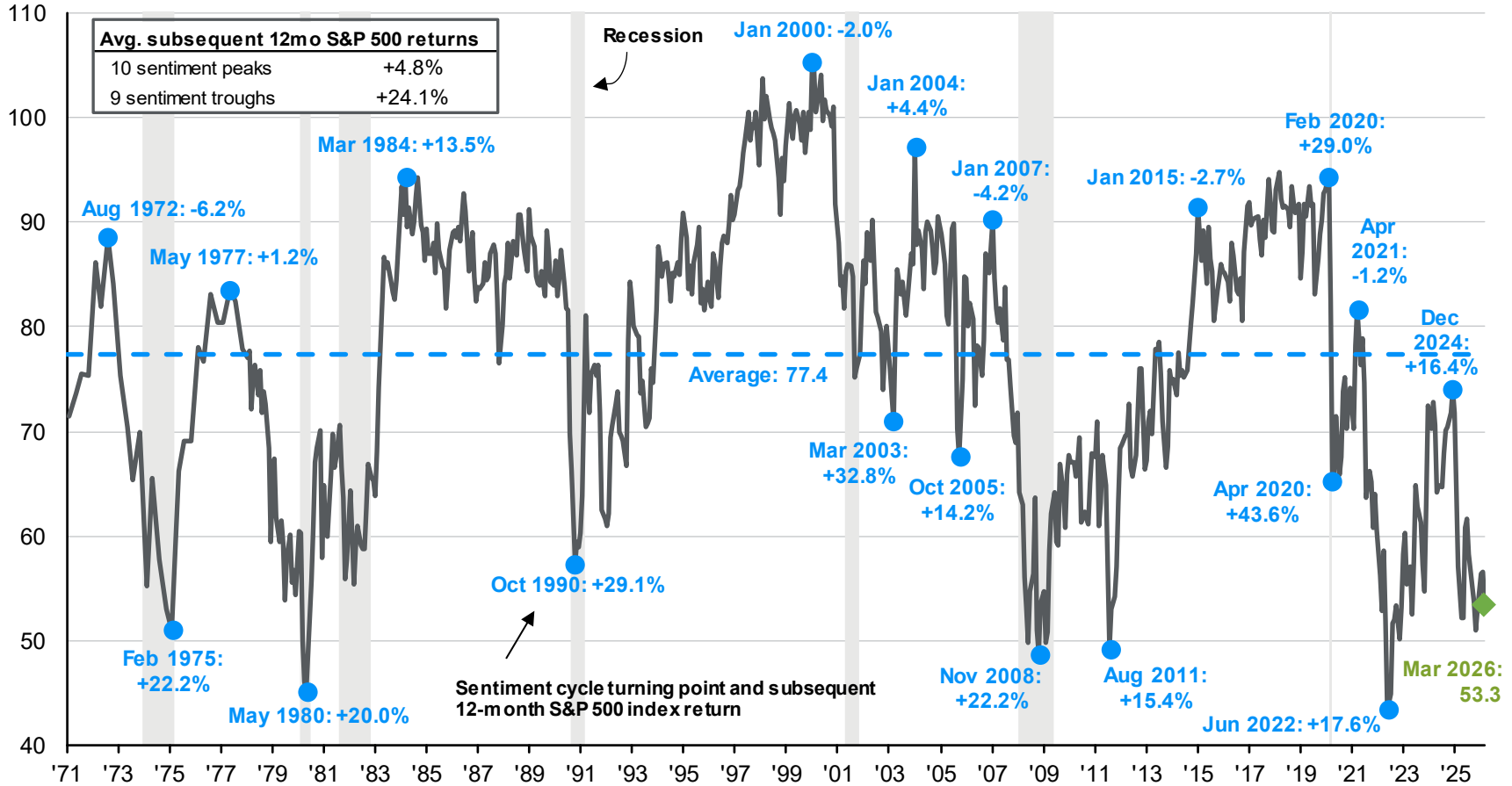

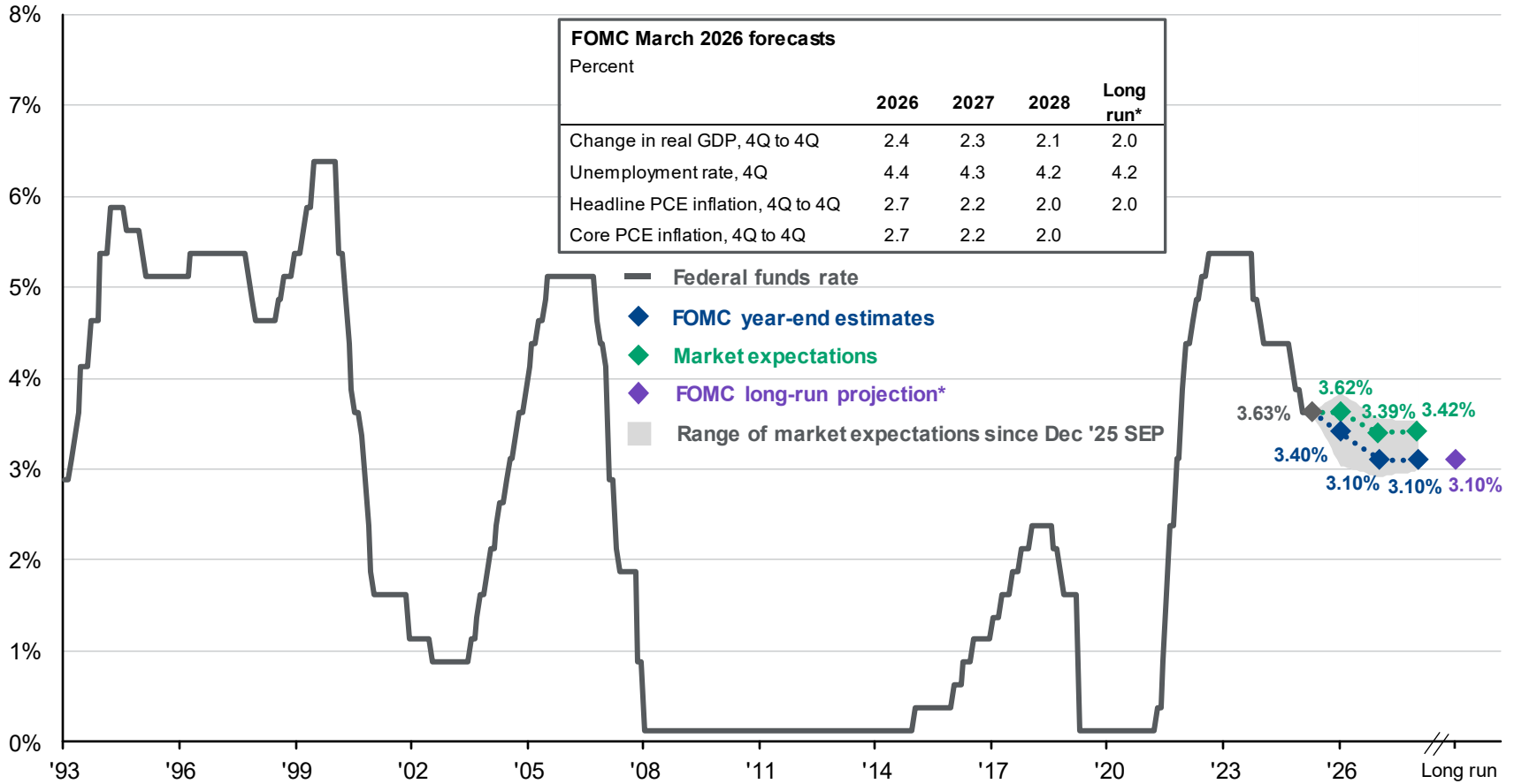

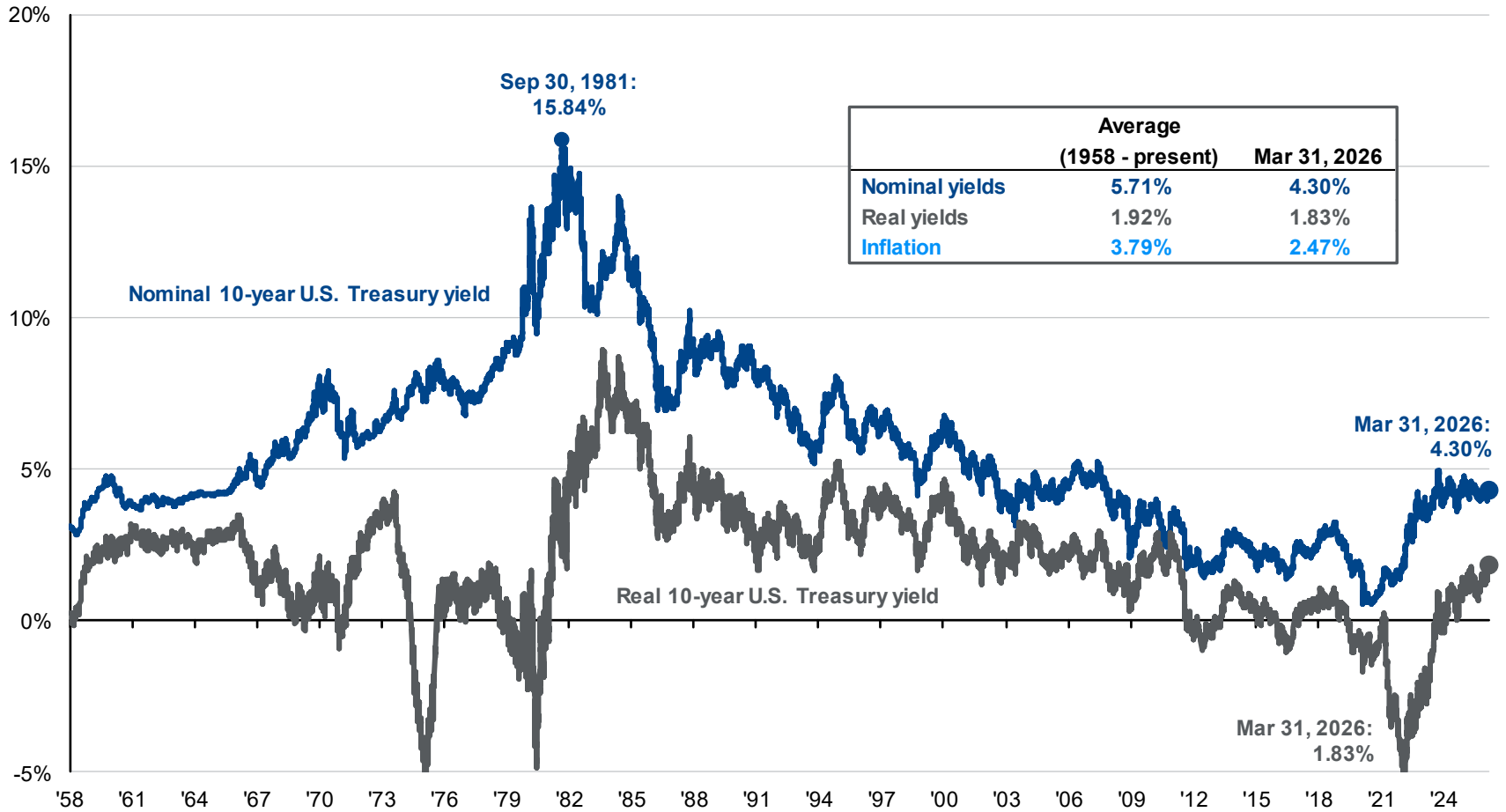

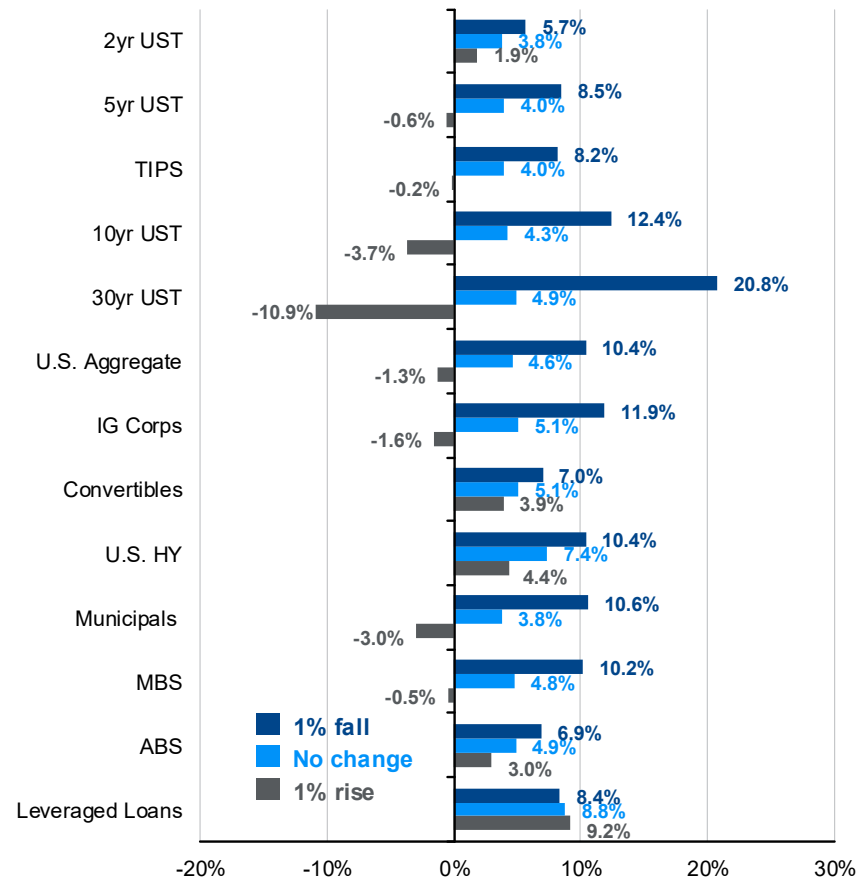

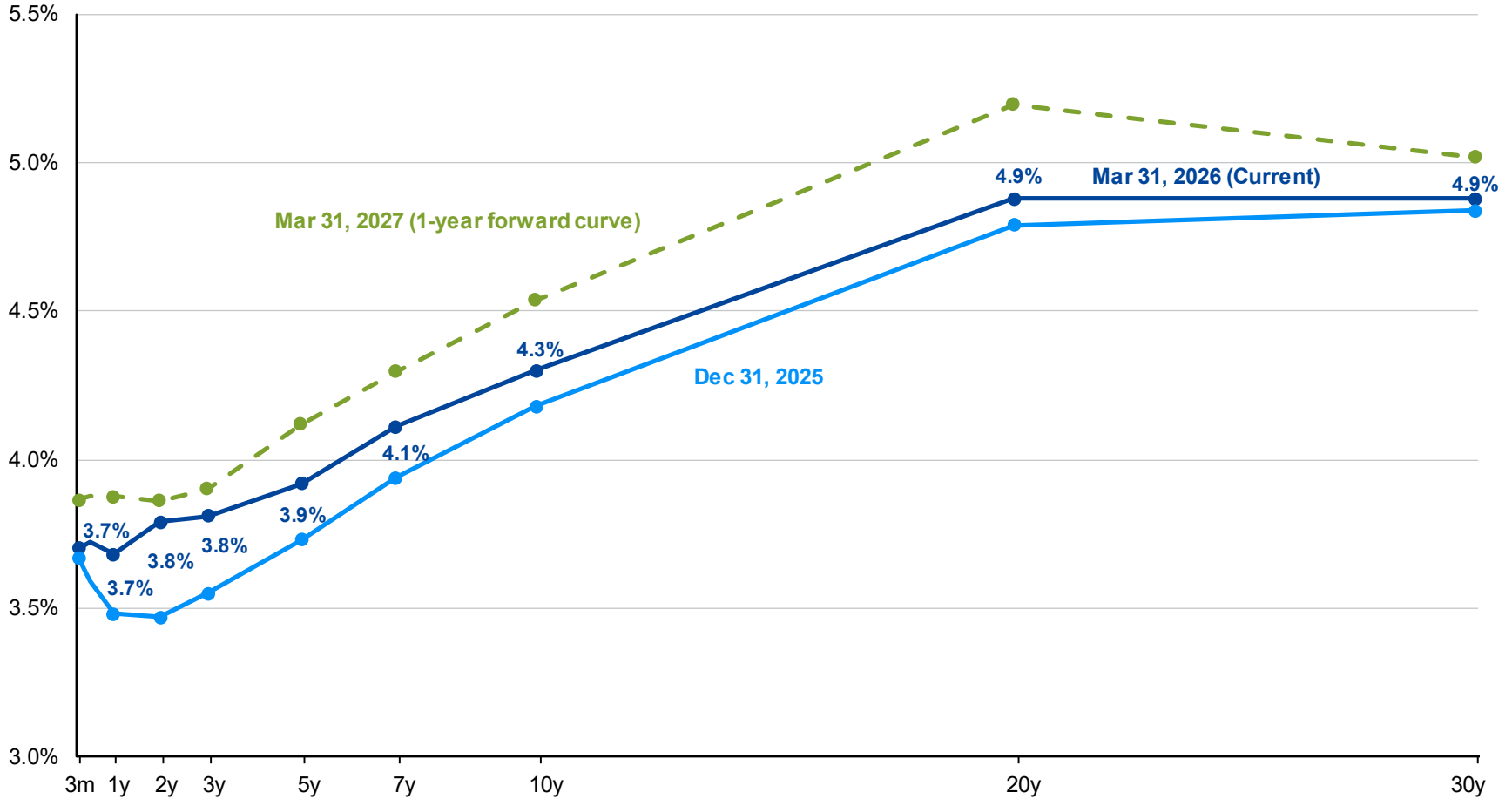

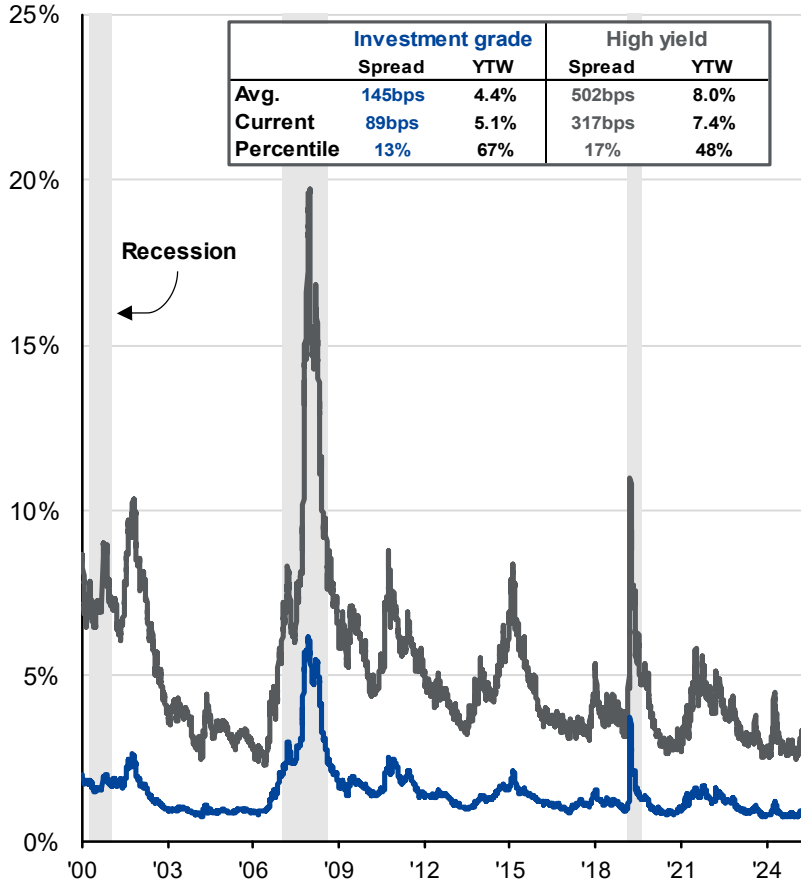

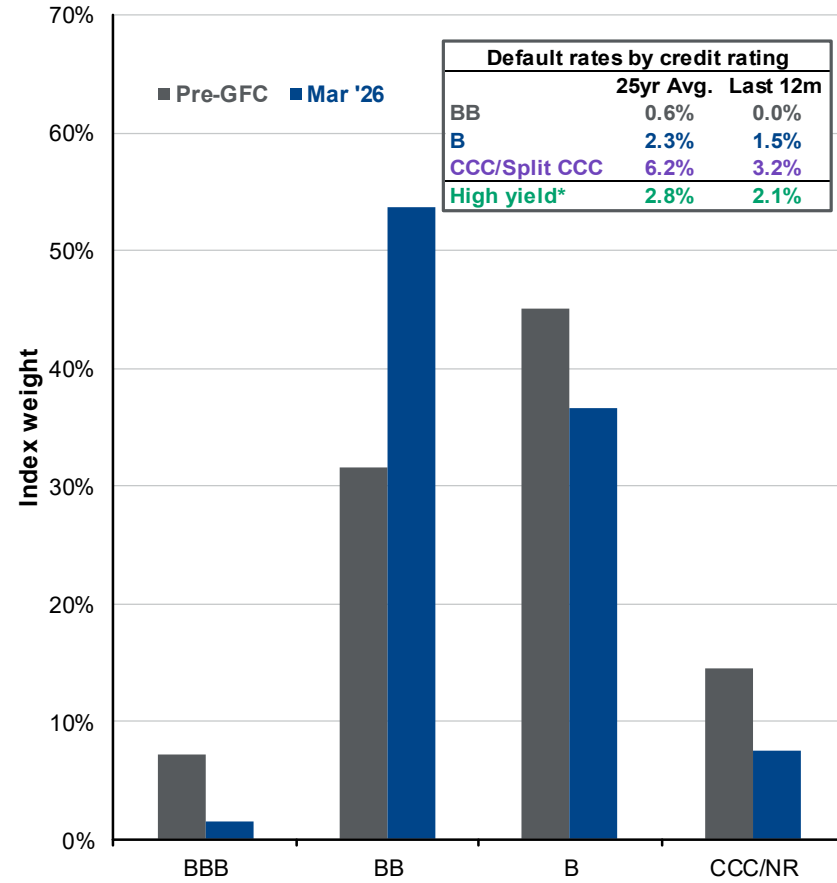

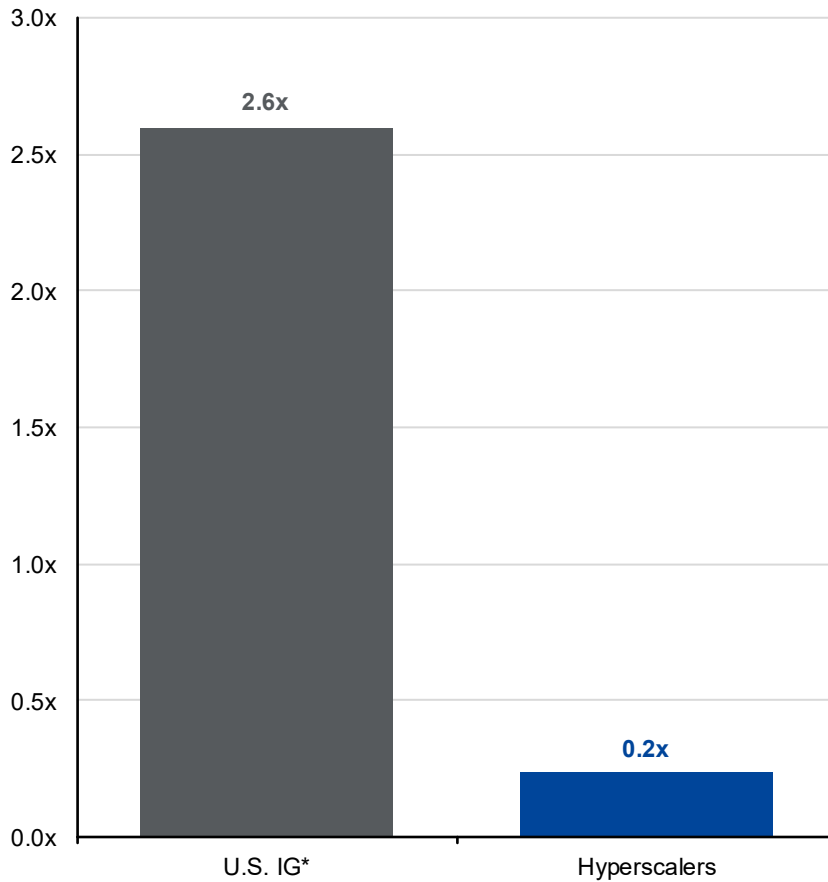

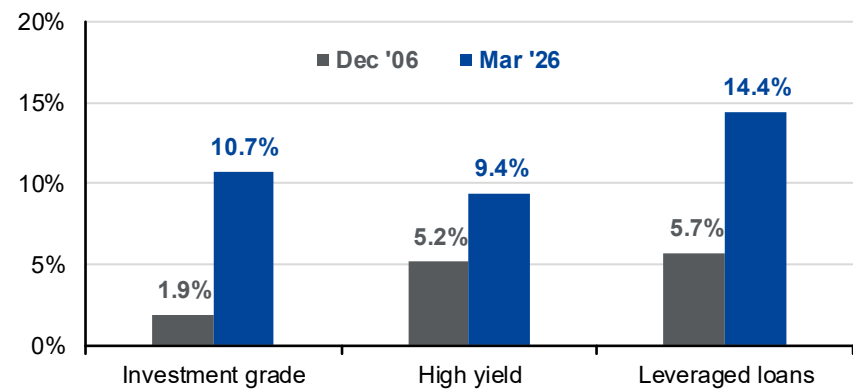
Hyperscaler net debt to EBITDA

4Q25, net debt divided by trailing 12-month EBITDA



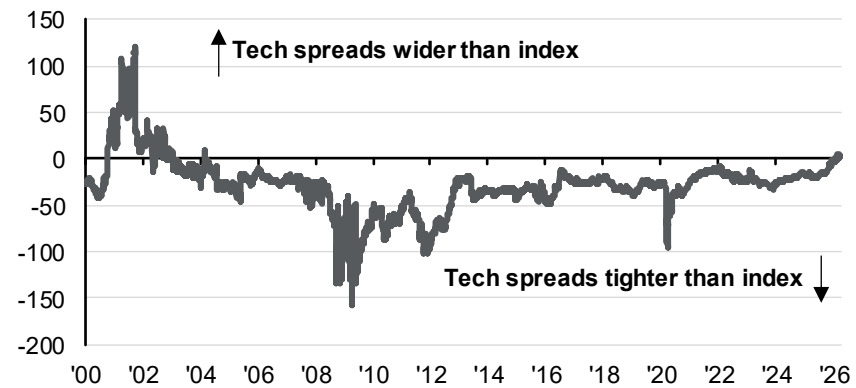
Tech sector share of U.S. credit markets

Tech sectors spreads minus overall index spreads, basis points



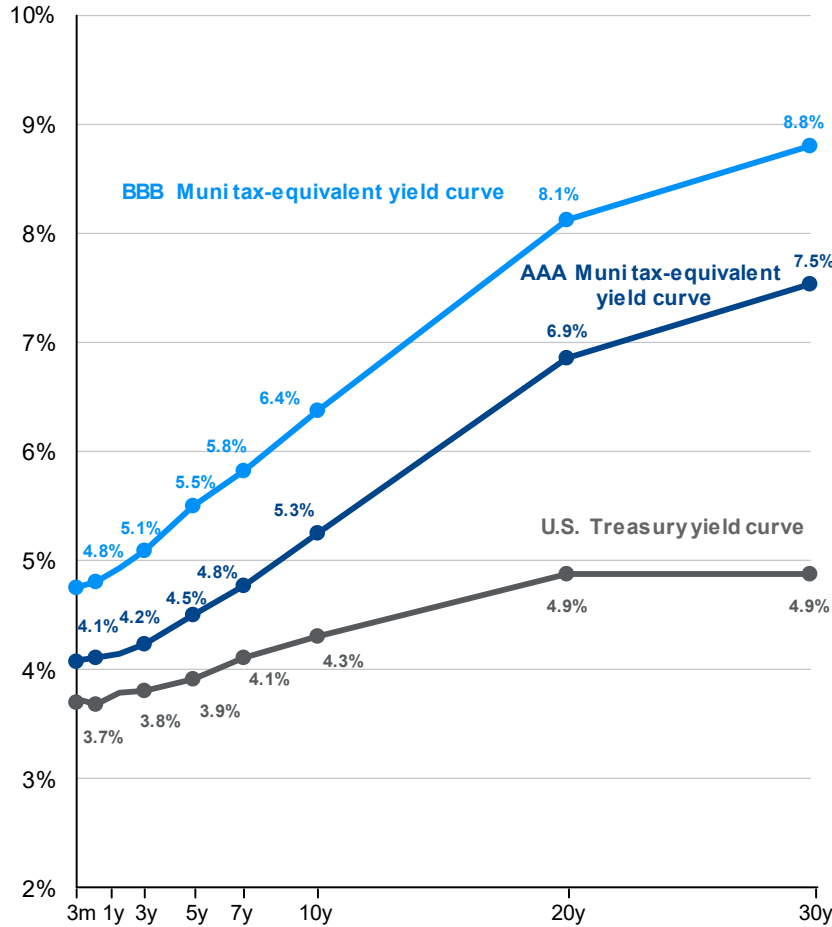

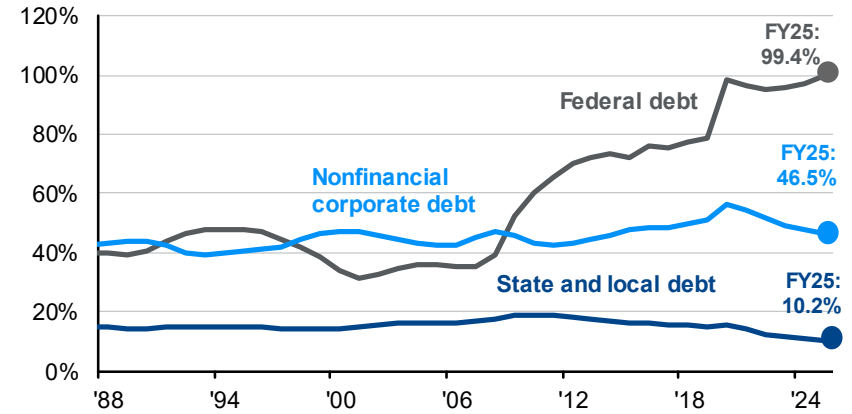


Muni tax-equivalent and Treasury yield curves



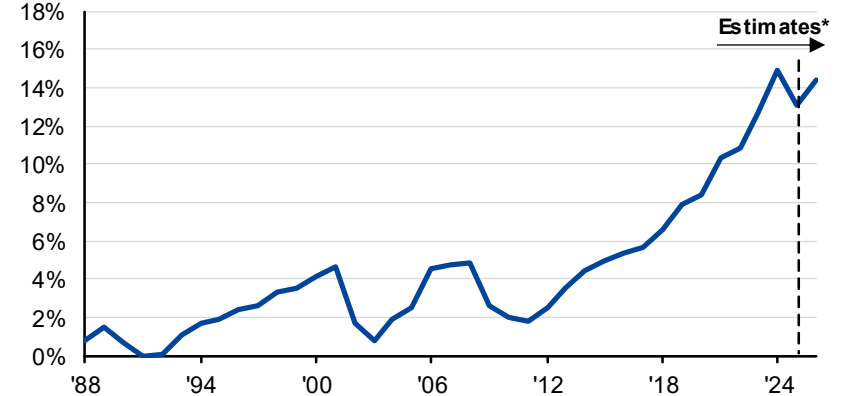
State and local, federal and corporate debt

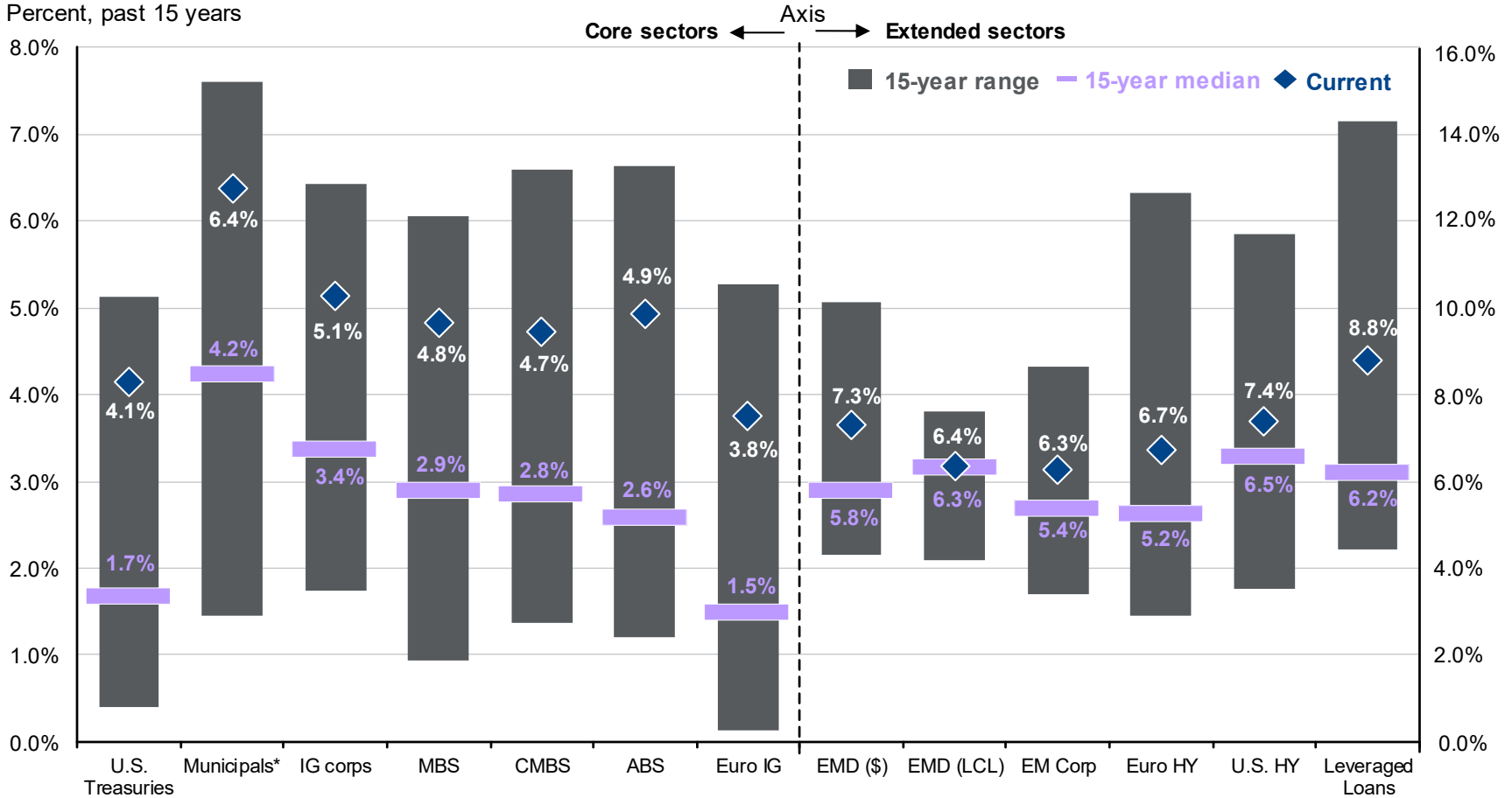

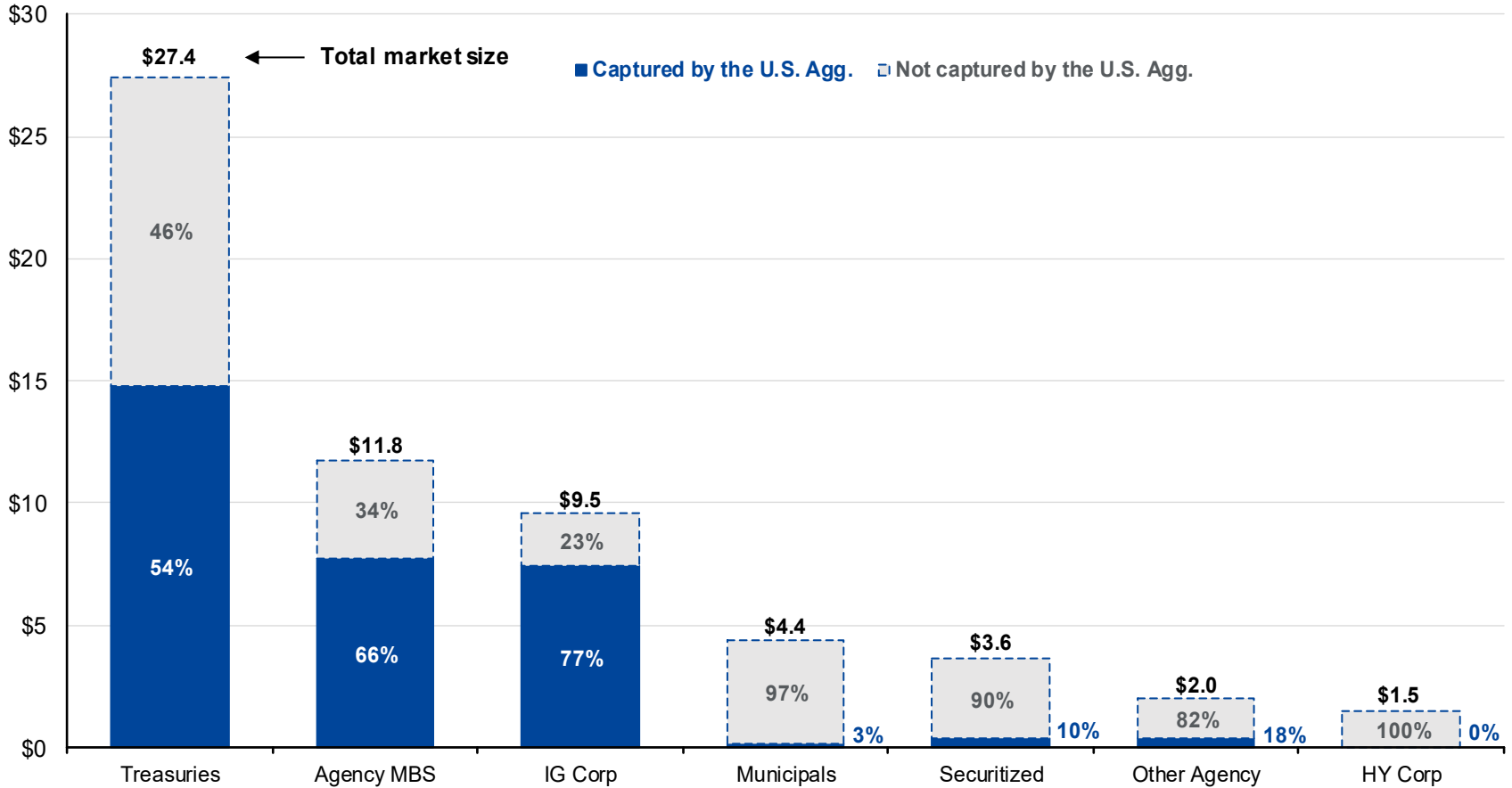

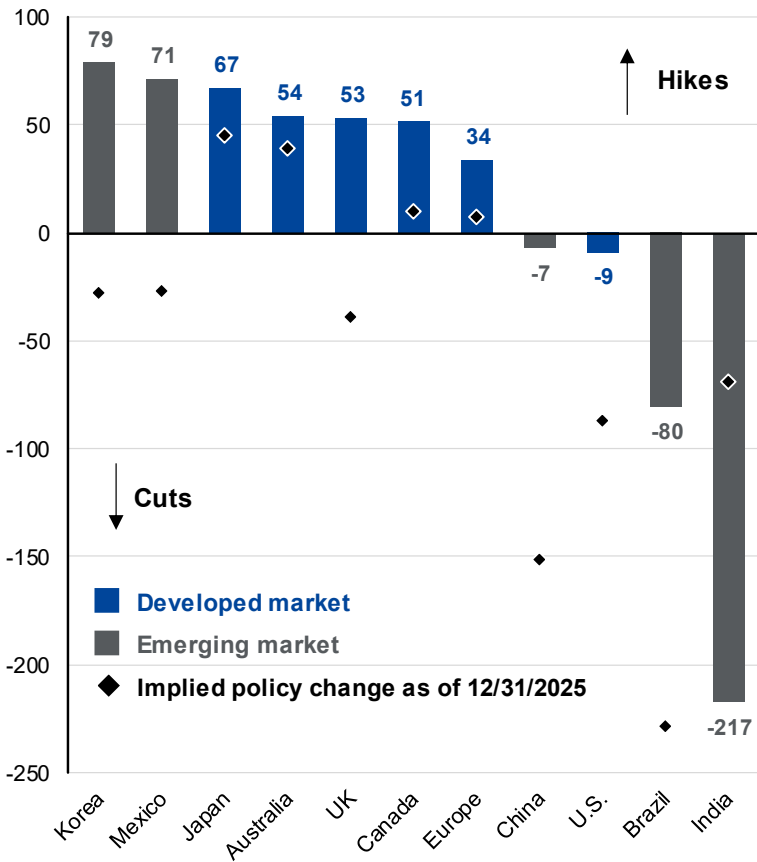

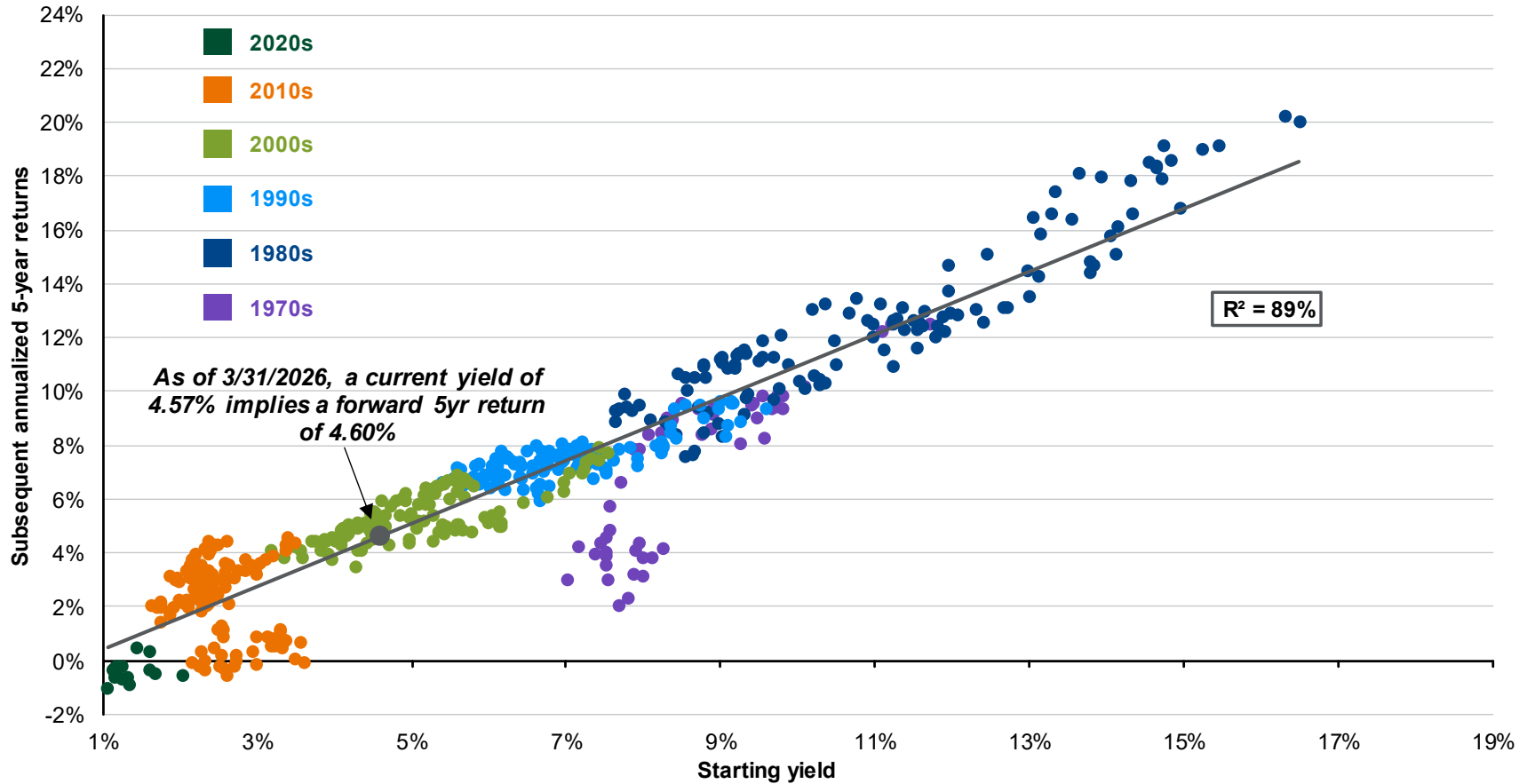

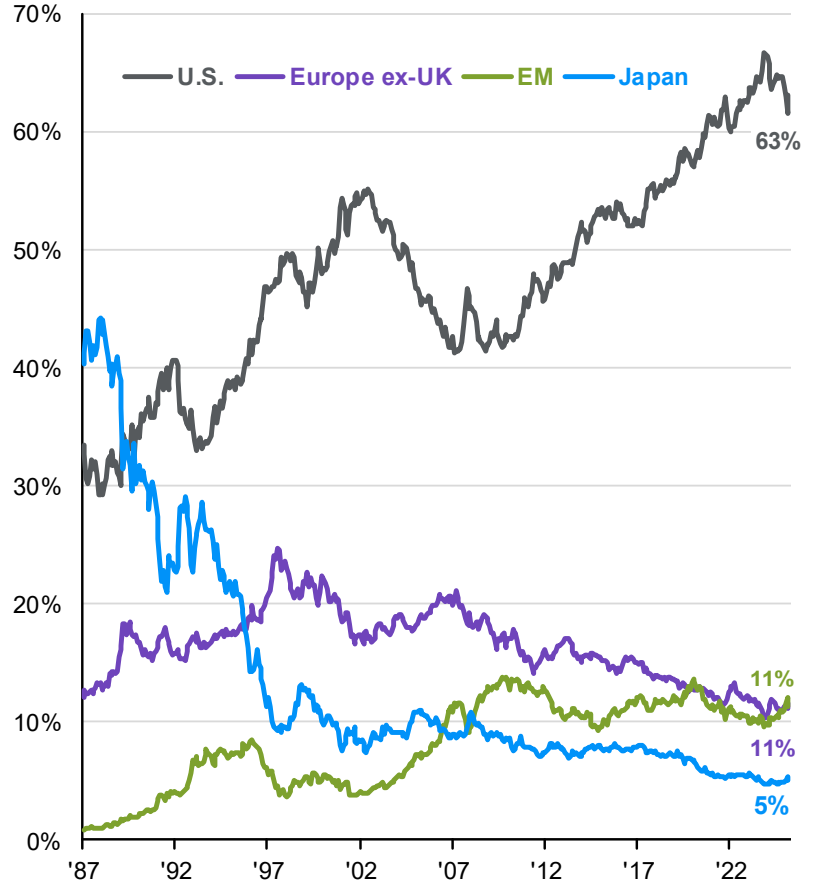

% weight in MSCI All Country World, USD, monthly



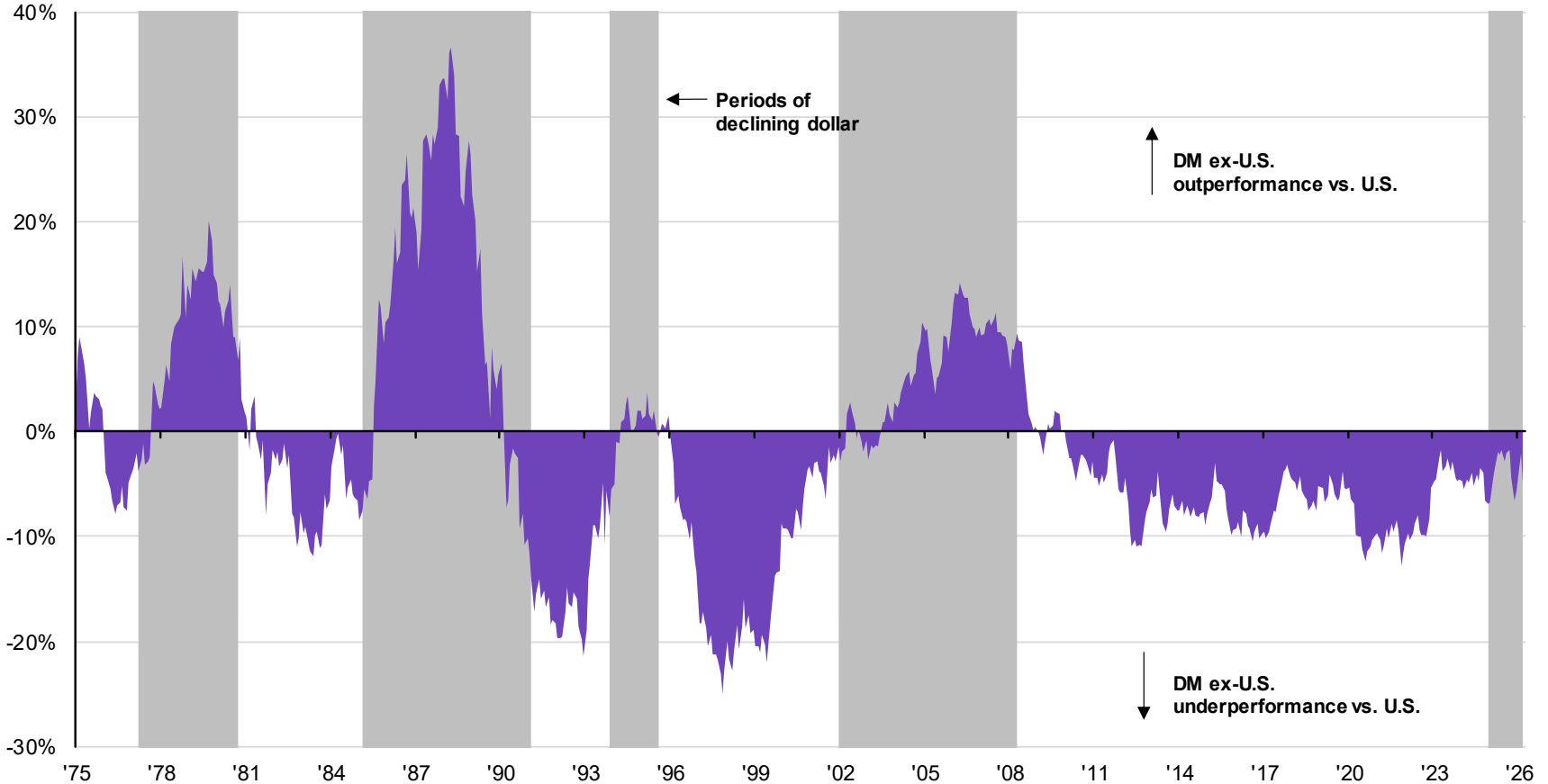

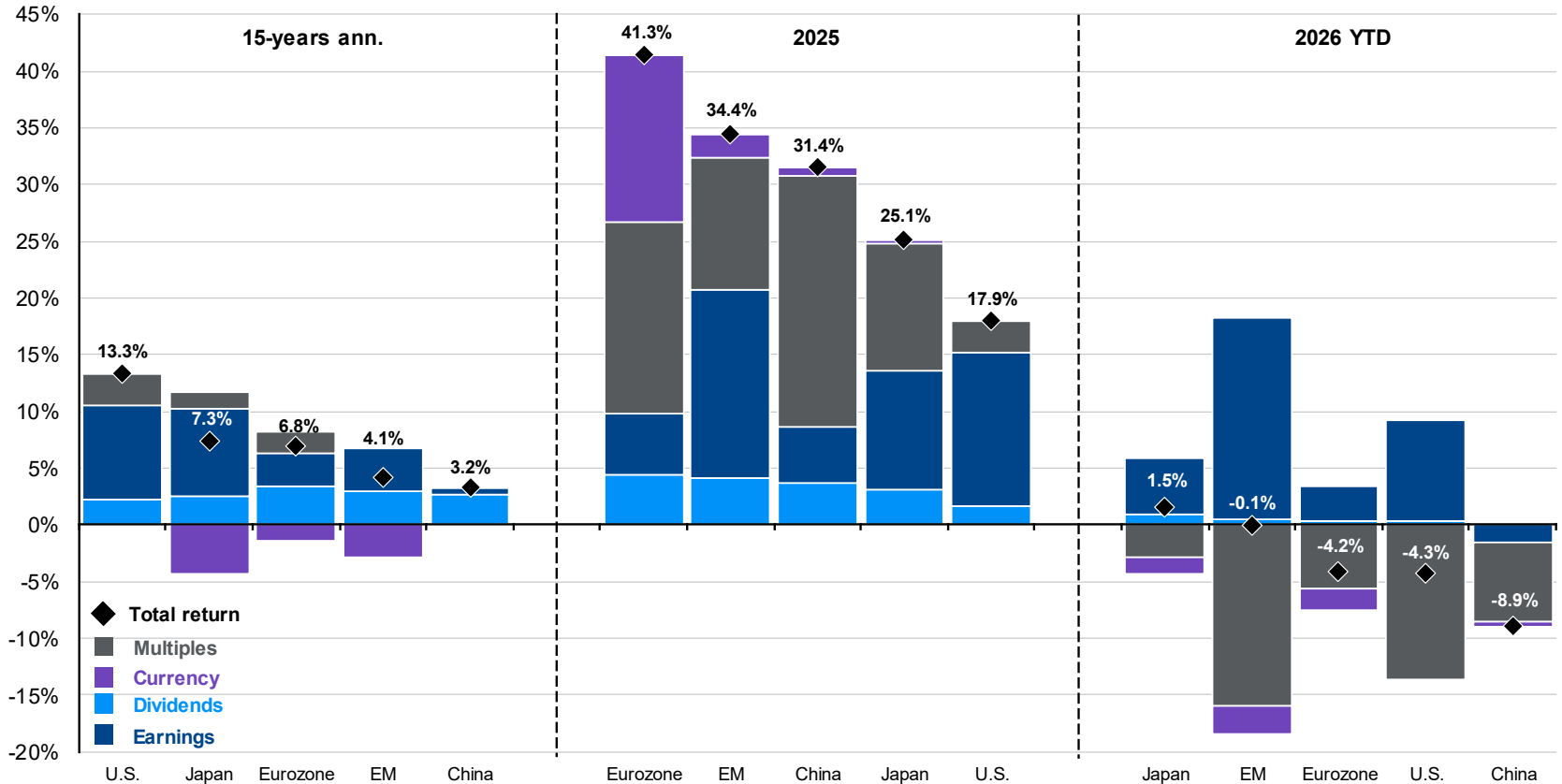

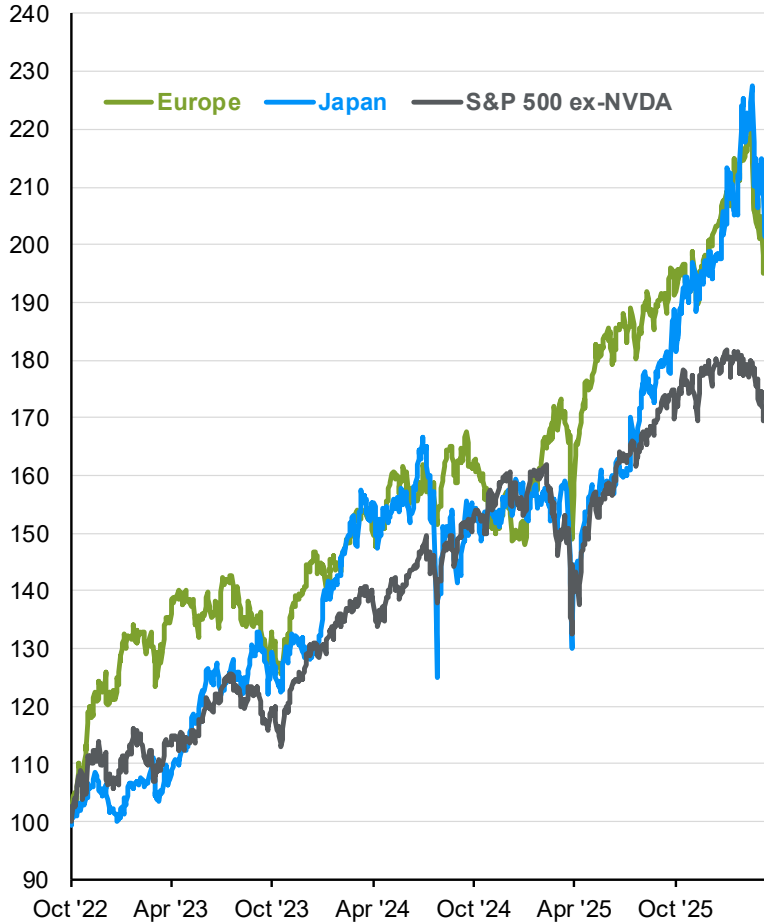

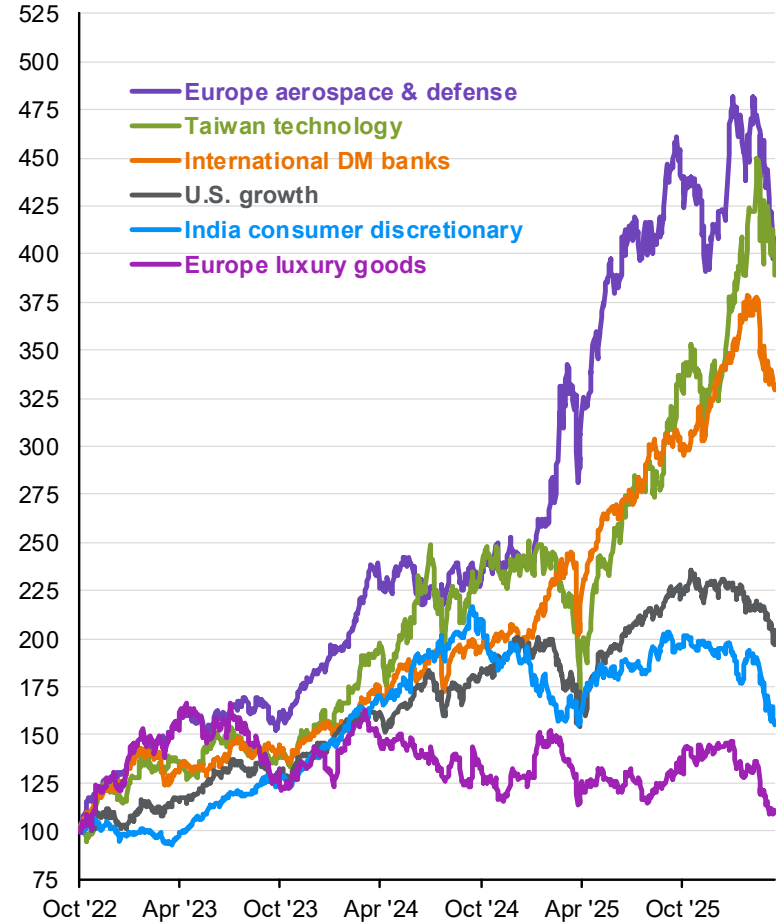
Regional performance since 2022

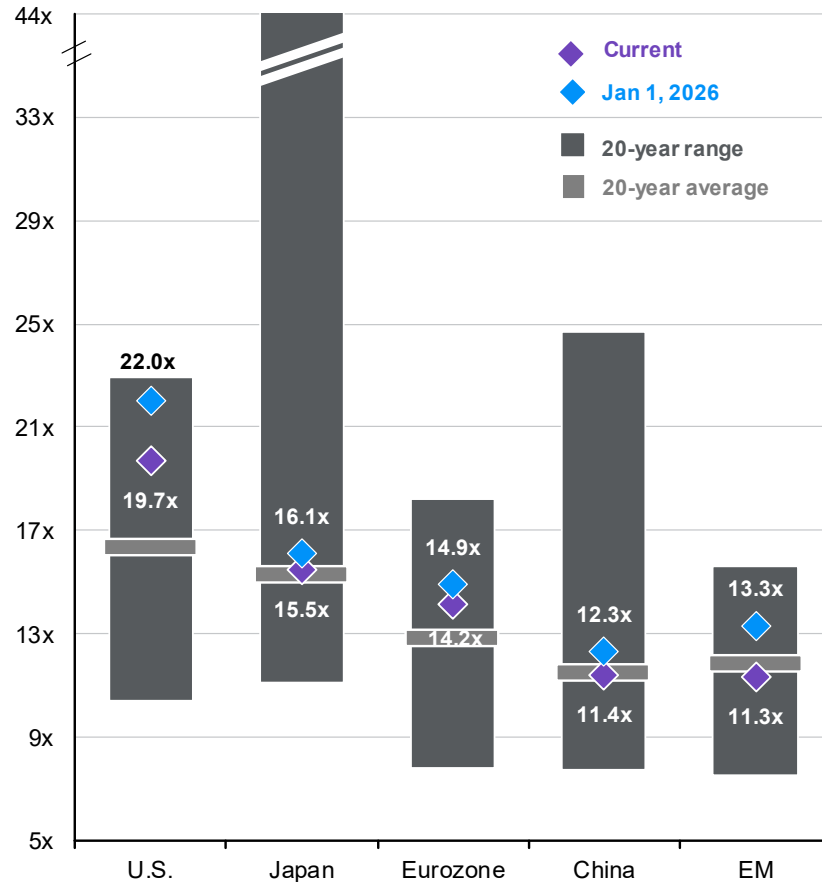

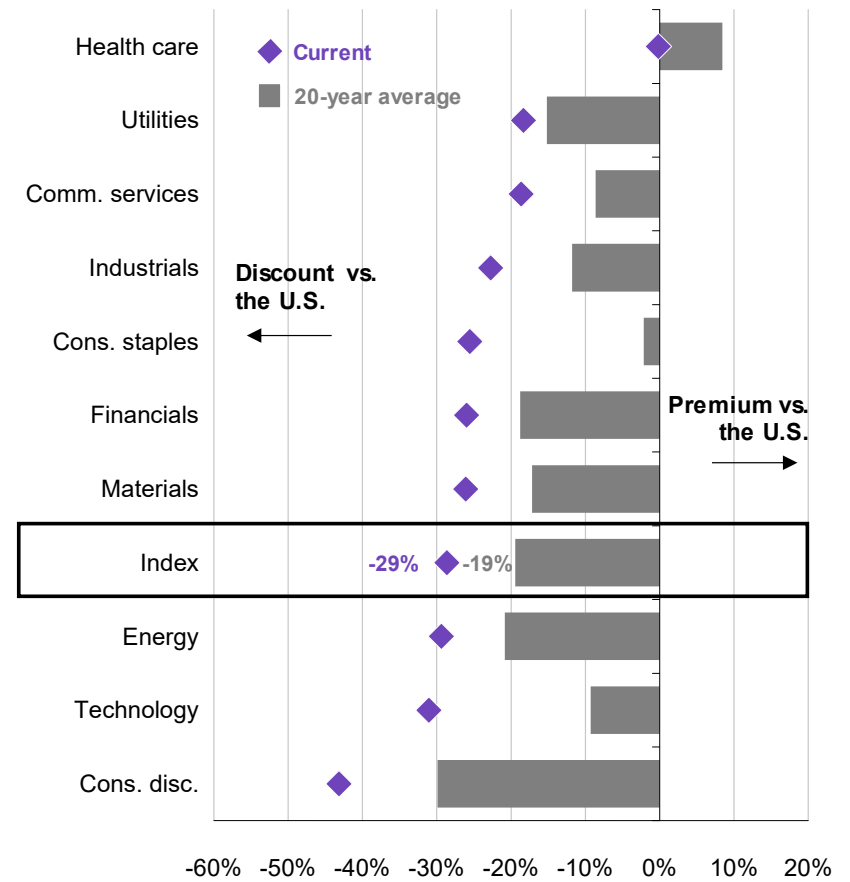
Valuations by region/country

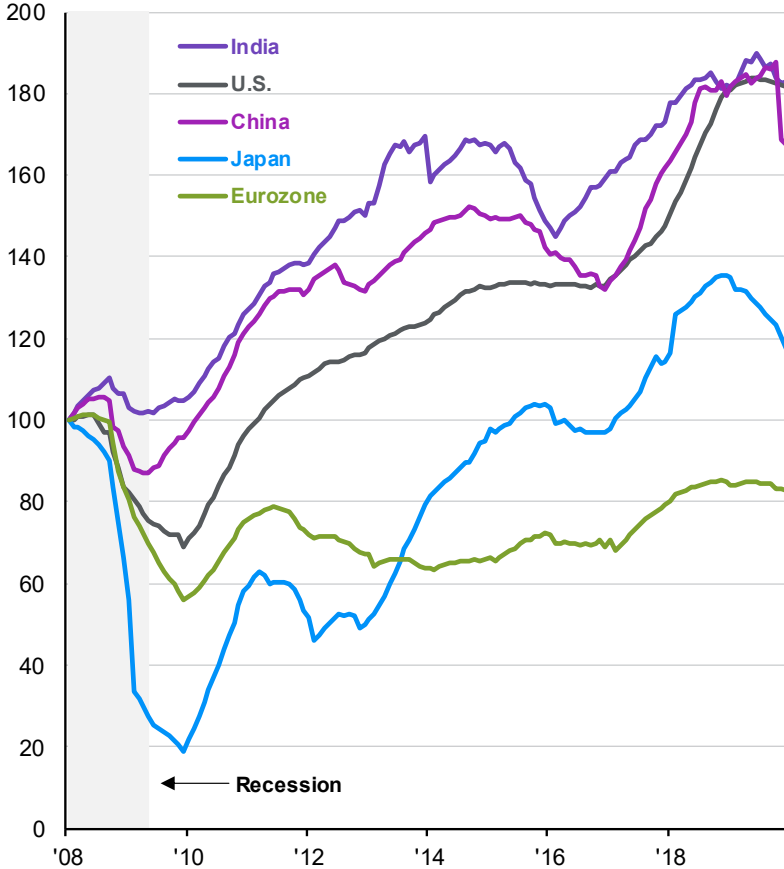

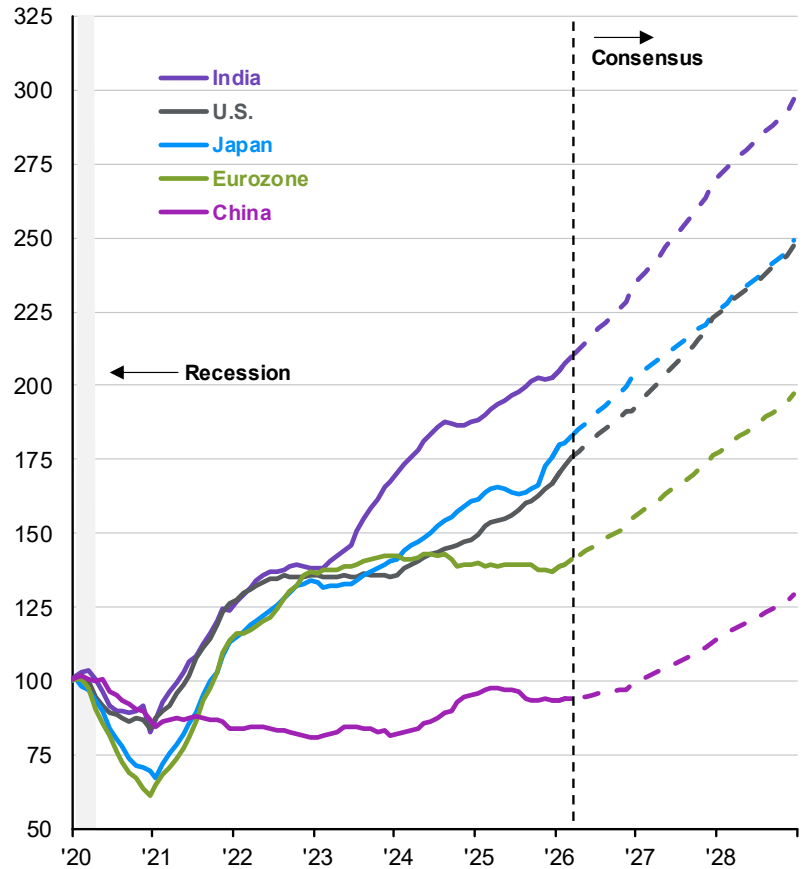
Earnings growth: GFC to pre-pandemic

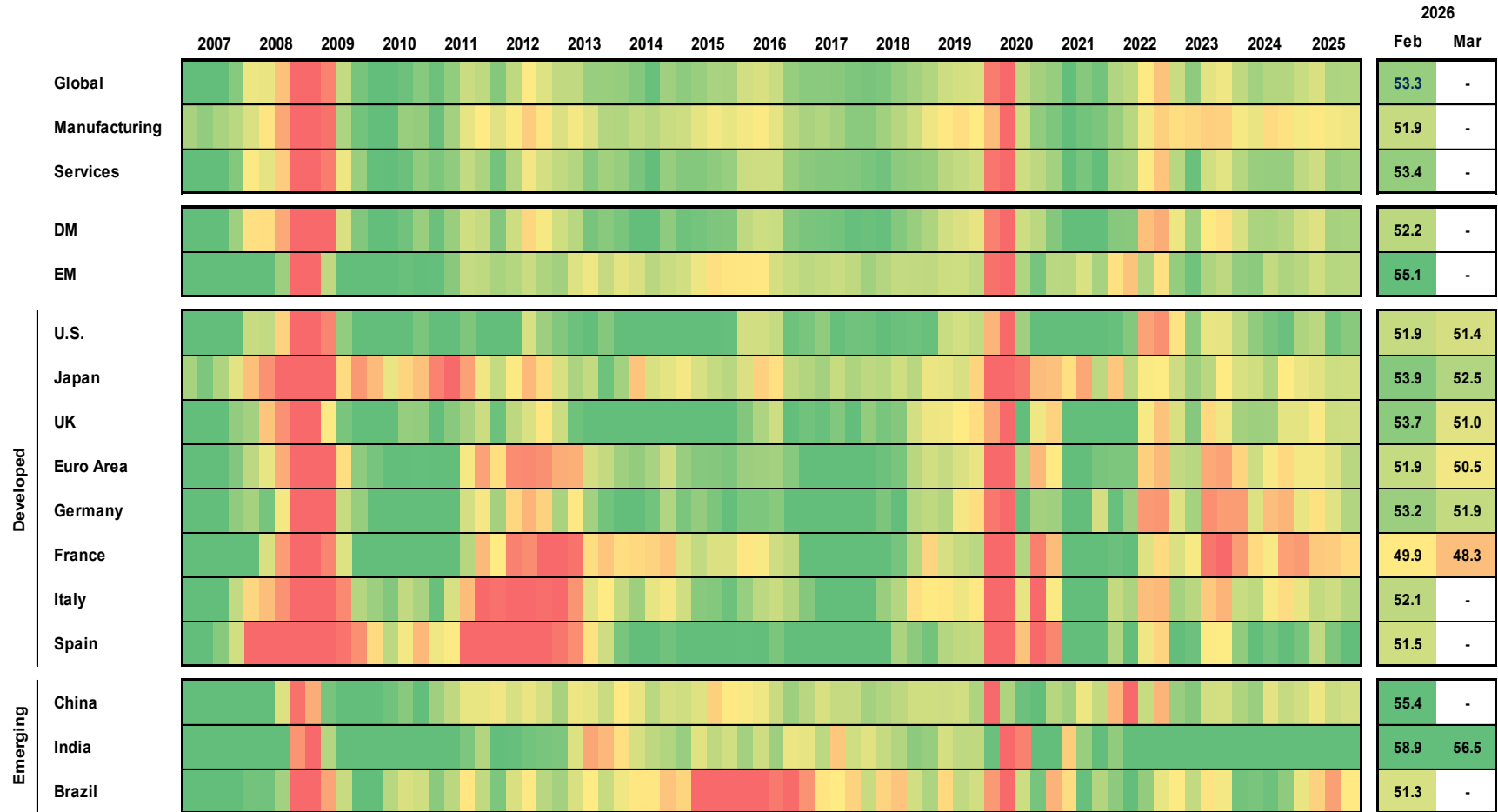

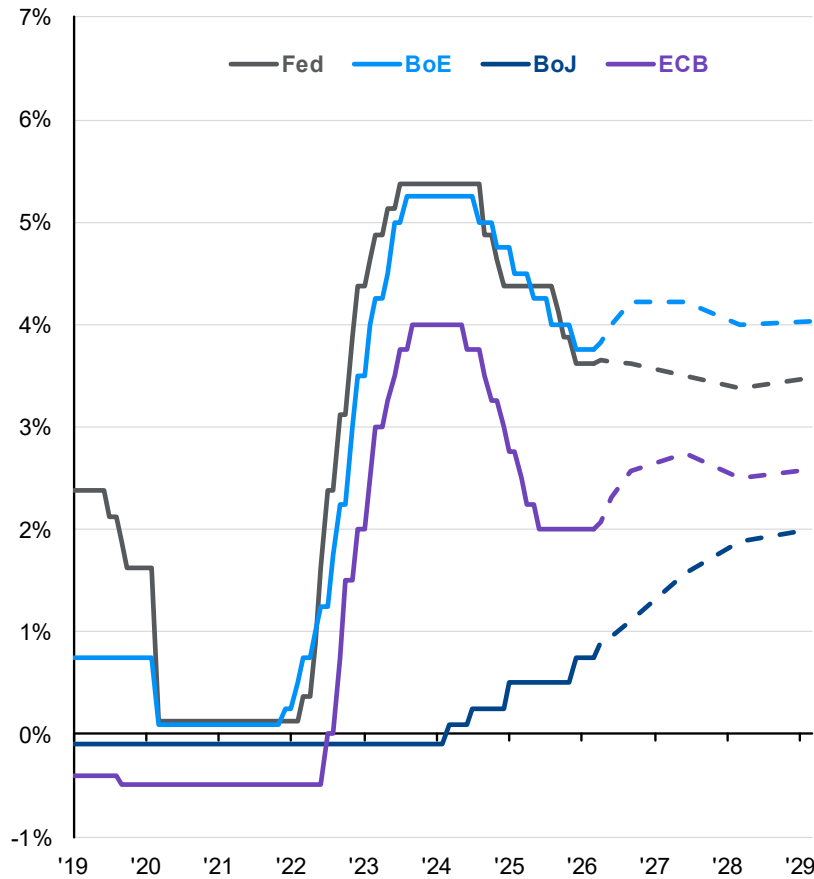

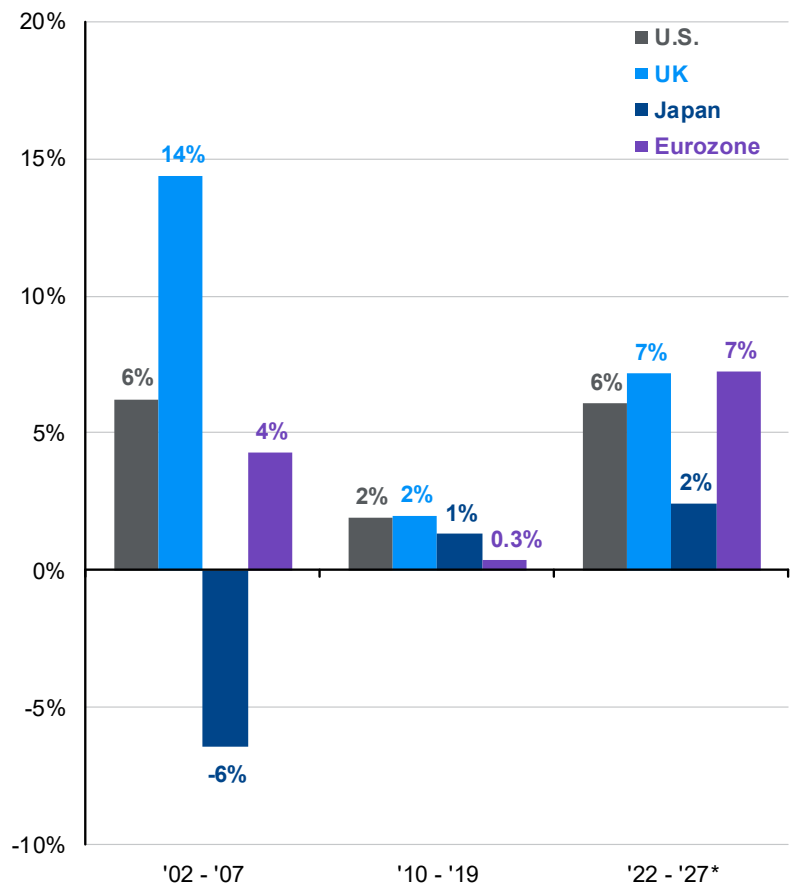

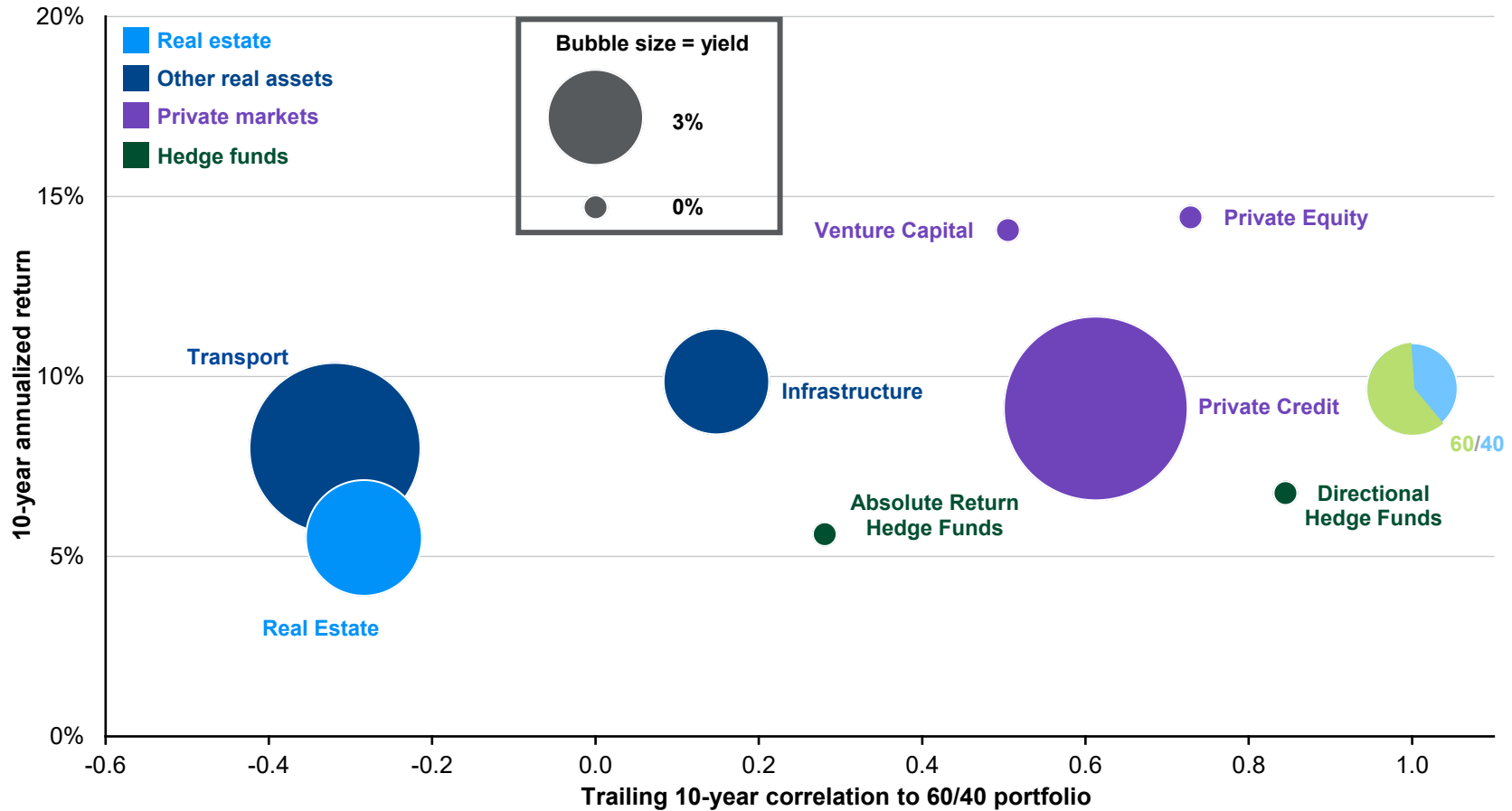

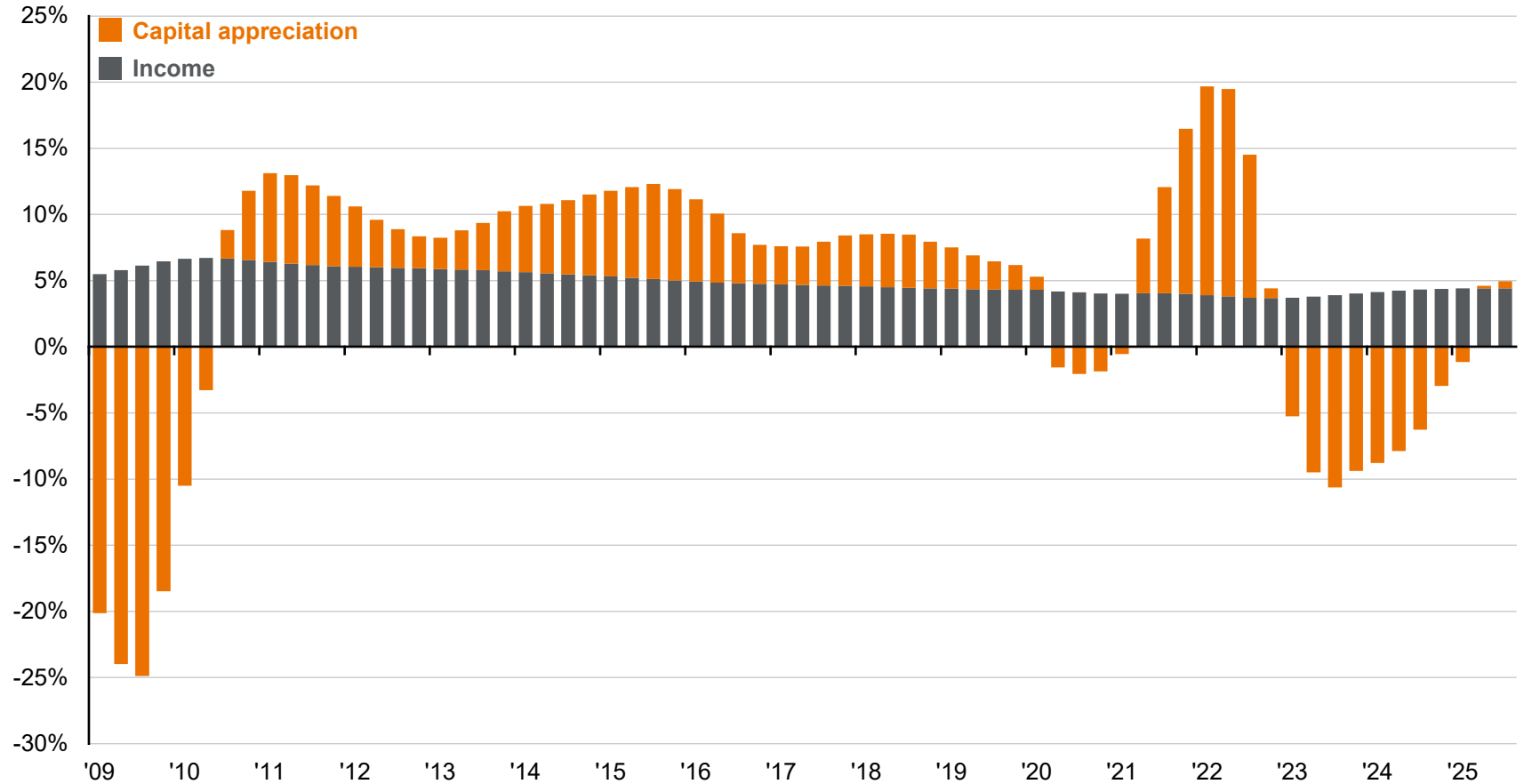

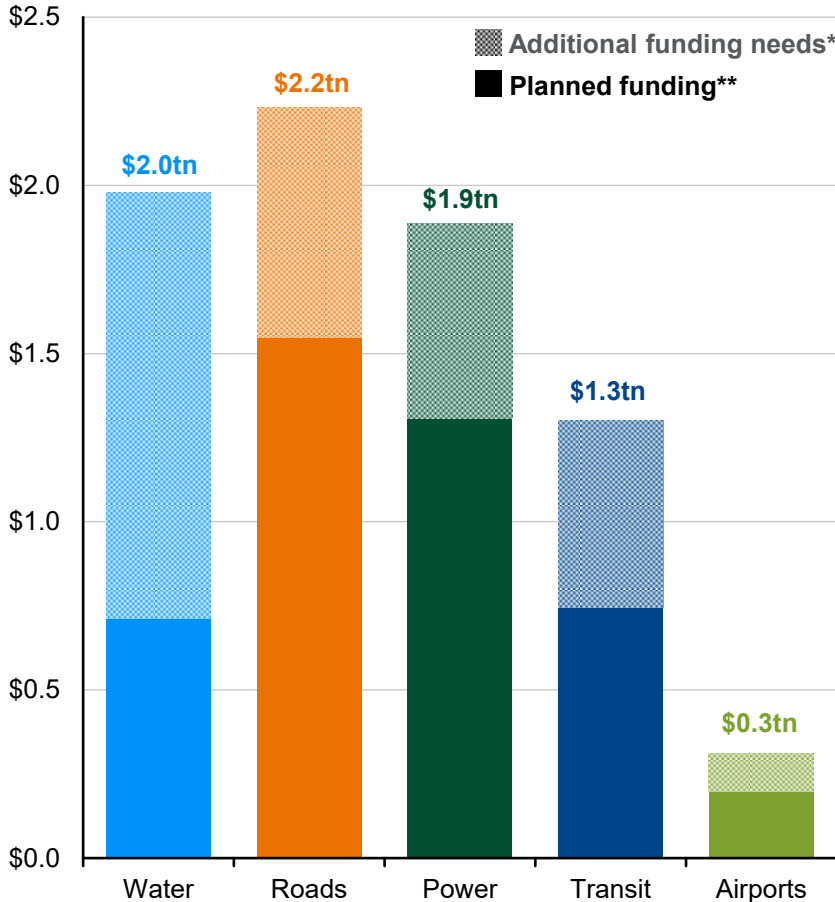

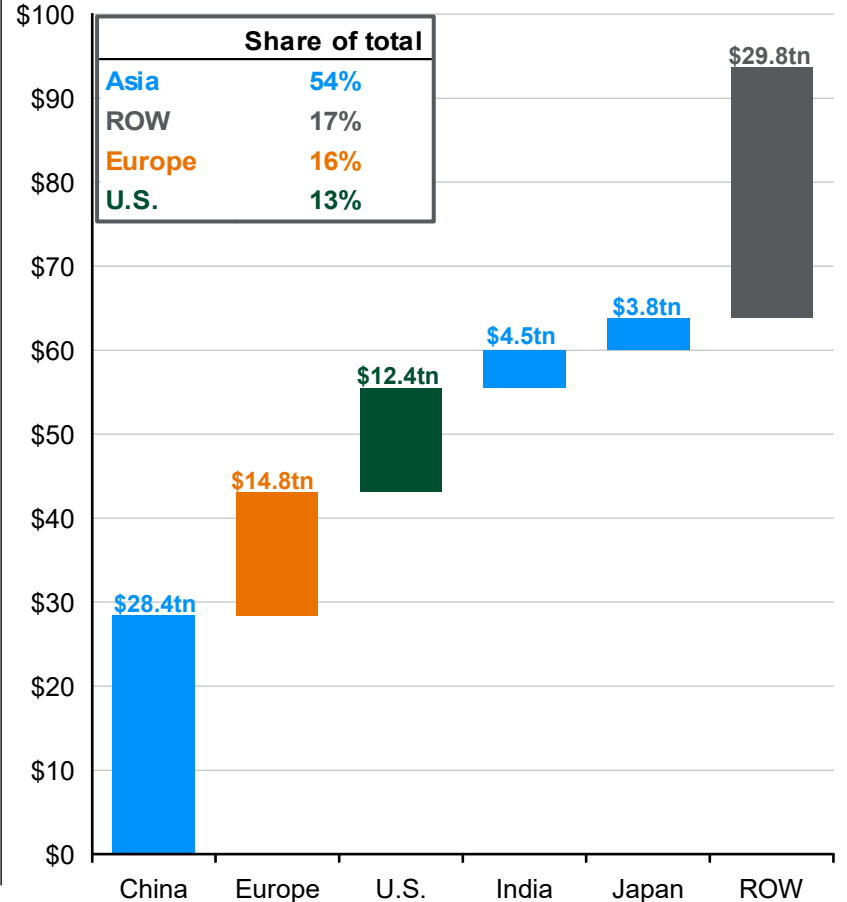
U.S. infrastructure funding & funding gaps

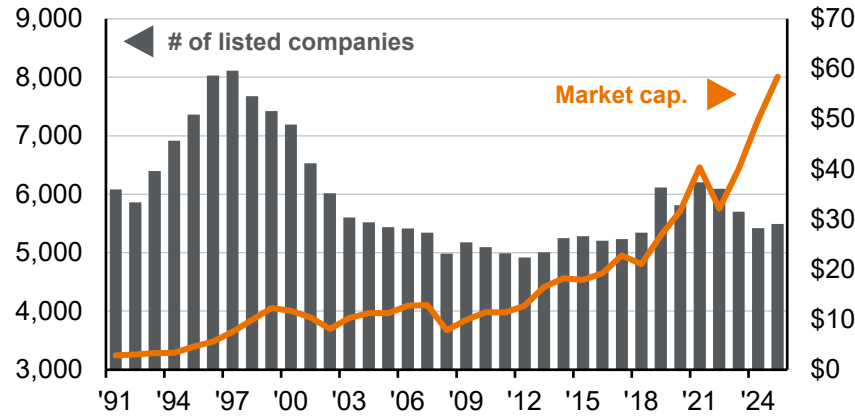

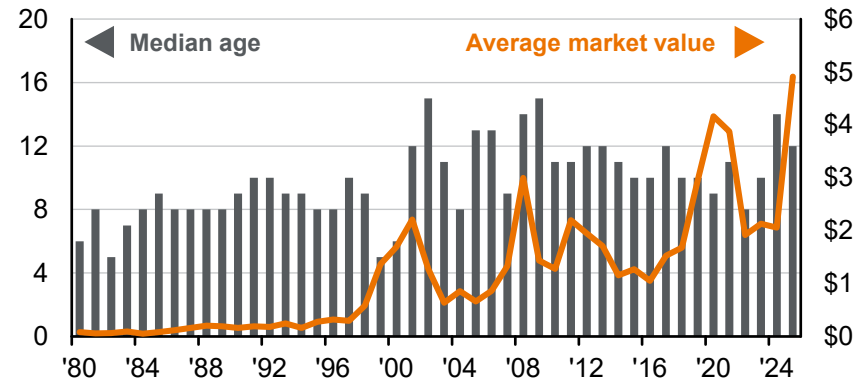

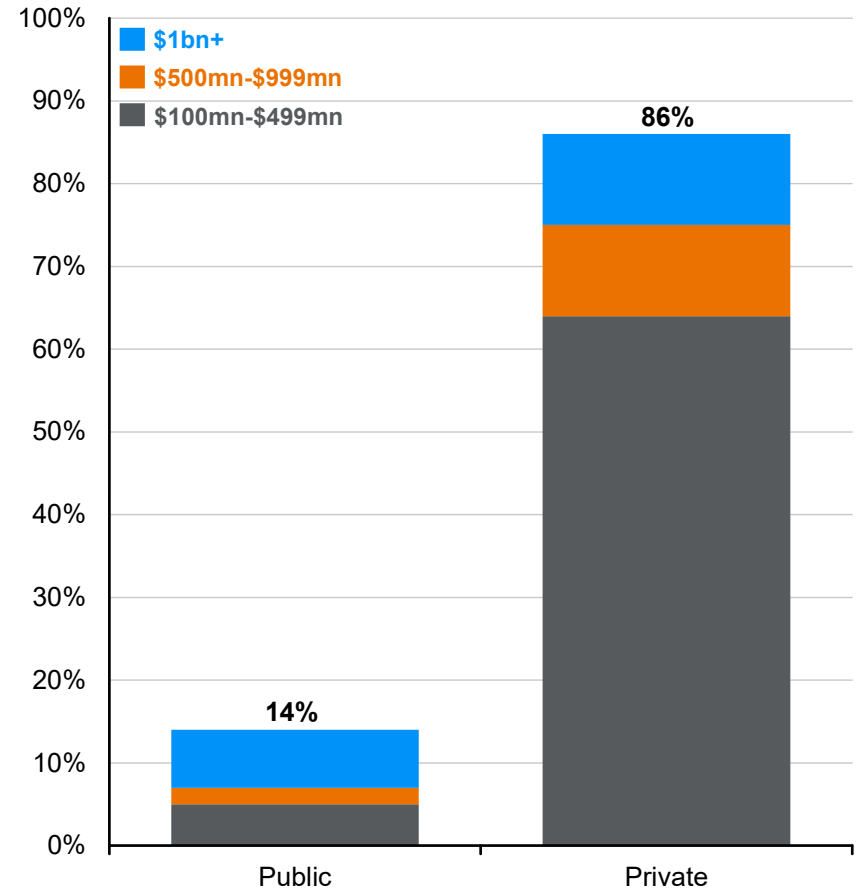
Median age and average market value at IPO

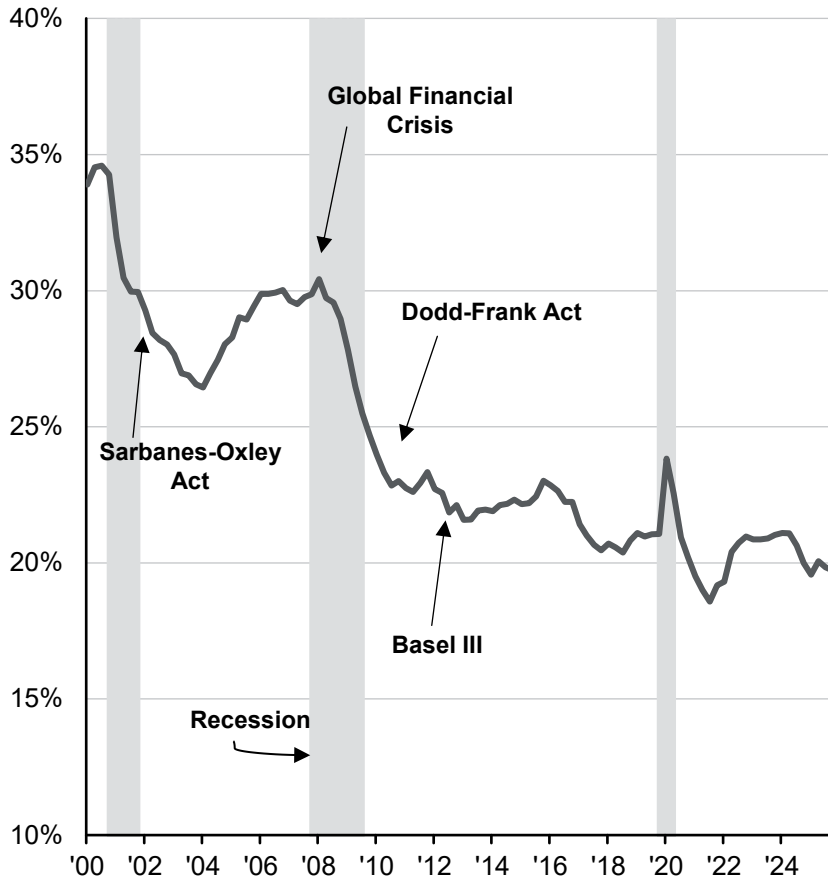


Private credit industry growth

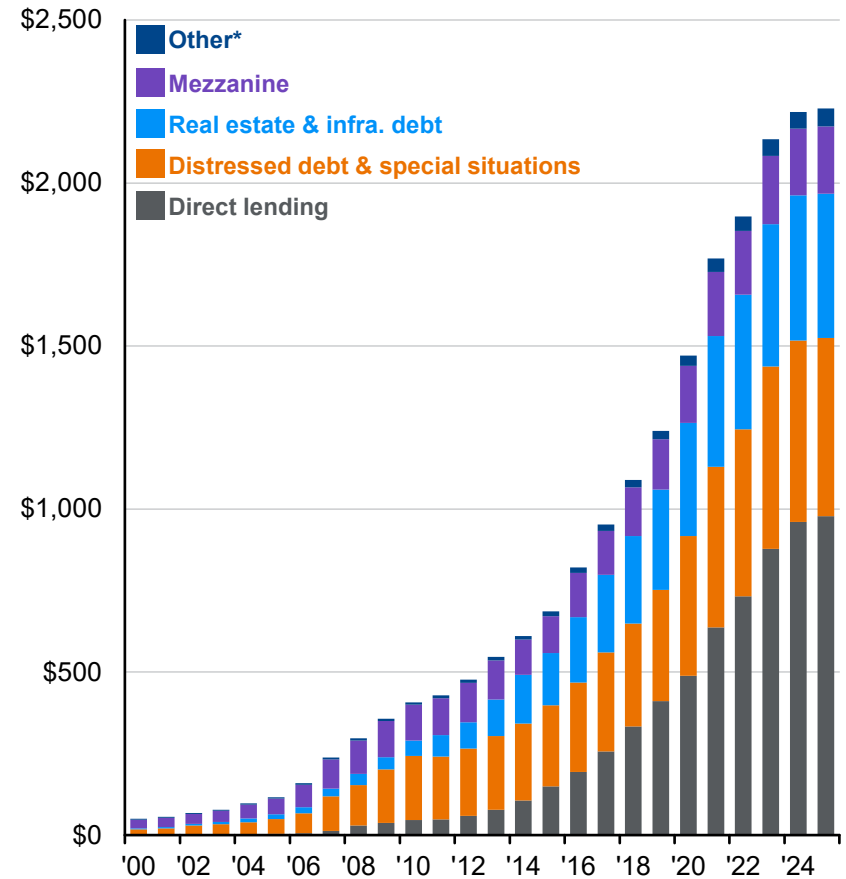
U.S. bank lending

USD billions, end of period



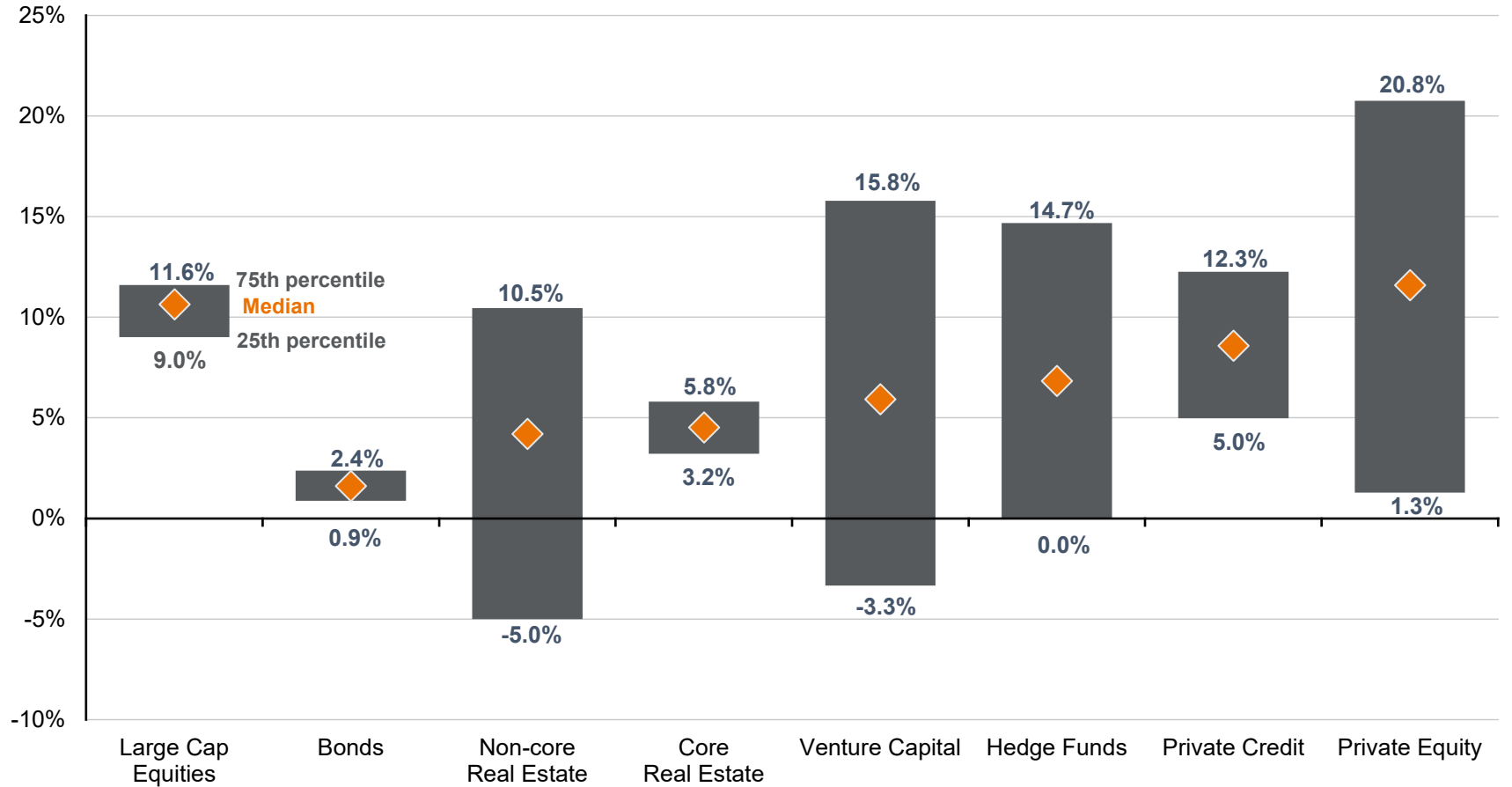

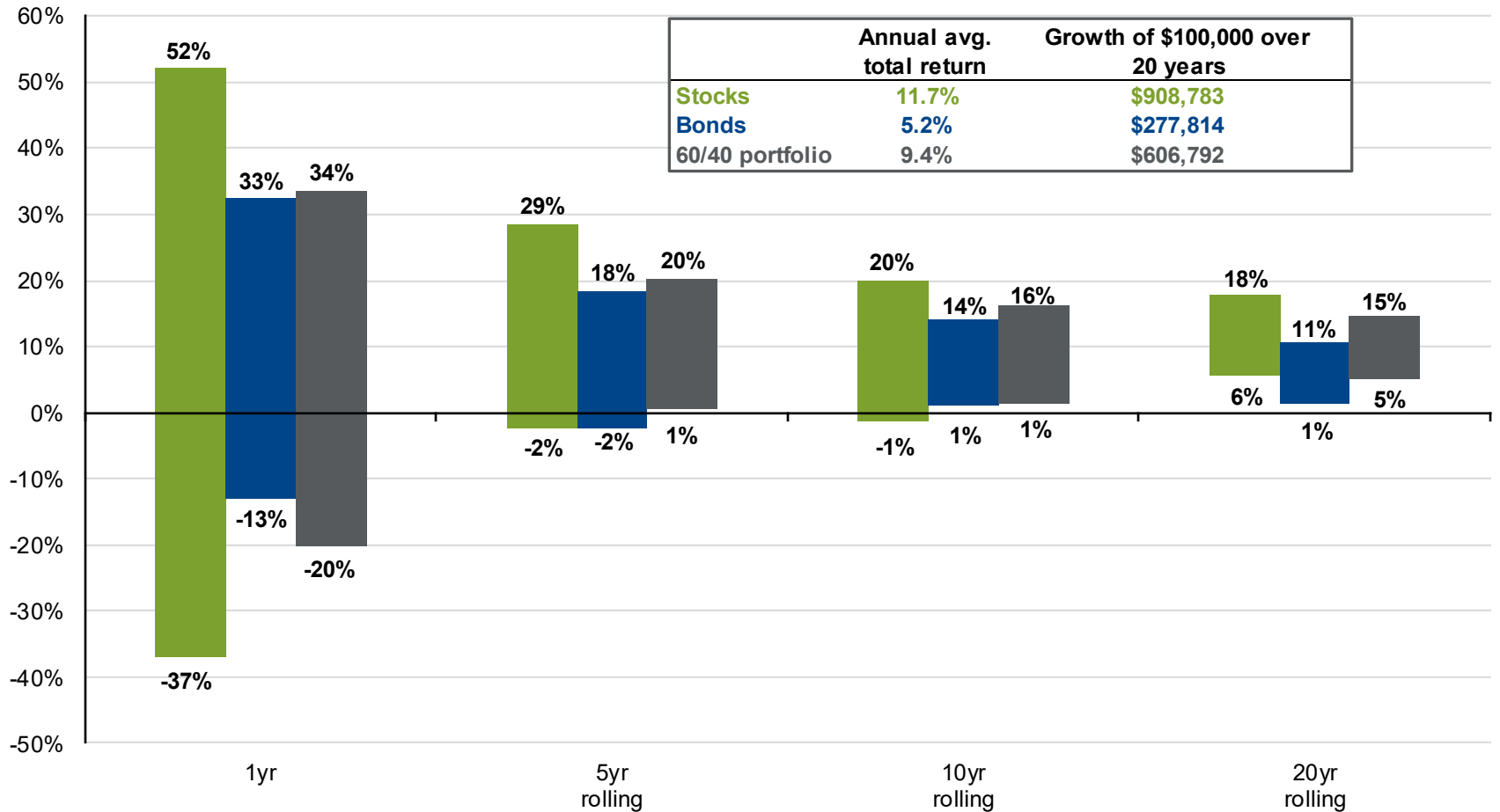

Annual total returns, 1950 - 2025



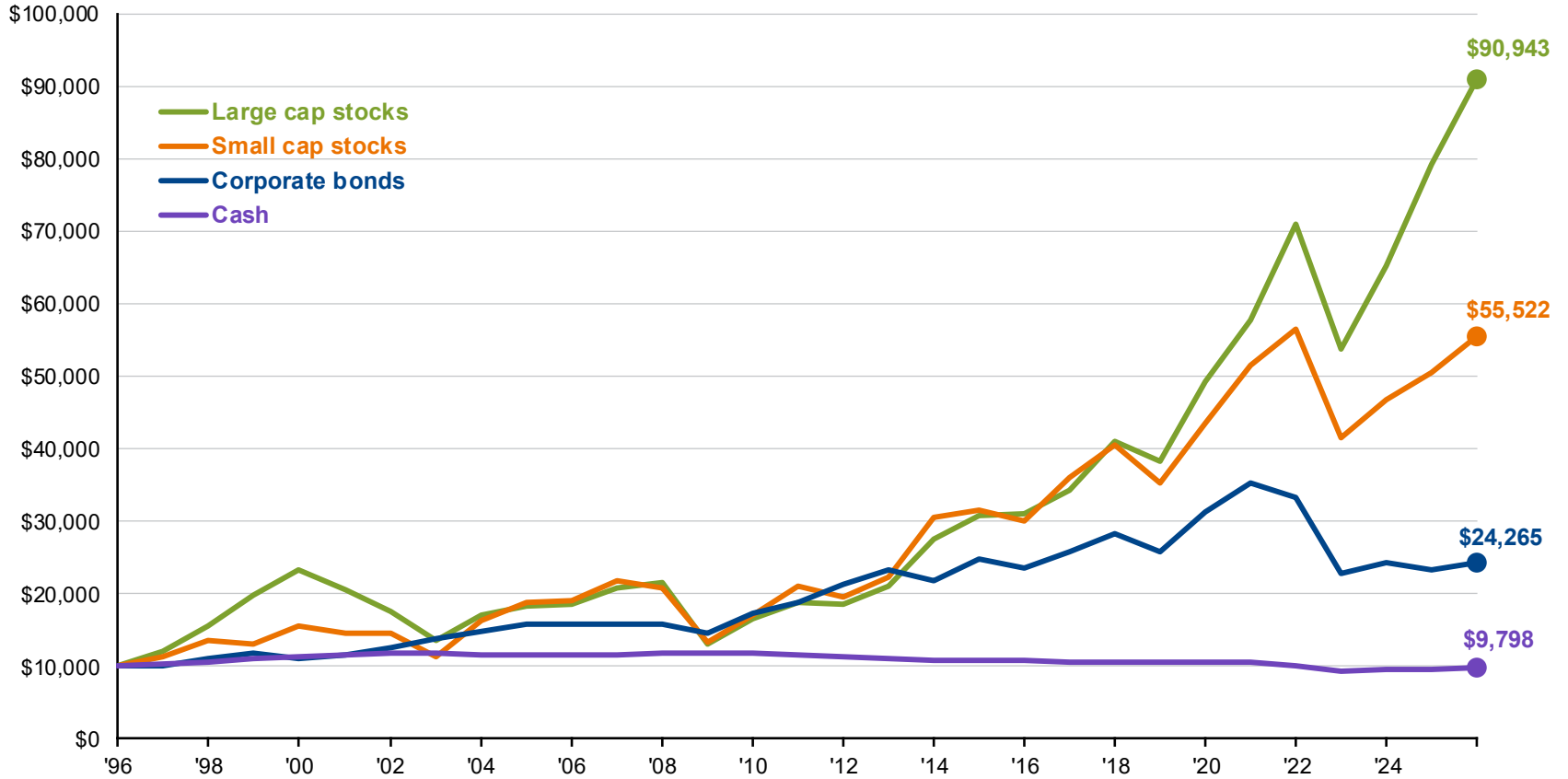

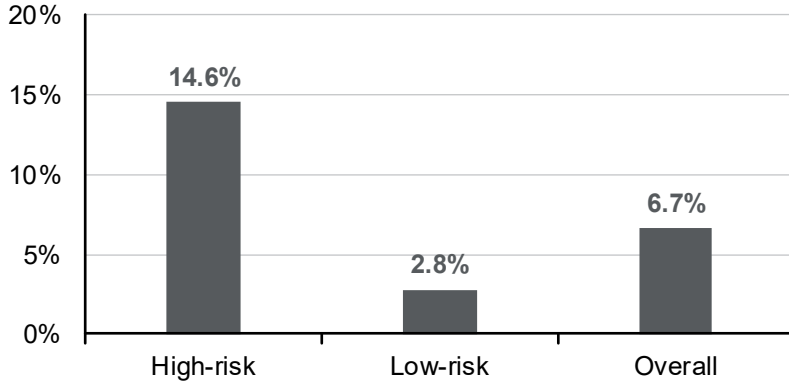

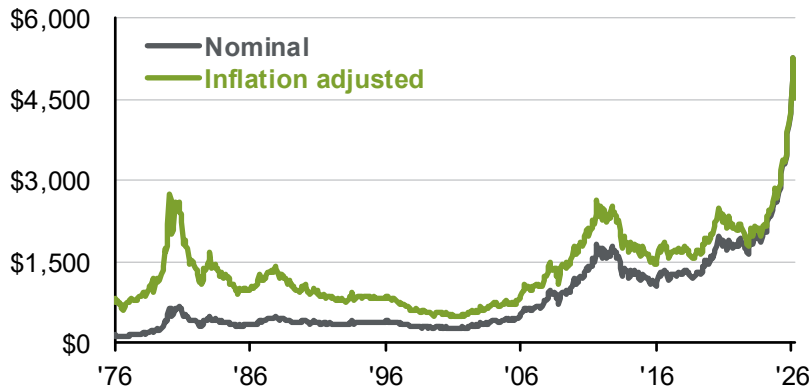
Gold performance across geopolitical risk regimes

Annualized returns, 1986 - 2025



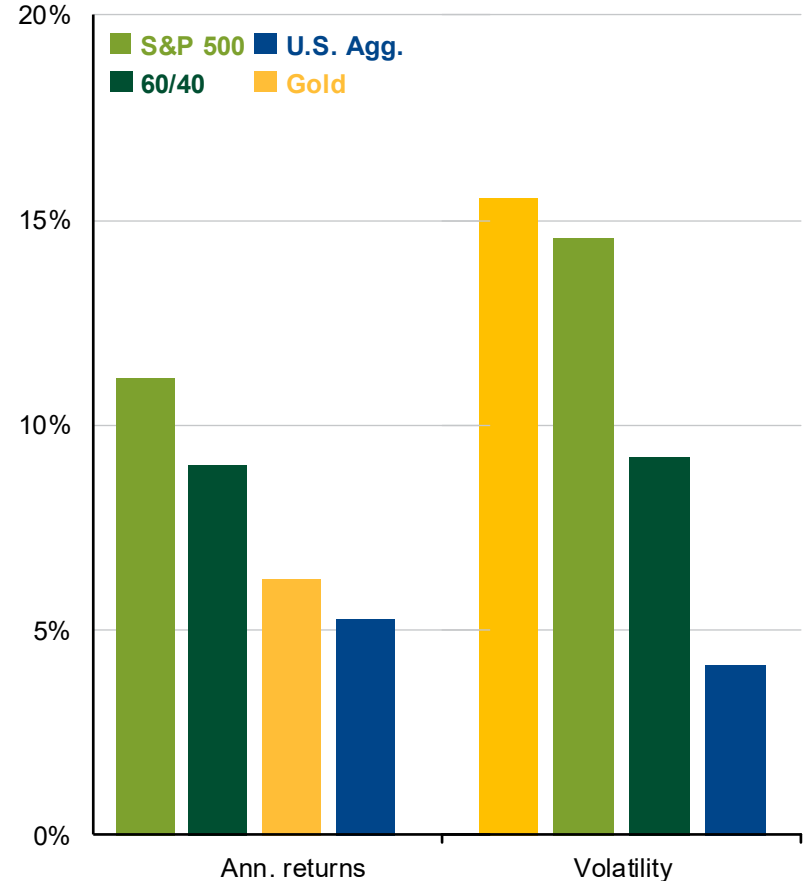
Gold price over time

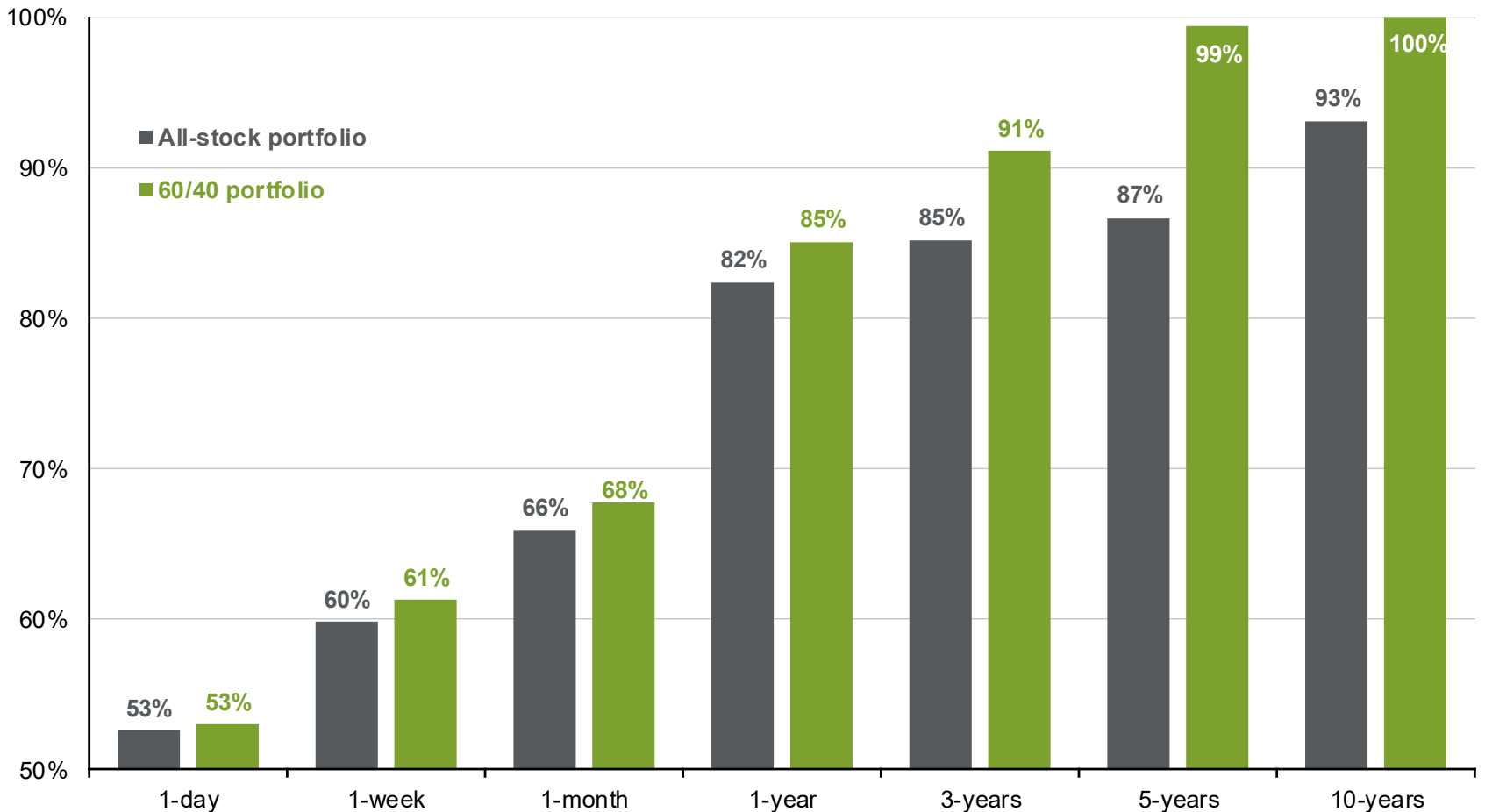

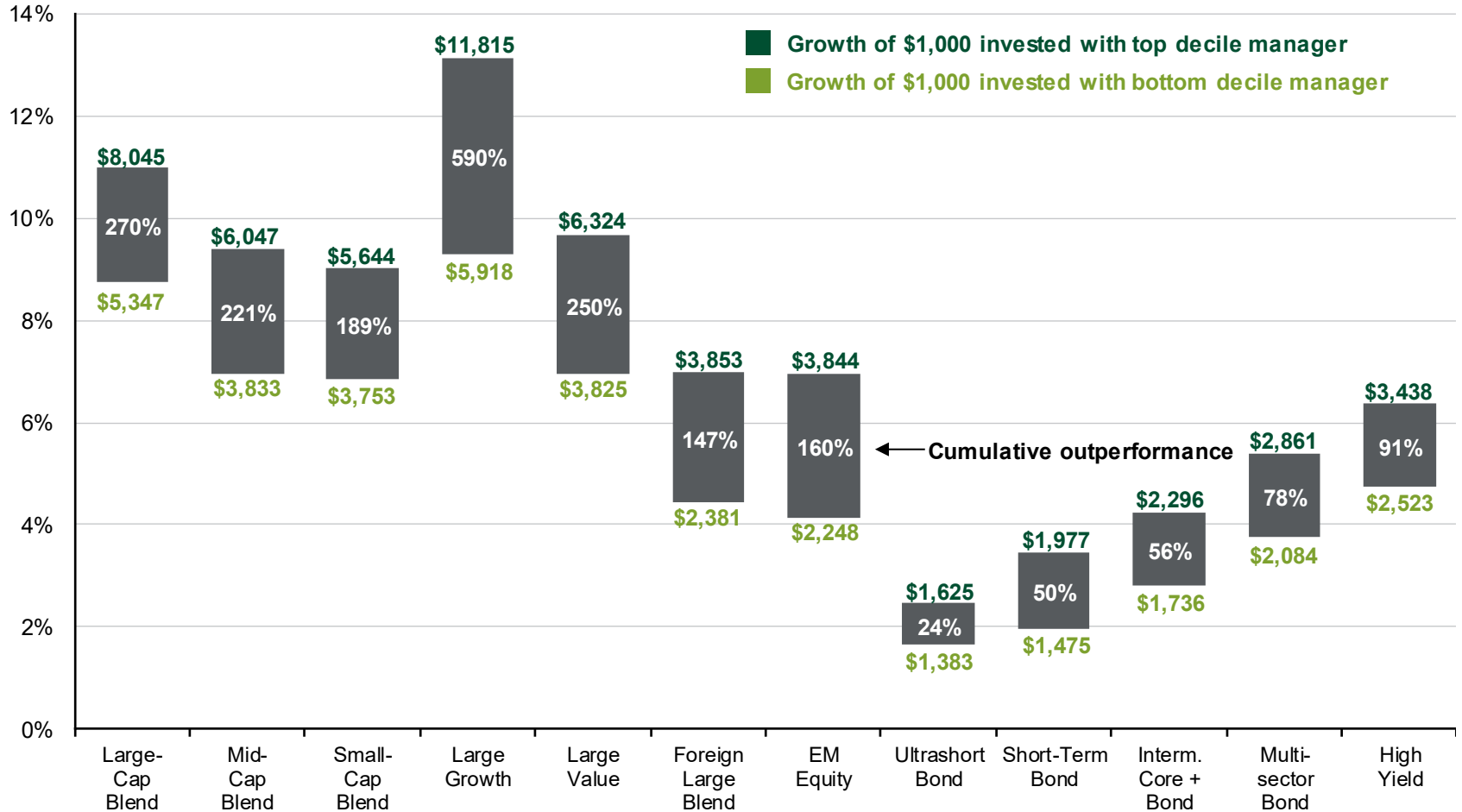

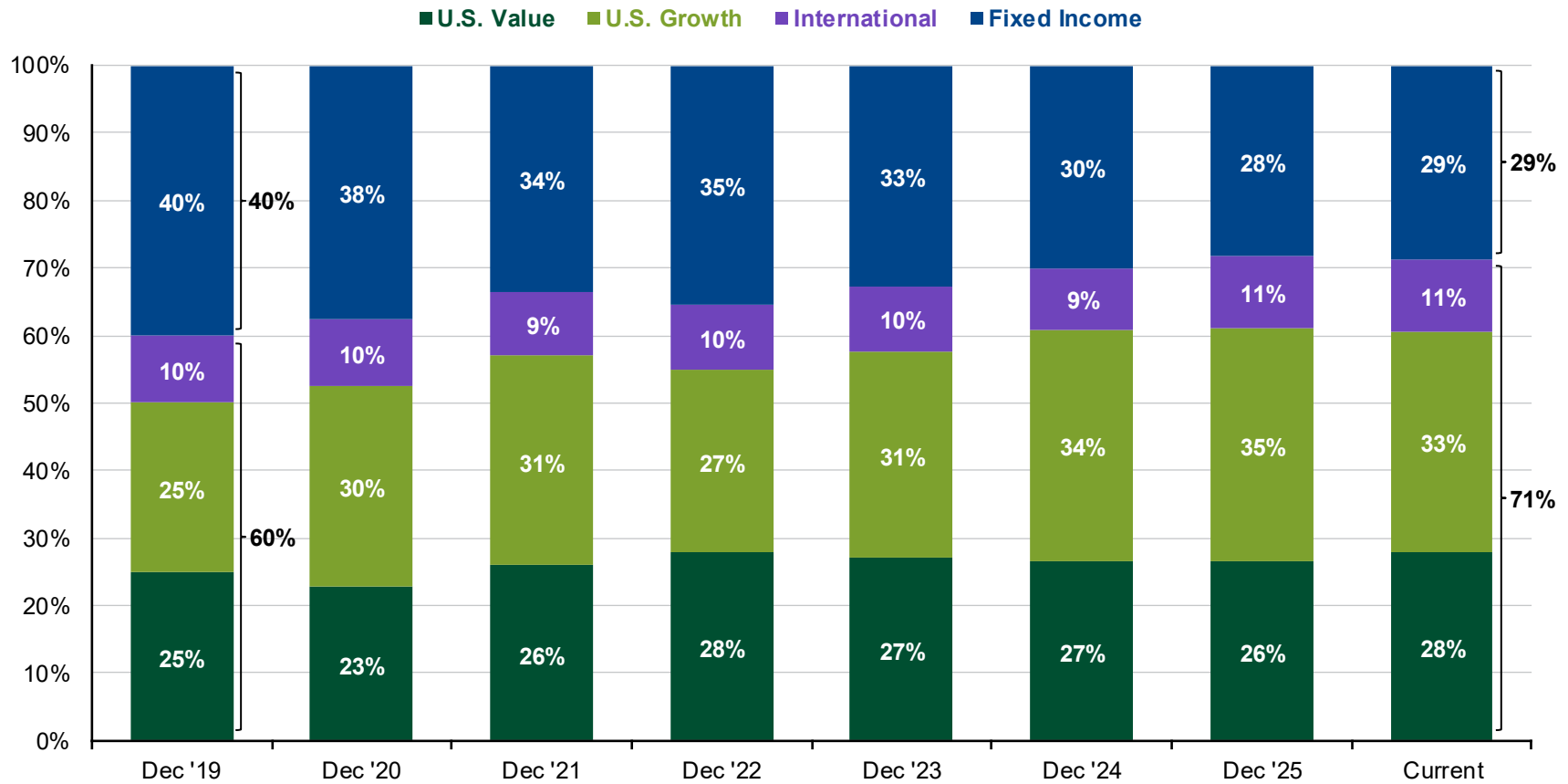

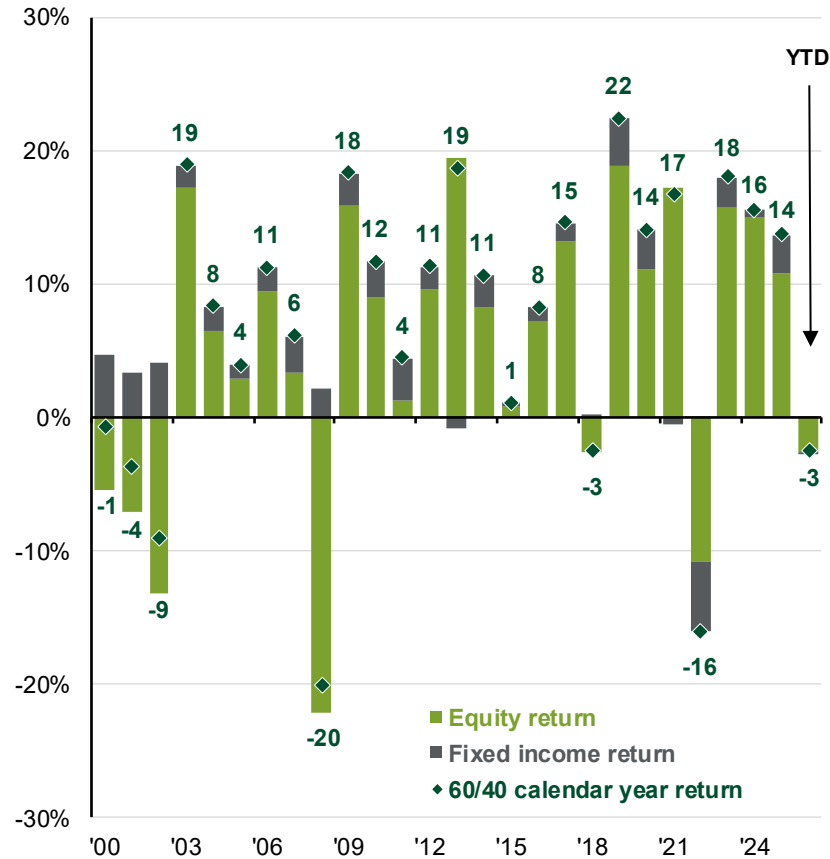

60/40 returns and stock-bond correlation

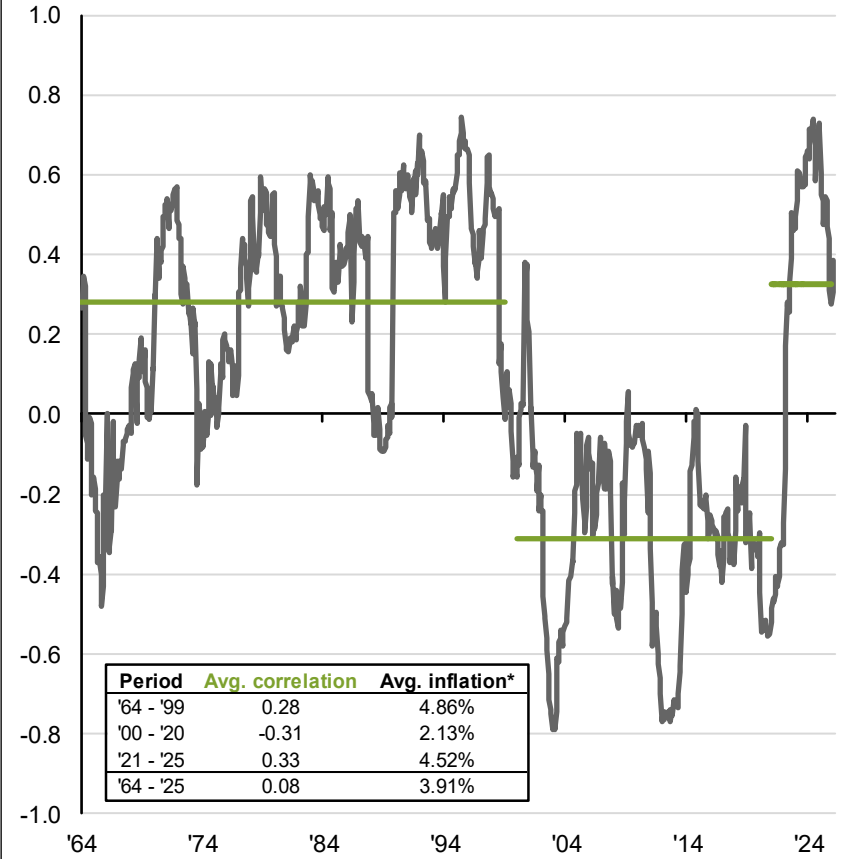
60/40 annual return decomposition

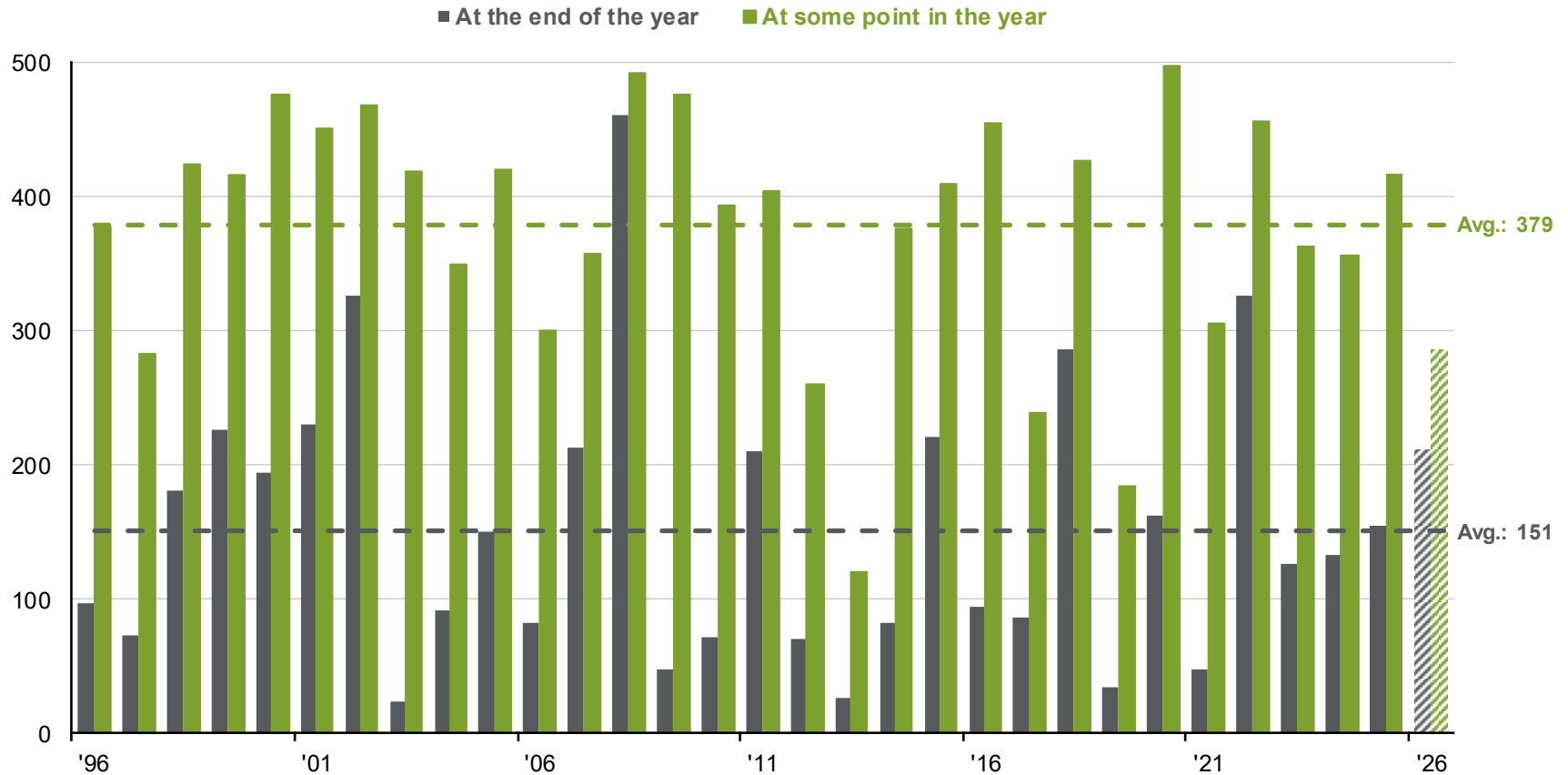

Despite positive index returns in 22 of 30 years, roughly 75% of stocks experienced a drawdown of 5% or more in any given year



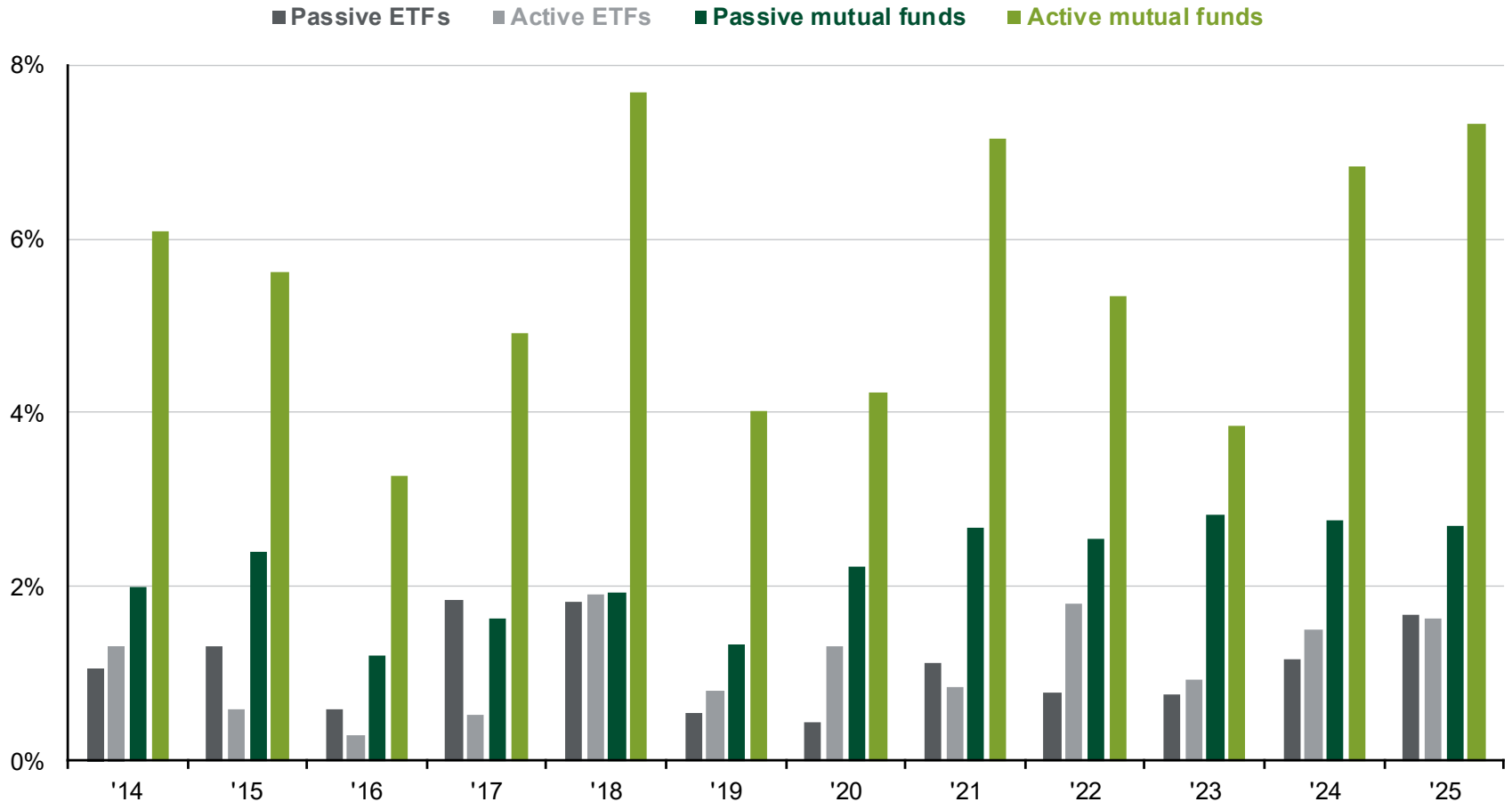

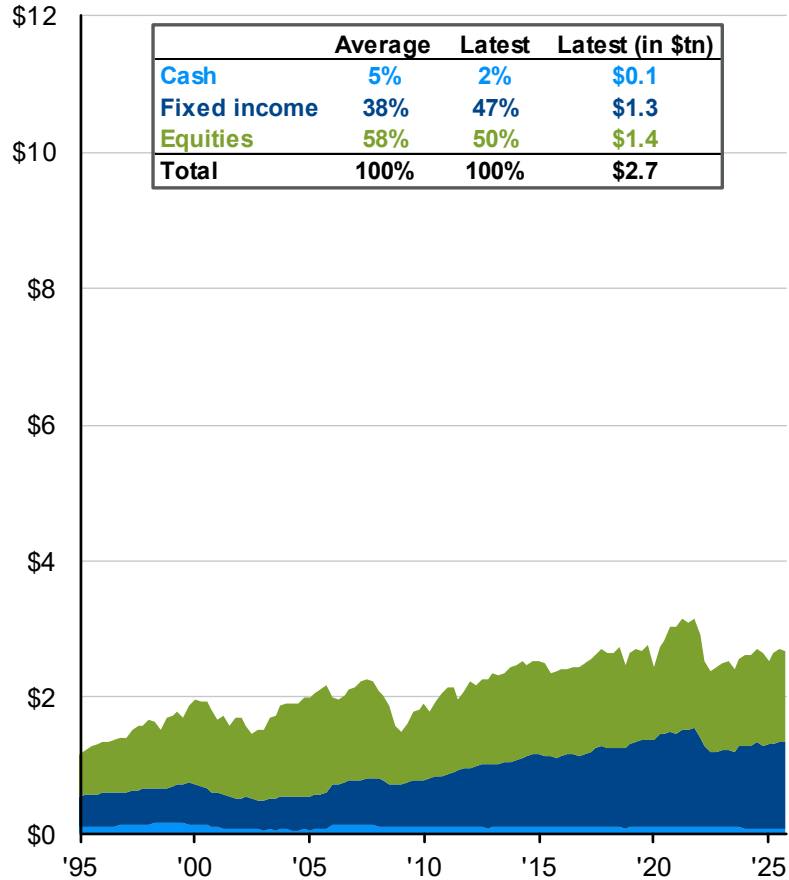

Asset allocation in retirement funds

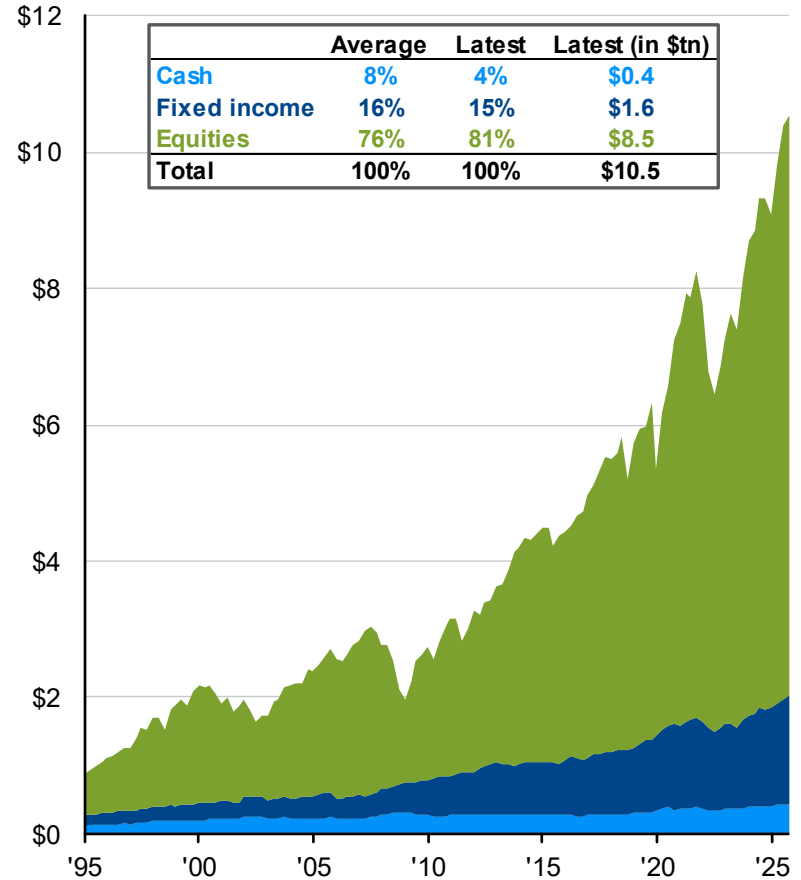

The **Alerian MLP Index** is a composite of the 50 most prominent energy Master Limited Partnerships (MLPs) that provides investors with an unbiased, comprehensive benchmark for the asset class.

The **HFRI Monthly Indices (HFRI)** are equally weighted performance indexes, utilized by numerous hedge fund managers as a benchmark for their own hedge funds. The HFRI are broken down into 4 main strategies, each with multiple sub strategies. All single-manager HFRI Index constituents are included in the HFRI Fund Weighted Composite, which accounts for over 2200 funds listed on the internal HFR Database.

The **NAREIT EQUITY REIT Index** is designed to provide the most comprehensive assessment of overall industry performance, and includes all tax-qualified real estate investment trusts (REITs) that are listed on the NYSE, the American Stock Exchange or the NASDAQ National Market List.

The **NFI-ODCE**, short for NCREIF Fund Index -Open End Diversified Core Equity, is an index of investment returns reporting on both a historical and current basis the results of 33 open-end commingled funds pursuing a core investment strategy, some of which have performance histories dating back to the 1970s. The NFI-ODCE Index is capitalization-weighted and is reported gross of fees. Measurement is time-weighted.

Definitions:
